PROCEEDINGS

The Georgia State Association of Free Will Baptists met with the South Georgia Association at the First Free Will Baptist Church of Jesup, Georgia on Tuesday evening, November 14, 1967 at 7:30 o'clock.

The 31st annual session was called to order by Rev. Kenneth Faison, clerk. The officers were introduced as follows: Promotional Secretary, Rev. Mance Cason; Assistant Moderator, Rev. Odell Harris; and Moderator, Rev. Harris Nix. Singing for the session was under the able direction of Rev. Vernon Maggart. The congregation joined in singing, "All Hail the Power." Rev. Gilbert O'String read Scripture from Duet. 8 and led the group in prayer. Rev. Theron Long, moderator of the South Georgia Association gave the welcome address. Recognition of visitors who were: Dr. L. C. Johnson, president of Free Will Baptist Bible College, Nashville, Tennessee; Rev. Mark Vandivort, representing the National Home Missions Dept. Nashville, Tennessee; Missionary Dave Franks, missionary to Brazil; Rev. A. J. Lambert, Rev. Carlton Lambert, Rev. L. B. Nix, and Mrs. Smith all from the Children's Home, Eldridge, Alabama. The program presented by the program committee was adopted with the moderator having the privilege to make minor changes if necessary.


The committee on committees was appointed: Callis Brannen, Gilbert O'String, Alton Everson, Edward Kimbrell, Gleason Fowler, William Travis, M. M. Franks, and C. B. Dowdney.

The congregation was led in singing "Rescue the Perishing" by Rev. Maggart. Special music was rendered by a quartet of ministers: Vernon Maggart, Kenneth Faison, James Ursrey, and Damon Dodd. They sang "Power in the Blood." The evening message was delivered by Dr. L. C. Johnson on the subject "The Power of the Preached Word." Using the scripture II Timothy 3:1-17, he pointed out that God's word is Holy and sacred. God used holy men to write the Bible, and that Word produces power and brings results.

The registration committee gave a partial report of 23 ministers, 34 delegates including 13 deacons, 40 visitors making a total registered thus far of 97. This partial report was adopted by the association. After recognizing the host pastor, Rev. J. E. Blanton for the placements, we were adjourned until Wednesday morn-ing at 9:30 o'clock.

WEDNESDAY MORNING--NOVEMBER 15, 1967--9:30

Song and prayer service led by Rev. Maggart. Prayer by Rev. Odell Harris. The moderator's message was delivered by Rev. Harris Nix. New pastors in the state were recognized. They were: Rev. Luther Reed, Satilla Church near Hazelhurst; Rev. Charles Hollingshead, First Church, Albany; Rev. Milton Fields, First Church, Blakely; Rev. Malone Cobb, Pine Level Church, Alma; and Rev. Calloway, Arlington.



We were led in singing "He Lives" by Rev. Kenneth Faison. Rev. Carlton Lambert gave a report from the Free Will Baptist Children's Home at Eldridge, Alabama. He expressed appreciation to Georgia Free Will Baptists for Harvest Day drive in October, which amounted to \$14,804.19. Motion, second to adopt report as information. Carried. Credentials committee reported. Motion to receive report and seat delegates. Carried.

Rev. Maggart led us in singing "Jesus Saves." The committee on committees gave their report as follows: NOMINATION: Grant Severance, J. B. Rice, and Eva Clenney. RESOLUTIONS: J. B. Mercer, Charles Hollingshead, and Vernon Maggart. Motion, second, to adopt. Carried.

The Budget committee was appointed: W. L. Purvis, Vernon Maggart, J. B. Mercer, Hermon Watson, Billy Livesay, Frank Newberry, Katherine Roddenbery, and Lorene Edwards.

As we entered into the worship period, Rev. Maggart led in singing "Tell me the Story" and "Faith is the Victory." An offering for the Cooperative Plan was received in the amount of \$82.00. Prayer by Billy Livesay. A motion, second that the study committee take into consideration a constitutional change involving the budgeting committee. Carried.

Mrs. Edward Kimbrell sang "It Took a Miracle."

The message was delivered by Rev. J. B. Mercer using as the subject "Thy Word is Truth." Text II Timothy 2:15-23. A very interesting message was brought after which we were dismissed in prayer until the afternoon session.

WEDNESDAY AFTERNOON--NOVEMBER 15, 1967--1:30

Song and prayer service led by Rev. Maggart. Devotional was by Rev. William Travis, using Psa. 28:25.


The report of the Executive Board was given by Rev. Kenneth Faison. (See report) A motion, second, to adopt item by item. Each item was adopted.

The promotional secretary, Rev. Mance Cason gave his report to the body and was adopted. (See report.)

President of Free Will Baptist Bible College, Dr. L. C. Johnson, gave a report of the Bible College. He placed emphasis on the expansion campaign, stating that 3 churches in Georgia had given \$1000.00 for expansion. They are Jesup, Okefenokee church at Waycross, and Pine Level near Alma. At least two others had made committments and were paying on that. Motion, second to accept report as information. Carried.

Rev. Roger Reeds, representing the National Sunday School dept. gave the report of his department. Among other things, he pointed out the fall enlargement campaign theme for 1968 will be "Doorways Unlimited." Also to encourage each church to have a teacher training course was an important aspect of the Sunday School department. Report received as information.

Rev. Charles Hollingshead presented the report from the National CTS department. Many things of interest was brought out including the all-out effort to promote more and vigorous youth activities during our National Association in Okla-



State Sunday School Convention report was given by Rev. J. B. Rice. (See reports) Motion to receive Sunday School report as information. Carried. **UUNY**

State CTS Rally report was given by Mrs. Edward Kimbrell. (See report) Received as information.

Motion by Rev. Cason to refer items from State Sunday School and State CTS conventions that require action of this body to resolution committee. Carried.

The State Woman's Auxiliary Convention report was given by Mrs. Billy Hatcher. Motion to accept as information and place in the minutes. Carried. (See reports)

The State Superannuation Board report was given by Leron Clower. Motion to adopt was carried. (See reports).

The special study committee that was appointed at the 1966 session made its report read by Rev. Damon Dodd. Since this required a change in the constitution, a motion, second and carried to lay on table until Thursday morning.

Rev. Emmett McDuffie gave a report of the State Ministers Association. Motion to accept report and place in minutes along with the Ministers constitution another year, and be paid for by minister's association. Carried. (See reports.)

Motion by Curtis Gay to adopt the Harvest Day drive for the Children's home, Eldridge, Alabama as an annual project the third week of October. Carried.

Motion to adjourn until the evening service. Dismissed in prayer by Rev. Emmett McDuffie.

WEDNESDAY EVENING--NOVEMBER 15, 1967--7:20

Song and prayer service led by Rev. Maggart. Prayer by Rev. Walter Keheley. The State Mission Board report was given by Rev. J. E. Blanton. Motion to receive report and adopt recommendations. Carried. (See reports).

Letters from Rev. Homer Willis, director of the National Home Mission Board, and from Rev. Sam Wilkinson, missionary to Brazil were read and received as information. The National Foreign Missions Department was represented by letter from Rev. Henry Van Kluyve, director of deputation. Letter received as information.

Special music was rendered by the Roddenbery Sisters of Philadelphia Church, Folkston, Georgia. Also Beth and Linda Smith of First Church, Savannah.

The evening message was delivered by Rev. Mark Vandivort, of the Home Missions Department on the subject "The Challenge of World Evangelism." A very impressive commissioning service for our two state missionaries, Rev. Hubert Henderson working at Sylvester; and Rev. J. E. Blanton who will be working in Atlanta, was conducted by Rev. Damon Dodd assisted by Rev. Rolls Smith. The scriptural charge was given by Rev. Smith; The dedicatory prayer was prayed by Rev. Dodd. The State Mission Board along with the ministers present assisted in the service. The service was concluded by the congregation's fellowship and blessing with a missionary offering of \$94.72. Many came in rededication of their lives to Christ. The service was a real blessing to each one. Dismissed until Thursday morning session.



THURSDAY MORNING--NOVEMBER 16, 1967--9:00

Song and prayer service led by Rev. C. B. Dowdney. Prayer by Rev. Emmett McDuffie. The devotion was rendered by Rev. Billy Livesay, reading from Phil. 2.

Motion to take from table the partial report of the special study committee relating to constitutional change, present to the body for action. Carried. Motion to receive partial report of study committee and deal with item by item. Carried. (See Reports)

Item #1-Read and adopted.

Item #2-Read and amended as in reports section.

Item #3-Read and adopted.

Item #4-Read and adopted.

Motion to adopt the study committee report concerning the duties of the Promotional Secretary. Carried. (See reports). Motion to carry these duties in state minutes each year. This was amended to read 'until such time as a By-Laws committee can arrange By-Laws section of constitution to include duties of promotional Secretary and standing boards who does not already have them.' The amendment was adopted and also the main motion. Motion to appoint a By-Laws committee to draft By-Laws of Association and report at next session-1968. Carried. Committee appointed: Carlton Houston, O. B. Everson, Billy Livesay, Grant Severance, and James Ursrey. Motion to release special study committee. Carried.

The Board of Christian Education report was given by C. J. Faison. (See reports). Motion to adopt was carried. Motion to adopt financial report of this Board also was carried. (See Reports).

The CampBoard report was given by Wallace Franks. (See Reports). Motion to adopt was carried. Announcements by campdirector, Kenneth Faison, were made relative to the youth retreat Nov. 23-25 at Camp Mt. Bethel.

Trustee Board made its report by Curtis Gay. (See Report) Motion to adopt report was adopted. Also to adopt their recommendation in report was carried. The registration committee gave its final report which was adopted. (See report).

The Auditors report was given by Earl Tabb. The report was adopted. The resolutions committee report was given by Charles Hollingshead. (See reports) Motion to receive report and act on item by item. Carried.

Items 1-6 was adopted as they appear in reports section-Item 6B was amended and is reported as amended.

Song service was led by Rev. Maggart. Special music was rendered by the quartet of ministers-Grant Severance, Kenneth Faison, James Ursrey, and Damon Dodd. The message was delivered by Rev. Charles Hollingshead using the subject "God Is Not Slack Concerning His Promises." Dismissed in prayer by Malone



THRUSDAY AFTERNOON--NOVEMBER 16, 1967--1:30

Singing was led by Rev. Maggart. Prayer by Buddy Morris. Moderator Nix read letter from Rufus Coffey, Executive secretary of National Association. The Budget Committee gave its report and a motion to adopt item by item was adopted. (See reports).

Nomination committee gave report. Motion to elect Board by Board was adopted. (See Reports).

Delegates to the National Association were appointed: O. B. Everson, Billy Hatcher, Hermon Watson, Mr. and Mrs. Gleason Fowler. Motion that Moderator or Promotional Secretary be authorized to fill quota of delegates in the event these cannot attend. Carried.

Motion to charge the Executive Board with the responsibility of making a study of the advisability of continuing the State Paper on free subscription basis or paid subscription basis and also the setting up of a state bookstore.

Motion to list first four names on Christian Education and Camping Board and the Budgeting Board terms to expire in 1969; the last four on these two boards terms to expire in 1971. Carried.

Motion to accept invitation to meet with the Chattahoochee Association, Thomaston, Georgia for our 1968 session. Carried.

Motion to extend rising vote of appreciation to South Georgia Association and Jesup Church for their hospitality shown during this session. Carried.

The placement committee was appointed: Damon Dodd, C. J. Faison and Charles Hollingshead.

Motion to elect Bill Lofton as State C T S Convention President. Carried. Motion to adjourn. Carried.

Dismissed in prayer by Harris Nix,

REPORT OF THE PROMOTIONAL SECRETARY

"And all things are of God, who hath reconciled us to Himself by Jesus Christ and hath given to us the ministry of reconcilation." II Corinthians 5:18. This year, perhaps as never before, we have sensed the urgency of our ministry as we seek to be instruments of God by which He reconciles men unto Himself. It has been a great joy and a privilege for me to serve this Association as Promotional Secretary again this year and I wish to express my sincere appreciation for the support which you have given to us in the work of promoting every ministry of the Free Will Baptist denomination. We trust that through our mutual endeavor there have been many who have come into the right relationship to God through Jesus Christ our Saviour. PROMOTION: Again this year we have traveled many miles in the interest of the work of our State Association. It was my privilege to visit with many of the churches and to present our program of worldwide ministry and it has been most gratifying to witness an enthusiastic acceptance of the program by both pastors and congregations. Several churches has



begun this year giving ten percent of their income to a world-wide ministry through the Cooperative Plan. Other phases of our work has also been more largely supported this year than here-to before.

It is encouraging to see the progress being made in each of the district associations relative to our total denominational ministries and especially the interest toward establishing new Free Will Baptist churches. At present we have five new missions in the State which reports meeting with good success. Of course, we are all thrilled about Bro. J. E. Blanton and family becoming our missionaries in our capitol city early next summer.

In March of this year, I attended a meeting for State Promotional Secretaries and Directors of the different departments of the National Association that was held in Nashville, Tennessee. Also the National Association which met in Jacksonville, Florida.

Other areas of promotion has included itinerates for both home and foreign missionaries, workshops and Teacher Training Courses.

PROMOTIONAL BULLETIN: Our State Pulbication is now going into more than

1,300 homes each month and the mailing list continues to grow each month. More and more we are endeavoring to use the publication as a medium to acquaint our people with each phase of our ministry as well as news of activities around the State and throughout the denomination.

OUR STEWARDSHIP: Denominational giving for the year was \$46,407.58 for all state and national ministeries. Of this amount \$17,596.28 was given through the Cooperative Plan of Support. We are grateful for the growing interest and support in the Cooperative Plan. A six year comparison follows:

Activities of the Board this year has been sponsoring a Bible Institute, Minister's Retreat, assisted one student in attending Free Will Baptist Bible College and continued its service in the 14 area of encouraging students who have secured previous loans from the Board to begin re-payment of their loans immediately. Our financial report will reflect a payment by one student in the amount of \$1000.00. The Bible Institute sponsored by the Board was under the auspices of the Extension Department of Free Will Baptist Bible College. We had 17 ministers, 1 missionary and 32 laymen to attend the five day Institute, with courses taught by Rev. Ralph Hampton, in New Testament survey and Church Administration. Seventy-one persons attended the Minister's Retreat which met under the general theme, "Evangelism-Christ's Imperative Commission."


MISSIONS BOARD GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS





Missions - 42% Superannuation - 22%, Christian Education and Camping -20%, Children's Home - 6%, Trustees - 10%.



REPORT OF SPECIAL STUDY COMMITTEE

The special study committee appointed at the 1966 session of the Georgia State Association of Free Will Baptists, after careful and thorough research, prayerfully and respectively submits the following recommendations and observations. Item #1. That the duties, functions, and treasuries of the Board of Christian Education and the Camp Board be consolidated into a single Board to be known as the Board of Christian Education and Camping. Members of this board shall be elected according to the provisions of Article III, Section 1 of the constitution of the Georgia State Association of Free Will Baptists.

Item #2. That Article III, Section 3, of the constitution of the Georgia State Association of Free Will Baptist be amended as follows: "There shall be a board of Christian Education and Camping whose duties shall be:

A. To schedule and arrange all Camp sessions to be held at Camp Mt. Bethel, and to nominate the camp director. It is understood and agreed in this connection that the camp director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.

B. To schedule and arrange all study courses, Bible Institutes, Minister's Retreats, and all other educational services or programs sponsored by this State Association.

C. To administer loan funds for students attending or desiring to attend Free Will Baptist Bible College in Nashville, Tennessee, under these stipulations,

- a. That a promissory note be drawn for the face amount of the loan at the time it is made, bearing the signature of the borrower and a qualified co-signer.
- b. That the note be properly executed and notorized.
- c. That repayment on all loans begin one (1) year after graduation or one (1) year after the date of any prior termination of the college program by the borrower, and that repayment be over a period of five (5) years on a monthly basis at the rate of 3% interest per annum on the unpaid balance.
 - d. That all interest charges on loans to ministerial students be cancelled from year to year, provided that after graduation the minister serves as a full-time pastor in the state of Georgia, or as a missionary under the Foreign or Home Missions Boards of the National Association; and

and a second second

provided that he is punctual in making all monthly payments as due. Consistent and deliberate failure to repay the loan or any part thereof, without good or legal cause, shall constitute forfeiture of this interest --cancelling clause.

- e. That a duly designated representative of the Georgia State Woman's Auxiliary Convention be present at each meeting in which any application for a student loan is considered.
- d. To keep this body informed of all Christian Education projects and programs sponsored by the body and to offer such recommendations as they shall deem proper from time to time.

Item #3. That Article III, Section 5, of the constitution be amended as follows: "There shall be a Board of Trustees whose duties shall be to hold title to all real properties belonging to this Body; the maintenance and upkeep of all such properties; and the planning and supervision of all future developments and expansions of these properties as directed by this Association.

It is agreed in this connection that the Board of Trustees shall at no time sell, rent, lease, nor otherwise convey or use any of these properties for gain without the express consent of this State Association; nor shall the Board of Trustees encumber these properties by mortgage, lien, nor otherwise, without the express consent of this Body.

The Board of Trustees is hereby authorized to receive in behalf of this State Association gifts, grants, monies, real estate, or other valuable assets.

The Board of Trustees shall act in behalf of this Association and for this Association in any and all transactions involving its properties, but shall do so strictly in accordance with instructions given by said State Association.

Item #4. That Article III, Section 7 be altered as follows: "There shall be a Budgeting Board whose duty it shall be to formulate the budget for the State Association annually, and to determine the allocations to be observed in the Cooperative Plan."

SUPPLEMENT TO THE REPORT OF THE SPECIAL STUDY COMMITTEE

In connection with the matter which we were instructed to study, the committee felt it necessary to take a look at the various educational programs sponsored by this State Association. Our findings convinced us that we were not giving the proper emphasis to the Sunday School and CTS Departments of our work. These conventions have become in a measure largely sterotyped. This is not a reflection on either of these organizations nor their leadership personnel.

It is a fact that Sunday School and CTS complement each other. Teaching and Training go hand in hand and one without the other is like the arm without the hand. None of us would think of denying the worth of the Sunday School as a teaching agency; nor would we belittle the value of the Training Service of the CTS. By the same token we realize the value of interaction and cooperation between the two

without divorcing the one from the other.

In the light of this thinking, we would like to submit these proposals for your consideration and study:

1. That we merge the Sunday School and CTS Conventions into one great meeting to be known as the Georgia State Teach and Train Rally.

2. This rally would be programmed to feature Clinic, Workshops, Training Courses, CTS competitive activities, and Worship Services.

3. The planning of programs, scheduling of rallies, and operation of the organization be the responsibility of the board of Christian Education and Camping; with financing of the rally annually on an associational prorata basis.

4. No business would be transacted during the rally. The Board of Christian Education and Camping would take care of the business of the organization and submit an annual report to the State Association for approval.

5. Since there would be no business, no delegates would be elected from local groups. Everyone would be urged to attend as a participate in some phase of the rally.

6. Since Sunday School and CTS statistics are reported in the letters sent from various district associations to this State Association, there would be no problem in this connection.

7. There would be a staff of officers elected for the Teach and Train Rally. The members of the Board of Christian Education and Camping would be responsible for the various activities and would preside at functions which call for a presid-ing officer.

In the matter of the Duties of the Promotional Secretary the Special Study Committee recommends the following:

1. That the Promotional Secretary formulate a calendar of Activities annually in which all of the State and National Programs are emphasized; and that copies of this schedule of Program emphases be sent each Church Clerk and Pastor over the state with proper promotional emphasis to be placed on each monthly program as the time arrives.

2. That the Promotional Secretary designate one Sunday annually as "Cooperative Program Sunday" and that this day be given wide and thorough coverage.

3. Inasmuch as the promotional and administrative duties of the Promotional Secretary are so vast and demanding, it is the opinion of the Committee that the Promotional Secretary should not be called on to fill pulpits over the State in a supply capacity. We would therefore recommend that the Promotional Secretary be instructed not to accept any further invitations of this nature.

4. That the Promotional Secretary serve as the editor of the State Publication. He shall use this medium to foster unity among our people and to promote the general program of this State Association.

5. That in the promotional activities for the various programs of the State Association, the Promotional Secretary shall be expected to visit the meetings of each District Association at least once per year.

6. It shall be the duty of the Promotional Secretary to coordinate as much as possible the work of the various boards of this Association. In this capacity he shall serve as ex-officio member of each of the standing Boards, acting only in an advisory capacity.



7. The Promotional Secretary shall submit an annual report of his activities to the State Association in its annual session.

8. As treasurer of the State Association, he shall be charged with the responsibility of receiving and disbursing all funds which are directed through the State Association's treasury by vote of this Body, and shall do so under the specific direction of this State Association. He shall publish an itemized report of all funds received and disbursed monthly in the State Publication, including an itemized account of all designated funds. He shall also submit an annual Treasurer's report to the State Association at its annual meeting.

9. The Promotional Secretary shall be reimbursed at the rate of ten cents (10°) per mile for travel expenses going and coming when he is used by churches for Study courses, revivals, and any other ministries that would not qualify strictly as promotional activity.

10. The Promotional Secretary shall direct the operation of the State Book Store. Books and supplies which the Promotional Secretary deems to be of general interest to our people over the state will be stocked.

The Georgia State Woman's Auxiliary Convention met November 14, 1967. There were 509 members paying a representation fee for this session. There were 155 registering for the Convention.

During the past year our auxiliaries have raised approximately \$2100.00 on the Larry Powell's bus and \$358.91 on the furnishings of one room at the Bible College dormitory. A total of \$6070.30 has been channeled through the State Woman's Auxiliary.







CONSTITUTION OF THE GEORGIA STATE ASSOCIATION OF ORIGINAL FREE WILL BAPTISTS

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constituion for the purpose of advancing, promoting, and increasing all phases of the cause of Christ.

ARTICLE I

Section I. The assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

ARTICLE II

Section I. The officers of this association shall be a Moderator, an Assistant Moderator, a Secretary, an Assistant Secretary, and a Promotional Secretary -Treasurer.

Section 2. All regular officers and the chairman of each standing board shall compose the Executive Board.

Section 3. This Association shall be composed of all active Ministers, deacons, and missionaries who are members of any affiliated bodies. One delegate for every 500 members, or fraction thereof, of each district association or union meeting; and one delegate for every 100 members or a fraction thereof of all local affiliated churches.

Section 4. All delegates from associations, union meetings, and local churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet current needs of the body shall be paid in on a voluntary basis to the treasurer of the association, however it is suggested that each association give as shall be allocated to them each year be a committee, and that each union meeting give five dollars and each local church give five cents per capita for their respective membership.

ARTICLE III

Section 1. It shall be the privilege of each affiliated association to furnish a member of each standing board with terms of office rotating which will necessitate the election of four members every two years giving each member a term of office of four years each. The exception will be the board of auditors which shall consist of two members who shall be elected at the time as the general officers.

Section 2. There shall be a board of missions composed of members who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian Education and Camping whose duties shall be:



- A. To schedule and arrange all camp sessions to be held at Camp Mt. Bethel, and to nominate the camp director. It is understood and agreed in this connection that the camp director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.
- B. To schedule and arrange all study courses, Bible Institutes, Minister's Retreats, and all other Educational services or programs sponsored by this State Association.
- C. To administer loan funds for students attending or desiring to attend Free Will Baptist Bible College in Nashville, Tennessee, under these stipulations.
 - a. That a promissory note be drawn for the face amount of the loan at the time it is made, bearing the signature of the borrower and a qualified co-signer.

b. That the note be properly executed and notorized.

c. That repayment on all loans begin one (1) year after graduation or one (1) year from the date of any prior termination of the college program by the borrower, and that repayment be over a period of five (5) years on a monthly basis at the rate of 3% interest per annum


on the unpaid balance.

- d. That all interest charges on loans to ministerial students be cancelled from year to year, provided that after graduation the minister serves as a full-time pastor in the state of Georgia, or a missionary under the Foreign or Home Missions Boards of the National Association; and provided that he is punctual in making all monthly payments as due. Consistent and deliberate failure to repay the loan or any part thereof, without good or legal cause, shall constitute forfeiture of this interestcancelling clause.
- e. That a duly designated representative of The Georgia State Woman's Auxiliary Convention be present at each meeting in which any application for a student loan is considered.
- d. To keep this body informed of all Christian Education projects and programs sponsored by the body and to offer such recommendations as they shall deem proper from time to time.

Section 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board and shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of Trustees whose duties shall be to hold title to all real properties belonging to this Body; the maintenance and upkeep of all such properties; and the planning and supervision of all future developments and expansions of these properties as directed by this Association.

It is agreed in this connection that the Board of Trustees shall at no time sell, rent, lease, nor otherwise convey or use any of these properties for gain without the express consent of this State Association; nor shall the Board of Trustees encumber these properties by mortgage, lien, nor otherwise, without



the express consent of this Body.

The Board of Trustees is hereby authorized to receive in behalf of this State Association gifts, grants, monies, real estate, or other valuable assets.

The Board of Trustees shall act in behalf of this Association and for this Association in any and all transactions involving its properties, but shall do so strictly in accordance with instructions given by said State Association.

Section 6. A board of auditors, whose duty it shall be to audit the books of the Association Treasurer and the Treasurers of all boards.

Section 7. There shall be a budgeting board whose duty it shall be to formulate the budget for the State association annually, and to determine the allocations to be observed in the cooperative plan.

ARTICLE IV

Section 1. All officers, except board members, shall be elected to serve a term of two years.

Section 2. Any officer may be re-elected as the body shall see fit.

Section 3. When vacancies occur for any cause they shall be filled by the Executive Board, or by any of the standing boards, subject to the approval of the Executive board, until the convening of the annual session of the body. Section 4. Election years shall take place on the odd years of the calendar. Section 5. A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent member has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have sufficient number of its members present to constitute a quorum, it shall become the duty of the executive board to deal with any delinquent members. Also, a charge against a member of this body and a member of a local church shall constitute a charge against said member in this body and the body abide accordingly.

Section 6. The duties of officers defined shall be the same as those for any deliberative assembly.

Section 7. All boards may be called in session only by the chairman of the executive board and any standing board may be called in session only by the chairman of said board, unless said chairman becomes incapacitated, in which case the assistant assumes the authority of said incapacitated chairman.

AMENDMENTS

This Constitution shall not be changed or altered except by a majority of all members present to regular session. All amendments shall lie on the table from the morning session until evening session or from evening session until morning prior to adoption and shall during the time be read at least twice in open session. Additions of boards or officers may be added as there is need.



CONSTITUTION AND BY-LAWS OF MINISTER'S ASSOCIATION

Article 1.

This Minister's Association shall be called The Georgia State Free Will Baptist Minister's Association, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of the Georgia State Association of Free Will Baptists.

The purpose of this Association shall be to edify one another through the preaching of the Word, and discussion of methods and to receive a general understanding of one another and to promote the work of our Lord as we see fit. Article 2.

The officers of this Association shall be President, Vice-President, Clerk-Treasurer, and assistant Clerk-Treasurer, who shall be elected annually. Article 3.

This Association shall have no disciplinary action. Article 4.

Every ordained minister in the State of Georgia should be a member of this Association and should represent in each session in person or by letter. Every member shall carry on his person a card of recommendation from this Association. A new card shall be issued or renewed annually.

THIRTIETH ANNUAL SESSION

Article 5.

This Association shall meet annually. Offerings shall be received to carry out its goals and purposes. In addition this Association shall set an annual membership fee.

Article 6.


This constitution may be amended by a two-thirds vote of the members present at any regular session.

BY-LAWS

Article 1.

The clerk or assistant clerk, or in their absence the senior minister in years, shall call the ministers into session. If a quorum is present the President or in his absence the Vice-President shall moderate the meeting. If neither are present, the senior minister in years shall be in charge. Twenty percent of active membership shall constitute a quorum for the transaction of business. Article 2.

It shall be the duty of the clerk to enroll the ministers of the Association. Ministers shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association. In case of questionable representation the case under question shall be referred



Article 3.

It shall be the duty of each minister belonging to this association to be active in pastoral, evangelistic, administrative, or promotional work (disabled and retired ministers excepted). Any minister belonging to this association shall represent to each session in person or by letter and failure to do so shall result in having his name taken from the list of members.

Article 4.

Each association shall be opened by reading a portion of God's Word and prayer and each session shall be closed with prayer.

Article 5.

By a two-third vote of the members present a ruling of the president may be overruled.

Article 6.

This association shall sit with open doors, except when it shall go into a committee as a whole.

Article 7.

No member shall absent himself from the association during its meeting without permission from the president.

Article 8.

No person shall be allowed to nominate more than one member, unless the person nominated is not elected.

Article 9.

The president shall not allow discussions when not carried on in a Christian Spirit, or when he thinks it will cause discord.

Article 10.

Anyone desiring to speak shall rise and address the president by the appellation, "Brother President" but shall not speak further until recognized.

Article 11.

No member of this association shall be allowed to speak more than five minutes nor more than twice on the same subject without permission from the President.

Article 12.

These By-Laws may be altered or amended at any regular or adjourned association by a two-thirds vote of the members present. this of session



CONSTITUTION AND BY-LAWS STATE CHURCH TRAINING SERVICE RALLY GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

CONSTITUTION

PREAMBLE

The purpose of this Rally shall be to promote the Church Training Service Program (CTS) in the State of Georgia; to unify, to devise and execute measures for the extension of the Kingdom of God in cooperation with the various District CTS Rallies of the State, so therefore we accept this Constitution to help strengthen our total Church training program.

ARTICLE I

NAME: The name of this organization shall be the State CTS Rally of the Georgia State Association of Free Will Baptists.

ARTICLE II

MEMBERSHIP: The membership shall be composed of all persons who are active members in the Church Training Service of a church which is a member of the State Association. Each member shall have voting privileges and may participate fully in all activities provided by the Rally. Ministers affilicated with the State Association shall be standing members.


ARTICLE III

OFFICERS: The officers of this Rally shall consist of a General Director, an Assistant General Director, a Secretary-Treasurer, an assistant Secretary-Treasurer, Song Director, Pianist, Sword Drill Leader, Bible Tic Tac Toe Leader, Bible Bowl Leader, a Declamation Leader and other officers which may be needed to carry on the work of the Rally.

ARTICLE IV

MEETING: This Rally shall meet annually, time and place of meeting to be decided by the Rally during its annual meeting.

ARTICLE V



ARTICLE VI

REPORTS: This Rally shall be under direct supervision of the State Association and shall give a written report annually to the association of all funds received and disbursed, and functions of the Rally during the year. The report should include objectives and any future plans being considered by the Rally.

ARTICLE VII

FINANCES: This Rally shall be supported by each local CTS representing with a gift of \$5.00, each district \$15.00, competitive activities entry fee; Bible Tic Tac Toe and Bible Bowl \$5.00 each, Sword Drill and Declamations \$3.00 each, and special offerings which might be received during the Rally.

ARTICLE VIII

AMENDMENT: This constitution may be amended at any regular meeting by a two-thirds majority of members present.

BY-LAWS

Section 1. Officers

All officers shall be elected during the annual meeting except the General Director who shall be elected by the State Association.

Section 2. General Director.

It shall be the duty of the General Director to perside at all meetings and perform such duties delegated to him by the State Association and this Rally. He shall also submit annual written reports to the State Association.

Section 3. Assistant General Director

It shall be the duty of the Assistant General Director to serve in full capacity of the General Director when he is absent. He shall also serve in those capacities assigned to him by this Rally.

Section 4. Secretary-Treasurer

The secretary-treasurer shall keep an accurate record of all transactions of the Rally and perserve the same, keepall valuable documents and surrender same to his successor in office. All funds shall be held and disbursed by the treasurer at the approval of the Rally.

Section 5. Assistant Secretary-Treasurer It shall be the duty of the Assistant Secretary-Treasurer to serve in the full capacity of the secretary-treasurer when he is absent.

Section 6. Song Leader

It shall be the duty of the song leader to be present, and on time, at all meetings and assist in planning and arranging the music for the Rally.



Section 7. Pianist

It shall be the duty of the pianist to be present at all meetings, and on time. Also assist in arranging music for the Rally.

Section 8. Sword Drill Leader

It shall be the duty of the Sword Drill Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Sword Drill. Also be responsible for conducting the Sword Drill Contest during the Rally.

Section 9. Bible Tic Tac Toe Leader

It shall be the duty of the Bible Bowl Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Bible Tic Tac Toe. Also be responsible for conducting the Bible Tic Tac Toe Contest during the Rally.

Section 10. Bible Bowl Leader

It shall be the duty of the Bible Bowl Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Bible Bowl. Also be responsible for conducting the Bible Bowl Contest during the Rally.

Section 11. Declamation Leader

It shall be the duty of the Declamation Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Declamation speeches. Also be responsible for conducting the Declamation Contest during the Rally.

Section 12. Committees

Committees will be appointed as deemed wise by the Rally and will serve at the discretion of the Rally.

Section 13. Executive Committee

All general officers shall be members of the executive committee. It shall be the duty of this committee to keep the business to a minimum so that the Rally can be geared toward promoting the Church Training Service program, and should be a time of inspiration, instruction and other special features pertaining to the CTS work. The executive committee shall also serve as the program committee.

Section 14. Amendment

These by-laws may be amended at any regular meeting by a two-thirds majority of members present.





RESOLUTION COMMITTEE REPORT

- 1. Recognizing the observance of WNAC EMPHASIS MONTH is necessary if WNAC is to continue its work of strengthening and correlating its growing program, and whereas, the observance should be a time of spiritual blessing and inspiration to the local churches as well as supplying the needs of WNAC, we recommend:

c. That each local auxiliary set as a goal for its WNAC Emphasis offering a minimum of \$1.00 per member.


2. That our Constitution and By-Laws be revised as follows:

ARTICLE IV. Membership.---This convention shall be composed of the officers of this convention together with district presidents and ten delegates (duly accredited by the credentials committee) from each district convention and four delegates and the president from each local auxiliary in good standing with its district convention and properly qualified by paying a representation fee of one dollar.

- 3. Whereas, the purpose of the Woman's Auxiliary is to help the Church promote missions, and because of the many deficit accounts found among our foreign missionaries, we recommend:
 - a. That the project for the Georgia Woman's Auxiliary Convention for 1967-68 be financial help toward these deficit missionary accounts.
 - b. That each local auxiliary set as its goal a minimum of \$3.00 per member toward this project.
 - c. That because of the urgency of the situation this money be sent to the district treasurers as it is received.
 - d. That the deadline for this project be September 1, 1968.
- 4. That we adopt the following rules relative to the Dot Harvey Loan Fund:

Loans may be made to students attending or desiring to attend Free Will Baptist Bible College in Nashville, Tennessee, under these stipulations:

- a. That a promissory note be drawn for the face amount of the loan at the time it is made, bearing the signature of the borrower and a qualified co-signer.
- b. That the note be properly executed and notarized in the county Seat of the County in which said loan was made.
- c. That repayment on all loans begin one (1) year after graduation or one (1) year from the date of any prior termination of the College program by the borrower, and that repayment be over a period of five (5) years on a monthly basis at the rate of 3% interest per annum on the unpaid balance.

- 5. That our auxiliaries be more faithful in regular support of Superannuation.
- 6. That each District Convention give \$10.00 this year toward the expense of the Woman's Auxiliary News in our State Promotional Bulletin.
- 7. That we give Brother Dave Franks a rising vote of appreciation for his informative and inspiring message today thus signifying by our vote our pledge to remember him, his family, and the work in Brazil in our prayers.
- 8. That we give the South Georgia District and Jesup Church a rising vote of thanks for the wonderful hospitality shown to us today.
