

PROCEEDINGS OF THE THIRTY-THIRD ANNUAL SESSION OF THE GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

The Georgia State Association of Free Will Baptists met at First Free Will Baptist Church, Albany, Georgia, November 11-13, 1969. The theme of the program was "Confronting the Issues".

The first session was held on Tuesday evening, November 11, and was opened with congregational singing led by Rev. Kenneth Faison, of Colquitt, Georgia. Prayer was offered by Rev. James Ursery. Rev. Rolla Smith led in the pledges to the American and Christian Flags after which the congregation sang, "America the Beautiful." Brother Faison again led the congregation in singing. Reverend Damon C. Dodd gave the official welcome to the Association and called for representatives from the various Associations over the State to stand. All of the constituent Associations were represented.

The Junior Choir of the Albany Church, under the direction of the Pastor, Reverend Charles Hollingshead, presented the special music. After recognizing the visitors present, Reverend Dodd, acting as Clerk of the Association, officially called the session to order and introduced the officers. Moderator, Reverend Rolla Smith, took charge. MSC that the program be adopted with the Moderator given the privilege of adapting the program as necessity arose.

The Moderator appointed the Committee on Committees at this time as follows:

Rev. Emmette McDuffie, Chairman Rev. Richard Meade Mr. M. M. Franks Mr. Hugh Willis Rev. Milton Fields

Just prior to the message of the evening special music was given by a duet composted of Mrs. Milton Fields and Mrs. Bobby Parker.


The message, "Fundamentalism versus Liberalism" was presented by Reverend Damon C. Dodd, Homerville pastor.

Following the message the congregation sang, "To God be the Glory".

The service was dismissed with prayer.

WEDNESDAY MORNING SESSION

The session was opened by congregational singing of "Showers of Blessing" and "Heavenly Sunshine" led by Brother Faison.



Scripture reading from Psalm 126 was given by Reverend Bobby Parker, who also led in prayer.

Reverend Rolla Smith presented his Moderator's message at this time, using Phillippians 1:27 as the basis of his remarks.

Following this message, the Moderator called for the report of the Committee on Committees. MSC to adopt the report. (See report section).

The partial report of the Credentials Committee was given by Reverend Larry Montgomery. MSC to adopt the report. (See report section). Following the reception of this report the Moderator officially seated the standing and elected delegates and charged them with their responsibilities.

Reverend Herman Hersey, representing the National Association's Board of Retirement and Insurance, was called on for a report on the new program being offered by the Denomination. He gave a most enlightening review of the proposals and urged Georgia ministers and Christian workers to take advantage of the provisions of the program.

At this time the Credentials Committee presented a petitionary letter from the newly organized Ogeechee Association asking for membership in the Georgia State Association. MSC to grant the petition and receive Ogeechee Association into full membership in the Georgia State Association of Free Will Baptists.

The report of the Executive Board was given at this time by Reverend Damon C. Dodd. MSC to adopt the report. Before the vote was taken it was MSC to amend the report by deferring the matter of the salary arrangement for the Promotional Secretary until a later session. (The report section shows the amended motion). On vote of the Body, the motion was adopted as amended.

Reverend Rufus Coffey, National Association's Executive Secretary, gave a report on the status of the Georgia State Association's invitation for the National Association's 1973 session. He revealed that Atlanta was ruled out as a possible site due to the unavailability of a suitable site and the exhorbitant prices. The Committee on Invitation was instructed to search for a more suitable site.

Mayor Fred Mills, Mayor of the City of Albany, was introduced at this time by the host Pastor. In his welcome to the Convention he made several pertinent remarks which were deeply appreciated by all of us.

The Moderator declared a recess at this time to extend until the time of the morning worship hour.

WEDNESDAY MORNING WORSHIP HOUR

The service opened with congregational singing of "Jesus Calls Us."



Prayer was offered by Mr. Jesse Griffin. Rev. Leron Clower, Assistant Moderator of Midway Association, gave a welcome to the Association in behalf of his Association.

Special music for the hour was given by a quartet composed of the following Ministers: Ken Faison, Milton Fields, James Ursery, and Damon Dodd.

The message, "Morality versus Free Expression" was brought by Rev. Larry Montgomery, of Glennville, Georgia. This was a thought-provoking and eye-opening presentation. Following the message, the congregation was dismissed with prayer.

WEDNESDAY AFTERNOON SESSION

Session opened with Kenneth Faison leading the congregation in the singing of "Leaning on the Everlasting Arms" and "Victory in Jesus". Rev. Lewis Williams read the Scripture from Jeremiah 18:1-6 and led the congregation in prayer.

The Moderator called for a report from all standing Boards relative to their having quorums as prescribed by the Constitution. It was discovered that the Board of Superannuation did not have a legal quorum.

Rev. Robert Shockey, Field Secretary for the National Home Missions Board, was present and gave a thrilling report of the work of his Board. He used Luke 10:1, 2 as the basis for this report.

Rev. Henry Van Kluyve, Deputation Director for the Board of Foreign Missions of the National Association, presented the report of the work of that Board.

Rev. Rufus Coffey gave a report of the work of the Executive Department of the National Association.


Rev. Eugene Hales, a member of the National Association's CTS Board, reported on the work and plans of that Agency.

Rev. George C. Lee, of the National Sunday School Board, represented the National Sunday School Department and presented the report of their work.

The report of the Georgia State Woman's Auxiliary Convention was given by Mrs. Doris Grant. MSC to receive this report. (See report section.)

The report of the Board of Christian Education and Camping was given by J. W. Franks. MSC to adopt the report. (See report section.)

The financial report of the Board of Superannuation was presented

A Partial report of the Registration Committee was given by Charles Hollingshead. MSC to adopt the report. (See report section.)

A Partial report was given by the Resolutions Committee. MSC to adopt the report and dispose of it item by item.

A Partial report of the Credentials Committee was given. The portion of the report dealing with Calvary Church, of Columbus, Georgia, relative to her status in this Association, was referred back to the Committee for clarification.

This concluded the business on the agenda for Wednesday afternoon.

The session was dismissed with prayer.

WEDNESDAY EVENING SERVICE

The service was opened by the singing of "To the Regions Beyond" led by Kenneth Faison. Prayer was led by Rev. James Ursery.

The Junior Choir of Albany Church sang, "Heaven Came Down . . ."

State Missionaries present were introduced by Rev. Kenneth Faison. They were:

> Rev. Luther Reed – Hazelhurst Rev. Hubert Henderson – Marietta

The financial report of the State Missions Board was given by Rev. Faison. MSC to adopt the report. (See report section.)

Rev. James Ursery made some pertinent remarks concerning the offering and explained that it would be divided as follows: 50% for National Home Missions, 25% Foreign Missions, 25% State Home Missions. An offering of \$169.07 was received.

The congregation was led in singing "Since Jesus Came Into My Heart."

Special music was given by the Adult Choir of Albany Church. They sang, "Goodness and Mercy Shall Follow Me."

The Moderator presented the speaker of the hour, Missionary Sammy Wilkinson, of Brazil. Using John 4:35, Rev. Wilkinson spoke from the subject, "The Great Commission versus the Tragic Omission."



Following the message the congregation sang, "Ready."

Moderator Smith challenged the people to pledge to the Sammy Wilkinson account and thus have a part in sending this missionary family back to their work in Brazil.

Following announcements, Rev. Tom Malone gave the benediction.

THURSDAY MORNING SESSION

Rev. Kenneth Faison opened the session by leading the congregation in singing "Praise Him" and "Jesus Saves."

Scripture reading from Psalm 133 was given by Rev. James Ursery, who also led in prayer.

Rev. Carlton Lambert, Superintendent of the Alabama Children's Home, gave a detailed report of the operation of the Home. During the course of his report he revealed the fact that the Home can once more process applications for the Home from Georgia children. MSC to receive the report and enter it into the Minutes of this session. (See report section.)

Rev. Tom Malone, representing Free Will Baptist Bible College, gave a report of that institution. MSC to receive the report as information.

The report of the Placement Committee was given by Rev. Hubert Henderson. MSC to adopt the report. (See report section.)

The Moderator called for Curtis Gay to give an up-to-date report on the physical condition of Rev. Mance Cason, who was unable to be present in the session due to illness. Following the report, special prayer for Bro. Cason was offered by Rev. A. J. Lambert.

MSC that the State Association pay Bro. Cason one month's additional salary subsequent to the official termination of his duties as Promotional Secretary. The motion was amended to provide for a love offering to be received today, to be applied on the amount of the monthly salary gift as designated in the original motion. MSC to adopt the amended motion. An offering of \$128.25 was received.

The final report of the Registration Committee was given by the Committee Chairman.

The deferred report of the Credentials Committee pertaining to the State Associational status of Calvary Church of Columbus, Georgia, was taken from the table on motion and second. The revised report was read. MSC to adopt. (See report section.)

The report of the Budgeting Board was presented at this time. Before

Chairman Herman Watson presented the report of the Obituary Committee. MSC to adopt the report and stand for a moment of silent prayer. Rev. David Matthews led in the Memorial Prayer.

The revised report of the Budgeting Board was given by Rev. Eugene Hales. MSC to receive the report and act on it item by item.

William Travis spoke on this proposal and offered a motion that the Board of Trustees study the proposal and report on its finding at the 1970 session of the State Association. Motion was carried.

Curtis Gay gave the final report of the Board of Trustees. MSC to adopt. (See report section.)

Rev. A. C. Truluck gave the financial report of the Promotional Secretary-Treasurer. MSC to receive the report as given. (See report section.)

The final report of the Resolutions Committee was given by Chairman Rev. Joe Esther. MSC to receive the report and act on it item by item.

Item No. 3 Adopted Item No. 4 Adopted (See report section.)

MSC to rescind the action regarding the auditing of the State Treasurer's records.

MSC that the Executive Board be, and hereby is, instructed to have



the State Treasurer's books set up by a Certified Public Accountant and also that the State Treasurer be bonded.

The report of the Nominating Committee was given by Rev. C. B. Dowdney. MSC to receive the report and act on it Section by Section.

There being no further nominations from the floor, it was MSC to elect all nominees. (See report section.)

MSC to extend a rising vote of thanks to the officers who have served for the past term. The vote was taken by Rev. C. B. Dowdney.

At this time the deferred matter concerning the financial arrangements for the Promotional Secretary was reconsidered. The original proposal was adopted with the one change — that the salary be set at \$400.00 per month rather than \$300.00 as originally suggested.

Rev. A. C. Truluck, Promotional Secretary-Treasurer-elect, was called on for a statement. He made some remarks concerning his plans for furthering the usefulness of the Office and stated that he would assume the position officially on December 1, 1969.

MSC that the Executive Board be directed to work out arrangements for the office to continue to function through the interim period and that Bro. Truluck be paid if he is able to carry on the work.

MSC to adjourn.

Benediction was pronounced by Rev. A. C. Truluck.







1. The purchase of land for the Atlanta/Decatur work.


- 2. The termination of the Sylvester Mission because of its organization into a self-supporting church.





The Boards were assigned to their respective meeting places and retired to their places for business.


MINUTES OF THE EXECUTIVE BOARD MEETING

The Board was called into session by Moderator Smith. Rev. James Ursery led in prayer.

A discussion on the general nature of the work and responsibility of the Executive Board was entered into for the purpose of determining the agenda for the day.

The first item of business was the matter of the Promotional Secretary and his work. Members were asked to express their opinions concerning the Promotional Department in relation to the work, schedule of activities, and the reaction of the people in our Churches over the State. The Moderator concluded the discussion by reading the By-laws adopted by the 1968 session of the State Association which set forth the relationship between the Executive Board and Promotional Department as well as the duties of the Promotional Secretary.

The Minutes of the 1968 session of the State Association contained a resolution instructing the Executive Board to make a thorough study of the Promotional Department in its overall operation, noting the need for equipment repair or replacement.



MSC that Friday, March 14, 9:30 A. M. be set as the date for this meeting at the State Office in Moultrie, Georgia.

MSC that the Moderator, Clerk, and Promotional Secretary serve as the Program Committee for the 1969 session of the State Association.

The matter of pursuing the invitation of the State Association for the National Association to hold its 1972 session in Atlanta was discussed. By common consent it was agreed that the Clerk write the Executive Secretary of the National Association and make arrangements for a meeting with him or his designated representative in Atlanta at his convenience.

At this time the Board of Trustees met with us to discuss the printing equipment in the State Office. After a brief discussion the matter was deferred until the afternoon session.

Following a brief recess the Boards came together for the service of dedication for our State property in Moultrie.



The group adjourned for the noon hour at the place arranged by Bro. Cason. Just before leaving the dining room following the meal it was MSC that the Clerk write a letter to the President of Free Will Baptist Bible College expressing the sentiment of the various Boards present as being favorable to launching phase 2 of the expansion program at FWBBC.

The afternoon session got underway at 2:00 P. M. with prayer by Curtis Gay.

The Missions Board asked for permission to discuss a matter with the Executive Board. They reported that there had been occasions when considerable delay had been experienced in the forwarding of Mission funds to them from the State Treasurer. Bro. Cason, the Treasurer, was called in and asked to state the reasons for these delays. He answered the queries and concluded his statements by promising that all receipts would be processed and deposited daily and that all funds would be forwarded to the proper Boards and Agencies on a monthly basis.

The matter of printing equipment for the State Office, which had been introduced by the Board of Trustees before the noon hour and deferred,



was taken up at this time. The Board of Trustees asked that they be authorized to purchase a Multilith Offset Machine Model 1250W, at a cost of \$3,638.25.

After due consideration and discussion, it was MSC that the Board of Trustees be authorized to purchase said machine under two stipulations, viz:

1. That the agency through which the machine is to be purchased print one edition of the Promotional Bulletin.

2. That the purchase be made on a Cash-in-60 days basis.

In the matter of financing the cost of this machine, it was MSC that the Clerk write letters to representatives of each of the Churches over the State asking for a contribution from Churches or individuals of one hundred dollars (\$100.00).

The Moderator asked for an expression financially toward this project from those present and \$1,000.00 was tentatively pledged.

After some announcements and some final words the meeting was adjourned.

The first order of business was a report on the progress of the fundraising campaign for the Offset machine. Bro. Cason revealed that \$1,008.65 had been received.

MSC that another letter be written and mailed before the next Board meeting to try to finalize this campaign.

MSC to set a selling price on the old machine of not more than \$350.00 nor less than \$200.00.



MSC that the Board of Trustees be, and hereby is, authorized to purchase a folding machine with the proceeds from the sale of the old printing machine.

Bro. Cason gave a financial report of the Promotional Office showing the operational expenses covering the period from January 1 through December 31, 1968. This report revealed the fact that actual expenses incurred by the Office had exceeded the income.

In this connection it was MSC that the Promotional Secretary be allowed the following benefits, retroactive to January 1, 1969:

Seven cents (7c) per mile travel allowance for trips involving the functions of the Office.

All utilities for the State Office.

Following a discussion relative to the accounting and bookkeeping procedures in the State Office, it was MSC to secure the services of a CPA to direct in the setting up of an efficient and acceptable system for this Office.

We adjourned for the noon hour and went together to the Hotel for the meal. Following the meal and while yet in the dining room, Moderator Smith again called the meeting to order and we entered into a discussion on the feasability of beginning a bookstore operation in connection with the State Office. Out of this discussion, and on motion and second, followed by a unanimous vote in the affirmative, the following items were adopted:

That the bookstore operation begin at once, to be under the management of the Promotional Secretary.

That the Promotional Secretary take materials on consignment for resale.

That the State Association assume financial responsibility for the entire operation through the Executive Board.

That the initial investment not exceed five hundred dollars (\$500.00) on a wholesale inventory.

That included in the bookstore stock shall be Church furniture and supplies, along with Bibles, books, etc.

The matter of job printing was introduced and thoroughtly discussed. MSC that the Promotional Secretary be, and hereby is, authorized to do Job-printing as time permits, Pricing on any and all jobs must be in line with

prevailing competitive prices. It is understood in this connection that the Promotional Secretary is to investigate the tax situation on this type of operation and accordingly to comply with the regulations.

After returning to the State Office, the Board voted to meet again on Tuesday, May 27, at 9:30 A. M.

The Executive Board of the Georgia State Association of Freewill Baptists met at the State Office, Moultrie, Georgia, Tuesday, May 20, 1969.



Present for the session were: Curtis Gay, M. M. Franks, Charles Hollingshead, Billy Hatcher, James Ursery, Rolla Smith, Mance Cason, and Damon Dodd.

The Minutes of the March, 1969 meeting were read and approved.

Mance Cason gave an up-to-date report on the fund for the new Offset Press. This report revealed that \$2,012.15 of the purchase price of \$3,783.19 had been received in the Office. Cason reported that the old machine had been sold for \$350.00 and that a new folding machine had been bought for \$267.40.

Following a discussion on how to raise the balance owing on the new machine Cason made a telephone call to the firm from which the purchase was made and was advised that a 45 day extension would be given on the balance. The Promotional Secretary was requested to arrange contacts with the Churches over the State in an effort to raise the balance owed.



MSC that in view of the fact that the 1972 session of the National Association would be west of the Mississippi River according to custom, that we change our invitation for the National Association to meet in Atlanta in 1973. Damon Dodd was instructed to arrange a meeting in Atlanta with the National Executive Secretary or his representative to check facilities for the meeting.

The matter of a revised report form to be used by the District Associations in reporting to the State Association was discussed. Charles Hollingshead and Damon Dodd were appointed to draft a proposed form and present it at the September meeting of this Board.

The proposed Bookstore operation was taken up and discussed. Mance Cason reported as follows:

10 or 12 companies had been contacted and most of them had responded favorably.

Some were unresponsive to doing business on a consignment basis. Most of them preferred a 30 day cash basis.

Standard Publishing Company offered a straight 15% arrangement on Vacation Bible School materials.

Investigation on doing business from the State Office in Moultrie revealed that we can operate here without a license unless legitimate and legal complaints are lodged.

Upon request, Mance Cason discussed the operation of the new press and the schedule of work at the State Office, pointing up the following: The backlog of work is being rapidly diminished.

The new machine is operating efficiently.

Plans are current and favorable to begin job-printing on a commercial basis.


Louis Sheffield, Jr., has been contacted relative to revising the bookkeeping system, with another meeting set before June 1, 1969.

The books are now in the hands of a CPA who is to offer suggestions before they are set up for the new Church year.

The May Bulletin is about ready to mail.

Most all of the incidental problems have been resolved and the operation will be back on regular schedule soon.

The question of receipts and disbursements since the last meeting has been settled by arranging for the present office help to take over this



duty. Thus receipts are being processed daily as they arrive and disbursements will be made henceforth on a regular monthly basis.

Following this discussion it was MSC that the Promotional Secretary submit an itemized list of disbursements from the State Office to the members of the Executive Board retroactive to January, 1969, and continuously therefrom on a monthly basis.

MSC that the Promotional Secretary be instructed to close the books on all accounts on the last day of each month and that the Promotional Bulletin be in the mail by the 10th of each month.

A discussion on the State Camping program and the Camp property was next on the agenda. Out of this discussion came the following action: MSC that a report be requested from the treasurer of the Board of Christian Education and Camping as stipulated by this Executive Board at its May 20, 1969 session, for the purpose of analyzing the overall operation of Camp Mt. Bethel, said report to be in the hands of the Board at the September meeting 1969.

MSC that the Board of Christian Education and Camping be instructed to provide Waivers of Liability properly executed, to be signed by each and

every group (other than our own Freewill Baptist groups using the Camp in a regularly scheduled and approved activity) using the facilities of Camp Mt. Bethel, absolving the Georgia State Association of Freewill Baptists and/or any of its Boards or Agencies of any responsibility of any nature in connection with any mishap of whatsoever nature that might occur while said group/s are occupying or using the facilities of Camp Mt. Bethel.

It is hereby understood and implied that no group/s other than regularly scheduled and authorized Freewill Baptist groups shall be protected by insurance coverage taken out in the name and style of Camp Mt. Bethel, the Georgia State Association or any of her Boards or Agencies. The Chairman of the Board of Christian Education and Camping is hereby charged with the responsibility of carrying out the aforementioned provisions.

MSC that the Board of Trustees of the Georgia State Association of Freewill Baptists be charged with the responsibility of securing Property Liability coverage for Camp Mt. Bethel.

MSC that the Board of Christian Education and Camping, through its Chairman, be instructed to settle any outstanding accounts which have been charged to Camp Mt. Bethel.

MSC that the Board of Christian Education and Camping be requested to submit an up-to-date report on the Student Loan Fund, showing loans outstanding, loan repayments current and on schedule, accounts delinquent along with the length of delinquency, and the current balance in the account.


The first item of business was to name Kenneth Faison secretary pro-tem. Faison read the Minutes of the May meeting of the Board and they were approved.

In compliance with the request of the Executive Board, C. J. Faison, chairman of the Board of Christian Education and Camping, reported that the matter of Liability Waivers to be signed by renters and/or users of Camp Mt. Bethel other than regularly authorized Freewill Baptist groups had been arranged and he presented the legal form to the Board. He also gave an up-to-date report on the outstanding bills to be paid by the Board.

Curtis Gay, Chairman of the Trustee Board, reported that the matter of Liability insurance for Camp Mt. Bethel had been investigated and he presented figures relative to cost. MSC that an appraisal be made of the facilities, exclusive of the land, and that maximum liability coverage be



taken on the basis of such appraisal. Nationwide or Hartford Insurance Companies were to be the insurors and Gay is to be responsible for the execution of this provision.

Hollingshead presented the proposed report form to be used by District Association in reporting to the State Association. After suggested additions were agreed on, the Board voted to present this matter to the State Association through its Resolutions Committee for action at the 1969 session.

The report of the Promotional Secretary was given at this time. MSC that the report be received and in view of Bro. Cason's incapacity brought on by illness, that his resignation be regretfully accepted. It is understood that the resignation becomes effective at the 1969 session of the Georgia State Association. The Clerk was instructed to write a letter of appreciation to Bro. Cason for his past services to the State Association.

MSC to adjourn for lunch.



Questions relating to funds paid out by the Treasurer of the State Association were raised and the current status of such funds as they are remitted to the Boards was examined. Cursory tests indicated that the balance in the State Treasury was sufficient to meet present demands on said treasury. A final decision was held in abeyance until a complete financial report is released by the Treasurer.

MSC that Rev. A. C. Truluck, a member of the State Auditing Board, be employed to assist in the Treasurer's office in completing the work on the accounts, and that he be reimbursed on the regular mileage basis. Hatcher was named to oversee this matter.

The matter of an official audit of the Treasurer's accounts was discussed in view of the fact that a new officer would take over the work soon. MSC that the accounts of the State Treasurer be audited by a Certified Public Accountant prior to the State Association November 11, 1969. Hatcher, Gay, and Faison were named a committee to implement this motion.

MSC that an allowance of \$100.00 per month for operational expenses for the Promotional Office be authorized and that said amount be taken from the Cooperative Plan receipts before any other allocations are made.

MSC that this Executive Board recommend the nomination of Rev. A. C. Truluck for the office of Promotional Secretary-Treasurer of the State Association.

MSC that the payments on the Moultrie property of \$120.00 per month be taken from the expense of the Promotional Department and placed in the budget of the Board of Trustees with the understanding that the allocation to said Board of Trustees be increased sufficiently to meet this additional demand on the Board of Trustees.

There being no further business it was MSC to adjourn.

CONSTITUTION OF THE GEORGIA STATE ASSOCIATION **OF ORIGINAL FREE WILL BAPTISTS**

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advancing, promoting, and increasing all phases of the cause of Christ.

ARTICLE I

The assembly shall be known as the Georgia State Section 1. Association of the Original Free Will Baptists.

ARTICLE II

Section 1. The officers of this association shall be a Moderator, an Assistant Moderator, a Secretary, an Assistant Secretary, and a Promotional Secretary-Treasurer.

Section 2. All regular officers and the chairman of each standing board shall compose the Executive Board.


Section 3. This Association shall be composed of all active Ministers, deacons, and missionaries who are members of any affiliated bodies. One delegate for every 500 members, or fraction thereof, of each district association or union meeting; and one delegate for every 100 members or a fraction thereof of all local affiliated churches. Section 4. All delegates from associations, union meetings, and local churches shall be elected from the laity of the body sending them. Section 5. Funds to meet current needs of the body shall be paid in on a voluntary basis to the treasurer of the association, however it is suggested that each association give as shall be allocated to them each year be a committee, and that each union meeting give five dollars and each local church give five cents per capita for their respective membership.

ARTICLE III

Section 1. It shall be the privilege of each affiliated association to furnish a member of each standing board with terms of office rotating which will necessitate the election of four members every two years giving each member a term of office of four years each. The exception will be the board of auditors which shall consist of two members who shall be elected at the time as the general officers.

Section 2. There shall be a board of missions composed of members who are noted for missionary zeal and they shall have the supervision of all mission interest sponsored by this body. All undesignated mission funds shall be equally divided between home and foreign.

Section 3. There shall be a board of Christian Education and Camping whose duties shall be:



- A. To schedule and arrange all camp sessions to be held at Camp Mt. Bethel, and to nominate the camp director. It is understood and agreed in this connection that the camp director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.
- B. To schedule and arrange all study courses, Bible Institutes, Minister's Retreats, and all other Educational services or programs sponsored by this State Association.
- C. To administer loan funds for students attending or desiring to attend Free Will Baptist Bible College in Nashville, Tennessee, under these stipulations.
 - a. That a promissory note be drawn for the face amount of the loan at the time it is made, bearing the signature of the borrower and a qualified co-signer.
 - b. That the note be properly executed and notorized.
 - c. That repayment on all loans begin one (1) year after graduation or one (1) year from the date of any prior termination of the college program by the borrower, and that repayment be over a period of five (5) years on a monthly basis at the rate of 3% interest per annum on the unpaid balance.
 - d. That all interest charges on loans to ministerial students be cancelled from year to year, provided that after graduation the minister serves as a full-time pastor in the State of Georgia, or a missionary under the Foreign or Home Missions Boards of the National Association; and provided that he is punctual in making all monthly payments as due. Consistent and deliberate failure to repay the loan or any part thereof, without good or legal cause, shall constitute forfeiture of this interest-cancelling clause.
 e. That a duly designated representative of The Georgia State Woman's Auxiliary Convention be present at each meeting in which any application for a student loan is considered.
 - d. To keep the body informed of all Christian Education projects and programs sponsored by the body and to offer such recommendations as they shall deem proper from time to time.

Section 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board and shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Section 5. There shall be a board of Trustees whose duties shall be to hold title to all real properties belonging to this Body; the maintenance and upkeep of all such properties; and the planning and supervision of all future developments and expansions of these properties as directed by this Association.

It is agreed in this connection that the Board of Trustees shall at no time sell, rent, lease, nor otherwise convey or use any of these properties for gain without the express consent of this State Association; nor shall the Board of Trustees encumber these properties by mortgage, lien, nor otherwise, without



the express consent of this Body.

The Board of Trustees is hereby authorized to receive in behalf of this State Association gifts, grants, monies, real estate, or other valuable assets. The Board of Trustees shall act in behalf of this Association and for this Association in any and all transactions involving its properties, but shall do so strictly in accordance with instructions given by said State Association. Section 6. A board of auditors, whose duty it shall be to audit the books of the Association Treasurer and the Treasurers of all boards.

Section 7. There shall be a budgeting board whose duty it shall be to formulate the budget for the State Association annually, and to determine the allocations to be observed in the cooperative plan.

ARTICLE IV

Section 1. All officers, except board members, shall be elected to serve a term of two years.

Section 2. Any officer may be re-elected as the body shall see fit. Section 3. When vacancies occur for any cause they shall be filled by the Executive Board, or by any of the standing boards, subject to the approval of the Executive Board, until the convening of the annual session of the body.

Section 4. Election years shall take place on the odd years of the calendar. Section 5. A member of any board who fails in the function of his or her duties without a reason, the board to which the delinquent member has been elected, shall declare the office vacant. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament. Should such board fail to have sufficient number of its members present to constitute a quorum, it shall become the duty of the executive board to deal with any delinquent members. Also, a charge against a member of this body and a member of a local church shall constitute a charge against said member in this body and the body abide accordingly.

Section 6. The duties of officers defined shall be the same as those for any deliberative assembly.

Section 7. All boards may be called in session only by the chairman of the executive board and any standing board may be called in session only by the chairman of said board, unless said chairman becomes incapacitated, in which case the assistant assumes the authority of said incapacitated chairman.

AMENDMENTS

This Constitution shall not be changed or altered except by a majority of all members present to regular session. All amendments shall lie on the table from the morning session until evening session or from evening session until morning prior to adoption and shall during the time be read at least twice in open session. Additions of boards or officers may be added as there is need.



CONSTITUTION AND BY-LAWS OF MINISTER'S ASSOCIATION

ARTICLE I

This Minister's Association shall be called The Georgia State Free Will Baptist Minister's Association, and shall be composed of Ordained Free Will Baptist Ministers who are regular members of the Georgia State Association of Free Will Baptists.

The purpose of this Association shall be to edify one another through the preaching of the Word, and discussion of methods and to receive a general understanding of one another and to promote the work of our Lord as we see fit.

ARTICLE II

The officers of this Association shall be President, Vice-President, Clerk-Treasurer, and assistant Clerk-Treasurer, who shall be elected annually.

ARTICLE III

This Association shall have no disciplinary action.

ARTICLE IV

Every ordained minister in the State of Georgia should be a member

of this Association and should represent in each session in person or by letter. Every member shall carry on his person a card of recommendation from this Association. A new card shall be issued or renewed annually.

ARTICLE V

This Association shall meet annually. Offerings shall be received to carry out its goals and purposes. In addition this Association shall set an annual membership fee.

ARTICLE VI

This constitution may be amended by a two-thirds vote of the members present at any regular session.

BY-LAWS

ARTICLE I

The clerk or assistant clerk, or in their absence the senior minister in years, shall call the ministers into session. If a quorum is present the President or in his absence the Vice-President shall moderate the meeting. If neither are present, the senior minister in years shall be in charge. Twenty percent of active membership shall constitute a quorum for the transaction of business.

It shall be the duty of the clerk to enroll the ministers of the Association. Ministers shall present themselves with proper evidence of their rights to seats therein, and those enrolled by the clerk shall compose the Association. In case of questionable representation the case under question shall be referred to the credentials committee.



ARTICLE III

It shall be the duty of each minister belonging to this association to be active in pastoral, evangelistic, administrative, or promotional work (disabled and retired ministers excepted). Any minister belonging to this association shall represent to each session in person or by letter and failure to do so shall result in having his name taken from the list of members.

ARTICLE IV

Each association shall be opened by reading a portion of God's Word and prayer and each session shall be closed with prayer.

ARTICLE V

By a two-third vote of the members present a ruling of the president may be overruled.

ARTICLE VI

This association shall sit with open doors, except when it shall go into a committee as a whole.

ARTICLE VII

No member shall absent himself from the association during its meeting without permission from the president.

ARTICLE VIII

No person shall be allowed to nominate more than one member, unless the person nominated is not elected.

ARTICLE IX

The president shall not allow discussions when not carried on in a Christian Spirit, or when he thinks it will cause discord.

ARTICLE X


Anyone desiring to speak shall rise and address the president by the appellation, "Brother President" but shall not speak further until recognized.

ARTICLE XI

No member of this association shall be allowed to speak more than five minutes nor more than twice on the same subject without permission from the President.

ARTICLE XII

These By-Laws may be altered or amended at any regular or adjourned session of this association by a two-thirds vote of the members present.



CONSTITUTION AND BY-LAWS STATE CHURCH TRAINING SERVICE RALLY **GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS**

CONSTITUTION

PREAMBLE

. The purpose of this Rally shall be to promote the Church Training Service Program (CTS) in the State of Georgia; to unify, to devise and execute measures for the extension of the Kingdom of God in cooperation with the various District CTS Rallies of the State, so therefore we accept this Constitution to help strengthen our total Church training program.

ARTICLE I

NAME: The name of this organization shall be the State CTS Rally of the Georgia State Association of Free Will Baptists.

ARTICLE II

MEMBERSHIP: The membership shall be composed of all persons who are active members in the Church Training Service of a church which is a member of the State Association. Each member shall have voting privileges and may participate fully in all activities provided by the Rally. Ministers affiliated with the State Association shall be standing members.

ARTICLE III

OFFICERS: The officers of this Rally shall consist of a General Director, an Assistant General Director, a Secretary-Treasurer, an assistant Secretary-Treasurer, Song Director, Pianist, Sword Drill Leader, Bible Tic Tac Toe Leader, Bible Bowl Leader, a Declamation Leader and other officers which may be needed to carry on the work of the Rally.

ARTICLE IV


MEETING: This Rally shall meet annually, time and place of meeting to be decided by the Rally during its annual meeting.

ARTICLE V

COMMITTEES: All committees needed to carry on the work of the Rally shall be appointed by the General Director.

ARTICLE VI

REPORTS: This Rally shall be under direct supervision of the State Association and shall give a written report annually to the association of all funds received and disbursed, and functions of the Rally during the year. The report should include objectives and any future plans being considered by the Rally.



ARTICLE VII

FINANCES: This Rally shall be supported by each local CTS representing with a gift of \$5.00, each district \$15.00, competitive activities entry fee; Bible Tic Tac Toe and Bible Bowl \$5.00 each, Sword Drill and Declamations \$3.00 each, and special offerings which might be received during the Rally.

ARTICLE VIII

AMENDMENT: This constitution may be amended at any regular meeting by a two-thirds majority of members present.

BY-LAWS

Section 1. Officers: All officers shall be elected during the annual meeting except the General Director who shall be elected by the State Association.

Section 2. General Director: It shall be the duty of the General Director to perside at all meetings and perform such duties delegated to him by the State Association and this Rally. He shall also submit

annual written reports to the State Association.

Section 3. Assistant General Director: It shall be the duty of the Assistant General Director to serve in full capacity of the General Director when he is absent. He shall also serve in those capacities assigned to him by this Rally.

Section 4. Secretary-Treasurer: The Secretary-Treasurer shall keep an accurate record of all transactions of the Rally and perserve the same, keep all valuable documents and surrender same to his successor in office. All funds shall be held and disbursed by the treasurer at the approval of the Rally.

Section 5. Assistant Secretary-Treasurer: It shall be the duty of the Assistant Secretary-Treasurer to serve in the full capacity of the Secretary-Treasurer when he is absent.

Section 6. Song Leader: It shall be the duty of the song leader to be present, and on time, at all meetings and assist in planning and arranging the music for the Rally.

Section 7. Pianist: It shall be the duty of the pianist to be present at all meetings, and on time. Also assist in arranging the music for the Rally. Section 8. Sword Drill Leader: It shall be the duty of the Sword Drill Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Sword Drill. Also be responsible for conducting the Sword Drill Contest during the Rally.

Section 9. Bible Tic Tac Toe Leader: It shall be the duty of the Bible Tic Tac Toe Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Bible Tic Tac Toe. Also be responsible for conducting the Bible Tic Tac Toe Contest during the Rally.



Section 10. Bible Bowl Leader: It shall be the duty of the Bible Bowl Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Bible Bowl. Also be responsible for conducting the Bible Bowl Contest during the Rally.

Section 11. Declamation Leader: It shall be the duty of the Declamation Leader to serve as a coordinating agency between the various districts in promoting and stimulating interest in the Declamation speeches. Also be responsible for conducting the Declamation Contest during the Rally. Section 12. Committees: Committees will be appointed as deemed wise by the Rally and will serve at the discretion of the Rally.

Section 13. Executive Committee: All general officers shall be members of the executive committee. It shall be the duty of this committee to keep the business to a minimum so that the Rally can be geared toward promoting the Church Training Service Program, and should be a time of inspiration, instruction and other special features pertaining to the CTS work. The executive committee shall also serve as the program committee.

Section 14. Amendment: These by-laws may be amended at any regular meeting by a two-thirds majority of members present.


