

PROCEEDINGS OF THE THIRTY-SIXTH ANNUAL SESSION OF THE GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

The Georgia State Association of Free Will Baptists met at the Martin Youth Camp, Colquitt, Georgia, November 16-18, 1972. The theme was "A Life With Meaning." The text for the meeting ws Philippians 2:5 "Let this mind be in you, which was also in Christ Jesus:". The first session was held on Wednesday evening, Nov. 16, 1972. The congregational singing was directed by the Rev. Billy Bevan, pastor of the First Free Will Baptist Church



in Blakely, Georgia. The hymn, "When We All Get To Heaven", was used to open the meeting. Rev. Rolla Smith led the Congregation in prayer, after which the hymns, "My Savior's Love" and "Revive Us Again" were sung. Rev. Billy Bevan led in the Pledge of Allegiance to the American Flag and to the Christian Flag, and to the Bible. Bro. Bobby Roberts brought the devotion.

The Clerk called the Association into session and presented the officers to the assembly. Those present were: Rev. Kenneth Faison, Moderator; Rev. Jerry Johnson, Asst. Moderator; Rev. William Morris, Clerk; and Rev. A. C. Truluck, Promotional Secretary. The Moderator was presented who in turn recognized the visitors present. The visiting ministers were: Denis Keen, Geo. Lee, Bro. Cook,, Bro. Mock, Bro. Bill Brewer, Bro. Arnold Woodlift, and Bro. Ronald Creech.

Special music was presented by a quartet of our ministers after which Rev. Ronald Creech brought a challenging message: "David's great men and God's great men." Taken from II Sam. 23.

After the message the Moderator appointed the Committee on Committees: Damon Dodd; Willie Lane; O. L. Fields; Earl Tabb; L. S. Anthony. We had a partial report from Bobby Roberts concerning the registration thus far. The Clerk read the "Proposed Revision — Constitution of the Georgia State Association of Free Will Baptists: Proposed — By-Laws." M.S.C. to lay Constitution and by-laws on the table until the next day. We were dismissed with prayer.

FRIDAY MORNING SESSION

This session was opened by the singing of "Footsteps of Jesus", and prayer was offered by Bro. Parrish. The Moderator's message was delivered by Rev. Kenneth Faison. He used Luke 12:35 for his text and spoke on the subject: "Girded Loins and Burning Lights." A partial report from the Credentials Committee was given (see reports). The Ministers; Deacons and Delegates were seated. The report from the Committee on Committees was given: The Nominating Committee was Rolla Smith, L. F. Ogeltree, and Danny Keen; M.S.C. to cease nominations and elect these. The Resolution Committee was Hollis Warren, Jerry Channey, Ted James, William Travis, and J. D. Norris. M.S.C. to use this committee if they came to the meeting, if not the Moderator would appoint some to fill in. M.S.C. to allow the Moderator to appoint replacements on the Board of Retirement and Insurance.

The Moderator checked to see if all of the Boards that would need to meet had a quorum. A proxy was appointed where one was needed on the various Boards.

The Executive Board report was given and a M.S.C. to receive this report. In discussing the adoption of the various items in this report and findings some need of clarification on some of the things reported it was M.S.C. to table this report until Sat. A.M. at which time the Executive Board will present some recommendations to this body.



The Moderator called on the following men to report from the various departments: Dr. L. C. Johnson brought greetings from our Free Will Baptist Bible College. Rev. A. C. Truluck gave a report from the Department of Retirement and 'Insurance. Rev. George Lee gave us greetings from the Sunday School Department. Mr. Bill Brewer brought greetings and information from "Christian Builders." These reports and information were received by the body.

There was a brief recess, and the group assembled for the morning worship service. The service was opened with the congregation singing "Old Time Power" followed with prayer offered by Rev. L. S. Anthony. An offering was received and was followed by all singing "Deeper, Deeper" and a special number in music by Rev. Malcom Fry. The Message was delivered by Rev. Reedy Saverance using Heh. 2:17-18 as his text. Calvin Henderson closed with prayer.

FRIDAY AFTERNOON SESSION

This session opened with the singing of "The Way of the Cross." and "prayer by Bro. Ed. Kimbrell. Rev. J. D. Norris brought a challenging devotion from Deut. 1:1-4.

The following reports were given from the various National Departments: Mr. O. B. Everson gave a report on "Master's Men" from the Layman's Board. Rev. Rufus Coffee brought greetings from the Executive Office. Rev. Malcolm Fry gave a brief report from the Church Training Service Department. Rev. Don Roberds brought greetings from the Foreign Missions office. M.S.C. to take Constitution off of table. As a Body we went over the "Proposed Revision and voted to make the necessary changes article by article and section by section. The Constitution and By-Laws as changed and corrected is printed in this copy of the State Minutes. The body voted to accept this constitution as corrected. (See Constitution and By-Laws on page 43). M.S.C. to continue session with the following reports: Mrs. Martha Everson gave State Woman's Auxiliary report — M.S.C. to adopt report. (See reports). The State Mission Report was given by Rev. Lewis Williams (see reports) and the board made the following recommendations:

- 1. That we go back to the "Target City Revivals" as we have known them in the past. (M.S.C.)
- 2. That Athens be selected as "Target City" for another year. (M.S.C.)
- 3. That March be designated as "Target City" month. (M.S.C.)
- 4. That each church elect a "Mission Chairman" to work with the Director and notify the director of this election. (M.S.C.)

Rev. A. C. Truluck gave the State Executive Sect. Report (see reports). M.S.C. to adopt the report. In connection with this report a special presentation was made to the Executive Secretary, A. C. Truluck and his wife Frances Truluck. A silver serving tray was presented to Mrs. Truluck to express our appreciation for her devotion to the work of the State in the State office. A "Cross" pen set was presented to Bro. A. C. Truluck in appreciation to him



for his devotton and service to our State work. The Moderator, Rev. Kenneth Faison made the presentations on behalf of the State Association.

FRIDAY EVENING SESSION

After the congregational singing we heard from the three State Missionaries that were present: Rev. Buddy Morris — Statesboro; Rev. Jerry Johnson — Athens; and Rev. Luther Burns — Swainsboro. Each gave a brief report on the work and praised God for the many blessings in the new mission stations.

Rev. Rolla Smith conducted a commissioning service for Rev. Luther Burns our latest missionary who is serving in Swainsboro, Ga.

Rev. Bob Shockey gave the report and greetings from the National Home missions office.

Rev. Malcolm Fry rendered our special music for this service "It Pays to Serve Jesus" and then Rev. Bob Shockey delivered a heart warming and challenging message entitled "The Great Mission". The Lord blessed in this service with a wonderful service and offering for the cause of Christ through missions, and many responded to the invitation.

SATURDAY MORNING SESSION

The session was opened by singing "On Jordon's Stormy Banks" and the special music was presented by Rev. Carlton Lambert from the Alabama's Childrens Home. Mr. Ted James, a layman from the Spring Grove church in Jesup, presented devotion taken from Col. 3:1-4 and 14-17 and Rom. 8:9-13.

The business got underway with the following reports: Rev. Kenneth Faison gave the State C.T.S. Rally report. M.S.C. to receive the report and adopt the recommendation. "Recommendation: That any balance in funds be channeled to the Christian Education and Camping Board for the T and T Rally." Rev. Carlton Lambert brought greetings and a report from the Free Will Baptist Children's Home in Eldridge, Alabama. M.S.C. to receive this report. (See reports). Rev. Bob Hesselmeyer gave the Christian Education and Camping Board report. M.S.C. to adopt report. (See reports).

The Credentials Committee Report was given by Mrs. Ida Tabb. M.S.C. to adopt this report. (See reports). Mr. Earl Tabb gave the report of the Board of Trustees (P.p14 & 15 in Digest) M.S.C. to adopt this report.

Rev. Harris Nix gave report from the State Retirement and Insurance. M.S.C. to receive the report and adopt the recommendation. After some discussion the following motion was presented: M.S.C. That the Board of Retirement and Insurance be charged to:

- (1) Check into the old minutes to determine whether or not guidelines have been adopted for use in determining the eligibility of retired ministers and minister's wives for monthly support.
- (2) Bring these guidelines to the surface, if indeed they have been adopted.



(3) Present for adoption in the next annual session some guidelines, in the event none have been adopted.

The Moderator read a portion of a letter received from Mrs. J. R. Davidson: "I know I have waited a long time to write but there was so many I should have written and it was so hard for me to sit down and write that I just haven't gotten around to writing to every one.

"I did appreciate the nice thing you said about Mr. Davidson, all the nice cards, gifts and every expression of sympathy from everyone. I believe the State Association will soon be meeting and I will appreciate it if you will extend my thanks to everyone and to the Midway Association for the nice resolution of respect that they passed in the Association."

M.S.C. to receive the letter as information and stand for a moment of silent prayer for Mrs. Davidson. Prayer was offered by Rev. Don Reed.

Mr. Jerry Chaney gave the Resolution Committee report. M.S.C. to receive the report and adopt item by item. (see reports). Amended that these resolutions be printed. M.S.C. to give a rising vote of appreciation to the Martin Association for hosting the State Association and doing such a fine job of it.

Rev. Jerry Johnson gave the budgeting Board report. M.S.C. to receive and adopt item by item: (see report on page 11 of Digest) Number four (4) of the recommendations was changed with a M.S.C. to list the allocations of the cooperative funds as follows: Missions 45%, Retirement and Insurance 22%, State Board of Trustees 20%, State Board of Christian Education and Camping 5%, State T.N.T. Rally 5%, Alabama Children's Home 3%. M.S.C. to add number 6 to this report which would read that of the cooperative receipts 60% be retained in the State and 40% be sent to the National Association. M.S.C. to take off of table the Executive Board's Report. The recommendations were read and M.S.C. to receive the report and act upon them item by item. Recommendations one, two and four were passed as stated in the report. Item number three (3) was passes with the following two amendments: That we change the mileage rate from \$.08 per mile to \$.10 per mile; and that we pay the actual utilities of the Executive Secretary's house. These amendments were passed with main motion, item 3. Recommendation number 5 was amended to add \$100.00 to each district quota. This amendment was defeated. A second amendment was made to leave the decision to charge, or not to charge, for the bus service at the National in Macon up to the Transportation Committee. This amendment was passed and the recommendation (5) was passed.

The clerk gave a list of the committees that had been appointed which are as folloos:

The "Steering Committee is made up of the Executive Board with Kenneth Faison Chairman. (The Chairman of each committee is the first name listed). Prayer Committee—C. B. Dowdney and Bob Hesselveyer. Registration Committee—Joe Owens and Melvin Worthington. Auditorium Committee—Jerry Johnson and J. E. Blanton. Ushering Committee—Lewis Williams and J. D. Norris. Transportation Committee— Paul Davis and Jim Osborne. Information and Publicity Committee— A. C. Truluck and Billy Hatcher. This committee will also serve as

finance committee.

The delegates to the National Association were appointed. They are: (M.S.C. for the Moderator to appoint these) Mr. and Mrs. Billy Hatcher; Mr. William Clower; and Mr. and Mrs. Edward Kimbrell. In case some of these could not make the National the following were appointed to fill in as delegates: Mr. Ted James; Mrs. Dodd; Mr. David Hodges; and Mr. and Mrs. John Grant.

The Auditing Board Report was given by Rev. Billy Bevan. M.S.C. to receive the report. (see report).

A motion and second was placed before the Body that all Boards be instructed that before any State Board employ a man that they present it to this association in regular session. The motion was amended that this does not apply to missionaries sent out under the Mission Board. The amendment carried and the motion with the amendment carried.

The Nominating Committee Report was given. M.S.C. to receive the report and deal with it item by item. The nominations were opened to the "floor" office by office and when no nominations were made from the "floor" there was a M.S.C. that the nominations cease and we proceed to elect.

There was a time for announcements and several were made. M.S. C. to adjourn. Prayer offered by Buddy Morris.

MINUTES OF THE MEETING OF THE EXECUTIVE BOARD


January 2, 1972

The Executive Board of the Georgia State Association met at Camp Mt. Bethel on January 2, 1972. The following members were present: M. M. Franks; Billy Hatcher; Kenneth Faison; Curtis Gay; Buddy Morris; C. B. Dowdney; A. C. Truluck; Jerry Johnson; James Ursery; Charles Holling-The session was opened with prayer by Curtis Gay. The Proshead. motional Secretary read a letter about authorization for the floor plan in handling pianos and organs at the bookstore. It was MSC that authorization be given and that the moderator and clerk sign the letter. (A copy of this letter is in the clerk's files).

A discussion concerning changing the days of the State Association was conducted. After a great deal of discussion it was MSC that the moderator and two members, appointed by the moderator, form a constitutional committee to report to the Executive Committee as a whole. Members of the committee are — Ken Faison, A. C. Truluck and Charles Hollingshead.

It was MSC that we try to plan the 1973 session of the State Association in Eastman and that the promotional secretary would seek a site for the 1974 session within the Little River Association. A report concerning this is to be made at the next session of the Executive Committee.

Each Board was instructed that they should have their treasurer bonded. It was stated that this was passed by the State Association several years

MINUTES OF THE EXECUTIVE BOARD MEETING

August 12, 1972

The executive Board of the Georgia State Association met at Moultrie on August 12, 1972. The following members were present: Kenneth Faison; A. C. Truluck; Billy Hatcher; James Ursery; Curtis Gay; M. M. Franks; Jerry Johnson; Buddy Morris.

The meeting was opened with prayer by M. M. Franks. The Moderator read Matt. 16:13-18 and made some timely remarks. The Clerk read the minutes from the last meeting which were accepted. The report of the Committee on Constitution Revision was also read: MSC to receive the report.

MS & C to approve and adopt Constitution and By-Laws as changed. The following are the changes adopted in this meeting:

MS & C: Article IV, Sec. 7 — All Boards may be called into session by the Chairman or Vice-chairman of said Board or by the Moderator or Assistant Moderator of this association upon request of the majority of the members of said Board.

MS & C: Article II, Sec. 1 — change to: "A clerk, an assistant clerk and an executive secretary-treasurer.

BY-LAWS

MS&C: Use "Executive Secretary" instead of "Promotional Secretary" in Article II, Sec. E.

MS & C: Article II, Sec. E-(8) — Change from "Budgeting Board" to "Executive Board."



OTHER ITEMS OF BUSINESS ACTED UPON IN THIS MEETING ARE AS FOLLOWS:

MS & C: That the month of the State Meeting should be left as November. This was decided after a discussion on changing the month.

The Executive Committee then went over some suggestions concerning the Program for the up-coming State Association in November.

M S-& C: That the Thursday night speaker be given an honorarium of \$75.00.

M S & C: If the Eastman Church cannot have the State Meeting in 1973 we go to camp Mt. Bethel. If we go to Eastman in 1973, we suggest Mt. Bethel for the 1974 session.

Upon hearing a report from the committee that investigated the possibilities of selling our printing press to the National Sunday School Dept.; and finding that they did not want to purchase it we had a **M S & C**: That we tentatively terminate the idea of selling the press.

M S & C: That, after hearing of a problem of help in the Book Store concerning part-time help, a committee, as appointed by the Moderator, look into this need and be authorized to increase from \$150.00 to \$200.00 if necessary. (Committee: Curtis Gay, James Ursery, and C. B. Dowdney)

M S & C: Since this is the Silver Anniversary of the State Office, that the Moderator and Clerk serve as a committee to plan a presentation to our Promotional Secretary and his wife in appreciation for their services, with a gift to be presented at the 1972 session of our State Association in connection with our Silver Anniversary. M S & C: That our Moderator prepare and deliver a message for our joint Board Meeting to instruct all members as to responsibilities and activities concerning promotion and work of the Boards. M S & C: To give the Mission Board a vote of confidence in their recent action of hiring Rev. Lewis Williams as a promotional man for the State Mission Board.

A. C. Truluck gave the Executive Committee a report on the Bookstore which covered the months of June and July.

MS&C: For the meeting to adjourn.

MINUTES OF THE JOINT BOARD MEETING

Camp Mt. Bethel — November 4, 1972

The Joint-board board meeting started at 10:00 A.M. with the singing of "Leaning on the Everlasting Arms" and prayer by Mr. Hermon Watson. Rev. A. C. Truluck brought a brief message to challenge us to be more involved in God's work and giving ourselves to His cause.

We then divided for the separate boards to meet and take care of their business. The Executive Committee met with the Budgeting Board to discuss

Changed the word "nominate" to "appoint" in Article III, Section 3. 3A of the Constitution.

AFTERNOON SESSION:

We met as a Joint-Board meeting to hear from the boards.

The Executive Secretary gave a report on the bookstore in Moultrie which revealed favorable results for the store.

We then heard a brief report from the various boards. Rev. James Ursery closed this meeting with prayer.

The Executive Board then went into session to finish the business of the day:

The assistant Clerk read the minutes from the last meeting of August 12, 1972 which were approved as read.

We heard from the committee appointed to look into the current need of the bookstore for additional funds for part-time help. The committee

increased the amount for part-time help from \$150.00 to \$600.00 and all

MS&C — To maintain a standing Bookstore Committee of three (3) men selected by the Executive Board and taken from the Executive Board annually in the November meeting of the Executive Board.

M S & C — After a long and through discussion — To raise the salary of the Executive Secretary from \$500.00 to \$600.00 and all proceeds from revivals, supply work, and promotional activities go into the "Promotion Fund" with the four (4) weeks allowed for revivals and vacation.

M S & C — That we pay mileage to the Executive Secretary at the rate of \$.08 per mile.

M S & C — To leave as in Article III, Section I of the Constitution.

M S & C --- To adjourn. Prayer offered by Buddy Morris.

MINUTES OF THE EXECUTIVE BOARD DURING THE STATE ASSOCIATION

November 1973

M.S.C. to give Rev. Ronald Creech \$150.00 instead of the \$75.00 that was first decided upon. The reason for this was due to him flying to the meeting instead of driving.

M.S.C. to put all moneys over \$3,500 (of the money that comes in designated for the National Association expenses) in the General Fund and to pay expenses of the Committees out of the General Fund.

The following recommendations were made to the State Association:

1. That the 1973 session of the State Association meet in Eastman, Ga.; and that the Executive Secretary seek a site for the 1974 session within the bounds of the Little River Association.

2. That the term of David Matthews, Mission Board; Hugh Willis, Board of Retirement and Insurance; Luther Burns, Board of Christian Education and Camping; G. S. Holton, Budgeting Board expire in 1975.

3. That the salary of the Executive Secretary be raised from \$500.00 to

\$600.00 per month; and all proceeds from revivals, supply work, and promotional activities go into the "Promotional Fund; and that we pay mileage at the rate of eight (8) cents per mile.

4. That the State Association designate the Executive Board to serve as "Steering Committee" for arranging the National Association in Macon, Ga.

5. That February be designated as National Association Month, with Feb. 18th. as special offering Sunday for the expenses of the National Association in our State. The following quotas for each district were suggested:

REPORT OF PROMOTIONAL SECRETARY to the Georgia State Association of Free Will Baptists Thirty-Sixth Annual Session November 16-18, 1972 Martin Youth Camp — Colquitt, Georgia

"Therefore my beloved brethern, be ye steadfast, unmoveable, always abounding in the work of the Lord, for as much as ye know that your labour is not in vain in the Lord." 1st Cor. 15:58.

One day soon we shall all cease from our earthly labors, cast our crowns before His feet, begin our eternal rest, and see Him who has redeemed, justified and kept us from eternal condemnation. The future of such rewards and events are as certain as our faith, but somehow being human we must know there are present achievements and blessingsto keep us steadfast, unmoveable, always abounding in order that we reach that day of eternal glory.

This thirty-sixth annual session shall serve as such a reminder of past blessings. With this in mind we submit our report, and "to God be the glory".

Twenty-five years ago the Executive Board of the Georgia State Assn. of Free Will Baptists employed Rev. E. C. Morris as the first full time Promotional Secretary, a position which he held for fourteen years. This was a first among Free Will Baptists, that is, the first full time state secretary. The work of Free Will Baptists in Georgia was strengthened through the efforts of Brother Morris. Rev. Mance Cason replaced Brother Morris and filled the position for eight years. During Brother Cason's terms in office a house was purchased in Moultrie, and an addition added to serve as office space. He also began a bookstore operation, purchase an offset press and began printing the Promotional Bulletin and other printing work. In 1969 I was elected as Brother Cason's replacement. These three years have been years of much growth in every phase of our State work. Most of the 130 churches have worked together to bring about this success story. Spiritual fires are burning, souls are being saved, new churches are being started and giving is increasing almost every month. A walk-in bookstore in downtown Moultrie was opened June 1 this year and has exceeded all expectations in sales. Sunday school literature has been distributed by the state office personnel for two quarters without any problems of any significance. The printing equipment and all office equipment and supplies has been located downtown in the same building with the bookstore. This is a great advantage to the overall work of the state office. There has been much accomplished, but there remains even moe to hope for. Let us set our goals high, plan big things, expect big success and see great things accomplished. This is one of the best motivators to help us remain steadfast, unmoveable, abounding in the work of our Lord. I would like to conclude my remarks with an excerpt from a report given by Rev. L. R.



Ennis, Executive Secretary, to the 1942 session of the National Association of Free Will Baptists.

"The spirit of good will and Christian fraternity has spread extensively among us in recent months; and again, we have been compelled to conclude that the wind that sways the tree promotes its growth. General church organization is to the orthodox Christian consecrated intelligence in action for the salvation of mankind. Doctrinally, we are sound; financially, we are poor; and educationally, we are ignorant. The Apostolic Church had exactly these; but Oh! it had moe — a fervent flaming love for Christ and a lost world. Without this our boasted orthodoxy is as trees without leaves and clouds without water. Would that we had more---"

Give us a passion for souls, dear Lord,

A passion to save the lost;

O that thy love were by all adored,

and welcomed at any cost.

Jesus we long, we long to be winning,

men who are lost, and constantly sinning;

O man this hour be one of beginning

The story of pardon to tell.

Here is a summary report of our activities during the past year:

- 2. witnessed 103 definite decisions & many others responding to some type of commitment
- traveled 21,036 miles in state work 3.
- 4. printed 12 issues of the Promotional Bulletin
- attended every district meeting 1 or more times 5.
- made 2 trips to Nashville (1 promotional meeting and 1 to plan 6. the literature distribution)
- opened the downtown bookstore (June 1, 1972) 7.
- 8. relocated the bookstore (October 20, 1972)
- 9. distributed literature for appx. 105 churches for the past two quarters
- planned an evangelism conference in Moultrie, Ga. and worked 10. with the national dept. to promote it
- helped to plan and attended the ministers retreat 11.
- 12. printed various promotional materials for revivals, evangelism, and departments
- printed district minutes for 5 districts and the state minutes (total 13. copies 3500)
- printed the second printing of Dodd's Handbook for new members 14. (2000 copies)
- 15. attended the North Carolina state meeting
- 16. attended some 8 different board meetings
- worked on the constitutional revision committee 17.

As an item of interest, there are 130 churches and missions on roll as members of our State Association. At some time for some type of meeting I



have been priviledged to visit in 112 of these churches and conduct revival services in 52 of them. If our Lord and our people permit me to continue in this office for another year, I have set as my goal to visit in the 18 churches which I have not visited. Pray for us.


- Request our churches to teach and preach more on the sin and 1. evil of alcoholic beverages.

The Mission Board also has undertaken a project in Swainsboro with Rev. Johnny Eason as missionary. After only a few weeks, Bro. Eason saw fit to resign from this work. God then placed this burden on Rev. Luther Burns. Souls have been saved and the land has been purchased for the church. Brother Burns deserves your support.

God is building a church in Athens, Statesboro, Swainsboro and he has built a growing church in Decatur.

Because of the growth of our mission work and the need to grow more, the Mission Board saw the need of a Missions Director. After much prayer, Lewis Williams was placed in this office. 

We the budgeting board would like to recommend the following items for consideration and necessary action:

- 1. We do not feel it practical to set a budget for designated giving as has been done in time past.
- 2. We further recommend that all **designated funds**, that is Foreign Missions, National Home Missions, Bible College and others, be sent direct to the particular department.
- 3. We recommend a Cooperative Budget for the coming associational year of \$32,000.00.
- 4. We recommend the allocations of the cooperative funds remain the same as last year with the following exceptions: a. the Camp Board Board to receive 5% instead of 7% and the TNT Rally (formerly CTS) to receive 5% instead of 3%.


The Macedonia Auxiliary presented an interesting skit "Doorway to Macon the 1973 WNAC."

CONSTITUTION AND BY-LAWS GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the Cause of Chrsit.

ARTICLE I

This assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

ARTICLE II

Section 1. The officers of this Association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk and an Executive Secretary-

Treasurer.

Section 2. All'regular oficers and the chairmen of each of the standing Boards shall compose the Executive Board.

Section 3. This Association shall be composed of all active ministers, deacons and missionaries who are members of affiliated bodies; one (1) delegate for every three hundred (300) members or fraction thereof from each District Association or Union Meeting; one (1) delegate for every one hundred (100) members of fraction thereof from each local affiliated Church.

Section 4. All delegates from District Associations, Union Meetings and local Churches shall be elected from the laity of the body sending them.

Section 5. Funds to meet current needs of this body shall be paid on a voluntary basis to the Treasurer of this Association. However, it is suggested that each District Association give a minimum of ten dollars (\$10.00) per delegate authorized; each Union Meeting give five dollars (\$5.00) and each local Church give five cents (\$.05) per capita for their respective memberships.

ARTICLE III

Section 1. It shall be the privilege of each affiliated District Association to recommend a member for each Standing Board. Terms of office on these Boards shall be on a rotating basis which will necessitate the election by the State Association of four (4) members every two years, thus giving each member a four (4) year term of office. The exception to this provision shall be the



Board of Auditors, which shall consist of two (2) members to be chosen at the time of the election of the General Officers.

Section 2. There shall be a Board of Missions, composed of members who are noted for their missionary seal. This Board shall have supervision of all missions interests sponsored by this Body.

Section 3. There shall be a Board of Christian Education and Camping whose duties shall be:

A. To schedule and arrange all Camp sessions to be held at Camp Mt. Bethel, and to appoint the Camp Director each year. It is understood and agreed in this connection that the Camp Director shall be in authority in matters of faculty, curriculum, administration, food service and recreation during Camp sessions.

B. To assist in promoting all educational services sponsored by this State Association in cooperation with the agency scheduling the activity.

Section 4. There shall be a Board of Retirement and Insurance whose duty it shall be to adopt plans and rules which are amendable with the National Association's Board of Retirement and Insurance. They shall also formulate plans for financing this ministry.

Section 5. There shall be a Board of Trustees whose duties shall be: hold tiele/s to all real property belonging to this Body; the maintenance and upkeep of all such properties; the planning and supervision of all future developmets and expansion of these properties as directed by this Association.

It is agreed in this connection that the Board of Trustees shall at no time sell or encumber these properties by mortgage, lien, or otherwise without the express consent of this Body given in regular or called session of this Georgia State Association of Free Will Baptists.

The Board of Trustees is hereby authorized to receive, in behalf of and for the Georgia State Association of Free Will Baptists, gifts, grants, monies, real estate or other valuable assets.


The Board of Trustees shall act for and in the behalf of the Georgia State Association of Free Will Baptists in any and all transactions involving any of its properties but shall do so strictly in accordance with instructions given by said State Association in regular or called session.

Section 6. There shall be a Board of Auditors whose duty it shall be to audit the accounts of all Board of this Association annually.

Section 7. There shall be a Budgeting Board whose duty it shall be to formulate the budget for the State Association annually and to recommend to the Body in session the allocations to be observed in the Cooperative Plan ofGiving. This Board shall, in addition to the above stated duties, also recommend a mileage rate for travel by the mebers of all of the Standing Boards of said Association.

Section 8. There shall be a member of the Board of Trustees of the Free Will Baptists Children's Home, Eldrige, Alabama elected during the 1971 session for a term of four (4) years. Election thereafter shall be for a four (4) year term.

Section 9. The Treasurer of each Board shall be bonded in an amount stipulated by the Board of which he is Treasurer. The Bonding Fee shall be paid from the Treasury of said Board/s.



ARTICLE IV

Section 1. All officers, except Board members, shall be elected for a term of two (2) years.

Section 2. Any officer may be re-elected at the pleasure of this Body.

Section 3. Vacancies in the list of General Officers or on any of the Boards, which occur between regular sessions of this State Association, may be filled by the Executive Board until the convening of the Annual session of said Association.

Section 4. Election of all General Officers shall take place on the odd years of the calendar.

Section 5. If a member of any Board fails in the function of his or her duty without good and sufficient reason/s, the Board of which the delinquent is a member may declare that particular office vacant. Further, this Body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian, bussness-like manner according to the rules of Christian conduct as set forth in the New Testament.

In the event that any Standing Board of this State Association shall find itself without a sufficient number of its members present to constitute a quorum at any of its official meetings, said Board/s are hereby granted the privilege by this State Association of appointing proxies to serve in lieu of the absent member/s. At the pleasure of the Board/s, and subsequent to the meeting from which the regular member absented himself, the Board/s have the right to deal with the delinquent member in the manner stated in the previous paragraph. Section 7. Boards may be called into session by the Chairma or Vice-Chairman of said Board, or by the Moderator or Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said Board/s.

AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this Association and shall lie on the table from one business session to the next during which time it shall be read at least two (2) times in open session. Officers, Standing Boards, and/or Standing Committees may be added or deleted as the need/s arises.

BY-LAWS

SECTION 1.

A. The Georgia State Association of Free Will Baptists shall meet for its regular session annually on Thursday following the second Sunday in



regular session annually on Thursday following the second Sunday in November and shall adjourn on the Saturday immediately following.

B. The Executive Board shall meet quarterly on Saturday before the second Sunday of the following months: February, May, August. The November meeting of said Board shall be held just prior to the regular meeting of the State Association.

The Executive Board of the Georgia State Association of Free Will Baptists shall act for and in behalf of said Association on matters which by their nature require immediate attention. All such actions by the Executive Board shall be subject to final action by the State Association.

SECTION 2.

A. The Moderator shall preside at the annual sessions of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board.

B. The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.

C. The Clerk shall keep records of the proceedings of the annual Associational meetings and of the Executive Board meetings. It shall also be his responsibility to have the Minutes of these sessions printed and distributed.

D. The Assistant Clerk, in the absence of the Clerk, shall fulfill the functions and duties of the Clerk as stated in paragraph C of this document.

SECTION 3.

A. The Executive Secretary shall serve as State Treasurer, receiving and disbursing funds which are directed through the State office. Disbursement of these funds shall be as directed by vote of said Association. All financial records of the Treasurer shall be audited annually by a recognized CPA and said Treasurer is required to submit a completely audited financial report of all operations under his jurisdiction to the State Association at its annual meeting.

B. The Executive Secretary shall serve as editor of the State publication, **The Promotional Bulletin.** This publication shall be used as a means of promoting unity among our people and providing information regarding the general program of this State Association for all our people.

C. The Executive Secretary shall be responsible for the management of the Book Store under the supervision of the Executive Board.

D. The Executive Secretary shall serve as ex-officio member of each of the Standing Boards of said Association, but he shall act only in an advisory capacity. As much as in possible, he shall coordinate the work of these various Boards with a view to preventing duplication and overlap.

E. The Executive Secretary shall submit a report of his activities to the Georgia State Association of Free Will Baptists in annual session.

F. The Executive Secretary shall be allowed four (4) weeks vacation per year with pay.

G. Funds received by the Executive Secretary for revivals, special speaking engagements and promotional meetings, shall go into the Promotional Fund. The exception to this regulation relates to any renumeration received



by the Executive Secretary during his four-weeks vacation, which funds shall be his personally and need not be accounted for before said Association.

H. Salary, mileage and operational expenses of the Executive Secretary shall be determined by recommendation of the Executive Board as approved by the Georgia State Association of Free Will Baptists.

SECTION 4.

A. The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the Board shall investigate places suitable for this meeting and make recommendations to said State Association. In as much as possible, this Association shall meet on a rotating basis within the District Associations. Meeting places shall be determined two (2) years in advance.

B. The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of parliamentary procedure.

SECTION 5.

Necessary Committees shall be appointed by the Moderator unless otherwise provided for by the Body.

SECTION 6.

These By-Laws may be altered, changed, or amended at any regular session of this Association by a two-thirds (2/3) vote of delegates present and voting.



Church Covenant

Having given ourselves to God, by faith in Christ, and adopted the Word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We agree faithfully to discharge our obligations to reverence to the study of the Scriptures, secret prayer, family devotions, and social worship; and by self-denial, faith, and good works endeavor to "grow in grace and the knowledge of our Lord and Saviour Jesus Christ."

We will not forsake the assemblying of ourselves together for church conferences, public worship, and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor, and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness, and to watch over one another in love, endeavoring to "keep unity of the Spirit" in the bonds of peace, to be careful of one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and, as far as we are able, promote the success of the Church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme, counting it our chief business in life to extend the influence of Christ in society, constantly praying and toiling that the Kingdom of God may come, and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises, the support of missions, the success of Sunday Schools and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

CORRECTION FOR LINE NO. 2 IN PARAGRAPH 6
