#### A TRIBUTE TO OUR FREE WILL BAPTIST PIONEERS

Those senior saints among us are preserving a sense of pioneering that keeps us on the right track in spite of the sirens of Satan which would draw us aside. Trained, alert leadership is challenging and directing us in an aggressive and constructive program of work for our Lord Jesus Christ. All of this is possible today because of our pioneer Free Will Baptist forefathers who pointed us in the right way and built for us a solid Scriptural foundation upon which to erect our present-day Free Will Baptist Church. They instilled in us that faith and courage that have kept us pressing forward in spite of the odds against us at times. They have made us proud of our heritage and bold in the proclamation of the Truth of God's Word. To them we owe much of the success we have enjoyed as the Georgia State Association of Free Will Baptists. We gratefully and proudly remember them today and shall preserve their memory in the years to come by continuing to work for and promote the cause of the Free Will Baptist Denomination which they founded and loved.



#### MINUTES OF THE FORTY-THIRD ANNUAL SESSION GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

The Georgia State Association of Free Will Baptists convened on Thursday evening, November 15, 1979 at the First Free Will Baptist Church in Albany, Georgia for its Forty-Third Annual Session. The service began promptly at 7:00 p.m. with the congregation singing "To God Be The Glory" under the direction of Mr. David Chamerlin, Minister of Music at the First Free Will Baptist Church in Jesup, Georgia. The meeting was officially declared in session by the Clerk, Rev. James Roebuck, Pastor Memorial Free Will Baptist Church in Surrency, Georgia. After introducing the General Officers, the Moderator, Dr. Worthington introduced the Rev. Roger Russell, Moderator of the Midway Association and Pastor of First Free Will Baptist Church in Blakely, Georgia. Moderator Russell extended a very warm welcome to everyone.



Votes to be counted that day and the announcement made—"Woman of the Year". She shall be honored in a special way. To be eligible for this nomination she must be a member in good standing (Representation Fee paid). She may be living or deceased. Suggestion: Districts should elect or decide on their representative at their District Convention or their Spring Workshop.

2. The Georgia WA retreat be held April 18-19, 1980 at Camp Mt. Bethel.

3. The State project be to give added financial support to the Northside Free Will Baptist Mission Land Fund (Larry Nix-Home Missionary, Marietta, Ga.) and to the Sandra and Dale Bishop Fund (Missionaries to Japan). That we have a goal of \$5,000 to be equally divided. The Bishop Fund to be completed by June 1, 1980, since their tentative schedule date to return to Japan is July. 4. The period of service for any one person as a state officer be a maximum of two elected consecutive terms (4 years); whereupon, she may not serve in any capacity as an officer for one term before being elected to another office. (The Constitution and By-Laws were changed to meet this resolution.) 5. Auxiliaries so desiring support the WNAC SOS (Save Old Stamps) Project. 6. Each district secretary include the date, time and place of their next annual auxiliary convention in their reports to state recording secretary. 7. Special Enlistment thrusts be promoted by local auxiliaries both during January (Enlistment Month) and August (WNAC Emphasis Month) for the purpose of enlisting women in membership and in active service. We encourage the use of the enlistment materials available from the WNAC office. 8. Whereas, at the request of WNAC, the Master's Men have taken over the promotion of Servicemen and Chaplain's Sunday, we concur with their recommendation that Servicemen and Chaplain's Sunday be designated Armed Forces Day to include both men and women. 9. A special effort be made to arouse interest in missions and in spiritual growth by establishing the individual reading plan. Each member is encouraged to "Know and Grow" by reading at least two books from WNAC's approved study list. That Mission Study Chairman may pass a carefully chosen book from one member to another, each signing her name indicating she has read the book. When all have completed reading the book, a summary may be given in the group meeting, climaxing what may have been two or

three months of diligent reading by the members. Homebound members may be included in the study.

10. Because of excessive inflation and ever increasing costs, our auxiliaries prayerfully consider increased support of WNAC by regular gifts to the Co-Laborer Fund by a tithe of monthly offerings or a designated budget.

11. The Ga. WA Convention support the first National WA Retreat to be held September 25-27, 1980 at the Smoky Shadows Conference Center, Pigeon Forge, Tenn. (4 Miles north of Gatlinburg).

12. We give the Albany Church and the Midway District Convention a rising vote of thanks for the wonderful hospitality extended to us today.

-Saturday, March 28, 1979-State Office, Moultrie, Ga.


-Saturday, May 12, 1979-State Office, Moultrie, Ga.

Another year has passed, summer has ended and business has been very successful. The meetings of the Executive Board have gone smoothly and the actions among the members has been decent and in order and especially in the Spirit of Christ. Therefore, resulting from these meetings, the following reports and recommendation are presented to this body assembled at our Forty-third Annual Session, November 15-17, 1979 for your actions and approval.

#### **REPORT OF THE EXECUTIVE SECRETARY TREASURER GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS**

The State Office was moved back to Moultrie in February, after almost two and a half years in Dublin. Giving to the state work had suffered during the past two years. However, the receipts from February to June show a marked increased. I believe this is because of the personal contact during the past few months. I have been able to be in thirty churches in the past five months.

The number of churches giving through the State Office has increased this year. Other churches have increased in the amount they gave.

Giving through the State Office is up more than five thousand dollars in the past fiscal year. Giving to State Missions is up over four thousand dollars this year. Giving to the State and National departments surpassed last years giving by more than twenty thousand dollars.

*Christian Supply Store* Mr. Wayne Lacey, who had served as manager of the Christian Supply Store for the past 16 months, resigned in March. Mrs. Ida Tabb accepted the position of manager in April. #### EXECUTIVE SECRETARY-TREASURER GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

#### I. POSITION DEFINITION AND RELATIONSHIPS

The Executive Secretary of The Georgia State Association of Free Will Baptists shall be the chief administrative officer of said organization and as such shall be charged with carrying out the duties, functions and business of the office as stipulated and set forth in this document. He shall have no legislative or judicial powers and shall be accountable to the Executive Board of The Georgia State Association, acting in the capacity of Employee Supervisor.

He shall also, in addition to his duties, functions, and business as Executive Secretary, serve as Treasurer of The Georgia State Association of Free Will Baptists. The functions, duties and responsibilities of his office are set forth in this document. Inasmuch as The Georgia State Association of Free Will Baptists is a democratic entity, composed of District Associations so separated by distance that only one meeting of the Body corporate is held once a year for business and deliberations, the Executive Board of said State Association is empower under Section I, Paragraph B, of the By-laws of said State Association to act for and in behalf of The State Association in matters which by their nature require immediate attention, said actions of which are subject to the action of The State Association in regular or called session. Therefore, the Executive Secretary shall be considered an employee of The State Association of Free Will Baptists, inasmuch as he is officially elected by the Body, and shall operate under the direct supervision of the Executive Board of said Association. It follows under this arrangement that the Executive Secretary, as an employee of The State Association, has the right of appeal from any decision of the Executive Board involving his office directly to The State as his employerin-fact, but only after all efforts at reconciliation, adjustments, and/or settlements of any and all differences between the two parties have been exhausted.

## II. TENURE OF OFFICE

The Executive Secretary shall be employed by the Executive Board of The Georgia State Association of Free Will Baptists, subject to the ratification of said Association at a Regular or called meeting, and shall serve for an indefinite period of time under the following provisions:

The Executive Secretary-Executive Board relationship may be termin-

ated by the Executive Secretary, who shall give a sixty (60) days' notice to the Executive Board of his intentions, along with his reason/s for terminating said relationship.

In the event the Executive Board desires to terminate the relationship, the procedure shall be the same as stated above.

When such termination of service is desired by either party, a twoweek's notice of intent shall be given by the party instituting the action to the other party, thus allowing for a joint hearing on the matter before the sixty (60) day termination clause becomes effective.

#### III. MATTERS OF DEALING

It is obvious that the Executive Secretary cannot have a multiplicity of bosses. Since the Executive Board is composed of several members, someone must be voice of all of them. The Executive Board shall designate two (2) of its number to serve as an Employer-Advisory Committee to handle all its external dealings with the Executive Secretary. The internal affairs connected with the office shall be handled deliberatively by the Executive Board in regular or called session.

The Employer-Advisory Committee shall be available to the Executive Secretary at all times for advice, counsel and assistance in all matters pertaining to the functions of the office in whatsoever capacity needed.

This Committee shall be appointed by the Moderator of the Executive Board annually immediately following each session of The Georgia State Association of Free Will Baptists. The actions of this Committee are subject to the final action of the Executive Board.

## IV. JOB DESCRIPTION

## A. EXECUTIVE SECRETARY

- 1. Editor of the State publication, The Promotional Bulletin.
- 2. Over-see the overall operation of the Free Will Baptists State Office, Christian Supply Store, Camp Mt. Bethel and all other Properties owned by The Georgia State Association of Free Will Baptists.
- 3. Serve as ex-officio member of each of the standing Boards of The State Association. Coordinate the work of these Boards so as to eliminate duplication and overlap. All Boards shall notify the Executive Secretary of the time and place of their meetings, and as possible, he will attend all Board meetings.
- 4. Submit an annual report to The Georgia State Association of Free Will Baptists at its annual session. This report will contain the report of all Boards.
- A. TREASURER
  - 1. Receive and disburse all funds directed through The State Office.
  - 2. Disbursement of these funds shall be as directed by vote of The State Association.
  - 3. Have all financial records audited annually by a recognized C.P.A.
  - 4. Submit a completely audited financial report of all operations



under his jurisdiction to The Georgia State Association at its annual meeting.

## V. REMUNERATION

The salary of the Executive Secretary shall be determined by the Executive Board. He shall receive the following additions.

- 1. Housing shall be furnished and all utilities paid.
- 2. Retirement and Insurance shall be determined by the Executive Board.
- 3. Employer share of Social Security.
- 4. Travel in connection with the office of Executive Secretary shall be paid at a rate as set by the Executive Board.
- 5. The Executive Secretary shall be allowed four (4) weeks vacation each year with pay.
- 6. Funds received by the Executive Secretary for revivals, special speaking engagements and promotional meetings, shall go into the cooperative fund. The exception to this regulation relates to any remuneration received by the Executive Secretary during his four-weeks vacation. These funds shall be his personally and need not be accounted for before The State Association.
- 7. The salary for secretarial help for the State Office shall be set by the

Executive Board. The Executive Secretary is given the right to employ a secretary at his discretion.



Method of Accounting—The accompanying statements of cash receipts and disbursements for the General Fund, and Special Fund have been prepared on a cash basis; taking into accounts cash receipts, and cash disbursements for the year ended June 30, 1979. The statement of net income for the Christian Supply Store has been prepared on a cash basis except for the inclusion of inventory, the accrual of inventory purchases, and the inclusion of charge sales for the period from July 1, 1978 to June 30, 1979.

Notes to Financial Statements

Note 1.

Payments totaling \$1,697.41 were made during the year on the notes payable to Citizens & Southern Bank of Colquitt County by the Christian Supply Store. Of the amount paid to Citizens & Southern Bank of Colquitt County, \$1,249.71 was paid on the \$7,500.00 installment note made February 2, 1972; and \$447.70 was paid on the \$13,532.50 note made March 29, 1979. The February 2, 1972 installment note had a remaining balance of \$2,786.88 and the March 29, 1979 note had a remaining balance of \$13,084.80.

The statements do not include a provision for depreciation.





#### **REPORT OF THE GEORGIA MISSION BOARD**

We your Georgia State Mission Board would like to thank you for your continual prayers and financial support through the past year. God has used you to support Georgia Missions and supply the financial needs of our mission board. It is with your prayers and support that many souls have been won to the Lord through our mission churches this past year.

The mission board held only one meeting this year, but had several committee meetings to handle the business. Some business was handled by the telephone.

The Northside Atlanta mission has been established in the Smyra, Merietta area of Atlanta. This church is located about 40 miles from the Decatur church. This group met in a community center for a few weeks, then in the home of Bro. Larry Nix until they were able to use a local school building.

On May 5, 1979 the mission board met in Atlanta with Bro. Larry Nix and some of the families of the church. The purpose of this meeting was to look at a piece of land the group was wanting to purchase. Due to the unusual circumstances and county ordinances in Cobb County concerning a church,



the mission board voted to approve Bro. Larry Nix and the Northside Atlanta mission to purchase 13.57 acres of land for the sum of \$54,280.00.

We have continued supporting Dalton, Georgia and Bro. Earnest Harrison for the past year. The Dalton church is a well established church, under the leadership of Bro. Robert Wood, who resigned last year due to his health. Bro. Earnest Harrison has pastored the church since June 1978. They will become self-supporting on December 1, 1979. Continue to pray for Bro. Harrison and the Dalton Church.

In January 1979 Bro. Dowdney moved from Dublin to Moultrie, Georgia. The Dublin church was without a pastor from February to July. Several preachers in the area would go to Dublin on Sunday afternoon to preach to the group. On May 5, 1979, the mission board hired Bro. James D. (Jimmy) Miller of Lancaster S. C. to pastor the church. Bro. Miller moved to Dublin in July 1979 and has reported continual growth in the church. We are paying Bro. Miller \$325.00 a month housing and no salary. Pray that we will have a strong Free Will Baptist Church in Dublin, Ga.

We have supported the churches in Statesboro, Athens, Swainsboro and Rome with the designated giving to these churches.

We the mission board, with Bro. Jerry Johnson and the Athens church would like to thank each of you who gave to the "Jerry Johnson Day" in support of the Athens bond payment. The offering was \$1,638.62.

## **REPORT OF GEORGIA BIBLE INSTITUTE**

Georgia Bible Institute opened officially on Monday, September 24, 1979, with four fulltime students and eleven part-time students. With the departure of Dr. Melvin Worthington from the State to assume the office of Executive Secretary of the National Association of Free Will Baptists, Dr. Damon C. Dodd was named President of the Institute. Dr. Irvin Hyman serves as Academic Dean and Vice-president, and Mr. Danny Thomas is Registrar. The opening days of the Institute were so smooth and harmonious that a casual observer would have thought it was an old, established school. Students

were eager and cooperative and the Administration and Faculty had prepared well for the occasion, so that we got off to a beautiful start. Some of our students had had previous college experience and they were most helpful in orienting the others to the pace of school life. We have a lovely spirit of cooperation and mutual endeavor among our students and faculty. Our teachers are efficient and well prepared, the Administration has the welfare of both faculty and students in mind, and up to this point no difficulties or problems have arisen.

Instruction in the classroom is on a high level and students have exhibited a genuine interest in the courses and a good level of comprehension of the courses being taught. Mid-term exams have just ended and we were all delighted at the student's grades in all courses. All in all, we are off to a better-than-average start and are looking forward to greater and better things in the future.

We are aware of the fact that not everyone can take the time to enroll as a fulltime student in GBI. Therefore, we are planning to take GBI to everyone. Our Christian Leadership Training Program will offer several practical courses in various localities over the State. They will be of two nights' duration, with three hours of instruction each night. Successful completion of a course will earn two hours' credit toward the CLTP Certificate, which will be awarded upon the completion of 18 hours of study. Information regarding this program will be made available as soon as the final details are worked out.

As the demand arises, we will be setting up Extension Units of GBI in various sections around the State. Local qualified people will be employed as instructors in these extension units and work done by students will be fully accredited by GBI. We feel that under our present program we can be justified in establishing an extension unit in any area where a minimum of eight students can be enrolled. If you would like to plan for such a unit in your area, please see President Dodd or Dean Hyman. Faculty members are presently receiving no salary for their services but are being given 15¢ per mile travel allowance to and from their assignments, plus allowance for one meal. As the Institute grows and finances permit, we will work out a salary schedule commensurate with our income. I would like to publicly express my appreciation to the faculty members for their unselfish and dedicated service. To see and hear them in action before their classes, one would think that they were being handsomely paid—and in reality they are as God pours out His very finest blessings on their efforts. Our special thanks go to First Free Will Baptist Church of Albany. This outstanding church is furnishing all facilities for the Institute program free of charge. For this Christian service and generous gesture in helping our State to launch her present education program, we would like for this Body to give a rising vote of thanks to First Free Will Baptist Church of Albany, Georgia. We need more students! GBI is not limited to ministers. We welcome lay people to our classes. Nor is GBI limited to Free Will Baptists. Any Christian who has a need for Bible training and church programming and procedures is invited to enroll. In the words of an Old Testament character, "Come thou with us and we will do thee good." GBI does not have an overplus of funds, but we are solvent and debt-free. We would like to have at least 20 churches over the State to give \$25.00 per month to help us get a good start in our program. Already two churches, First of Colquitt and New Home of Miller County, have voluntarily begun sending

us this amount. If you feel that we have a worthy program—one in which you would like to have a part—put us in your budget.

Thank you for your prayers and support. Please continue both in the days and months ahead.

#### **GEORGIA BIBLE INSTITUTE**

Georgia Bible Institute opened for classes on September 24, 1979 in the facilities of First Free Will Baptist Church, Albany, Georgia, with 14 students and 5 instructors.

The students are taking courses in six different areas: Bible, Music, Communications, Evangelism, Pastoral Theology, and Theology.

Each of the students appear to be very pleased with the programs of study. They are making good grades, and are looking forward to the time when their work with GBI will be completed.

At the present time, classes are being conducted on Monday of each week from 8:00 A.M. to 9:00 P.M.

Every effort is being made to provide a good Christian education at the lowest possible costs. The tuition at GBI is \$16.00 per quarter-hour. This means that if a student takes a full load of 10 quarter-hours, the total comes to \$160.00. In addition, the students are required to furnish their own textbooks, which amounts to about \$35.00 per quarter. Our purpose at GBI is to provide quality training for those who will not be able to secure it at FWBBC or other Christian institutions. The school seeks to meet this need of training on an institute level. The program of study is a 3 year terminal course designed to adequately aquaint the student with subjects that are most essential in doing the work of the Lord more effectively. If you are interested in taking work at GBI please go by our booth and secure an application along with a brochure that explains more fully the school's program.

### GEORGIA STATE ASSOCIATION OF FREE WILL BAPTIST NOVEMBER 15-17 FINANCIAL COMMITTEE REPORT

At the Forty-Second Annual Session of the Georgia State Association, meeting with the Dublin Free Will Baptist Church in Dublin, Ga., a study committee was appointed to study the financial structure of the State Assoc. The purpose of the Committee, as expressed by the Executive Committee, was to study the methods of giving in our State, and to suggest possible ways of improving the financial structure.

The committee proceeded in the study by sending out a questionnaire to the Churches in our state to get an across the board opinion of what people wanted and would best support as the methods of giving. The questionnaire showed a very favorable acceptance and support to the Co-Operative Plan of giving. A few expressed support to designated giving only. The committee concluded that the majority of our Churches and ministers were for the present system of giving. We therefore turned our attention to ways of improving the present system of giving.

The purpose of the Co-Op Plan is to provide for the financial needs of our Denominational works on each level by giving our income to a central source and then distributing these funds to every phase of the work. We co-operate together in a unified effort, working together, giving together, to support every area of the ministries of Free Will Baptist. This is true co-operative giving. What might we do to have the best co-operative effort? How can we improve our use of the Co-op plan in our state? The Financial Committee feels there are at least two things worth our consideration.

1. That there should be established in our State a regular training program to present the Co-Operative Plan to our Churches, both pastors and membership, and to educate them concerning Co-operative giving.

2. That our State should work under a State Budget that would include all the funds given through our State to outside causes. The budget would consist of the money given to the Co-op plan, the money designated, and the money given directly from Churches to outside causes.

These two proposals are further explained separately in the balance of this report.

Proposal 1. That there should be established in our State a regular training program to present the Co-op plan to our Churches, pastors and membership, and to educate them concerning Co-operative giving. The proposal would include the following in its implementation:

- a. A pastoral training program by means of cassette tapes explaining the Co-operative plan.
- b. Special ministerial training programs and discussion meeting at the district associational meetings.
- c. A special training session at the State meeting in the form of a work-shop or seminar conducted by a qualified person.
- d. A three-session study course designed for the local Church to be used on Sunday Evening or Wednesday night explaining the Co-op plan in layman terms.
- e. A publicity campaign coordinated from the State Office that would include a presentation at each quarterly meeting, a feature article each month in the Promotional Bulletin, and distribution of a wellwritten, illustrated pamphlet explaining the Co-op plan.
- f. The use of motivation and incentive to encourage support to the Co-op plan such as, annual goals set for enlisting new supporters to the program, recognition of new supporters by an appropriate plaque, and a Church-of-the-Year Award for the Church with the highest per-capita giving, and also a yearly listing of the State's top ten supporters to the Co-op plan.

*Proposal 2.* That the State should work under a State Budget that would be made-up of all the funds given through our State. The budget would consist of the money given to the Co-op plan, the money given designated, and the


money given directly to outside causes.

How will the State budget work?

- a. All the money given by our Churches to outside causes would be included in the budget. We would consider all money given to be a part of the State's total financial picture. Look to page 6 of the report which is an example budget. The figures used are not real budget figures but are used to illustrate only. Now find the figure for Foreign Missions as an example. This figure would represent money given designated, the percentage of the Co-op plan, and what the Foreign Mission Board received directly from Georgia.
- b. All designated funds will go to the place as designated. If the designated funds exceed the amount budgeted to any part of the budget then it will go as designated. For example, the budget includes \$3,000.00 for State Missions. If the State Missions Board received \$35,000.00 in designated funds then all that money would go as designated, even though it is \$5,000.00 over the budget.
- c. The budget will be drafted each year by the budgeting committee. Each State Board or Committee will submit a proposed budget each year to the Budgeting Committee. The Budgeting Committee will draft the budget and present it to the State Meeting for ratification.

What are some benefits for using a Budget for our State?

1. A budget would move our State closer to a true total Co-operative effort. Since all money given to outside causes make-up the total budget and manifests what we are doing together from our State. 2. A budget has built-in incentives. a. It encourages giving because everyone can have an equal share in providing for all our ministries on the State and National levels. b. It gives a closer accounting to our State of the money given from our Churches to outside causes. We will have in one report the sum of our outside finances. c. It sets goals for each ministry as to money needed to minister. The goals will be set by the State Association as the budget is adopted. We set the goals. We meet the budget by working together. d. It helps us to be better stewards of the money from our Churches. One idea in stewardship is proper management. You will have an active voice in helping to manage our State finances. 3. A budget has some built-in checks and balances. It would prevent a State Board or Committee from spending in excess the amount of money budgeted by the State Association. It would require preplanning by these State Boards as to money needed for the year. Since they will submit a proposed budget to the Budgeting Committee of the amount of money needed, it should be possible to work within that amount. 4. Our State needs an established, consistent method of managing our finances. A budget will give us that method needed. It should deliver us from frequent changes being made in the management of the State's money. 5. Many Churches have found the benefits of using a Church budget to



manage Church finances. It would be wise for our State to adopt the best methods available to manage our business.

### **REPORT OF GEORGIA WOMAN'S AUXILIARY CONVENTION**


The theme was "Keys to Service" at the Georgia WA Retreat last April when 116 ladies gathered at Camp Mt. Bethel to share in this annual time of inspiration, information and fellowship. Each district was given a specific part of the program to develop and this proved to be a great blessing to all.

The 1978-79 Georgia WA Project was very successful. We gave \$5,804.18 for the Jerry Banks' Account—over \$800.00 above our \$5,000.00 goal!!! And we praise the Lord for this!!!

The Albany FWB Church hosted the 1979 annual convention on November 14 and 15 with Dale Bishop, missionary to Japan briging the Wednesday night message on "Christ, Our Missionary Example." The convention theme was "Knowing and Growing" based on Ephesians 4:16b. Sandra Bishop was the featured speaker with Dale Bishop and Jean Hyman bringing devotional thoughts on Thursday when 192 registered.

Gifts to Missions and missionary causes totaled almost \$23,000 the past year and a convention love offering of \$600.00 was given to the Dale Bishops' Account. A total membership of 636 was reported through 55 local auxiliaries: 54 reported through 8 district conventions and 1 local in the Ogeechee Association. Plans made for the coming year included the adopting of a joint project with a goal of \$5,000.00 to be equally divided between the Dale Bishops' Account (this part should be completed before June 1 since they plan to return to Japan in July of 1980) and the Northside FWB Mission (Smyrna, Ga.) ## **REPORT OF THE HISTORICAL COMMISSION**

The Historical Commission has completed its first project—that of

restoring the burial place of Rev. John Brodnax, Sr., the founder of Free Will Baptists in Georgia. The site, located in Providence Church cemetery, Columbus, Georgia, has been cleaned up, an attractive headstone placed at the grave, and the entire plot enclosed with curbing and covered with marble chips. Since the 1980 session of the State Association will be held in the Columbus area, we will conduct the dedication and memorial service during that time.

Our next project is the placing of an historical marker on the grounds of Providence designating this as the site of the first Free Will Baptist Church in the State. # **RETIREMENT CENTER STUDY REPORT**

Last year at this time the State Association appointed this committee to investigate the possibilities of our state work having a Christian retirement center. We saw our work chiefly as gathering information. A questionnaire was sent to 2,300 names on the state office mailing list so that we might get a cross-section of opinion. We asked five questions:

1) Do you understand what a "retirement village" is?

(78% of those responding said they did)

2) Would you be in favor of our state work having a Free Will Baptist retirement village?

(71% said, yes) (8% said, no) (11% were undecided)

3) If our state had this kind of ministry would you support it?

(70% said, yes) (12 said, no) (8% were undecided)

4) If we had this ministry in Georgia would you consider moving to it upon retirement age?

(34% said, yes) (37% said, no) (19% were undecided)

5) Do you have plans for your retirement made already?

(38% said, yes) (40% said, no) (8% had indefinite plans)

We also solicited the comments of those responding. There were many interesting comments. There was an overwhelming response of favorable comments.

The committee chairman went to Nashville, and had a consultation visit with Rev. Herman Hersey, Director of the Board of Retirement and Insurance. Bro. Hersey gave much help and presented the committee a book on the subject.

The committee recommends that this study be continued another year and that at the 1980 annual session concrete recommendations be made. We ask that additional committee members be appointed to assist.

## CONSTITUTION AND BY-LAWS GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

## PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the Cause of Christ.

## **ARTICLE I**

This assembly shall be known as the Georgia State Association of the Original Free Will Baptists, Inc.

#### **ARTICLE II**

SECTION 1. The officers of this association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and an Executive-Secretary-Treasurer.

SECTION 2. All regular officers and the chairman of each of the

standing boards shall compose the Executive Board.

SECTION 3. This association shall be composed of all active Ministers, Deacons, Missionaries, and Board Members who are members of affiliated bodies: one (1) delegate for every three hundred (300) members or fraction thereof from District Associations: one (1) delegate for every one hundred (100) members or fraction thereof from each local affiliated church.

SECTION 4. All delegates from District Associations and local churches shall be elected from the laity of the body sending them.

SECTION 5. Funds to meet current needs of this body shall be paid to the treasurer of this association. Each District Association give a minimum of fifteen dollars (\$15) per delegate authorized, and each local church give ten cents (\$.10) per capita of their respective memberships.

## ARTICLE III

SECTION 1. It shall be the privilege of each affiliated District Association to recommend a member for each standard board. Terms of office on these boards shall be on a rotating basis which will necessitate the election by the State Association of four (4) members every two (2) years, thus giving each member a four (4) year term of office.

SECTION 2. There shall be a Board of Missions composed of members who are noted for their missionary zeal. This board shall have supervision of all missions interests sponsored by this body.

SECTION 3. There shall be a Board of Christian Education and Camping whose duties shall be:

A. To be responsible for maintenance, upkeep, and insurance of Camp Mt. Bethel.

B. To schedule and arrange all camp sessions to be held at Camp Mt. Bethel, and to appoint the Camp Director each year. It is understood and agreed in this connection that the Camp Director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.

C. To assist in promoting all educational services sponsored by this State Association in cooperation with the agency scheduling the activity.

SECTION 4. There shall be a Board of Retirement and Insurance whose duty it shall be to adopt plans and rules which are amendable with the National Association's Board of Retirement and Insurance. They shall also formulate plans for financing this ministry.

SECTION 5. There shall be a Board Of Trustees whose duties shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all future developments; and expansion of these properties as directed by this association except as otherwise provided in this Constitution.

SECTION 6. There shall be a Credentials Committee which shall consist of three (3) members who shall be in charge of the registration and examination of delegates and the receiving of all dues. These members are to be elected at the time of the General Officers.

SECTION 7. There shall be a member of the Board of Trustees of the Free Will Baptist Children's Home, Eldridge, Alabama elected during the 1971 session for a term of four (4) years. Election thereafter shall be for a four (4) year term.

SECTION 8. The treasurer of each board shall be bonded through the State Office in an amount stipulated by the board of which he is treasurer. The bonding fee shall be paid from the treasury of said boards.

# ARTICLE IV

SECTION 1. All officers except board members and the Executive-Secretary-Treasurer shall be elected to serve a term of two (2) years. The Executive-Secretary-Treasurer shall be employed by the Executive Board of the Georgia State Association of Free Will Baptists, subject to the ratification of the Georgia State Association of Free Will Baptists as its next regular session, for an indefinite period, with an agreement of a sixty (60) day notice of termination by both the employee and the Executive Board as the employer.

SECTION 2. Standing boards of this Georgia State Association of Free Will Baptists have no power or final authority to hire fulltime employees until the matter has been presented to and acted on by this association in regular session. This does not apply to fulltime Missionaries sent out under the Mission Board.

SECTION 3. Vacancies on any of the boards or committees which occur between regular sessions of this State Association, may be filled by the Executive Board until the convening of the annual session of said association.

SECTION 4. Election of all General Officers shall take place on the odd years of the calendar.

SECTION 5. If a member of any board fails in the function of his or her duty without good and sufficient reasons, the board of which the deliquent is a member may declare that particular office vacant. Further, this body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian, business-like manner according to the rules of Christian conduct as set forth in the New Testament.

Any standing board of this State Association may appoint proxies to serve in lieu of the absent members.

At the pleasure of the boards, and subsequent to the meeting from which the regular member absented himself, the boards have the right to deal with the deliquent member in the manner stated in the previous paragraph.

SECTION 6. Boards may be called into session by the Chairman or Vice-chairman of said board, or by the Moderator or Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said boards.

### AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this association and shall lie on the table from one (1) business meeting to the next during the same session, during which time it shall be read at least two (2) times in open session. Officers, standing boards, and/or standing committees may be added or deleted as the need arises.

## **BY-LAWS**

SECTION 1.

A. The Georgia State Association of Free Will Baptists shall meet for its regular session annually on Thursday following the second Sunday in November and shall adjourn on the Saturday immediately following.

B. The Executive Board shall meet quarterly on Saturday before the second Sunday of the following months: February, May, August. The November meeting of said board shall be held just prior to regular meeting of the State Association.

The Executive Board of the Georgia State Association of Free Will Baptists shall act for and in behalf of said association on matters which by their nature require immediate attention. All such actions by the Executive Board shall be subject to the final action by the State Association.

**SECTION 2.** 

A. The Moderator shall preside at the Annual Sessions of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board. The Moderator shall be the President of the Corporation known as the Georgia State Association of Free Will Baptists Inc.

B. The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.

C. The Clerk shall keep records of the proceedings of the Annual Associational meetings and of the Executive Board meetings. It shall also be his responsibility to have the minutes of these sessions printed and distributed. The Clerk shall be the Vice-President of the Corporation known as the Georgia

State Association of Free Will Baptists Inc.

D. The Assistant Clerk, in the absence of the Clerk, shall fullfill the functions and duties of the Clerk as stated in paragraph C of this document. SECTION 3.

A. The Executive-Secretary shall be responsible and accountable to the Executive Board in the fullfillment of the duties of his office as determined by said board.

B. The Executive-Secretary shall be allowed four (4) weeks vacation per year with pay.

C. Funds received by the Executive-Secretary for revivals, special speaking engagements and promotional meetings, shall go into the Cooperative Fund. The exception to this regulation relates to any renumeration received by the Executive-Secretary during his four (4) weeks vacation, which funds shall be his personally and need not be accounted for before said association.

D. Salary, mileage, and operational expenses of the Executive-Secretary shall be determined by the Executive Board.

E. The Executive-Secretary shall be Secretary-Treasurer of the Corporation known as the Georgia State Association of Free Will Baptists Inc.

SECTION 4.

A. The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the board shall investigate places suitable for this meeting and make recommendations to said State Association. In as much as possible, this association shall meet on a rotating basis within the District Associations. Meeting places shall be determined two (2) years in advance. B. The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of Parliamentary Procedure. C. The Executive Board shall formulate the budget for the State Association annually and recommend to the body in session the allocations to be observed in the Cooperative Plan of Giving. This board shall in addition to the above stated duties, also recommend a mileage rate for travel by the members of all of the standing boards of said association. **SECTION 5.** Necessary committees shall be appointed by the Moderator unless otherwise provided for by the body. **SECTION 6.** These By-Laws may be altered, changed, or amended at any regular session of this association by a two-thirds (2/3) vote of delegates present and voting.
