PROCEEDINGS OF ANNUAL MEETING

The Forty-Eighth Annual Session of the Georgia State Association of Free Will Baptists convened at the Norman Baptist Assembly, Norman Park, Georgia, on November 15-17, 1984. The theme was "Building His Church", taken from Matthew 16:18. The music for this session was provided by Danny Thomas, coordinator and Sandra Jackson, pianist.

THURSDAY EVENING

Randy Jackson directed the congregation in singing, "He Keeps Me Singing", and "Whosoever Meaneth Me". The presiding officer, Jimmy Brown, welcomed the audience to the meeting. Prayer was led by Jimmy Corsey. The Clerk, Ronald Wallace, declared the Forty-Eighth Annual Session in order. The Officers of the Association were introduced. Moderator, William Morris, recognized the 167 attenders by a roll call of the District Associations.

The Moderator appointed the Committee on Committees which are: Mance Cason, Chairman, with Russell Horne, Bill Robinson, Harris Nix, and Leroy Lowery serving.

The Clerk gave a partial report of the Executive Board's report which contained a recommendation requiring a Constitutional change. A motion to accept the North Georgia Association into membership of the Georgia State Association, and the necessitated constitutional change in Article III, Section I, of the Constitution was placed on the table by vote of the Standing Delegates. Randy Jackson led the congregation in singing, "The Banner of the Cross". Herbert Waid led in prayer. An evening offering of \$113.28 was received for expense of the meeting. Russell Brewton provided special music by singing, "Jesus Laid His Glory Aside". Rev. I. Bennie Turner brought the message on the subject, "The Course of the Church", taken from Matthew 16:13-18. Ricky Cason gave a partial report of the Credentials Committee reporting a total attendance of 167 with 132 registering. A motion to recess was received. Sam Wilkinson closed in prayer.

FRIDAY MORNING

The presiding officer, Charles Corley, opened this session by calling on Leroy Lowery to lead in prayer. Song leader, Jack Lysaker, led the congregation in singing, "Since Jesus Came Into My Heart". Special music was provided by Mrs. Dorita Suggs with the song "Whatever It Takes". The morning devotional on the theme "The Cause of The Church", was given by Curtis Alligood.

A partial report of the Credentials Committee revealed an attendance



of 153, with 136 voting. Moderator, William Morris, called for a vote to seat the elected delegates. Several visitors from the National Departments were recognized. The Committee on Committees' report was given by Mance Cason. The following will serve on the Nominating Committee: Curtis Alligood, Chairman, Sam Wilkinson, Bobby Clyatt, Edward Newman, and Irvin Murphy. The Resolutions Committee for the 1985 Annual Meeting were named as follows: Jack Lysaker, Chairman, Gerald Baxley, O. B. Everson, Roger Spivey, and Jimmy Brown. A motion passed to adopt the report.

The Clerk gave the report of the Executive Board. A motion passed to receive the report and act on each item separately. The Committee appointed to study the problem of Short-term pastorates within Georgia gave a detailed report. Copies of the study, titled "Pastor Tenure Study", were handed out, additional copies are to be sent to each Pastor and Deacon Board Chairman of the Churches. A motion passed to receive the report and to retain the Study Committee to study the Financial Relationship of the Pastor and the Church.

A motion passed to remove from the table the recommended Constitutional change. A motion was adopted granting the North Georgia Association admittance into the Georgia State Association. A motion also passed approving the proposed Constitutional change. The change effects the second sentence in Article III, Section I, of the constitution which will be amended to read: "... the election by the State Association of five (5) members every two (2) years . . ." The proposed State Budget for the 1985-86 fiscal year was adopted. A motion to have a Special Day for Georgia Missionaries was tabled to allow for time to prepare copies of the full report for distribution. Executive Secretary Herbert Waid gave a report on the State Office which was received as information. A motion passed to give Herbert and Geraldine Waid a standing vote of appreciation for the outstanding ministry rendered in the State Office. Paul Suggs the presiding officer for the Worship Service called on Bobby Clyatt to lead in prayer. Randy Jackson led as the congregation sang, "Who Is On The Lord's Side". An offering of \$69.10 was received for the Meeting's expense. Special music was provided by Mr. and Mrs. Randy Jackson. "The Conviction of the Church" was the theme of the message delivered by Rev. Roger Russell. William Morris closed in prayer as the session recessed for lunch.

FRIDAY AFTERNOON

David Dollar the presiding officer called upon Len Blanchard to lead in prayer. Reuben Cason directed the congregation in singing "When We All Get To Heaven". The special music, "It Is Well With My Soul" was performed by Reuben Cason. Charles Clark brought the devotional message "The Confidence Of The Church" from the text

The Christian Education Board report was given by Mance Cason. A motion passed to adopt the report. Steve Hasty was recognized to give a report on the Historical Society. A motion was adopted to approve the formation of the Georgia Free Will Baptist Historical Society.

The following reports from State Boards were adopted: The Board of Camping report as given by Luther Burns; The Board of Trustees report as given by Herbert Waid; and the Board of Missions report as given by Benny Lariscy.

The following reports from the National Ministries were received as information: The National Executive Office report given by Dr. Melvin Worthington; The report for Free Will Baptist Bible College given by Ronald Creech; The report for the Sunday School and C.T.S. Department given by Harrold Harrison; The National Master's Men report given by Jim Vallance; And the Home Missions Board report given by Connie Cariker.

A partial report from the Credentials Committee revealed a total of 196 had registered. The session was declared in recess as Jerry Lepere closed in prayer.

FRIDAY EVENING

Malcolm Freeman presided over the Missions service. Prayer was led by Curtis Alligood. The congregation sang "Redeemed" as directed by song leader Ken Faison. Special music was provided by Bruce Kembrel with the song "Sometimes Hallelujah". Missionary Dale Bishop presented a letter from a Japanese Pastor sharing his burden with the sister Churches of Georgia. Ken Faison led as the congregation sang "I Love To Tell The Story".

A commissioning service was held for Luther and Delores Burns appointees to the South Atlanta area as Georgia Missionaries. The Missionary charge was given by Missions Board member James E. Bryant. The Missions Board members gathered around the Burns for the laying on of hands and a prayer of dedication. Johnny Beasley led the prayer.

The congregation sang "Standing On The Promises". A Missions offering of \$410.20 was received. The offering is to be shared by the Bishops and the Burns. The evening message "The Commitment Of The Church" was delivered by Home Missions Director of Evangelism Connie Cariker using the text Luke 7:19-23.

After several announcements were made, Dr. Melvin Worthington closed in prayer.



SATURDAY MORNING

S. E. Newberry the presiding officer called upon Harris Nix to open in prayer. Song leader Russell Horne directed the singing of "There Is A Fountain" and "Jesus Saves". The devotional message "The Completion Of The Church" was brought by Rev. Ken Murphy. A special time of invitation and altar call was extended during the service. "Just As I Am" was sung as an invitation hymn. Altar prayer was led by William Morris.

Billy Sharpston gave a report for the State Ministers Fellowship which was received as information.

Alabama Children's Home director Carlton Lambert reported on the past years activity at the Children's Home. The report was received as information.

Missionary to Japan Dale Bishop gave the report for the Foreign Missions Board. The report was received as information.

The final Credentials Committee report was given by Ricky Cason, and was received as information. The full report is in the reports section of the minutes.

The final Nominating Committee report was given by Curtis Alligood. A motion was adopted to accept the report and elect the nominees as submitted. Elected to the Trustee Board was Norman McFall. The following were elected to the Camping Board: Luther Burns, and these to replace former members, Ronnie Knighton, Ken Murphy, Gary Page, Randy Jackson, and John Freeman. Elected to the Christian Education Board were Gary Smith and as a replacement Tony Mitchell. Elected to the Board of Missions were B. Frank McKinney and as a replacement Ricky Cason. Elected to the Auditing Committee for 1985 were Mrs. Marian James, Mrs. Linda Gay and Mrs. Louvenia Kleedehn. Elected to serve as the General Board member for Georgia on the National General Board was Herbert Waid. The Resolutions Committee submitted three resolutions for consideration. A motion was passed to receive the report and act on each resolution separately. Item I received a motion to be rejected. This motion was defeated. A motion passed to limit debate to fifteen minutes. A motion to adopt Item I and limit debate to two minutes, two people each side was passed.

Item II was adopted. A motion passed for the Executive Board to appoint the Commission suggested in the resolution.

Item III was adopted. The complete Resolutions committees' report is in the reports section of the minutes.

A motion carried to remove from the table the recommendation to have a Special Day for Georgia Missionaries. The recommendation for A Special Day for Georgia Missionaries on an annual basis was adopted.

A motion passed to elect the folowing delegates to the National Association meeting: Gleason Fowler, Mary Lee Fowler, Russell Brewton, James Horne and Caffery Harris. The alternates will be: Dianne Martin, Shirley Sharpston, Curtis Gay, Pauline Gay and Charlene Neuenschwander.

A motion to adjourn was accepted. Tim Jordan prayed the benediction.

EXECUTIVE BOARD REPORT

It has been the joy and privilege of the men making up the Executive Board for the Georgia State Association to serve our Lord and Georgia Free Will Baptists this year. Looking over the State Ministries in retrospect, and observing new programs and leaders in motion, we can say with confidence that our State is well and progressing forward with favorable speed. We are grateful for your dedicated support to the Ministries of the State Association. We submit this report for your approval at this 48th Annual Session. The meetings of the Executive Board were held as follows: February 11, 1984 White Oaks, Macon State Office, Moultrie May 18, 1984 White Oaks, Macon August 11, 1984 September 22, 1984 White Oaks, Macon Norman Baptist Assembly, Norman Park November 14, 1984

WATCHCARE COMMITTEE APPOINTED

A Watchcare Committee was appointed to assist the North Georgia Association in becoming a member of the State Association. The Committee members are William Morris, Luther Burns, and Billy Sharpston. A recommendation is pending this meeting.

STUDY COMMITTEE APPOINTED

A Committee was appointed to study the problems of Short-Term Pastorates within our State. The Committee members are Leroy Lowery, James Ursrey, and laymen Billy James, Sherman Jones, and Joe Martin.

A copy of the Study committee's report is available for your reading. It is not reprinted here due to its length. However, it is included as a part of this report as a supplement.



We further recommend that the Study Committee be retained and that they pursue the subject of the Financial Relationship between the Church and its Pastor.

BOOKSTORE EMPLOYEE ADDED

Due to the work demands at the Christian Supply Store, Mrs. Charlene Neuenschwander was hired on a part-time basis beginning February 1, 1984.

PERSONNEL SALARIES INCREASED

Upon review of the salary base for the Executive Secretary and the Office Secretary Assistant, the Executive Board granted increases for each as follows: Executive Secretary increased to \$1200.00 per month, and Office Assistant to \$400.00 per month. It is also the candid opinion of the Executive Board that these salaries are below the norm for comparable work, and should be increased as funds permit.

SPECIAL DAY FOR STATE MISSIONS

A request was made by the Missions Board to be granted a special day each year to raise funds to be used for land and buildings by Mission Churches. This money was not to count against the amount budgeted to the State Missions Board. In light of this request a Committee was appointed to study the possibility of having a special day. This committee is to make its final report at the November Executive Board meeting.

PROGRAM COMMITTEE APPOINTED

The Moderator appointed the following to serve as the Program Committee for the 1984 State Meeting: Herbert Waid, Billy Sharpston and Eugene Ross. The program theme is "Building His Church", taken from Matthew 16:18.

COMPUTER FOR STATE OFFICE

A committee was appointed to look into the benefits and advantages of purchasing a computer for the State Office. No recommendation is ready at this time.

BUDGET COMMITTEE APPOINTED

A committee was appointed to submit a proposed State Budget for the 1985-86 fiscal year. The committee members are Herbert Waid, Emmett Dunaway and Eugene Ross.

At the time of the printing of the Digest and this report, the Executive Board still has the November meeting to attend. Any business or recommendations from that meeting will be included at the reading of this report.

Last year 72% of our churches made some contribution cooperatively to the State budget. We thank the regular givers for their faithfulness and the new cooperative givers that caused a 9% increased over last years 63% participation. If Free Will Baptists ever fulfill our potential to serve the Lord as a denomination we must work together. Those who would neglect cooperative giving responsibility by supposing that it is a "new" untried method and that the "old" no giving or selective giving designated to neglect ministries is better should read Free Will Baptist history.

Brother Damon C. Dodd in his *The Free Will Baptist Story*, page 102 states:

"The idea of a cooperative plan of support is not a novel one in the Free Will Baptist movement. At the 21st session of General Conference in Hillsdale, Michigan, October 4, 1871, a cooperative program was adopted as follows:

"Conference decides to raise annually a sum of not less than fifty cents per resident member of the denomination'

"Thus, the original cooperative program in the Free Will Baptist denomination was 40% for foreign missions, 40% for home missions, and 20% for education."

We are pleased to be recommending to the Executive Board a decrease in the 1984/1985 State budget percentages for State administrative and promotional ministries. This will allow a larger percentage of the State's 50% of the State budget to go to the State

Mission Board, Camp Mt. Bethel and the Board of Christian Education. As cooperative giving continues to increase, we hope to see this trend accelerate.

Again, designated giving to some national ministries, as worthy as they individually are, has denied other national ministries their proportionate need to be met.

This fact is clearly illustrated as one examines the receipts of our two Georgia foreign mission families, the Bishops and the Crowsons. The State of Georgia votes to support their ministries by putting them in the State budget. Meantime, other national ministries receive so much designated money each month that the total national ministries' 50% of the budget is not only pre-emptied but exceeded leaving our in-the-budget missionaries virtually without any budget money.

In fact designated national giving last year exceeded the national ministries 50% by 12.5% forcing Georgia State ministries to have to make do with 37.5% of Georgia giving. Note:

The ideal solution is not to decrease designated giving but to up the cooperative giving base until designated giving is not able to throw the budget out of balance. If all of our churches were to give 10% of their undesignated income to the State budget cooperatively this whole explanation would be unnecessary.

All in all this has been an exciting year seeing the blessing of our Lord on our denominational ministries. Thank you for allowing us to see from the prospective of the State Office the blessing on and through the good people of the Georgia State Association of Free Will Baptists.

COMMITTEE REPORTS

AUDITING COMMITTEE REPORT

The various financial statements and reports comprising the "State Association" were examined as to their accuracy and method of record keeping. In general the records were found to be extremely well kept and a true picture of the financial condition of the board. Since the auditing board is not independent of the state work there is no attempt on its part to "certify" the statements. The statements of the executive office were found to be in order and properly documented by signed receipts, canceled checks, and well kept records. The same was true for the Mission Board and Georgia Bible Institute. The statements for the Board of Christian Education, the Trustee Board, The Christian Supply Store, and the Camp Board all had to be developed after the information reached the Auditing Board and/or State Office. The Trustee Board and the Board of Christian Education provided adequate information to accomplish this job and adequate support materials to audit their statements. The Camp Board did not provide enough support materials to audit their statement. The statements for the Christian Supply Store were developed by the Auditing Board after examining the records. The Auditing Board under the direction of Mrs. Linda Gay observed the inventory and the value of the inventory was determined by the calculations of Mrs. Linda Gay and Mrs. Louvenia Kleedehn. There was in the records of the store some voids in the area of record keeping. Some entries were not included. In the development of the statements these voids were filled by backtracking from the information that was provided. It is our feeling that even with this problems the statements do adequately set

forth the financial position of the store.

As a whole the record keeping of the various boards is more than adequate. The State Office and Mission Board has established a model record keeping system for the other boards. Georgia Bible Institute also had a good set of records this time. The other boards and Christian Supply Store should be aware that they are responsible for the development of their own statements (they may use those in the Digest of Reports as examples) and that it is critical to document every transaction with supporting materials. Each treasurer should note that he is responsible for denominational funds thus he is responsible to some ten thousand Free Will Baptist in the State of Georgia. It is to the treasurer's advantage to keep exemplary records that his testimony and that of the denomination be preserved.

2. Whereas in recent years the church and state have been in conflict, and

whereas, a humanistic philosophy of life has made inroads into our society, and,

whereas we see a continuous secularization of our society by our



government as it passes legislation which is destroying the Godgiven liberties of individuals, families, and churches.

BE IS RESOLVED that the Georgia State Association of Free Will Baptist establish a commission which shall endeavor to keep well informed of what is taking place in our legal systems of our state and nation which affects individuals, families, and churches, and

BE IT FURTHER RESOLVED that this commission immediately report any legal decision in the making or having been established as law to our Executive Secretary who may in turn inform our congregations of what has or what may transpire, and

FINALLY that this commission seek to awaken the conscience of our people by informing and encouraging them to take an active part in the political interest of our state and country. *Adopted*

3. Whereas, the Consultation on Pornography and Indecency was organized because pornography in this country has reached epidemic proportions with emphasis on sexual exploitation/abuse of women and children, and




Our goal for '85 is to expand and encourage Master's Men Programs into more churches and build the programs that are in present churches even stronger.

CONSTITUTION AND BY-LAWS GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the Cause of Christ.

ARTICLE I

This assembly shall be known as the Georgia State Association of the Original Free Will Baptists, Inc.

ARTICLE II

SECTION 1. The officers of this association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and an Executive-Secretary-Treasurer.

SECTION 2. The Executive Board shall be composed of the regular officers; the chairman of each of the standing boards; and the previous moderator, as an exofficio member for a period of two years following his term of office. SECTION 3. This association shall be composed of all active Ministers, Deacons, Missionaries, and Board Members who are members of affiliated bodies: one (1) delegate for every three hundred (300) members or fraction thereof from District Associations: one (1) delegate for every one hundred (100) members or fraction thereof from each local affiliated church.

SECTION 4. All delegates from District Associations and local churches shall be elected from the laity of the body sending them.

SECTION 5. Funds to meet current needs of this body shall be paid to the treasurer of this association. Each District Association give a minimum of fifteen dollars (\$15) per delegate authorized, and each local church give ten cents (\$.10) per capita of their respective memberships.

SECTION 6. In order to pay our Georgia State Association's annual representation fee to the National Association, each local association is to be responsible to promote, receive and forward the amount designated by the National Association per church per year to the State Office, along with their annual State Association representation fee, on or before our annual State Association session.

ARTICLE III

SECTION 1. It shall be the privilege of each affiliated District Association to recommend a member for each standard board. Terms of office on these boards shall be on a rotating basis which will necessitate the election by the State Association of five (5) members every two (2) years, thus giving each member a four (4) year term of office.



SECTION 2. There shall be a Board of Missions composed of members who are noted for their missionary zeal. This board shall have supervision of all missions interests sponsored by this body.

SECTION 3. There shall be a Board of Camping whose duties shall be:

A. To be responsible for maintenance, upkeep, and insurance of Camp Mt. Bethel.

B. To schedule and arrange all camp sessions to be held at Camp Mt. Bethel, and to appoint the Camp Director each year. It is understood and agreed in this connection that the Camp Director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.

C. To assist in promoting all educational services sponsored by this State Association in cooperation with the agency scheduling the activity.

SECTION 4. There shall be a Board of Christian Education whose duties shall be:

A. To set policy and supervise the operation of Georgia Bible Institute. This Board shall appoint a President and a Dean to carry out Board policy. Also, the faculty, curriculum, materials, tuition, salaries and benefits are subject to the approval of this Board.

B. To set policy and supervise the functions of a State Youth Committee. This Board shall appoint this Committee to carry out Board policy.

C. To set policy and supervise the functions of a Historical Committee. This Board shall appoint this Committee to gather and set forth for public

knowledge and posterity the history of Georgia Free Will Baptists.

D. To set policy and supervise the functions of the Ministerial Fellowship. The Ministerial Fellowship shall elect its own officers.

All educational services sponsored by the Georgia State Association shall be under the sponsorship of this Board. Such things as annual Sunday School and Church Training Service seminars shall be the responsibility of this Board to plan, promote and supervise.

SECTION 5. There shall be a Board Of Trustees whose duties shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all future developments; and expansion of these properties as directed by this association except as otherwise provided in this Constitution.

SECTION 6. There shall be a Credentials Committee which shall consist of three (3) members who shall be in charge of the registration and examination of delegates and the receiving of all dues. These members are to be elected at the time of the General Officers.

SECTION 7. There shall be a member of the Board of Trustees of the Free Will Baptist Children's Home, Eldridge, Alabama elected during the 1971 session for a term of four (4) years. Election thereafter shall be for a four (4) year term.

SECTION 8. The treasurer of each board shall be bonded through the State Office in an amount stipulated by the board of which he is treasurer. The bonding fee shall be paid from the treasury of said boards.

ARTICLE IV

SECTION 1. All officers except board members and the Executive-Secretary-Treasurer shall be elected to serve a term of two (2) years. The Executive-Secretary-Treasurer shall be employed by the Executive Board of the Georgia State Association of Free Will Baptists, subject to the ratification of the Georgia State Association of Free Will Baptists as its next regular session, for an indefinite period, with an agreement of a sixty (60) day notice of termination by both the employee and the Executive Board as the employer.

SECTION 2. Standing boards of this Georgia State Association of Free Will Baptists have no power or final authority to hire fulltime employees until the matter has been presented to and acted on by this association in regular session. This does not apply to fulltime Missionaries sent out under the Mission Board.

SECTION 3. Vacancies on any of the boards or committees which occur between regular sessions of this State Association, may be filled by the Executive Board until the convening of the annual session of said association.

SECTION 4. Election of all General Officers shall take place on the odd years of the calendar.

SECTION 5. If a member of any board fails in the function of his or her duty without good and sufficient reasons, the board of which the deliquent is a member may declare that particular office vacant. Further, this body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian, business-like manner according to the rules of Christian conduct as set forth in the New Testament. Any standing board of this State Association may appoint proxies to serve in lieu of the absent members. At the pleasure of the boards, and subsequent to the meeting from which the regular member absented himself, the boards have the right to deal with the deliquent member in the manner stated in the previous paragraph. SECTION 6. Boards may be called into session by the Chairman or Vice-chairman of said board, or by the Moderator or Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said boards.

AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this association and shall lie on the table from one (1) business meeting to the next during the same session, during which time it shall be read at least two (2) times in open session. Officers, standing boards, and/or standing committees may be added or deleted as the need arises.

BY-LAWS

SECTION 1. A. The Georgia State Association of Free Will Baptists shall meet for its



regular session annually on Thursday following the second Sunday in November and shall adjourn on the Saturday immediately following.

B. The Executive Board shall meet quarterly on Saturday before the second Sunday of the following months: February, May, August. The November meeting of said board shall be held just prior to regular meeting of the State Association.

The Executive Board of the Georgia State Association of Free Will Baptists shall act for and in behalf of said association on matters which by their nature require immediate attention. All such actions by the Executive Board shall be subject to the final action by the State Association.

SECTION 2.

A. The Moderator shall preside at the Annual Sessions of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board. The Moderator shall be the President of the Corporation known as the Georgia State Association of Free Will Baptists Inc.

B. The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.

C. The Clerk shall keep records of the proceedings of the Annual Associational meetings and of the Executive Board meetings. It shall also be his responsibility to have the minutes of these sessions printed and distributed. The Clerk shall be the Vice-President of the Corporation known as the Georgia State Association of Free Will Baptists Inc.

D. The Assistant Clerk, in the absence of the Clerk, shall fullfill the functions and duties of the Clerk as stated in paragraph C of this document. SECTION 3. A. The Executive-Secretary shall be responsible and accountable to the Executive Board in the fullfillment of the duties of his office as determined by said board.

B. The Executive-Secretary shall be allowed four (4) weeks vacation per year with pay.

C. Funds received by the Executive-Secretary for revivals, special speaking engagements and promotional meetings, shall go into the Cooperative Fund. The exception to this regulation relates to any renumeration received by the Executive-Secretary during his four (4) weeks vacation, which funds shall be his personally and need not be accounted for before said association.

D. Salary, mileage, and operational expenses of the Executive-Secretary shall be determined by the Executive Board.

E. The Executive-Secretary shall be Secretary-Treasurer of the Corporation known as the Georgia State Association of Free Will Baptists Inc.

SECTION 4.

A. The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the board shall investigate places suitable for this meeting and make recommendations to said State Association. Meeting places shall be determined two (2) years in advance.

B. The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of Parliamentary Procedure.

C. The Executive Board shall formulate the budget for the State Association annually and recommend to the body in session the allocations to be observed in the Cooperative Plan of Giving. This board shall in addition to the above stated duties, also recommend a mileage rate for travel by the members of all of the standing boards of said association.

SECTION 5.

Necessary committees shall be appointed by the Moderator unless otherwise provided for by the body.

SECTION 6.

These By-Laws may be altered, changed, or amended at any regular session of this association by a two-thirds (2/3) vote of delegates present and voting.
