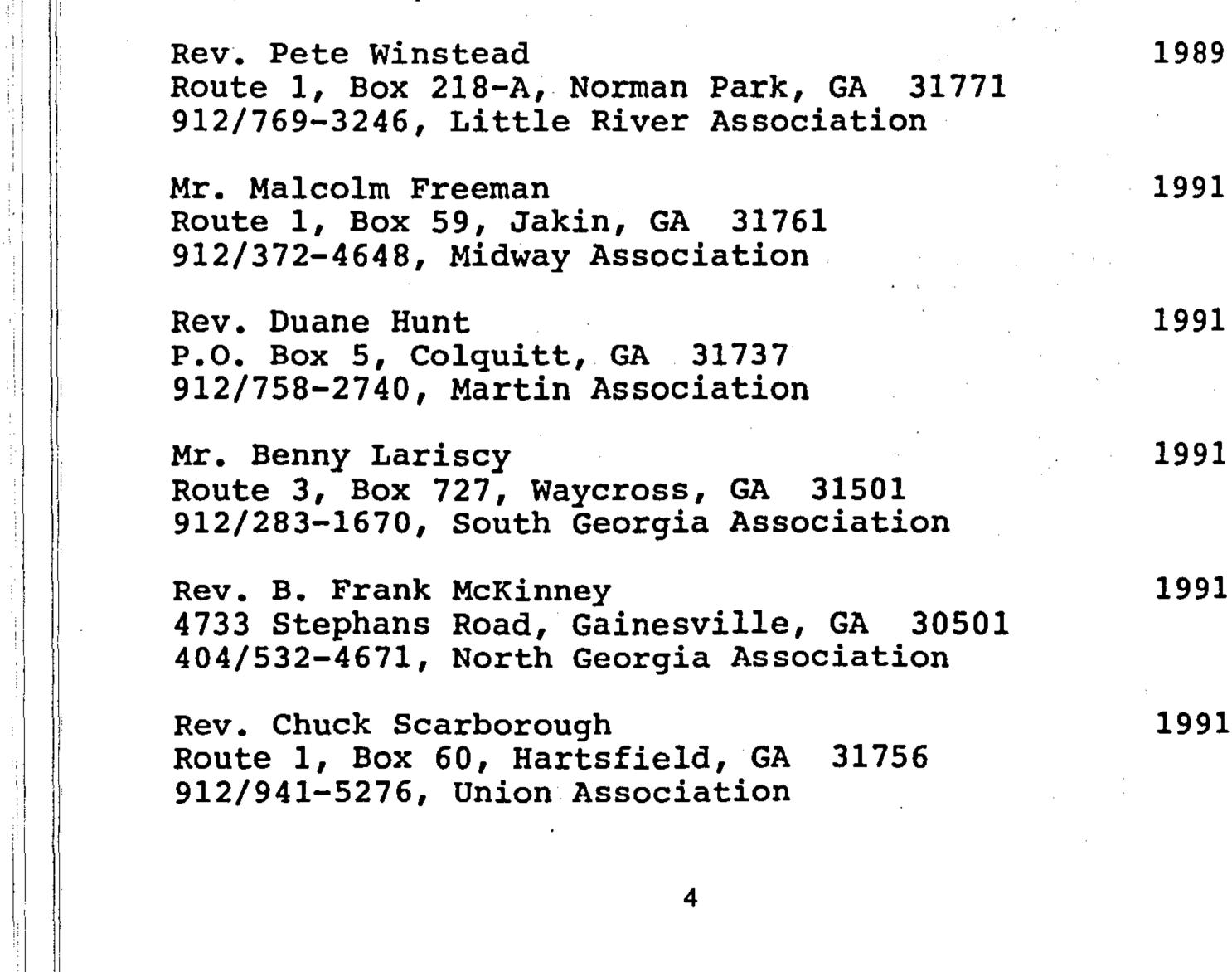

## PROCEEDINGS OF ANNUAL MEETING

The fifty-first Annual Session of the Georgia State Association of Free Will Baptists convened at the Norman Baptist Assembly, Norman Park, Georgia, on November 12-14, 1987. The theme of the meeting was "In The Cross of Christ", taken from Philippians 2:8. Music was coordinanted by the Rev. Billy Sharpston, and provided by various song leaders and singers, with Mrs. Barbara Fletcher as pianist.

### THURSDAY EVENING

Rev. Walter Daniels, the presiding officer, welcomed everyone to the meeting. Rev. Ken Faison led the congregation in singing, "Redeemed." Prayer was offered by Rev. Marty McWilliams. Pledges were made to both the American and Christian flags. The Clerk, Rev. James Ursrey, called the Session to order and declared the meeting open for business. He then introduced the Moderator, Rev. Ronald Wallace who extended a welcome to everyone. The Moderator appointed the Committee on Committees made up of the following: Rex Lynn, Chairman, Glenn Thomas, Bill Travis, Duane Hunt, and Russell Horne.

The Moderator called for a partial reading of the Executive Board Report by the Clerk. The item read dealt with the closing or selling of the Christian Supply Store. (See report). The Moderator made some additional statements regarding this matter for clarification. Discussion on this matter was set for 3:30 p.m. Friday. Rev. Ken Faison led us in singing "Are You Washed In The Blood?" The Presiding Officer, Rev. Walter Daniels then introduced Mrs. Brenda McNeese of Mother's Home Church, who directed the Church in presenting a most inspiring play, "The Last Days of Jesus". The Moderator received an offering of \$188.65 to help defray the expense incurred by the Church in preparing and presenting the play. Attendance for the Thursday evening service was 210. Some announcements were made. We were dismissed with prayer by Rev. Talmadge Worsley.

### FRIDAY MORNING

The presiding officer, Rev. Bobby Whitaker, welcomed the delegates and visitors to the service. Rev. Ken Faison led us in singing, "There Shall Be Showers of Blessings". Prayer was offered by Rev. Herbert Waid. Special music was provided by a minister's quartet singing "Oh, What A Saviour!" Rev. Tony Tilly developed the devotional theme, "In The Cross Is Suffering and Shame", using the text Hebrews 12:2. The Credentials Committee gave a partial report declaring a voting delegation of 108, with a total registration of 120.

The Moderator recognized the standing delegates and entertained a motion to seat the elected delegates. The motion was adopted. The Moderator recognized corresponding messengers and all visitors, including Norwood Gibson representing the South Carolina Children's Home and Bryan Ray from the Atlanta area. Representatives from the following National Departments were present: National Executive Office, Melvin Worthington; Bible College, Ronald Creech; Foreign Missions, Fred Warner; Randall House, Irvin and Lucy Hyman.

The Committee on Committees report was given by Chairman Rex Lynn. Those nominees were: Nominating Committee: Curtis Alligood, Chairman; Danny Ryals, B. Frank McKinney, David Dollar and Bill Barksdale. Resolutions Committee: Roger Russell, Chairman; Lamar Parrish, Dwight Fletcher, Gerald Baxley and Jack Lysaker. Motion was carried to receive the report and all nominees be elected.

The Clerk gave the report of the Executive Board. Motion was carried to receive the report with the discussion of the the Christian Supply Store item to be deferred to 3:30 that afternoon. The Executive Secretary reported for the State office, the Christian Supply Store and the Auditing Committee. Motion was carried to receive and adopt the above.

The Moderator appointed a Study Committee with regard to the State Accounting System. Those to serve on this Committee are: Malcolm Freeman, Billy Hanna and James

Ursrey. Motion was carried to approve this Committee.

Motion was carried to adopt the proposed budget for the year 1988. A question was asked, "Why was the National Master's Men not included in the proposed budget?" Motion was carried to include the National Master's Men in the 1989 budget.

National Executive Secretary, Melvin Worthington gave his report. Motion was carried to receive as information. We were recessed.

The presiding officer, Rev. Bill Barksdale, called the body together for the morning worship hour. Rev. David Thomas led in singing "We're Marching to Zion." Prayer was offered by Rev. Leroy Lowery. Special music, "Somebody Touched Heaven For Me", was furnished by the Calvary Trio. An offering was received in the amount of \$67.35.

Rev. Bill Barksdale, presiding officer, introduced the speaker, Rev. Randy Corn. He developed the subject, "In The Cross Is Reconciliation", using Colossians 1:15-23 with emphasis on verse 20. Announcements were made and we were dismissed for lunch.

### FRIDAY AFTERNOON

The presiding officer, Rev. Larry E. Williams, called the body to order for the afternoon session. Mr. Mark Stripling led in singing "To God Be The Glory". Prayer was offered by Rev. Robert Stiles. Special music was presented by Mr. Steve Faison. He sang a "Cross Medley". The Rev. Jackie Cabaniss brought an inspiring devotional on the subject, "In The Cross Is Glory", using Galatians 6:14 as a basis.

The Moderator called for reports from State and National Ministries. President Martha Everson gave a report for the Georgia State Woman's Auxiliary. Motion was carried to receive as information. Additional reports were given as follows:

Sunday School & CTS (Randall House) by Irvin and Lucy Hyman. State Master's Men by Horace Johnson (See report). National Master's Men by Jim Vallance. National Foreign Missions by Fred Warner. Free Will Baptist Bible College by Ronald Creech.

Motion was carried to receive all the above reports as information.

The Moderator called for the reports of State Boards:

Board of Christian Education by Rex Lynn. Board of Camping by Larry Williams. Board of Trustees by Emmett Dunaway.

Motion was carried to receive the above reports (See report).

The Moderator called for a second reading of the item from the Executive Board Report dealing with the Christian Supply Store. There was a motion to amend the proposition to give the Executive Board the authority to sell, close and/or liquidate the inventory of the Store and determine the best time to do so. Motion to adopt was carried as amended. Motion was again amended to state that all receipts from the sale of the Christian Supply Store go into Georgia State COOPerative Fund receipts. Announcements were made and we recessed in prayer.

### FRIDAY EVENING

Mr. Malcolm Freeman, Chairman of the State Board of Missions, was the presiding officer. Mr. Steve Faison led in singing, "Power In The Blood". Prayer was offered by Rev. Billy McKinney. We then sang, "The Banner Of The Cross". Brother Freeman welcomed everyone to the Friday Evening Missions Service. An offering was received for the Bishop's account in the amount of \$265.80. Miss Lisa Wallace brought the special music singing, "They Could Not". It was very moving. Brother Freeman introduced the speaker for the service, Rev. Fred Warner, Foreign Mission Director of Church Ministries, Nashville, Tennessee, who spoke on the subject, "In The Cross Is Power". He used I Corinthians 1:17-18. We sang an invitational hymn "The Old Rugged Cross". Announcements were made and we were dismissed with prayer by Rev. Walter Baxley.

### SATURDAY MORNING

Presiding officer, Rev. Glenn Thomas, welcomed the body to the Saturday Morning schedule and introduced Rev. Willie Martin who led us in singing, "My Saviour's Love". Prayer was offered by Rev. Glenn Thomas. Special music was by Rev. Jack Lysaker. Rev. Lamar Parrish brought the morning devotional from Galatians 6:12. His theme was "In The Cross Is Persecution".

The Moderator called for the Boards and Committees to make final reports. A partial report from the Nominating Committee was given by Curtis Alligood (See the listings of officers, boards, committees, etc. in the front of these Minutes). Motion was carried that all nominees be elected as nominated. Malcolm Freeman gave the Georgia State Board of Missions Report (See report). Motion was carried to receive this report.

Glenn Thomas gave the report from National Home Missions. Curtis Gay gave a report from the Alabama Children's Home. Motion was carried to receive as information.

Billy Sharpston gave the Resolutions Committee report (See report). Motion carried to receive the report and vote on items 1,3,4 and 5 together, with item 2 to be dealt with separately. Bryan Ray was asked to state clearly his position with Free Will Baptists. He did so. Motion was carried to adopt item 2. An additional resolution was presented from the floor to be #6 (See report). Motion was carried to adopt.

Norwood Gibson gave a brief oral report from the South Carolina Children's Home. Motion was carried to receive as information.

Luther Burns gave the final report from the Credentials Committee. He stated that we had a voting delegation of 122 with a total registration of 245. Motion was carried to receive this report.

The following were elected as delegates to the National Association convening in Kansas City, Missouri in 1988: Calfry Harris, James Horne, Shirley Sharpston, Barbara

Fletcher and Dorcas Scarborough. Alternates are: Kathleen Thomas, Ann Summerlin, Donnie Bargeron, Becky Woods and Gall Smith. Motion was carried to elect the above.

The Nominating Committee gave its final report. Motion was carried to receive and elect by acclamation.

After a few personal remarks from members of the body we were adjourned with prayer by Ronald Wallace.

**BOARD REPORTS** 

## EXECUTIVE BOARD REPORT:

The Executive Board is Constitutionally charged with the responsibility of acting for the Georgia State Association when it is not in session, and then reporting to the State Association in session for approval of its actions. The decisions made by the Executive Board are made with prayerful consideration and an acute awareness of our responsibility and accountability. The following items are presented for your approval at this Fifty-First Annual Session.

### **1987 STATE PROGRAM**

The Program Theme for the 1987 session of our State Association is "In The Cross Of Christ" taken from Philippians 2:8 "...after He had appeared in human form He abased and humbled Himself (still further) and carried His obedience to the extreme of death, even the death of (the) cross!" - (The Amplified Bible).

### LAURA BELLE BARNARD DAY:

Our third annual Laura Belle Barnard Day was observed on October 11, 1987. A goal of \$20,000 was set with 50% of these funds remaining in the State to be used by our State Board of Missions. The 50% that goes to Foreign Missions will be divided thusly: 25% for the Bishop's and 25% for the Crowson's. Debbie Griffin's account is in good condition.

STATE OFFICERS RESIGN AND REPLACED

After the election of State officers, and during the year, two resigned and were replaced by the Board. Assistant Moderator, Bill Robinson was replaced with Kenneth Faison, and Assistant Clerk, Eugene Ross with Billy Hanna.

CHRISTIAN SUPPLY STORE MANAGER RESIGNS:

During the 1986 State Session, Victor Neuenschwander tendered his resignation as manager of Christian Supply Store effective January 31, 1987. No new manager has been employed.

GEORGIA STATE BUDGET PROPOSED:

A 1988 Calendar Year \$400,000 Budget, 50% for National Ministries and 50% for Georgia State Ministries, is proposed

elsewhere for your consideration and adoption.

OFFICE PERSONNEL EVALUATION, ETC.:

The Board did its annual evaluation of the State Office Personnel. The monthly salary of the Executive Secretary was increased from \$1,400 to \$1,500. The State Office Secretary/Bookkeeper is to receive \$4.50 per hour for extra work done in or on behalf of the Christian Supply Store.

RECOMMENDS CLOSING CHRISTIAN SUPPLY STORE:

For more than four years the Christian Supply Store has operated at a deficit. Although a profit was shown for one of these years, after further checking it was discovered that year was a deficit year also. The Store hasn't really been in a position financially to employ a full-time manager during this time. After Victor Neuenschwander resigned, and due to the financial condition, the Board appointed Curtis Alligood as temporary manager with minimal pay. After a couple of months this responsibility was given to the Executive Secretary, his wife and one additional worker.

Due to the above facts and the difficulty of continued operation without a full-time manager, we recommend that we close Christian Supply Store.

TARGET 90:

The emphasis for next year (1988) in the Target 90 concept will be on Sunday School with special emphasis in March and October.

### STUDY COMMITTEE:

We recommend that the Moderator appoint a Committee to study the feasibility of restructuring our accounting system or procedure to a Central Accounting for all funds.

Since our last State Association Session, the Executive Board has met to conduct State business the following times:

### EXECUTIVE SECRETARY/TREASURER REPORT

One vital God given provision for man's spiritual wellbeing is the church. The church should never become an object of worship -- we worship only God Himself. The church must never become our source of truth -- the Bible is the only infallible source of our faith and practice. But God has given us our Free Will Baptist Church for a number of reasons:

1. The local church provides the place and means of group worship [Scripture study, public prayer, hymn singing and the giving of tithes and offering], personal edification and Christian fellowship and service.

2. The greater church [greater in numbers and boundaries of service -- but not greater in importance or value] embraces the same goals as the local church has for its members -- the spiritual wellbeing of every believer and the effective witness to every lost person in the world. District, State and National Associations make up this "greater church". Every aspect of our structure is important performing its unique functions for the maturing of every church member and evangelizing the lost.

Every Christian function requires structure [organization] and leadership [personnel]. Even

uncomplicated activities such as personal prayer and Bible study time must be organized [person + structure] to be consistent and meaningful. The local church would be a mockery without responsible people functioning within a planned structure. Even those who think they are free from structure in their services because they do not have a written Order of Service, "I just let God lead", are rigidly bound by their own mental concept of how a service should be conducted. Admit it or not, we all have leadership and structure in our local churches.

The more people involved and the more complex the task, the greater the need for leadership and structure. Studied, conscientious effort by qualified, dedicated people affords the kind of leadership the church needs on every level of our denomination. Where are we going to find such people to lead us? From our own churches. Who is going to train them? We are. Who is going to pay the bills? Neither the Jehovah's Witnesses, the Mormons, the town drunk nor even City Hall or Uncle Sam will pay for our worship and service. God is blessing our own people sufficiently to enable us to

tithe and to give sacrificial offerings to finance all of our denominational ministries. Is He not? What is your testimony?

Are you supporting God's work in and through Free Will Baptists? Do you have enough salvation to care? Are you loyal enough to give?

At the Georgia State Association's 1979 session, a Finance Study Committee [Brothers Ronald Wallace, Damon Dodd, Billy Sharpston, William Morris, Bill Travis and C. B. Dowdney] reported that they had sent out "State Finance Questionnaires" to our churches. In light of their research and evaluation of the returned church questionnaires, they proposed a comprehensive State Budget. COOPerative Giving was the recommended method of supporting the State and National ministries. Moreover, COOPerative, Designated and Direct funds would all be accounted for in this "total" budget. In other words, all money given by our churches for ministries outside the local church would be involved in this budget. By vote of the State Association in session, since July 1982 your State has been functioning under this budget.

Through the State Budget, your State affords your church the means to:

1. Be an active partner with all of the other churches in the State Association.

2. Be sure that none of the worthy ministries of the State Budget are neglected.

3. Exhibit our loyalty to the "total" Free Will Baptist ministry.

Some have excuses and other are getting the job done. Thank you COOPerative givers!

The following reports will show our State's financial picture for the period from January 1, 1986 through December 31, 1986, and our proposed budget for 1988. Board chairmen's reports are current.

## BOARD OF MISSIONS REPORT November 1986 - November 1987

I want to preface my report by thanking each church that contributed to the ministries of the Georgia State Board of Missions. Our main source of income is COOPerative funds. We also receive a significant sum from our Laura Belle Barnard Day Offerings. Without your generosity we could not function. Speaking for the whole board, let me say a grateful thank you to our supporters.

Your Mission Board met on December 12, 1986 at Perry. Two items of business were conducted.

\* The policy and procedure for a mission church to be recognized as being a legitimate Free Will Baptist Church was established. Hereby, we have criteria by which to determine when a mission church is no longer a mission and thereby is entitled to receive as their own the mission property that they are currently using.

\* A committee from the board as a whole was appointed to work with Brother Luther Burns (North Fayette) in selecting plans and building procedures for that mission church's building.

On May 30, 1987 the board met at the State Office, Moultrie.

\* Dublin Missionary, Brother Jack Lysaker, gave us a progress report. Last year we reported our hope that we will be finished

with our Dublin bond payments by October of 1988. This date now has been revised earlier to May 1, 1988. We thank the Lord for this victory and appreciate each of you that have faithfully helped us in Dublin through the years.

\* As anticipated in last year's report, the Northside (Marietta) mission church left mission status on June 1, 1987. The maturing of this ministry speaks well for the leadership of Brother Ronald Wallace and his good people.

Our third and final board meeting was on August 29, 1987 at the State Office.

\* Brother Burns reported the progress made toward a building for the North Fayette Mission Church. Together we discussed proposed building plans, specific construction companies and the possibility of using a bond program to finance the construction.

\* Some of the Ogeechee District Association leaders were present to petition the State Mission Board to grant them an interest free loan of \$20,000 to be used for purchasing land for

their Augusta mission. This request was approved.

\* The above mentioned committee had their duties expanded to include investigating possible future sites of new mission projects for our board. They are now in the process of doing just that.

\* By vote, we designated the use our 50% of this year's Laura Belle Barnard receipts for the North Fayette church building.

I would like to commend the Georgia Union District Association for paying back the loan of \$15,000 we granted to them, for their mission church at Perry, in less than a year.

Brethren, pray for us as we try to fulfill our mandate to establish new Free Will Baptist churches in Georgia.

## BOARD OF TRUSTEES REPORT November 1986 - November 1987

The Georgia State Board of Trustees has a threefold mandate:

A. To maintain adequate insurance coverage for all State property. (The Board of Camping and the Christian Supply Store pay their proportionate part of the State's insurance premium.)

B. To pay the monthly payments toward the purchase of the State Office building and property.

C. To perform regular maintenance and up-keep, primarily, of the State Office.

Along with the above routine functions of the Board of Trustees, the following improvements have been made at the State Office:

1. A new carpet was installed (one room).

2. To prepare to lay the carpet, some measures had to be taken to keep rain water from coming into the room. They were:

\* Along one outside wall, cement was poured to seal the base of the wall against seepage.

\* Landscaping to control the rush of rain water from our "high" neighbor's yard included: (1) an earth terrace was built-up in our back yard to turn rain water away from the office; (2) a one block high wall was built beside our "high" neighbor's fence; (3) a 12 inch high block wall was built on the far side of the carport.

\* Two rain gutters were installed.

\* Some scraping of the yard was done to facilitate drainage away from the office area.

\* The floor of the room itself was prepared by: (1) patching a hole with cement; (2) sealing the floor with two coats of cement sealer.

3. Since the State Office has neighbors who have chain-link fenced one side and across the back of our property, we have installed a compatible fence on the remaining side.

The routineness of our duties and the Board's earlier decision to do the above mentioned specific improvements to the State Office enabled us to function normally without



further deliberation by the whole board.

As chairman of the board, I would like to convey my appreciation to:

1. The able and congenial board members who work with me as the State Board of Trustees.

2. The generosity of our churches who support our board's functions by COOPeratively giving to the Georgia State Budget. One hundred percent of our operating funds come from this source.

## REPORT OF THE AUDITING COMMITTEE OF THE GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

January 1 - December 31, 1986

The Financial statements and records of the boards comprising the FWB State Association have been examined as to their accuracy and accounting procedures. The Auditing Committee feels that the treasurers of the various boards have been diligent in their record keeping and have done a good job. Since the Auditing Committee is not independent of the State Association, there is no attempt on its part to certify the statements.

The statements of the Executive Office were found to be in order and properly documented by signed receipts, canceled checks and well-kept records. The same was true for the Board of Missions, Board of Trustees, Board of Camping, and Board of Christian Education. The statements for the Christian Supply Store had to be developed by the Auditing Committee from the information provided. As a whole the record keeping of the various boards is more than adequate.

The statements for the Christian Supply Store were developed by the Auditing Committee after examining the records. The manager and personnel inventoried the store on January 2, 1987, basing the value on retail calculation. Cost was obtained at the percentage provided by the store manager. Basically, the day to day records, cash receipts and expenses, and bank books were in good order.

The State Office is to be commended for the professional record keeping system they have established. The Auditing Committee would like to express their thanks to Rev. and Mrs. Herbert Waid for the untiring assistance they gave in obtaining the records from the various boards and for providing a central place for the Committee to meet and perform their duties. Rev. and Mrs. Waid take care of many tasks that go unrewarded, and our thanks to them can never be enough.

We propose that the Executive Board consider an amendment to the State Constitution & By-Laws to have all the different bank accounts be relocated in Moultrie, and that the State Executive Secretary be authorized to receive and disburse all moneys from the central accounting office. We recommend that each Board's account require two signatures, one of which shall be the Executive Secretary,

and the other a member designated by the board. All checks may only be written when a written board requisition is presented to the central accounting office. The annual reports to the State Association shall be prepared and reviewed by each board prior to the State Body convening in November. We feel that the bookkeeping and records would be handled in a more uniform manner and each of the records would have access to computerization.

## CONSTITUTION AND BY-LAWS

## GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

## PREAMBLE

We, the Original Free Will Baptists of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the Cause of Christ.

## ARTICLE I

This assembly shall be known as the Georgia State Association of the Original Free Will Baptists, Inc.

### ARTICLE II

SECTION 1. The officers of this association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and an Executive Secretary-Treasurer.

SECTION 2. The Executive Board shall be composed of the regular officers; the chairman of each of the standing boards; and the previous moderator, as an ex-officio member for a period of two years following his term of office.

SECTION 3. This association shall be composed of all active Ministers, Deacons, Missionaries, and Board Members who are members of affiliated bodies: one (1) delegate for every three hundred (300) members or fraction thereof from District Associations; one (1) delegate for every one hundred (100) members or fraction thereof from each local affiliated church.

SECTION 4. All delegates from District Associations and local churches shall be elected from the laity of the body sending them.

SECTION 5. Funds to meet current needs of this body shall be paid to the treasurer of this

association. Each District Association will give a minimum of fifteen dollars (\$15) per delegate authorized, and each local church will give ten cents (\$.10) per capita of their respective memberships.

SECTION 6. In order to pay our Georgia State Association's annual representation fee to the National Association, each local association is to be responsible to promote, receive and forward the amount designated by the National Association per church per year to the State Office, along with their annual State Association representation fee, on or before our annual State Association session.

#### ARTICLE III

SECTION 1. It shall be the privilege of each affiliated District Association to recommend a member for each standing board. Terms of office on these boards shall be on a rotating basis which will necessitate the election by the State Association of five (5) members every two (2) years, thus giving each member a four (4) year term of office.

SECTION 2. There shall be a Board of Missions composed of members who are noted for their missionary zeal. This board shall have supervision of all missions interests sponsored by this body.

SECTION 3. There shall be a Board of Camping whose duties shall be:

A. To be responsible for maintenance, upkeep and insurance of Camp Mt. Bethel. This Board is to repair, modify or alter any building at Camp Mt. Bethel at their discretion with the provision that the Board of Trustees shall be considered if the cost of a project is to exceed \$2,500. The above "shall be considered" here means that the Board of Camping and the Board of Trustees shall function as a single joint board with co-equal authority and responsibility.

B. To schedule and arrange all camp sessions to be held at Camp Mt. Bethel, and to appoint the Camp Director each year. It is understood and agreed in this connection that the Camp Director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.

SECTION 4. There shall be a Board of Christian Education whose duties shall be:

A. To set policy and supervise the operation of Georgia Bible Institute. This Board shall appoint a President and a Dean to carry out Board policy. Also, the faculty, curriculum, materials, tuition, salaries and benefits are subject to the approval of this Board.

B. To set policy and supervise the functions of a State Youth Committee. This Board shall appoint this Committee to carry out Board policy.

C. To set policy and supervise the functions of a Historical Committee. This Board shall appoint this Committee to gather and set forth for public knowledge and posterity the history of Georgia Free Will Baptists.

D. To set policy and supervise the functions of the Ministerial Fellowship. The Ministerial Fellowship shall elect its own officers.

All educational services sponsored by the Georgia State Association shall be under the sponsorship of this Board. Such things as annual Sunday School and Church Training Service seminars shall be the responsibility of this Board to plan, promote and supervise.

SECTION 5. There shall be a Board of Trustees whose duties shall be to hold titles to all real property belonging to this body; the maintenance and upkeep of all such properties; the planning and supervision of all future developments; and expansion of these properties as directed by this association except as otherwise provided in this Constitution.

SECTION 6. There shall be a Credentials Committee which shall consist of three (3) members who shall be in charge of the registration and examination of delegates and the receiving of all dues. These members are to be elected at the time of the General Officers. SECTION 7. There shall be a member of the Board of Trustees of the Free Will Baptist Children's Home, Eldridge, Alabama, elected during the 1971 session for a term of four (4) years. Election thereafter shall be for a four (4) year term.

SECTION 8. The treasurer of each board shall be bonded through the State Office in an amount stipulated by the board of which he is treasurer. The bonding fee shall be paid from the treasury of said boards.

## ARTICLE IV

SECTION 1. All officers except board members and the Executive Secretary-Treasurer shall be elected to serve a term of two (2) years. The Executive Secretary-Treasurer shall be employed by the Executive Board of the Georgia State Association of Free Will Baptists, subject to the ratification of the Georgia State Association of Free Will Baptists at its next regular session, for an indefinite period, with an agreement of a sixty (60) day notice of termination by both the employee and the Executive Board as the employer.

SECTION 2. Standing boards of this Georgia

State Association of Free Will Baptists have no power or final authority to hire full-time employees until the matter has been presented to and acted on by this association in regular session. This does not apply to full-time Missionaries sent out under the Mission Board.

SECTION 3. Vacancies on any of the boards or committees which occur between regular sessions of this State Association, may be filled by the Executive Board until the convening of the annual session of said association.

SECTION 4. Election of all General Officers shall take place on the odd years of the calendar.

SECTION 5. If a member of any board fails in the function of his or her duty without good and sufficient reasons, the board of which the delinquent is a member may declare that particular office

vacant. Further, this body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian, business-like manner according to the rules of Christian conduct as set forth in the New Testament.

Any standing board of this State Association may appoint proxies to serve in lieu of the absent members.

At the pleasure of the boards, and subsequent to the meeting from which the regular member absented himself, the boards have the right to deal with the delinquent member in the manner stated in the previous paragraph.

SECTION 6. Boards may be called into session by the Chairman or Vice-Chairman of said board, or by the Moderator or Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said boards.

AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this association and shall lie on the table from one (1) business meeting to the next during the same session, during which time it shall be read at least two (2) times in open session. Officers, standing boards, and/or standing committees may be added or deleted as the need arises.

#### BY-LAWS

#### SECTION 1.

A. The Georgia State Association of Free Will Baptists shall meet for its regular session annually on Thursday following the second Sunday in November



and shall adjourn on the Saturday immediately following.

B. The Executive Board shall meet quarterly on Saturday before the second Sunday of the following months: February, May, August. The November meeting of said board shall be held just prior to regular meeting of the State Association.

The Executive Board of the Georgia State Association of Free Will Baptists shall act for and in behalf of said association on matters which by their nature require immediate attention. All such actions by the Executive Board shall be subject to the final action by the State Association.

SECTION 2.

A. The Moderator shall preside at the Annual Sessions of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board. The Moderator shall be the President of the Corporation known as the Georgia State Association of Free Will Baptists, Inc.

B. The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.

C. The Clerk shall keep records of the proceedings of the Annual Associational meetings and of the Executive Board meetings. It shall also be his responsibility to have the minutes of these sessions printed and distributed. The Clerk shall be the Vice-President of the Corporation known as the Georgia State Association of Free Will Baptists, Inc.

D. The Assistant Clerk, in the absence of the Clerk, shall fulfill the functions and duties of the Clerk as stated in paragraph C of this document.

SECTION 3.

A. The Executive Secretary shall be responsible and accountable to the Executive Board in the fulfillment of the duties of his office as determined by said board.

B. The Executive Secretary shall be allowed four (4) weeks vacation per year with pay.

C. Funds received by the Executive Secretary for revivals, special speaking engagements and

promotional meetings, shall go into the Cooperative Fund. The exception to this regulation relates to any remuneration received by the Executive Secretary during his four (4) weeks vacation, which funds shall be his personally and need not be accounted for before said association.

D. Salary, mileage, and operational expenses of the Executive Secretary shall be determined by the Executive Board.

E. The Executive Secretary shall be Secretary-Treasurer of the Corporation known as the Georgia State Association of Free Will Baptists, Inc.

SECTION 4.

A. The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the board shall investigate places suitable for this meeting and make recommendations to said State Association. Meeting places shall be determined two (2) years in advance.

B. The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings

shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of Parliamentary Procedure.

C. The Executive Board shall formulate the budget for the State Association annually and recommend to the body in session the allocations to be observed in the Cooperative Plan of Giving. This board shall in addition to the above stated duties, also recommend a mileage rate for travel by the members of all of the standing boards of said association.

SECTION 5.

Necessary committees shall be appointed by the Moderator unless otherwise provided for by the body. SECTION 6.

These By-Laws may be altered, changed, or amended at any regular session of this association by a two-thirds (2/3) vote of delegates present and voting.
