## **PROCEEDINGS OF THE ANNUAL MEETING**

The fifty-sixth Annual Session of the Georgia State Association of Free Will Baptists convened at the Norman Baptist Assembly, Norman Park, Georgia, on November 12-14, 1992. The theme of the meeting was "A Time For Excellence" using Philippians 3:8 as a Scripture text. Music was coordinated by Rev. Lamar Parrish, and provided by several different individuals and groups and song leaders. Mrs. Amelia McCombs served as pianist.

### THURSDAY EVENING

Music Director, Trent Walley, opened the worship session with the singing of "Victory In Jesus". Opening prayer was offered by Rev. J. M. Creech. Mr. Walley led the congregation in pledges to the American and Christian Flags.

The 56th Annual Session of the Georgia State Association of Free Will Baptists was officially called in session by the State Clerk, Rev. Terry Pierce. He introduced the Moderator, Rev. Paul Smith, who extended a welcome to everyone.

Clerk Pierce called the roll of district associations with representatives from all ten districts answering. Moderator Smith then appointed Committee on Committees members who were: Dwight Fletcher, Chairman, Danny Bailey, Marvin Castle, James Ursery, William Travis. The congregation then sang "To God Be The Glory". After a prayer by Rev. Mark Barber the congregation worshipped through giving with an offering of \$93.00. Special music was provided by Mr. Mike Mercer. Rev. Russell Horne presented the keynote speaker. Rev. Roy Harris, pastor of First Free Will Baptist Church in Savannah, gave a challenging message from Philippians 3:8 on the "The Excellency of Christ." Moderator Smith recognized Rev. Jeff Lunsford, Chairman of the Credentials Committee, who gave a partial report with the following information: 10 districts; 6 churches; voting delegation of 86; 51 visitors; with a total registered of 137.

Announcements were made by Moderator Smith and Rev. Herbert Waid. Meeting closed in prayer by Rev. Carl Miller.

#### FRIDAY MORNING

Rev. Ronald Wallace called the morning session to order. Mr. Jack Lysaker led the congregation in

singing "O, Worship The King". Prayer was offered by Rev. William Morris. Special music was provided by Rev. James Ursery who sang "No Other Word for Grace But Amazing".

The morning devotional was brought by Rev. Dwight Fletcher, pastor of the Piney Grove Free Will Baptist Church in Bristol. He brought a stirring message from Psalm 95:1-7 entitled "Excellence in Worship".

The Moderator called for a report from the Credentials Committee. Rev. Jeff Lunsford gave a partial report declaring a voting delegation of 107, with a total registration of 173.

Moderator Smith recognized the standing delegates and entertained a motion to seat all elected delegates. The motion adopted. The Moderator recognized all corresponding visitors: Rev.Ronald Creech of Free Will Baptist Bible College; Dr. Melvin Worthington, the National Executive Secretary; Rev. Roy Thomas of the Home Missions Department; Rev. Billy Brown of Randall House Publications.

Rev. Dwight Fletcher gave the report of the Committee on Committees with the following nominations:

**Resolutions Committee:** 

Chuck Scarborough, Chairman Carl Miller, Roger Russell James Bryant Charles Clark Nominating Committee: Larry D. Williams, Chairman Wayne Miracle Kent Barwick David Dollar Mark Barber

Motion was carried to receive this report and all nominees be elected.

Clerk Terry Pierce gave the report of the Executive Board as stated in the Digest Of Reports with appropriate additions. Addition (1) To accept the 1993 Budget proposal. Motion was seconded and carried. (2) Recommend that the Annual State Association be held Thursday through Saturday after the first Sunday in June beginning in 1994 and that the By-Laws be amended to accommodate this change. A motion was made and seconded but defeated by majority vote. (3) Recommend that the 1994 Annual Session be held at the First Free Will Baptist Church in Albany. A motion was made and seconded but defeated by majority vote. (4) Recommend to release the property of the Dublin Church on or about December 31, 1992 pending the approval of their



church Constitution by the Executive Board and a special organizational service on the above date. A motion was made, seconded and carried.

Executive Secretary, Herbert Waid, presented a report from the State Office. Motion, seconded and carried to adopt the report.

Mr. Malcom Freeman gave the State Missions Board report. A motion was passed to receive the report.

Rev. William Morris opened the morning worship service. Music director, Russell Horne, led the congregation in singing "When The Roll Is Called Up Yonder". After prayer by Rev. Tony Trott, the congregation worshipped in giving. Special music was provided by Mike and Judy Wiggins. Rev. Morris presented the morning speaker, Rev. Kent Barwick, Pastor of Homerville Free Will Baptist Church, Homerville. He preached on the subject of "Excellence In Warfare", found in Ephesians 6:13. Closing prayer was by Rev. Kent Barwick.

### FRIDAY AFTERNOON SESSION

Rev. Irwin Murphy, introduced Rev. Danny Thomas who led the congregation in singing "The Way Of The Cross Leads Home". Rev. Lamar Parrish led in prayer. Special music was presented by Horace Johnson. He sang "Sweet Beulah Land". The Rev. Ralph Lightsey brought the afternoon devotional on the subject of "Excellence In The Word", using Hebrews 4:12 as a basis. The Moderator called for reports from State and National ministries. Secretary Rachel Horne gave the report from the Woman's Auxiliary. Mr. Jack Lysaker, Chairman, gave the report of the Board of Camp Mt. Bethel. Secretary Mark Findley, gave the report of the Board of Christian Education. Rev. William Smith, Chairman, gave the report of the Board of Trustees, Motion, seconded and carried to receive these State ministry reports. National ministry reports were began by Rev. Roy Thomas, Director of Home Missions. Dr. Melvin Worthington, National Executive Secretary, gave a report from the National Offices. Rev. Ronald Creech, presented the report from Free Will Baptist Bible College. Randall House Publications representative, Billy Brown, reported for Randall House Publications. Motion, seconded and carried to receive these National ministry reports. Rev. Jeff Lunsford gave an updated report of the Credentials Committee with a count of 119 voting delegates and 191 total registered. A motion was seconded and approved to receive this report.



Rev. Galen Dunbar reported for the Foreign Missions Department. His report was received. Rev. Larry Williams gave a report from the Nominating Committee. Rev. Tommy Dubose led in the dismissal prayer.

#### FRIDAY EVENING WORSHIP SERVICE

Rev. James Ursery opened the service by leading the congregation in singing "Jesus Saves". Rev. Jackie Cabiness led in the opening prayer. Special music was provided by the Glennville Christian Academy Choir as they sang several stirring songs.

Mr. Malcom Freeman, Chairman of the State Mission Board, presided over the service. An offering of \$385.00 was received after Rev. Benny Smith led in prayer. Rev. Roy Thomas challenged us on the subject of "Excellence In Witnessing" from Acts 1:8. Several responded during the altar call and Malcom Freeman led in a prayer of consecration. Rev. M. C. Powell dismissed in prayer after announcements were made.

Rev. Bud Hill, opened the final service by presenting Rev. S. E. Newberry who led the congregation in singing "Victory In Jesus". Opening prayer was offered by Rev. Galen Dunbar. Special music was presented by the Roddenberry Sisters. Rev. Owen Ganey preached the final devotional on "Excellence In Our Walk" from I John 2:6. Moderator Paul Smith led in prayer.

Moderator Rev. Paul Smith continued the business session by asking for more reports. Rev. Dwight Fletcher gave a report from the National Master's Men. Rev. Levi Corey, Director of the Alabama Children's Home, gave a report. Rev. Terry Pierce reported on the progress of the Georgia Double In A Decade. Motion carried to receive these reports as information.

Moderator Smith read Item (5) from the Executive Board report that had been inadvertently omitted from the previous report. Motion carried to accept the recommendations for distributing the 1992 Laura Belle Barnard Day receipts: one half for Georgia State Missions; one half for Georgia Foreign Missionaries. Of the Foreign Missions half: Bishops, two thirds; Snows, one third.

Rev. William Smith gave the Resolutions Committee report. Both resolutions passed with an amendment being added to Item (1). (See



Resolutions.) A motion, seconded and carried to acknowledge the efforts of all the persons who worked behind the scenes to make for an enjoyable State Meeting. A motion to recognize the efforts of the Executive Board was passed.

Rev. Jeff Lunsford gave a final report from the Credentials Committee. He stated that we had a voting delegation of 132 with a total registration of 264.

Rev. David Dollar gave a final report from the Nominating Committee. Motion was carried to receive and elect by acclamation.

Delegates to the National Association were elected as follows: Mrs. Mary Lee Fowler, Mrs. Bessie Bryant; Mrs. Edwina Drinkwater, Mrs. Barbara Dunbar, Mrs. Gail Smith. Alternates are: Mrs. Belyn Pierce, Mrs. Carol Dubose, Mrs. Diane Martin, Mrs. Cheryl Barwick, Mrs. Rachel Horne. Motion was carried to elect the above.

The next State Association meeting was announced for November 18-20 at Norman Baptist Assembly in Norman Park. Motion, seconded and carried to adjourn. Prayer of dismissal was by the Assistant Moderator, Rev. Russell Horne.

#### EXECUTIVE BOARD REPORT

November 1991 - November 1992

The Executive Board is Constitutionally charged with the responsibility of acting for the Georgia State Association when it is not in session, and then reporting to the State Association in session for approval of its actions. The decisions made by the Executive Board are made by consideration and an acute awareness of our responsibility and accountability. The following items are presented for your approval at this Fifty-Sixth Annual Session.

**1992 STATE PROGRAM** 

The program theme for the 1992 session of our State Association is "The Excellency of Christ" taken from Philippians 3:8.

DOUBLE IN A DECADE

The Georgia Double in a Decade Committee met on February 15, 1992 and August 8, 1992 to further this effort. Every pastor in the State was given a booklet entitled "Double in a Decade" by Trymon Messer. The Committee also established district association goals for reaching "20,000 in 2,000". A state-wide rally is planned for November 12 at Norman Park.

#### GEORGIA STATE BUDGET PROPOSED

A 1993 calendar year overall budget of \$500,000 is proposed. A Georgia State Cooperative Budget of \$175,000.00 is included in the overall budget. You will find the budget included with this report for your approval.

#### STATE MEETING SITES CONSIDERED

Concerns about a lack of participation and rising costs prompted a detailed study of our State Association Meeting location. Several Free Will Baptist churches were evaluated as potential alternate sites based upon location, access to motels and restaurants, and seating capacities. In light of our findings and in keeping with our

Constitution's By-Laws, Section 5-A, we recommend the 1994 Annual Session be at the First Free Will Baptist Church in Albany.

#### HOSTING THE NATIONAL ASSOCIATION PREPARATION

In 1999 Georgia is to host the National Association. In anticipation of having to pay some of the expense of this meeting, the Executive Board is setting aside \$200.00 per month in a contingency fund known simply as the Special Fund.

Since our last State Association Session, the Executive Board has met to conduct State business the following times:

EXECUTIVE SECRETARY/TREASURER REPORT

They did what was necessary to establish the first Free Will Baptist State Office in our nation. Georgia has worked hard for a well developed camping program and facility for our young people. Our Board of State Missions, Board of Christian Education and Board of Trustees have done well fulfilling their constitutionally mandated ministries. Our past has been exciting but our future is even brighter.

Thank the Lord for our churches that have shared in these ministries by unselfishly supporting our State Budget. This is the means by which all of our State ministries are able to function. Neither a vision without willing hands nor workers without financial means can accomplish ministry.

Our best years are ahead. Sleeping churches can be awakened. Every church can grow. All churches can generously contribute to the total ministry. Existing programs can be improved. Younger leadership can build on the present and show us the way to attain greater ministry. Today, Georgia Free Will Baptists are challenged by an unprecedented potential to excel for the glory of God.

Note: The State Association convening November 12-14, 1981 adopted a new *TOTAL BUDGET* concept. All Georgia and National Association ministries were included. COOPerative monies were distributed according to the current voted budget *taking into account* designated monies the State Office received and monies the budgeted ministries received directly. Consequently, monies received one month could not be distributed until the middle of the next month. In January 1982 no monies were distributed. January receipts were distributed the middle of February.

In 1991 the Georgia State Association in session adopted a different budget concept. Designated monies have no influence on the distribution of COOPerative receipts. The 1981 voted budget was a TOTAL BUDGET. The 1991 voted budget is a GEORGIA STATE COOPERATIVE RECEIPTS BUDGET. Consequently, now COOPerative receipts can be distributed on the last business day of each month.

The State Office distributed ministry funds 13 times in 1991. November's receipts were distributed the middle of December. From January 1992, each month's receipts are distributed the month they are received. December 1991 receipts did not fit in either year's budget period making it a *stand alone* 13th month.

No financial report found elsewhere in these minutes will reflect a 13th month problem. All other financial reports are unqualified. Funds were received in the State Office, disbursed and audited as shown for the annual fiscal period of January 1, 1991 through December 31, 1991.

### BOARD OF CAMP MT. BETHEL REPORT

The Board is pleased to report a very good year of work at Camp Mt. Bethel both in updating the facilities and camping for the year. For the fourth year we have been able to make significant progress on the camp facilities, and have continued to develop a planned strategy to improve the camp.

Our first activity of the year was the teen camp that exceeded our expectations. It was great!

Prior to the summer session we had a few work days and were able to correct many deficiencies which included:

- \* A new roof on the chapel, painting the structure and removal of the old carpet.
- \* Put vinyl siding on the dorms, kitchen and dining hall.
- \* Tiled the dining hall and painted it and the kitchen with a light blue and white decor.
- \* Installed new counter tops in the kitchen.
- \* Repaired the tractor clutch assembly.
- \* Built BBQ pit across the pond by the shelter.
- \* Replaced several wooden doors with fire

retardant ones.

\* Put mattress covers on all new mattresses.

We commend the many people and groups who have made all these nice improvements possible.

The State Camp Director, Rev. Chuck Scarborough planned and carefully supervised another great year. The regular camp staff members were: Evangelist, Eric Thomsen; Lifeguard, Tim Wilhoite; Cook, Mrs. Sarah Thompson; Caretaker, Jim Lamb. In addition several of the districts provided volunteer workers for their respective sessions.

We conducted seven camp sessions this summer, with a total of 414 campers, 95 workers and 41 visitors. We experienced a true revival among the youth this summer. Eighty-seven of the campers prayed to accept Jesus as Saviour and another 101 campers prayed to rededicate their lives to Jesus. Eight other decisions were indicated concerning going to Bible College, etc.

We greatly appreciate the support we are receiving from the Georgia State Budget of COOP

giving and other gifts that make the workings of the camp a reality. These funds along with campers fees allow us to maintain and improve the camp for the honor of the Lord.

In the next several months it is our intention to rework the washroom facilities for the two dorms. They are in need of immediate attention.

The board has reviewed our sessions and have determined to have a high teen (15 and up) and lo teen (13-14) camp next year.

Thanks for helping us make the camp a more comfortable and convenient place, for allowing us to be a part of the Christian education process and for allowing the Camp Board to do these things on your behalf.

#### BOARD OF MISSIONS REPORT

November 1991 - November 1992

"To everything there is a season, and a time to every purpose under heaven: a time to be born, and a time to die; a time to plant, and a time to pluck up that which is planted. A time to kill and a time to heal; a time to break down, and a time to build up:" Ecclesiates 3:1-3.

Your State Mission Board has been given the task of making those decisions that have to do with expanding and increasing the outreach of Free Will Baptists in Georgia.

These have been the best of times; these have been the worst of times. There have been times that the Board probably did not make decisions that were wise, proper, nor did we follow the letter or intent of the law exactly. In other words, we have made wrong decisions at times... but our decisions have not been made with malice, but with prayer. Over the years, this Mission Board made commitments to missions and missionaries and we tried to honor these commitments and even going the second mile of service to some.

The Dublin work was planted, watered, pruned, and supported for many years. As alluded to in Ecclesiastes, there comes a time when one must become responsible for their own subsistence. The Dublin Church and Board employed Brother Albert Rollins over two years ago for a period of eighteen months. This Board felt an obligation to Brother Rollins--and to the State Association, and a decision was made that effective December 31, 1992, the Board cannot continue to underwrite the pastor's salary. It was a difficult decision because here is a pastor and his family that have served Free Will Baptists for many years and now they are in limbo. The Board requests that you earnestly pray for this pastor and this church.

For several years, the Board has been working with the church in Athens. The Board promised to assist them in their getting a pastor and promising some financial support. Brother Waid worked

diligently with them, always assuring them that the Board was standing by. Now this church has informed us that the Board is free from that commitment that was made to them. They appreciated the commitment and the integrity shown by the Board in determining to assisting them if it need be.

The Tifton Church was given a commitment by the Board for 18 months. The church used eight of those months and there were ten months left on that promise; however, the church has gotten its own pastor and has now released the Board from our commitment to them. They feel they are able to go on their own.

The North Fayette Church is on the move. There is slow, steady progress that is building a firm foundation of believers in a city that is on the move, and that is not "home". Adding stability under these conditions requires much from Brother Luther Burns.

The Lord has given us the vision for the North Fayette Church. He has provided, you have given. We want to be good stewards of your gifts. We recognize that the North Fayette Church is making Bond payments on time. The Board recognized that in the event the church defaults on the Bond payments, the Board will need to make the necessary payments--therefore, there must of necessity, be a reserve to maintain the Association's integrity and fiscal responsibility reputation. One year reserve of Bond payments does not appear to be an excessive reserve.

The Mission Board believes that in 1993, there will be viable options for furthering the cause of Christ in Free Will Baptists in Georgia.

We covet your prayers for the leadership of the Holy Spirit during the days ahead.



#### BOARD OF TRUSTEES REPORT

The Georgia State Board of Trustees is the general overseer and insurer of all State property and works together with the Board of Camp Mt. Bethel on major Camp projects. It has the sole responsibility of upkeep of the State Office building and grounds.

This has been a year of change for the Board of Trustees. We have seen change in personnel who make up the Board and change in our property. Brother Emmett Dunaway, who faithfully served as our Board chairman, resigned due to health problems. We appreciate the work Brother Dunaway did for our State Association these past few years.

The State Office building needed some long overdue work. Our heating system was antique and we were using window units for air conditioning. During December we installed central heating and cooling in the house. The office area was equipped with a separate heating and cooling unit. Along with this more insulation was added in the attic to bring the insulation up to standard. This new system is much safer and is more efficient than the previous unit.

The windows were in need of repair or replacing. The Board decided to install storm windows. This will help with the insulation and will cut down on the need to paint the windows as often as we did in the past. The storm windows were also built with a feature to cut down on window sweat.

# CONSTITUTION AND BY-LAWS

# GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS

## PREAMBLE

We, the Free Will Baptist of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the cause of Christ.

# ARTICLE I

This assembly shall be known as the Georgia State Association of Free Will Baptists, Inc.

## ARTICLE II

SECTION 1. The officers of this association shall be a Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and an Executive Secretary/Treasurer.

SECTION 2. The Executive Board shall be composed of the regular officers; the chairman of each of the standing boards; and the previous moderator, as an ex officio member for a period of two years following his term of office. SECTION 3. This association shall be composed of all active Ministers, Deacons, Missionaries, and Board Members who are members of affiliated bodies: one (1) delegate for every three hundred (300) members or fraction thereof from District Associations; one (1) delegate for every one hundred (100) members or fraction thereof from each local affiliated church. SECTION 4. All delegates from District Associations and local churches shall be elected from the laity of the body sending them. SECTION 5. Funds to meet current needs of this body shall be paid to the treasurer of this association. Each District Association will give a minimum of fifteen dollars (\$15) per delegate authorized, and each local church will give ten cents (\$.10) per capita of their respective memberships. SECTION 6. In order to pay our Georgia State Association's annual representation fee to the National Association, each local association is to be responsible to promote, receive and forward the amount designated by the National Association per church per year to the State Office, along with their annual State Association representation fee, on our before our annual State Association session.

# ARTICLE III

SECTION 1. It shall be the privilege of each affiliated District Association to recommend a member for each standing board. Terms of office on these boards shall be on a rotating basis which will necessitate the election by the State Association of five (5) members every two (2) years, thus giving each member a four (4) year term of office.

SECTION 2. There shall be a Board of Missions composed of members who are noted for their missionary zeal.

A. The Board of Missions shall employ missionaries as needed to establish Free Will Baptist mission/churches in the State of Georgia. These missionaries may be employed exclusively or jointly with other Free Will Baptist mission agencies.

B. A mission/church sponsored by the Georgia State Association and its missionary are under the authority of the State Association and the supervision of the Georgia State Board of Missions.

C. A mission/church does not have autonomous church status. As long as the mission/church is unable to provide for its own financial needs, enlist its own members and officers, maintain its own worship and outreach ministries and conduct its own business, it is in a dependent relationship to the State Association and its Board of Missions. D. When the mission/church is self-sustaining, self-governing, self-discipling and self-propagating it should be organized into an autonomous Free Will Baptist church following the procedures adopted by the Georgia State Association. E. After proper procedures are satisfied and the church is duly organized into an autonomous Free Will Baptist church it shall have all the normal rights, privileges and responsibilities of any other Free Will Baptist Church.

SECTION 3. There shall be a Board of Camp Mt. Bethel whose duties shall be:

A. To be responsible for maintenance, upkeep and insurance of Camp Mt. Bethel. This Board is to repair, modify or alter any building at Camp Mt. Bethel at their discretion with the provision that the Board of Trustees shall be considered if the cost of a project is to exceed \$2,500. The above "shall be considered" here means that the Board of Camp Mt. Bethel and the Board of Trustees shall function as a single joint board with co-equal authority and responsibility.

B. To schedule and arrange all camp sessions to be held at Camp Mt. Bethel, and to appoint the Camp Director each year. It is understood and agreed in this connection that the Camp Director shall be in authority in matters of faculty, curriculum, administration, food service, and recreation during camp sessions.



SECTION 4. There shall be a Board of Christian Education whose duties shall be:

A. To provide educational services for the members of the Georgia State Association of Free Will Baptists.

B. To set policy and supervise the functions of a State Youth Committee. This Board shall appoint this Committee to carry out Board policy.

C. To organize, sponsor and promote educational and inspirational retreats for our members.

D. To organize, sponsor and promote Sunday School and Church Training Service seminars.

E. To set policy and supervise the functions of a Historical Committee. This Board shall appoint the Historical Committee to gather and set forth for public knowledge and posterity the history of Georgia Free Will Baptists.

SECTION 5. There shall be a Board of Trustees whose duties shall be: the maintenance, upkeep and insuring of all State Association properties; the planning and supervision of all future developments and expansion of these properties as directed by this State Association except as otherwise provided in this Constitution.

SECTION 6. There shall be a Credentials Committee which shall consist of three (3) members who shall be in charge of the registration and examination of delegates and the receiving of all dues. These members are to be elected at the time of the General Officers.

SECTION 7. There shall be a member of the Board of Trustees of the Free Will Baptist Children's Home, Eldridge, Alabama, elected during the 1971 session for a term of four (4) years. Election thereafter shall be for a four (4) year term.

SECTION 8. There shall be a Georgia State Master's Men. They shall select their own officers and conduct their own business.

SECTION 9. There shall be a Georgia State Woman's Auxiliary Convention. They shall elect their officers, conduct their business and maintain their treasury.

# ARTICLE IV

SECTION 1. All officers except board members and the Executive Secretary/Treasurer shall be elected to serve a term of two (2) years. The Executive Secretary/Treasurer shall be employed by the Executive Board of the Georgia State Association of Free Will Baptists, subject to the ratification of the Georgia State Association of Free Will Baptists at its next regular session, for an indefinite period, with an agreement of a sixty (60) day notice of termination by either the Executive Secretary or the Executive Board. SECTION 2. Standing boards of the State Association have no power or final authority to hire full-time employees until the matter has been presented to and acted on by the State Association in session except where otherwise provided.

SECTION 3. Vacancies on any of the boards or committees which occur between regular sessions of this State Association, may be filled by the Executive Board until the convening of the annual session of said association.

SECTION 4. Election of all General Officers shall take place on the odd years of the calendar.

SECTION 5. If a member of any board fails in the function of his or her duty without good and sufficient reasons, the board of which the delinquent is a member may declare that particular office vacant. Further, this body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian, businesslike manner according to the rules of Christian conduct as set forth in the New Testament.

Any standing board of this State Association may appoint proxies to serve in lieu of the absent members.

At the pleasure of the boards, and subsequent to the meeting from which the regular member is absent, the boards have the right to deal with the delinquent member in the manner stated in this section.

SECTION 6. Boards may be called into session by the Chairman or Vice-Chairman of said board, or by the Moderator of Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said boards.

# AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this association and shall lie on the table from one (1) business meeting to the next during the same session, during which time it shall be read at least two (2) times in open session. Officers, standing boards, and/or standing committees may be added or deleted as the need arises. SECTION 1.

A. All real property, checking and savings accounts or any other assets of this Association shall be in the name of the Georgia State Association of Free Will Baptists, Inc.

B. One or more of the corporate officers of the Association shall be the legal signers for all Georgia State Association of Free Will Baptists' business. These officers are: the Moderator as the corporate President; the Clerk as the corporate Vice-President; the Executive Secretary/Treasurer as the corporate Secretary/Treasurer.

C. The State Office shall be responsible for the safekeeping of the corporate seal and all official documents of this Association.

D. No State board may borrow money or financially obligate the State Association without the approval of the State Executive Board.

E. The fixed assets (building, land) of the Georgia State Association of Free Will Baptists shall not be liquidated except by a two-thirds (2/3) vote of the delegates present and voting at any regular session of the Association.

F. The records of all financial transactions shall be open to all members of the Georgia State Association. The financial transactions of the State Office and State boards shall be audited annually.

G. Annual financial reports of the State Office and State boards and the auditor's report shall be made to the State Association in session and be entered in the Annual State Minutes.

H. The State Treasurer shall be bonded in an amount stipulated by the State Executive Board.

I. This Association shall meet for its regular session annually on Thursday following the second Sunday in November and shall adjourn on the Saturday immediately following.

SECTION 2.

A. When the State Association is not in session, the State Executive Board shall be fully authorized to do business in the name of the State Association.

B. The State Association has full authority to direct the State Executive Board in all business conducted on its behalf.

C. The State Executive Board shall report to the State Association in session concerning the business conducted for the State Association since its last convening.

D. The State Executive Board has the prerogative of deferring any matter to the State Association as a whole but is not under obligation to do so.

E. The State Executive Board shall meet quarterly on Friday or Saturday before the second Sunday of the following months: February; May; August. The November meeting shall be held just prior to regular meeting of the State Association.

SECTION 3.

A. The Moderator shall preside at the Annual Sessions of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board. The Moderator shall be the President of the Corporation known as the Georgia State Association of Free Will Baptists, Inc.

B. The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.

C. The Clerk shall keep records of the proceedings of the Annual Associational meetings and of the Executive Board meetings. It shall also be his responsibility to have the minutes of these sessions printed and distributed. The Clerk shall be the Vice-President of the Corporation known as the Georgia State Association of Free Will Baptists, Inc.

D. The Assistant Clerk, in the absence of the Clerk, shall fulfill the functions and duties of the Clerk as stated in paragraph C of this document.

SECTION 4

The Executive Secretary shall be responsible and accountable to the Executive Board in the fulfillment of the duties of his office as determined by the Executive Board. B. The Executive Secretary shall be allowed four (4) weeks vacation per year with pay. C. Funds received by the Executive Secretary for revivals, special speaking engagements and promotional meetings, shall go into the Cooperative Fund. The exception to this regulation relates to any remuneration received by the Executive Secretary during his four (4) weeks vacation, which funds shall be his personally and need not be accounted for to this State Association. D. Salary, mileage, and operational expenses of the Executive Secretary shall be determined by the Executive Board. E. The Executive Secretary shall be Secretary/Treasurer of the Corporation known as the Georgia State Association of Free Will Baptists, Inc.

SECTION 5.

A. The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the board shall investigate places suitable for this meeting and make recommendations to said State Association. Meeting places shall be determined two (2) years in advance.

B. The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of Parliamentary Procedure.

C. The Executive Board shall formulate the budget for the State Association annually and recommend to the body in session the allocations to be observed in the Cooperative Plan of Giving. This board shall in addition to the above stated duties, also recommend a mileage rate for travel by the members of all of the standing boards of said association. SECTION 6.

Necessary committees shall be appointed by the Moderator unless otherwise provided for by the body.

SECTION 7.

These By-Laws may be altered, changed, or amended at any regular session of this association by a two-thirds (2/3) vote of delegates present and voting.
