Proceedings of the Sixty-sixth Annual Session:

The Sixty-sixth Annual Session of the Georgia State Association of Free Will Baptists convened at the Camden Free Will Baptist Church in Kingsland, Georgia, on March 14-16, 2002. Music was coordinated by Rev. Frank Miller and provided by several different individuals, groups, and song leaders. Mrs. Latrelle McDowell served as pianist.

THURSDAY EVENING WORSHIP SESSION

Rev. Danny Ryals welcomed everyone to the Sixty-sixth Annual Session of the Georgia State Association of Free Will Baptists and to the Camden FWB Church in Kingsland, Georgia. Rev. Brian Claire opened the meeting in prayer and Rev. Frank Miller then led the congregation in singing "When We All Get To Heaven" and "Leaning On The Everlasting Arms". Rev. Ryals led the congregation in the pledges to the Christian flag, the American flag, and to the Holy Word of God.

Acting Clerk, Rev. Keith Lloyd, officially called the sixty-sixth Annual Session of the Georgia State Association of Free Will Baptists into session, and introduced the Moderator, Rev. Paul Smith. The Moderator welcomed everyone and appointed the Committee on Committees. The appointed members were: Chairman Mitch Griffin, Arthur Smith, Rick Wilson, Danny Ryals, and Rudy Woods.

Rev. Frank Miller led the congregation in singing "Tis So Sweet To Trust In Jesus" and then introduced special guest singers, The Roddenberry Trio, who blessed us with two special selections. Rev. Danny Ryals introduced the keynote speaker, Rev. James Forlines, Director of Free Will Baptist Foreign Missions. Rev. Forlines challenged us on the subject of "There Is More Beyond", using Ephesians 5:14-17 as his text. "I Will Serve Thee Because I Love Thee" was played softly as an invitational hymn. Many responded to the message on an altar of prayer.

Moderator Paul Smith made several announcements concerning committees, registrations, and meeting times. Rev. Herbert Waid dismissed the evening in prayer.

FRIDAY MORNING BUSINESS SESSION

Rev. Frank Miller led the congregation in singing "Set My Soul Afire", and opened the session in prayer. Moderator Paul Smith began the session with a Scripture reading from 1 Kings 18:21-38 and a prayer.

Rev. S.E. Newberry gave the Credentials Committee Report. He reported a voting delegation of 91 with 121 total registrations. Moderator Smith recognized the standing delegates, national messengers, and visitors. A motion was made, seconded, and carried to seat all elected delegates. Clerk Keith Lloyd presented the Committee on Committees report with the following nominations:

Motion was carried to receive this report and that all nominees be elected.

Clerk Keith Lloyd gave the report of the Executive Board as stated in the Digest of Reports with the following items to be voted on individually:

Item 1: A 2003 calendar year overall budget of \$675,000 is proposed. A Georgia State Cooperative Budget of \$250,000 (page 15) is included in the overall budget. Motion, seconded and carried to adopt the proposed 2003 budget.

Item 2: To have the State Meeting at the First Free Will Baptist Church of Jesup, Georgia, March 18-20, 2004. Motion, seconded and carried.

Item 3: To appoint Rev. Keith Lloyd as acting Clerk for this session, and Rev. Tim Horne as acting Assistant Clerk for this session. Motion, seconded and carried.

Executive Secretary/Treasurer William Smith gave the Executive Office report. His report included, among other things: that Georgia had experienced an increase of 5.5% in total giving in 2001; the status of foreign missionaries from Georgia is positive; current home mission projects in Georgia and the joint project in Alaska are all experiencing growth; statistics from district associations reflects a need for renewed emphasis on evangelism; our pastorates, mission fields, and congregations are aging, reflecting a need for a renewed emphasis on full-time Christian service; the acquisition of several endowments and trusts give us the promise of future financial blessings. Motion, seconded and carried to receive his report.

Executive Secretary/Treasurer William Smith presented a plaque of appreciation to Sis. Wynelle Clower for her gift of \$29,000 to various Free Will Baptist ministries in memory of J.W. Clower and Mischa Bevan.

Sis. Debra Van Pelt gave the report for the Georgia Women Active for Christ and the National Women Active for Christ. Motion, seconded and carried to receive her report as information. Rev. William Smith gave the Board of Christian Education report on behalf of Rev. Willie Martin. Motion, seconded and carried to receive this report. Rev. Paul Creech gave the Board of Camping report. Motion, seconded and carried to receive his report.

Rev. Wayne Miracle gave the report for the Board of Trustees. Work on the State Office project is proceeding. October 27, 2002 has been designated as "State Office Commitment Day", when each church is requested to receive a special offering; and November 2, 2002 has been designated as "State Office Ground-Breaking Day", when all churches are invited to bring their special offering. The goal is for every Georgia FWB church to give \$25 per member toward this project. Motion, seconded and carried to receive his report.

FRIDAY MORNING WORSHIP SESSION

Following a brief recess, the session resumed at 10:45 am with Rev. Larry Montgomery presiding over the morning worship session. Rev. Montgomery opened the meeting in prayer. Rev. Frank Miller led the congregation in singing, "Send the Light" and "I Love to Tell the Story". Rev Michael Bryan led in prayer. Special music was provided by Sis. Heather Goodman. Rev. Montgomery introduced our keynote speaker, Rev. James Forlines. His subject was presented in seminar format and was entitled "Refocusing the Inward-Focused Church: Clear Vision in Dim Light". Rev. William Smith shared a few announcements and Bro. Kyle McDowell dismissed us in prayer.

FRIDAY AFTERNOON BUSINESS SESSION

After a lunch break, the session resumed at 1:30 pm, as Rev. Frank Miller led us in singing "Victory in Jesus", and an opening prayer. Assistant Moderator Russell Horne read a Scripture selection from Matthew 28:18-20 and offered a prayer for God's continued blessing and guidance.

Rev. Russell Horne gave the report for the Board of Missions. Several questions were asked concerning the financial status of the Missions Account. Rev. William Smith assisted Rev. Horne in addressing these questions. Motion, seconded and carried to receive his report.

Rev. William Smith gave the report for the National Executive Office on behalf of Rev. Melvin Worthington. Motion, seconded and carried to receive this report as information. Rev. Ron Hunter, new director for Randall House Publications, gave the report for the National Sunday School & CTS Department and a Spanish curriculum report. Motion, seconded and carried to receive these reports as information. Rev. Tim Campbell gave the report for the Free Will Baptist Bible College. A rising vote of thanks was given to Rev. Campbell for his efforts on behalf of the College. Motion, seconded and carried to receive his report as information. Rev. Bill Evans gave a report for the Retirement and Insurance Department and the Free Will Baptist Foundation. Motion, seconded and carried to receive his report as information.

Following a brief recess, Rev. Roy Roach gave a report for the Tennessee Family Ministries. Rev. Bill McCarty shared additional promotional information concerning this ministry. Motion, seconded and carried to receive their reports as information. Rev. S.E. Newberry gave a partial Credentials Committee report with 91 voting delegates and 122 registered. Motion, seconded and carried to receive this partial report. Rev. James Forlines gave a report for the National Foreign Missions Department. Several questions were answered concerning the financial status of the Foreign Missions Department. Motion, seconded and carried to receive his report as information. Rev. James Wilhide gave a report for the South Carolina Children's Home. Motion, seconded and carried to receive his report as information. Rev. Richard Atwood gave a report for the National Home Missions Department. Special prayer was offered by the association on behalf of Sis. Carolyn Adams and Bro. Nathan Atwood. Motion, seconded and carried to receive his report as information.

Clerk Keith Lloyd read the Nominating Committee report. No other nominations were offered. Motion, seconded and carried to receive these nominations and to elect those individuals nominated. A plea was made from the floor encouraging all elected board members to actively participate in the business of the association. Rev. William Smith shared several announcements. Rev. Rick Wilson dismissed us in prayer.

FRIDAY EVENING WORSHIP SESSION

The Horne family ministered to the congregation in song as a prelude to the evening worship session. Rev. Billy Hanna presided over the session, and Rev. Fred Lockwood directed the music, accompanied by Rev. Todd Horne on the keyboard.

Rev. Lockwood led the congregation in singing "Jesus Saves", "Majesty", and "A Hill Called Mount Calvary". Rev. Paul Creech led in an opening prayer. Rev. Executive Secretary/Treasurer Report March 2001 – March 2002

Welcome to the Sixty-sixth Annual Session of the Georgia State Association of Free Will Baptists. We have gathered to celebrate the victories of 2001, worship and praise the Lord, and conduct business. As we look over the reports of 2001 and see how the Lord has blessed our state, we need to be mindful of the tremendous opportunities and responsibilities that lie before us.

Thank you for your faithful financial support during 2001. Receipts through the State Office totaled \$689,338.37. Of this amount \$227,346.57 was *Cooperative Giving*, \$140,898.61 was *Georgia Acts 1:8 Giving*, and \$321,093.19 was *Designated Giving*. Compared to 2000 we had a 5.5% increase in giving through the State Office. All of the financial reports found in this digest cover the period from January 1, 2001 to December 31, 2001.

The combined attendance for Teen Camp and all the district Junior Camps set a new record. We had record attendance for our Couples Retreat and Winter Teen Retreat. There was an increase in attendance for our Minister's Retreat, Minister's Wives Retreat, and State CTS competition. The events of September 11th had an effect on the attendance at our Minister's Wives Retreat and Senior Citizens Retreat.

The Georgia Foreign Mission team of Dale and Sandra Bishop, Debbie Griffin, and Nathan and Linda Snow are making progress in establishing new Mission Churches in the city of Hokkaido, Japan. Nathan and Linda will be returning home at the end of April for a year of stateside ministry. If you would like to have the Snows visit your church please contact the State Office.

Ron and Janice Wallace have seen some growth in Fairbanks, Alaska. They were able to purchase eleven acres of land on the main highway between Fairbanks and North Pole, Alaska. Plans are being made to construct the new church building during the summers of 2002 and 2003. Paul and Gail Smith continue to labor in Hampton, Georgia. They have completed their first year in the new building. The church has seen many visitors during the past quarter. Billy and Shara Bevan have just completed their second year in Kingsland, Georgia. The church has seen significant growth since last June. They now average in the mid-fifties for morning worship. There is a large turn over in population in Camden County due to the Navy base. Please continue to pray as this church tries to reach the many new young people who move into the area each month.

One area of concern is the continued rise in the average age of the pastors in the state of Georgia. In the next ten years over half of our current pastors will be reaching retirement age. Please pray that "the Lord of the Harvest" will send forth laborers. We need to be concerned when we see how few of our young men are answering the call to the ministry. Soon there will be a large number of pulpits empty and missionary assignments to be filled.

Board of Camping Report March 2001 – March 2002

Camp season 2001 will be remembered in the years to come as a high-water mark for Free Will Baptist youth. From each associational Junior Camp to Teen Camp, these gatherings were blessed by God's presence and His guidance.

As a little boy, I often tired before my father. When I complained that I was tired, he would say, "I'm tired too, but it's a good kind of tired." Now, I fully understand what my father meant. After spending much of June in camp, I was tired physically, but it was that good kind of tired.

NO OTHER NAME. At Teen Camp, 2001, 148 teens came together to spend a week together at the FFA/FHA Camp at Covington. Arriving on Sunday afternoon, it was soon evident that this would be no ordinary week. The enemy broke a young girl's foot as she was entering the building to register. Sunday night, as the alter call was made, seventeen made first time decisions for Christ. I pondered, "How can this get any better?" Well, my faith was weak. God met with us in a fantastic way. Each day got better and better. By the end of the week, as best we can tell, twenty-five made first time decisions, over 100 rededications and assurances of salvation, and twenty answered a call to ministry (preaching, missionary work, pastor's wife, Christian School teacher, etc.). Thursday evening was the highlight, as each one that answered a call to ministry came to the altar, and we had a dedicatory prayer for them. In the evaluation surveys, the worship services and the morning classes garnered the highest marks, while the food and facilities came in lower. What a testimony to the power of prayer and the hand of God at work.

Teen Camp will be at Camp Echeconnee, in Lizella, Georgia, July 14-19. Mark Walker will serve as director this year. He will assemble a capable staff to assist him with Teen Camp this summer. He deserves our prayers and support as he leads this vital ministry.

Favorable comments continue to be received concerning the grants from this board to our local associations to assist them in the operation of their camp sessions. We ask each local camp board to remember the guidelines for those grants.

- Each association is to submit a written request for the grant by April 15th preceding the camp session. Failure to meet the deadline will result in the forfeiture of the grant.
- Following the camp session, a deadline of October 1st, is set for you to give a financial account of your camp session. A form will be provided by the board, and this form will require two signatures. Failure to meet the deadline will result in the forfeiture of the grant for the following year.

Our prayer is that these funds will enable our local associations to provide a quality camping

ministry to the highest possible number of campers.

Mission Board Report March 2001 – March 2002

The primary purpose of the State Mission Board is to establish churches within the state of Georgia. At the present time we are working to establish churches in Hampton and Kingsland, Georgia. The Georgia State Mission Board has also adopted Ron Wallace as a joint project with the National Home Mission Board to establish a church in Fairbanks, Alaska.

Paul and Gail Smith are our missionaries to Hampton, Georgia. Paul moved to the Atlanta area five years ago to work with the North Fayette mission, which was started by Luther Burns. The congregation along with the Mission Board thought it would be best to relocate because of the changing demographics of the area where the original building was constructed. After a long process the congregation moved into their new building in September of 2000, with dedication service in November 2000.

Many of you were able to see the new building at last years State Association. The new building has a sanctuary that will seat 190 people comfortably. It also has six Sunday school rooms, a nursery, fellowship hall, kitchen, secretary office, and pastor office. Sod was added to the front portion of the property in August.

At this time the congregation is averaging twenty-five for worship on Sunday mornings. There are several homes being built in the area. Please pray for Brother Paul to be able to reach some of the new families who are moving into this area.

The South Georgia Association asked the Georgia State Mission Board to take over the Camden Mission in the summer of 1999. Billy and Shara Bevan moved to Kingsland, in November of 1999. When Billy first arrived he spent quiet a bit of time cleaning and painting the present facility. A Sunday school program and Children's Church was organized during the first few months.

When arriving in Kingsland Billy had about fifteen people to work with. This included adults and children. After two years of much prayer and hard work the mission is now averaging about fifty-five on Sunday mornings. This is a real blessing when you consider the turn over rate in the Kingsland area due to the military base. Please continue to pray for Billy and Shara as they have the opportunity to minister to the many young people that God moves into this area.

Ron and Janice Wallace have done a tremendous job in Fairbanks, Alaska. They started with eight people three years ago and are now averaging in the mid thirties. The congregation was able to purchase eleven acres of land last year for the purpose to relocate their mission church. Plans are now being made to build a new building. Because of the inclement conditions it will take two years to complete the new building. Please pray for Ron and Janice as they labor in the Fairbanks area.

The mission board is in the process of writing a Mission Board Manual. Guidelines will be established for hiring new missionaries and working with new mission projects. The board feels this manual is needed as we plan to move into new areas and build churches in the future.

Please continue to pray for our mission projects and our mission board.

CONSTITUTION AND BY-LAWS

GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS, Inc.

PREAMBLE

We, the Free Will Baptist of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the cause of Christ.

ARTICLE I

This assembly shall be known as the Georgia State Association of Free Will Baptists, Inc.

Article II

SECTION 1. The officers of this association shall be Moderator, an Assistant Moderator, a Clerk, and Assistant Clerk, and an Executive Secretary/Treasurer.

SECTION 2. The Executive Board shall be composed of the regular officers; the chairman of each of the standing boards; and the previous moderator, as an ex officio member for a period of two years following his term of office.

SECTION 3. This Association shall be composed of ordained Ministers, ordained Deacons, Missionaries, and Board Members who are members of affiliated bodies; one (1) delegate for every three hundred (300) members or fraction thereof from District Associations; one (1) delegate for every one hundred (100) members or fraction thereof from each local affiliated church.

SECTION 4. All delegates from District Associations and local churches shall be elected from the laity of the body sending them.

SECTION 5. Funds to meet current needs of this body shall be paid to the treasurer of this association. Each District Association will give a minimum of fifteen dollars (\$15.00) per delegate authorized, and each local church will give ten cents (\$.10) per capita of their respective memberships.

SECTION 6. In order to pay our Georgia State Association's annual representation fee to the National Association, each local association is to be responsible to promote, receive and forward the amount designated by the National Association per church per year to the State Office, along with their annual State Association representation fee, on or before our annual State Association session.

ARTICLE III

SECTION 1. It shall be the privilege of each affiliated District Association to recommend a member for each standing board. Terms of office on these boards shall be on a rotating basis which will necessitate the election by the State Association of five (5) members every two (2) years, thus giving each member a four (4) year term of office.

SECTION 2. There shall be a **Board of Missions** composed of members who are noted for their missionary zeal.

A. The Board of Missions shall employ missionaries as needed to establish Free Will Baptist mission/churches in the State of Georgia. These missionaries may be employed exclusively or jointly with other Free Will Baptist agencies.

B. A mission/church sponsored by the Georgia State Association and their missionaries are under the authority of the State Association and the supervision of the Georgia State Board of Missions.

C. A mission/church does not have autonomous church status. As long as the mission/church is unable to provide for its own business, it is in a dependent relationship to the State Association and its Board of Missions.

D. When the mission/church is self-sustaining, self-governing, self-discipline, and self-propagating. It should be organized into an autonomous Free Will Baptist Church following the procedures adopted by the Georgia State Association.

E. After proper procedures are satisfied and the church is duly organized into autonomous Free Will Baptist church it shall have all normal rights, privileges, and responsibilities of any other Free Will Baptist Church.

SECTION 3. There shall be a **Board of Camping** whose duties shall be to schedule and arrange all camp sessions, and to appoint the Camp Director each year.

SECTION 4. There shall be a Board of Christian Education whose duties shall be:

A. To provide educational services for the members of the Georgia State Association of Free Will Baptists.

B. To set policy and supervise the functions of the State Youth Committee. This Board shall appoint this Committee to carry out Board policy.

C. To organize sponsor and promote educational and inspirational retreats for our members.

D. To organize, sponsor and promote Sunday School and Church Training seminars.

E. To set policy and supervise the Historical Committee. This Board shall appoint the Historical Committee to gather and set forth for public knowledge and posterity the history of Georgia Free Will Baptists.

SECTION 5. There shall be a **Board of Trustees** whose duties shall be; maintenance, upkeep and insuring of all State Association properties; the planning and supervision of all future developments and expansion of these properties as directed by the State Association except otherwise provided in this Constitution.

SECTION 6. There shall be a **Credentials Committee**, which shall consist of three (3) members of three-year terms. And the term of one expiring each year thereafter according to seniority of service, who shall be in charge of the registration and examination of delegates and the receiving of all dues.

SECTION 7. There shall be two members on the Board of Trustees of the Free Will Baptist Children's Home, Eldridge, Alabama, elected for terms of four (4) years. Election will take place on odd years and shall be staggered.

SECTION 8. There shall be a **Georgia State Master's Men.** They shall select their own officers and conduct their own business.

SECTION 9. There shall be a **Georgia State Woman's Auxiliary Convention** (**GWAC**). They shall elect their officers, conduct their business and maintain their treasury.

ARTICLE IV

SECTION 1. All officers except board members and the Executive Secretary/Treasurer shall be elected to serve a term of two (2) years. The Executive Secretary/Treasurer shall be employed by the Executive Board of the Georgia State Association of Free Will Baptists, subject to the ratification of the Georgia State Association of Free Will Baptists at its next regular session, for an indefinite period, with an agreement of sixty (60) day notice of termination by either the Executive Secretary/Treasurer or the Executive Board.

SECTION 2. Standing Boards of the State Association have no power of final authority to hire, full–time employees until the matter has been presented to and acted on by the State Association in session except where otherwise provided.

SECTION 3. The Executive Board may fill vacancies on any of the boards or committees, which occur between regular sessions of this State Association, until the convening of the annual session of said association.

SECTION 4. Election of all General Officers shall take place on the odd years of the calendar.

SECTION 5. If a member of any board fails in the function of his or her duty without good and sufficient reasons, the board of which the delinquent is a member may declare that particular office vacant. Further, this body shall have and does reserve the right to deal with the officer or board member who does not conduct his or her office in a Christian, business like manner according to the rules of Christian conduct as set forth in the New Testament.

Any standing board of this State Association may appoint proxies to serve in lieu of the absent members.

At the pleasure of the boards, and subsequent to the meeting from which the regular member is absent, the boards have the right to deal with the delinquent member in the manner stated in this section.

SECTION 6. The Chairman or Vice-Chairman of said board, or by the Moderator or Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said boards, may call boards into session.

SECTION 7. An auditing Committee of three (3) members will be elected annually.

AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this association and shall lie on the table from one (1) business meeting to the next during the same session, during which time it shall be read at least two (2) times in open session. Officers, standing boards, and/or standing committees may be added or deleted as the need arises.

BY-LAWS

SECTION 1:

A. All real property, checking and savings account or any other assets of this Association shall be in the name of the *Georgia State Association of Free Will Baptists, Inc.*

B. One or more of the corporate officers of the Association shall be the legal signers of all Georgia State Association of Free Will Baptists, Inc. business. These officers are: the Moderator as the corporate President; the Clerk as the corporate Vice-President; and the Executive Secretary/Treasurer as the Secretary/Treasurer.

C. The State Office shall be responsible for the safekeeping of the corporate seal and all official documents of the State Association.

D. No State Board may borrow money or financially obligated the State Association without the approval of the Executive Board.

E. The fixed assets (building, land) of the Georgia State Association of Free Will Baptists shall not be liquidated except by a two-thirds (2/3) vote of the delegates present and voting at any regular session of the Association.

F. The records of all financial transaction shall be open to all members of the Georgia State Association. The financial transactions of the State Office and State Boards shall be audited annually.

G. Annual financial reports of the State Office and State Boards and the auditor's report shall be made to the State Association in session an be entered in the Annual State Minutes.

H. The State Treasurer shall be bonded in amount stipulated by the State Executive Board.

I. This Association shall meet for its regular session annually on Thursday following the second Sunday in March and shall adjourn on the Saturday immediately following.

SECTION 2.

A. When the State Association is not in session, the State Executive Board shall be duly authorized to do business in the name of the State Association.

B. The State Association has full authority to direct the State Executive Board in all business conducted on its behalf.

C. The State Executive Board shall report to the State Association in session concerning the business conducted for the State Association since its last convening.

D. The State Executive Board has the prerogative of deferring any matter to the State Association as a whole but is not under obligation to do so.

E. The State Executive Board shall meet quarterly in the following months: March, June, September, and December. The March meeting shall be held just prior to the regular meeting of the State Association.

F. Any and all correspondence from any member of this State Association, (includes either individual, group, Board or District Association) directed to any Board, or

Chairman of said Board, or any officer of this State Association, or any open letters to any or all District Associations of this State, that pertains to any business which is desired or required to be brought before this body at any scheduled or special called meeting, shall be properly sent directly to the Clerk of the Georgia State Association of Free Will Baptists, The clerk will be responsible for routing the correspondence to its proper designation. All correspondence as mentioned above, shall be required to be received by the Clerk of the State Association at least 30 days prior to any scheduled State Association Meeting if said correspondence contains business that is to be introduced and discussed at said meeting.

SECTION 3.

A. The moderator shall preside at the Annual Session of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board. The Moderator shall be the President of the Corporation known as the *Georgia State Association of Free Will Baptists, Inc.*

B. The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.

C. The Clerk shall keep records of the proceedings of the Annual Associational meeting and of the Executive Board meetings. It shall also be his responsibility to have the minutes of these sessions printed and distributed. The Clerk shall be the Vice-President of the Corporation known as *Georgia State Association of Free Will Baptists, Inc.*

D. The Assistant Clerk in the absence of the Clerk, shall fulfill the functions and duties of the Clerk as stated in paragraph C of this document.

SECTION 4.

A. The Executive Secretary/Treasurer shall be responsible and accountable to the Executive Board in the fulfillment of the duties of his office as determined by the Executive Board.

B. The Executive Secretary/Treasurer shall be allowed four (4) weeks vacation per year with pay.

C. Funds received by the Executive Secretary/Treasurer for revivals, special speaking engagements and promotional meetings shall go into the Cooperative Fund. The exception to this regulation relates to remuneration received by the Executive Secretary during his four (4) weeks vacation, which shall be his personally and need not be accounted for to this State Association.

D. Salary, mileage and operational expenses of the Executive Secretary/ Treasurer shall be determined by the Executive Board.

E. The Executive Secretary/Treasurer shall be the Secretary/Treasurer of the Corporation known as the *Georgia State Association of Free Will Baptists, Inc.*

F. General Promotion. He is to represent, or cause to be represented, the association at all affairs of interest to the association and he is to promote the work of the association in such a manner so as to unify the association as well as promote both the state and national works, missionaries, mission conferences, etc. Through personal communication he shall keep close contact with pastors, churches, and district association.

G. Administration. He shall administer the affairs of the executive office and carry out the responsibilities delegated to him by the State Association and the Executive

Board. He is to serve with all standing boards and committees of the association in an exofficial capacity. He is to report to the association during each annual session.

H. Stewardship. He shall serve as treasurer of this association. An accurate and complete record of all funds received and disbursed shall be kept and a written report shall be included in his report to this association in its annual session. He shall receive, hold and disburse money as is made available by the State Association to the various boards. Disbursements to the various boards will be made available when requested.

I. Publication. It shall be his duty to edit and publish the state paper. He shall direct the production of general promotional materials, pamphlets, audiovisuals, and books as approved by the Executive Board.

J. Arranging State Association. He shall expedite the planning of the State Association program, enroll all ministers and delegates, print and distribute minutes, and investigate future sites for the annual session.

SECTION 5.

A. The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the board shall investigate places suitable for this meeting and make recommendations to said State Association. Meeting places shall be determined two (2) years in advance.

B. The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of Parliamentary Procedure.

C. The Executive Board shall formulate the budget for the State Association annually and recommend to the body in the session the allocations to be observed in the Cooperative Plan for Giving. This board shall, in addition to the above stated duties, also recommend a mileage rate for travel by the members of all standing boards in said association.

SECTION 6.

The Moderator shall appoint necessary committees unless otherwise provided for by the body.

SECTION 7.

These By-Laws may be altered, changed, or amended at any regular session of this association by a two-thirds (2/3) vote of delegates present and voting (Revised 2001)

Vice-President Debra Van Pelt welcomed everyone prior to the business session. Rachel Horne led the congregation in "We Have Come Into His House" and "People Need the Lord". Vice President Debra Van Pelt gave the Credentials Committee Report with 8 districts and 1 local church reporting, including 26 locals and 35 delegates. The voting delegates were then seated.

Secretary Donna Jewell read the minutes from the 2001 meeting. M/S/C to accept as read.

Treasurer Christine Daniels read the financial report. The beginning balance as of January 31, 2002 was \$3,826.25, with \$33,913.79 received and \$34,986.08 disbursed, leaving a balance in the treasury of \$2,753.96.

Old Business:

Sammie Montgomery gave the report of the 2001 Retreat at Norman Park. Our guest speaker, Susan Turnbough, missionary to Spain, did an outstanding job. She commented on the song written by Shirley Kimbrel, the apple bags and the apple theme in general. The National Convention had good seminars including the themes of "criticism" and "record keeping". James Forlines was the guest speaker.

Committee Reports:

A. Terra Smith gave the Resolutions Committee Report.

Whereas, the women of the Camden Free Will Baptist Church of Kingsland have hosted the state convention of the GWAC. BE IT RESOLVED that this body give them a rising vote of thanks for their gracious hospitality. M/S/C by everyone standing.

B. Christine Daniel gave the Finance Committee Report.

\$2,753.96 balance brought forward, today's offering was \$166, leaving a balance of \$2,919.96. Recommended giving our speaker \$200 honorarium, plus \$185 travel

expenses, which leaves a balance of \$2,534.96. Recommended that the Acts 1:8 project remain at \$7,000. M/S/C to accept.

C. Janice Temples gave the Registration Committee Report.

51 registered, 1 missionary, 9 visitors, 36 delegates, 8 state officers, and 9 districts represented. M/S/C to accept.

New Business:

National Report. Gail handed out an information sheet from the National Office. Gail also noted that the national office is struggling financially and that WNAC President, Debe Taylor, had asked for each lady to consider a monthly faith commitment of \$10 to help defray costs. July 22-23 is the National WAC Convention in Memphis. Report accepted as information.

We then went over the revisions to the Constitution and Bylaws, the main changes being that our official name is Georgia Women Active for Christ (GWAC), and officer and committee revisions. Motion and second to revise as drafted, and after discussion and clarification, the motion was carried.

The proposed 2003 budget was reviewed and after explanation, M/S/C to adopt.

The 2002 Retreat will be at Norman Park October 18 and 19.

Announcements were given. Gail brought greetings from Marjorie Workman and Janice Wallace. Gail encouraged everyone to read the Promotional Bulletin for announcements and articles. Historian Marie Glover was complemented for her hard work on the history book. It was noted that Mrs. Lora Shutes had recuperated for a short time but is now in ill health and mostly bedridden. Nathan and Linda Snow will be home soon on furlough.

The meeting was adjourned and Marie Glover dismissed in prayer.

GEORGIA WOMEN ACTIVE FOR CHRIST Of the Georgia State Association of Free Will Baptists, Inc. Constitution and By-Laws 2002

Article I

<u>Name</u>

This organization shall be known as Georgia Women Active for Christ a division of the Georgia Association of Free Will Baptists, Inc., commonly known by its initials, GWAC. Its members shall elect officers, conduct business and maintain a treasury.

Article II

<u>Purpose</u>

The purpose of this organization shall be to assist the various women composing the GWAC in providing opportunities to understand and fulfill the Great Commission through their responsibilities in the family, church, community, and around the world.

It shall bring the women of each district together for fellowship, sharing information, encouraging one another in the work of the Lord and furthering the purpose and goals of the Georgia State Association of Free Will Baptists.

Article III

Officers

- The officers of this convention shall be president, vice president, secretary, treasurer, field worker, historian, and three members at large, all of which are elected by the convention. These officers shall serve as the State Executive Board. A minimum of five officers shall be a quorum for transacting business.
- Any officer or elected board member of this convention must be an active member of a local Free Will Baptist Church and an active member of the GWAC group of a local church.
- Executive Board members are required to attend all scheduled board meetings. Any officer missing three meetings is subject to review and removal by the Executive Board.

Article IV

Membership

- This convention shall be composed of: the officers of the convention, district presidents, district field workers, ten delegates (duly accredited by the credentials committee) from each district convention, four delegates and the president from each local GWAC in good standing with its district convention.
- 2. Local groups in an area where there is no district convention may be represented with five delegates by payment of their membership dues. All delegates, as well as officers of the convention, shall be in good standing with a church that is in good standing with the Georgia State Association of Free Will Baptists, and shall perform the duties as set forth for them in the present WNAC manual and this Constitution and By-Laws.

<u>Meetings</u>

Article V

- The annual meeting shall be held each year the day before the Georgia State Association of Free Will Baptists convention in the same place or at such a time and place determined at the previous annual meeting or by the Executive Board.
- 2. A prayer retreat shall be held annually, time and place to be planned by the Executive Board.

Article VI

Amendments

This Constitution may be amended at any annual meeting of the convention by a two-thirds vote of the members present.

By-Laws

Article I

Duties of Officers

President – The president shall preside over all meetings, appoint such committees as may be needed; call the Executive Board together when necessary; be exofficio member of all committees, except the nominating committee; see that reports are sent promptly to the WNAC secretary; and perform all duties pertaining to such an office. She should see that GWAC is represented in the State Promotional Bulletin. Articles should be sent to the state executive office by the 1st of each month. She may either write the articles or ask someone to write the articles for her.

Vice President – The vice president shall preside in the absence of the president or by her request and otherwise assist her in the oversight of the work in general. She shall serve as chairman of the credentials committee.

Secretary – The secretary shall keep an accurate record of all proceedings of the convention and Executive Board meetings; preserve all valuable papers and turn same over to her successor; make an annual report to the WNAC secretary on a form available from the WNAC office within 15 days after the State GWAC Convention; compile the districts' slate of officers and addresses immediately after the convention; send a slate of state officers to the WNAC secretary and to each state officer. She is responsible for getting the minutes prepared and to the state associational office in time to be included in the state minutes each year.

Treasurer – The treasurer shall have charge of all funds belonging to this convention and shall pay out same only when authorized by the convention. The treasurer shall keep an accurate account, and give a written report of all funds received and disbursed at each annual meeting of the convention. She is required to deposit all checks in her possession and disburse all designated funds by the 30th of each month. She shall be bonded through the state office and audited annually.

Field Worker – The field worker shall promote GWAC programs through personal contact and the distribution of literature and serve where needed as directed by the Executive Board.

Historian – The historian shall keep a historical record and have a display at all state meetings and serve where needed as directed by the Executive Board.

Members at Large – The members at large shall help promote the work in general, meet with the Executive Board, and serve where needed as directed by the Executive Board.

Article II

Elections

A nominating committee shall nominate the general officers and members at large. Following the nominating committee's report, opportunity shall be given for nominations from the floor. In case of more than one nominee for any particular office, a vote will be taken for each; otherwise they may be elected by acclamation. The officers shall be elected every two years on odd number years. Not more than one-half of the elected officers shall be changed in any regular election. All elections shall be held at the closing sessions of the annual convention.

Article III

Expenses

Estimated expenses for the state work shall be set by an annual budget approved by the convention. The Executive Board must approve all reimbursement.

Article IV

Boards and Committees

Executive Board – This Board shall be composed of six officers and three members at large elected by the convention. Five of these shall compose a quorum. They shall hold meetings for the transaction of business as often as necessary. It shall be the duty of the Executive Board to maintain an oversight of the work at large. The Board shall act for the convention when necessary. It shall prepare the program for the regular meetings and fill any vacancy between elections.

Resolutions Committee – A resolutions committee shall be appointed by the president. A member of the Executive Board shall chair this committee. This committee shall review all resolutions presented, having the prerogative of passing on to the convention those resolutions that are deemed proper and profitable. Resolutions should be properly worded, i.e. "Be it Resolved....."

Nominating Committee – The nominating committee shall be composed of one member from each district convention and shall be elected one year prior to making their report. The names of the members from each district shall be submitted with the convention annual report. The president shall appoint a chairperson from the members of the nominating committee.

Credentials Committee – The vice president shall be the chairman of the credentials committee and the president shall appoint two other members. This committee shall examine the reports of the represented women's groups to see if fees are paid and if reports are in order.

Finance Committee – The treasurer shall be chairman of the finance committee and the president may appoint four other members. This committee reviews the financial records for the year, reports on same to the convention, and makes recommendations of disbursements of funds to the convention.

Registration Committee – The president shall appoint members as needed to serve on this committee. This committee registers those in attendance and gives a report to the convention.

Article V

Dues and Reports

Active members shall pay dues yearly as required by the GWAC Convention for membership. These dues should come through the district treasurers by January 10th following the close of the previous year. District secretaries and treasurers annual reports should be filed with the state secretary and treasurer no later than February 1 following the close of the previous year. Beginning 2002 the dues are \$12.50 per member with Georgia retaining \$2.50 per member and WNAC receiving dues of \$10.00 per member.

Gifts

Article VI

- Season of Prayer Offerings-
 - 1. **Pre-Easter Week of Prayer** offering is used for Foreign Missions in memory of Laura Bell Barnard, our first foreign missionary.

- 2. **Pre-Thanksgiving Week of Prayer** offering is used for National Home Missions in memory of Mrs. Lizzie McAdams, a great writer of our literature and one of the first National officers.
- 3. The December Week of Prayer offering is used for State Missions in memory of Mrs. Alice E. Lupton, our first National president.

Co-Laborer Offering – A financial plan of support for WNAC. Each local GWAC is encouraged to support the WNAC office with a monthly offering.

Provision Closet - This project helps missionaries as they return home to pick up household items, etc., from the closet at the National Office. Each local GWAC is encouraged to keep abreast of the items and supplies needed as they are periodically listed in the **Co-Laborer** magazine, and give to this project as needed.

WNAC Emphasis – A special offering to supplement the Co-Laborer Offerings for WNAC expenses of operation, literature, etc. This offering is received during August.

Remembrance Fund – This is a fund established by WNAC and a distinct way to honor any occasion the donor wishes to note: Anniversaries, birthdays, or as a memorial gift at the time of death. A remembrance card notifying the family of the person being honored, and the donor, will be entered in the permanent Book of Remembrances in the WNAC office. These gifts will be used to advance the kingdom of God through WNAC. A Remembrance Service is to be conducted at our state GWAC convention each year.

Dr. Mary Ruth Wisehart Foreign Student Scholarship Fund – Any GWAC group who wishes may contribute to this special fund set up by WNAC to train Nationals from our foreign fields. February is designated as Foreign Student month.

Dot Harvey Loan Fund – This revolving loan fund was established in honor of Miss Dot Harvey, a forerunner of youth work in Georgia, by the Georgia Women's Auxiliary Convention in 1954 to aid worthy Georgia students attending Free Will Baptist Bible College. Each local group is asked to donate monthly toward this project. A special offering is received in September to add to this fund.

Westfield Church Fund – This fund is used to assist the church in Kotogiri, South India in memory of Miss Laura Bell Barnard. All groups are encouraged to give to this Georgia project monthly.

Other Gifts – The state GWAC may decide on and promote other projects for funds at its own discretion.

Lora Shutes Mission Project – This is a statewide project with the goal set each year at the annual convention. Funds are disbursed to missionaries through the State Acts 1:8 Program.

GWAC Emphasis – June is designated as GWAC Emphasis Month. Each group is asked to receive a special offering to supplement GWAC operational expenses.
