Proceedings of the 72nd Annual Session of the GAFWB

The minutes of the Seventy-second Annual Session of the Georgia State Association of Free Will Baptists, convened at the First Free Will Baptist Church in Albany, Georgia, on March $12^{th} - 14^{th}$, 2008.

WEDNESDAY EVENING WORSHIP SERVICE

The evening began with a prelude of special music by "Greater Joy", a group of ladies from the Albany First FWB Church. Rev. Billy Hanna welcomed everyone to the 72nd Annual Session of Georgia Free Will Baptists.

The congregation and choir, led by Rev. Ben Crabtree, joined together in singing "Come Christians Join and Sing" and "Joyful, Joyful We Adore Thee". Rev. Irvin Hyman led in prayer.

Soloist Sister Donna Walker, accompanied by the Celebration Choir, sang a worship inspiring song entitled, "I Bless Your Name". The choir and congregation lifted their voices in praise, singing together "Sanctuary" and "Take My Life". A group of men and women from the Albany church called "Sounds of Praise" brought the congregation to their feet with a rousing rendition of "Total Praise".

Rev. Billy Hanna introduced the evening speaker Rev. Grover Jewell, the pastor of Cornerstone FWB Church in Ft. Valley, Georgia. Rev. Jewell brought the evening message entitled "Lifting Up Laymen", using Ephesians 4:1-7 as his text.

The congregation sang "Just As I Am" as an invitational hymn.

Moderator Len Blanchard appointed the Committee and Committees as follows: Rev. S.E. Newberry – Chairman, Rev. Steve Dowless, Rev. Mike Mounts, Rev. Rick Cason, and Rev. Aaron Baldridge.

The congregation sang "We Will Stand" as a closing song.

THURSDAY MORNING BIBLE CONFERENCE

Rev. Len Blanchard presided over the Thursday morning Bible Conference and Rev. Ron Wallace opened the meeting with prayer.

Rev. Donnie Burke led the men in singing "Blessed Be the Name of the Lord". Rev. Ben Crabtree ministered in song with a special selection entitled "Ancient Words".

Rev. Len Blanchard, speaking as the Moderator and on behalf of the Executive Board, explained that this year's Bible Conference would focus on the vision casting of the State Boards. He challenged each Board and each church to let the Light of Christ shine in and through them, leaving behind a legacy of faithfulness and fruitfulness.

The Chairman of the State Trustee Board, Rev. Russell Horne, spoke concerning the responsibilities of the Board as managers of state properties. The desire of the Board is to continue to be good stewards of God's blessings. He read from Romans 15:1-15 and closed by showing a slide show of recent renovations at the State Office, with Rev. William Smith providing commentary.

After a brief recess, Brother Todd Horne led the men in "To God Be the Glory". The Horne men (Russell, Tim and Todd), accompanied by Len Blanchard, sang "He Touched Me", with the other men in attendance joining in on the last verse.

Rev. Danny Ryals, Assistant Chairman of the State Mission Board, spoke in the absence of the Chairman, Rev. Paul Creech, who is undergoing treatment for cancer. He read the 127th Psalm as an introduction to his comments. The Board's objective is to plant churches in Georgia. There are currently three church plants in progress: Cartersville, Valdosta, and the newest work in Harris County. The biggest obstacle to new church plants is finding a suitable and qualified church-planter. Rev. Jay Hollis, the church planter in Harris County, shared briefly concerning the work there and asked the association to be in special prayer for some new contacts he has made with area residents.

State Christian Education Board Chairman Rev. Randy Jackson began his comments by reading Joel 2:28. The C.E. Board is charged with organizing retreats, administering scholarships and overseeing the State Youth Competition. They are constantly searching

for new and creative ways to get more of our people involved and see their role as one of promoting discipleship at the statewide level.

Rev. Mark Walker, serving as the State Camp Board Chairman, read 1 Corinthians 15:58 and then shared concerning the particular challenges to reaching this generation of young people with the Gospel. The Board is constantly looking for ways to get more youth to the summer camp and winter retreat, without compromising or watering down the message of Christ. He closed his comments by reading Psalm 78:1-8.

Rev. Len Blanchard dismissed the meeting in prayer.

THURSDAY AFTERNOON BUSINESS SESSION

Call to Session & Preliminaries

At 2:00 PM, the GAFWB convened with Rev. Tim Horne leading the congregation in "When We All Get To Heaven". Clerk Keith Lloyd officially called the Seventy-second Annual Session of the Georgia State Association of Free Will Baptists to order and introduced the Moderator, Rev. Len Blanchard.

Moderator Len Blanchard began the session with a Scripture reading from Psalm 91. The Assistant Moderator, Rev. Wayne Miracle, led the Association in an opening prayer.

The Moderator welcomed everyone and recognized the Standing Delegates, which includes ordained ministers and deacons, board members and missionaries.

Rev. Bobby Taylor gave a partial report of the Credentials Committee. A motion was made, seconded, and carried to seat all elected delegates.

The Moderator then recognized the national messengers and welcomed other visitors.

Executive Board Report

Clerk Keith Lloyd gave the Executive Board report. The report included a proposed 2009 COOP Budget of \$350,000.00 and a proposal to hold the 2009 GAFWB at the Calvary FWB Church in Columbus. A motion was made to receive the report as read. The motion was seconded and carried.

Executive Secretary / Treasurer Report

Executive Secretary/Treasurer William Smith gave the Executive Office report and began by thanking the First FWB Church of Albany for hosting the session again.

In spite of a downturn in the economy and a slight decrease in COOP gifts, all of our Georgia missionary accounts are in the black and the State Boards are also in good shape financially. The goal of the Executive Office is to have all of our churches giving to the COOP and Acts 1:8 budgets.

Bro. William reminded the Association that God has blessed Georgia and placed us in a unique position to fulfill the Great Commission by bringing the mission field to our door. With that position also comes a great responsibility: "To whom much is given, much is also required."

Randall House will offer a Team Church Seminar in August to provide training for church leadership; and, the National Association International Mission Board will hold a meeting in April to present and gain input concerning the implementation of a new missions funding program.

A motion was made, seconded and carried to receive the report.

GWAC & National Reports

Executive Secretary Rev. Keith Burden presented a report for the **National Executive Office** and *ONE Magazine*. He began by thanking Georgia for their support and for their representation on various National boards and ministries. He also shared information concerning registration for the 2008 National Convention. *ONE Magazine* continues to expand its circulation. The report was received as information.

Sister Debra Van Pelt reported for the **Georgia Women Active for Christ (GWAC)**. A motion was made, seconded and carried to receive the report. The GWAC report will be included in its entirety in the minutes of the 72nd Annual Session. Sister Marjorie Workman also submitted a written report for **Women Nationally Active for Christ (WNAC)**.

Rev. David Williford reported for the *Free Will Baptist Bible College (FWBBC)*, thanking Georgia for their longstanding support and encouraging continued investment in the present and future of our denomination. The report was received as information.

Brother Eric Pushman reported for *Randall House Publications*. The D6 campaign is going well, emphasizing that Christian education begins in the home, not the church. Several new books have been published and sales continue to increase. Randall House remains committed to FWB doctrinal distinctives in their Sunday School literature. The report was received as information.

Rev. Barry Simpson reported for the *International Missions Department (FWBIM)*. He began by asking for special prayer for the Rev. Bob Shockey family as they grieve the loss of their husband and father. FWBIM is grateful for the support of Georgia. The World Mission Offering continues to grow and the department anticipates another record-breaking year. Rev. Nathan Snow, missionary to Japan, also thanked Georgia for their investment in home and foreign missions. The report was received as information.

Rev. Ray Lewis gave a report from the national association's **Retirement and Insurance Department**. He thanked Georgia for their representation in the department and encouraged greater participation from Association pastors. The department is available to answer questions and structure plans according to each individual's need. The report was received as information.

Brother David Brown represented the *Free Will Baptist Foundation* and thanked several individuals for their support and involvement in the Foundation. Investments managed by the Foundation will benefit FWB missions and ministries for generations to come. The report was received as information.

Rev. Tim Eaton reported for *Hillsdale Free Will Baptist Bible College*. He thanked the Association for their support and offered to answer any questions concerning the Hillsdale Master's Degree program in Georgia. The report was received as information.

Rev. Herbert Waid led the Association in prayer for many special needs among our denomination and its faithful men and women, and dismissed the session.

THURSDAY EVENING WORSHIP SESSION

The Georgia Boys Quartet (Donnie Burke, Mark Walker, Tim and Todd Horne) provided special music as a prelude to the evening worship service.

Bro. Monte McKenzie led the congregation in singing "At the Cross". Rev. Rick Cason welcomed everyone and Rev. Mike Mounts led in an opening prayer.

The congregation pledged allegiance to the American and Christian flags and to the Word of God.

The congregation sang a medley of worshipful songs that included "Near the Cross", "My Jesus I Love Thee" and "Above All". The Jewell family sang a special selection entitled "I'll Serve You Honestly".

Rev. Cason introduced the speaker for the evening, our National Executive Secretary, Rev. Keith Burden. Using several related passages of Scripture, Bro. Keith spoke to us on the subject of "Celebrating the Ordinances".

The congregation sang "Near the Cross" as an invitational hymn.

Announcements were made and Rev. Willie Martin led the session in prayer. The meeting closed with the congregation singing "We Will Stand".

FRIDAY MORNING BUSINESS SESSION

Rev. Randy Jackson led the congregation in singing "Joy Unspeakable" and Dr. Bill Lewis led in an opening prayer. Assistant Moderator Wayne Miracle began the session with a Scripture reading from 2 Timothy 4:1.

After welcoming remarks by the Moderator, Dr. Charles Thigpen appealed to the Association to help retire debt on FWBBC properties on West End Avenue that have been renovated. Prayer and support was solicited with a goal to retire the debt by May.

Board of Christian Education

Rev. Randy Jackson gave a report for the Board of Christian Education. The State retreats were well attended and a blessing to our people. The Historical Society continues to generate interest and support and will be publishing two articles annually in the Promotional Bulletin. Youth Competition was held at White Oaks Church in Macon. Several of our youth also placed at the National level. The Master's Course is still progressing at the rate of one class every quarter. Charles Clark Scholarships have been provided to 22 FWBBC students from Georgia. This report and the financial report are included in the Digest of Reports.

A motion was made, seconded and carried to receive the report as information.

Board of Camping Report

Rev. Mark Walker gave the report for the Board of Camping. Teen Camp will be held at Camp Echeconnee in Lizella on May 25-30. Rev. Matt Price will serve as the camp evangelist. With public schools systems moving towards a "year-round" calendar, it is getting more difficult to accommodate everyone with the timing of camp. The Winter Retreat was held at Epworth by the Sea on St. Simon's Island. The Camp Board continues to support district Junior Camps with \$1,600.00 "grants". Though the Camp Board budget is in the red, adjustments have been made and the issue will be resolved in the 2009 budget. This report and the financial report are included in the Digest of Reports.

A motion was made, seconded and carried to receive the report as information.

Board of Missions Report

Rev. Paul Creech gave the Board of Missions report. Georgia missionaries Dr. Bill Lewis, Rev. Bill Crank, Rev. Jay Hollis and Rev. Ron Wallace were recognized. Property has been acquired in both Cartersville and in Valdosta. The church planter and launch team are ready to begin a new work in Harris County. The Northern Lights FWB Church continues to reach souls for Christ in Alaska. This report and the financial report are included in the Digest of Reports.

A motion was made, seconded and carried to receive this report as information.

Board of Trustees Report

Rev. Russell Horne gave the report for the Board of Trustees. All of the work on the State Office is now complete. The Archives Room itself is worth a visit. Slides were shown that revealed the quality of the work. Sister Geraldine Waid, who has tirelessly worked on the Archives, shared her excitement and enthusiasm over the large collection of historical documents and displays in the Archives Room. The State has very adequate insurance that covers not only property loss or damage, but also personal injury and liability. This report and the financial report are included in the Digest of Reports.

A motion was made, seconded and carried to receive this report as information.

National Reports (continued)

Brother Ken Akers reported for the *Master's Men Department*. Several projects, fellowship opportunities and fund-raising efforts are in the works. Participation and support was encouraged. The report was received as information.

Rev. Larry Powell gave a report from the *Home Missions Department*. He thanked the state for their prayers and financial support. Twenty-three new churches have been

planted in North America and quite a few more are in the planning and preparation stage. The report was received as information.

Rev. Mike Nabors reported for the *Alabama Children's Home*. There are presently twenty children in the home and thirty-four have been served this year. Five of those have made decisions to receive Christ as Savior. Several projects are in the works to expand and enhance the ministry of the Home. The report was received as information.

Rev. Jim Tolbert reported for the *Free Will Baptist Family Ministries*, which are headquartered in Greeneville, Tennessee. The ministry is reaching out to every phase of the family. He asked the Association to pick up the various brochures that outline each of the ministries that are available. Last year, over 100 young people made decisions to receive Christ as Savior and many others rededicated their lives to Him. The ministry has averaged over 100 salvation decisions per year for the last eight years. He thanked Georgia for helping to make it possible. The report was received as information.

Hearing no other nominations from the floor, a motion was made, seconded and carried to close nominations and elect these by acclamation.

Rev. Billy McKinney dismissed the morning business session in prayer.

FRIDAY MORNING WORSHIP SESSION

Following a brief recess, the session resumed. With only about forty-five minutes of business left on the agenda, the Moderator gave the session two options: to resume and finish the business immediately following the morning worship and then break for lunch; or, to break for lunch and reassemble at 1:30 pm for the conclusion of business. By a show of hands, the session expressed their desire to finish the business immediately following the morning worship.

Rev. Harold Williams presided over the morning worship service and read a passage of Scripture from John 4:22-24. Rev. Jeff Goodman prayed.

Rev. Randy Jackson led the congregation in singing "Onward Christian Soldiers". Rev. Nathan Snow and two of his children, Daniel and Megan, ministered in song with a special entitled, "How Great You Are".

Rev. Harold Williams introduced our speaker for the morning, Rev. Keith Horn, pastor of the Cedar Springs FWB Church. Bro. Keith's subject was "Worthy Workmen" and he used Matthew 10:5-10 as his text. Using Joseph from the Old Testament book of Genesis as an example, he preached concerning how to stay worthy for ministry.

"I Surrender All" was sung as men and women gathered around the altar for prayer.

FRIDAY AFTERNOON BUSINESS SESSION

The business session resumed immediately after the morning worship service.

National Convention Delegates

A motion was made, seconded and carried to seat the following as delegates to the 2008 FWB National Convention to be held in Charleston, West Virginia: Donna Jewell, June Hersey, Edwina Drinkwater, Kim Dowless, and Lynda Blanchard. A motion was made, seconded and carried to seat these as delegates.

Resolutions Committee Report

Committee Chairman, Rev. Ron Wallace, presented the following resolutions for the Association's approval and action:

- 1. "Whereas, the Church Family of First FWB Church, Albany, GA, has generously made available their church facilities for the annual meeting of the Georgia State Association of Free Will Baptists, 2008; and, Whereas the Church Family has been a gracious host, often exceeding the normal bounds of kind hospitality, providing food and snacks and providing many servants to assist the meeting in many ways...Be it resolved, that we give a rising vote of appreciation, accompanied with a ringing applause, and encourage individual words of thanks to the Pastor and people of Albany Church."
- 2. "Whereas, we are saddened with the earthly loss of fellow-servants of our Georgia State Association, men who gave many years of faithful service to Christ and Georgia Free Will Baptists, we note the passing of two men who served many years as Chairmen of the Georgia State Mission Board, Mr. Malcolm Freeman and Mr. Billy Hatcher...Be it resolved, that this Body send a letter of belated condolence and appreciation for service to the spouses of these two men, Mr. Billy Hatcher and Mr. Malcolm Freeman."
- 3. "Whereas, we are in a Presidential election year,...In light of the upcoming election, We resolve to be in constant prayer for God's wisdom and direction; and, We resolve to encourage our people to get out and vote, understanding the importance of this 2008 Presidential election; and, We resolve to support only those candidates who espouse Christian principles and values, especially as they regard the sanctity of human life from conception to natural death, and the sanctity of marriage as a Divinely-ordained institution and life-long covenant between a man and a woman."
- 4. "A Call to Prayer: We resolve, that each pastor set aside time to call out the names of all of our State Association leaders and board members in prayer and encourage their people to do the same, also encouraging more support to all our board's activities."

A motion was made, seconded and carried to approve the $1^{\rm st}$ resolution. The body acted upon the resolution accordingly

A motion was made, seconded and carried to approve the 2nd resolution. Rev. Billy McKinney offered personal thanks and appreciation for the lives of these two men.

The 3rd resolution was amended to include our support of candidates who espouse the issues of the sanctity of life and of marriage. A motion was made, seconded and carried to receive the amendment to the resolution. A motion was made, seconded and carried to approve the amended resolution.

A motion was made, seconded and carried to approve the 4th resolution.

Miscellaneous Business

Rev. Billy Hanna, speaking on behalf of the Albany First FWB Church and the Trustee Board, extended a welcome for the GAFWB Annual Session to be held at the Albany First FWB Church at any time in the future.

Rev. Billy Hanna requested that the State consider supporting Sister Candace Blanchard in her efforts as a missionary to Mexico. Because Sister Candace is the daughter of the Moderator, he allowed Executive Secretary William Smith to speak to the issue of providing for the underwriting of her ministry. Brother William expressed confidence that because she needs minimal financial support to meet her needs, the Acts 1:8 program is capable of providing such. With Assistant Moderator Wayne Miracle temporarily presiding, a motion was made and seconded to include Sister Candace Blanchard in the Georgia Acts 1:8 budget. The motion carried.

Rev. Billy Hanna expressed concern that the business meetings at every level of our denomination are sparsely attended, especially at the National Convention, and that as such, small minorities of people are given the responsibility of making major decisions. He suggested a letter be sent to churches strongly encouraging attendance at all business sessions. Executive Secretary William Smith informed the Association that articles addressing this issue will be forthcoming in State and National publications.

Rev. Billy Hanna also expressed concern about the way that National Association's General Board members from Georgia were chosen and suggested a change in the GAFWB Constitution to have those General Board members elected by the voting body of the State Association. The Executive Board will take this concern under consideration at its next meeting.

Rev. Ron Wallace read a list of military-connected, Free Will Baptist men and women who have been involved in the ministry of Northern Lights FWB Church. They are as follows: serving in the United States Army, Zack & Mandy Bartlett of California, Bill & Patti Land of Arkansas, Tara Crews of West Virginia, Robert & Pam Sullivan of Georgia, and Chaplain David Spears of Georgia; and, serving in the United States Air Force, Joe & Diedre Ziegler of Georgia. Bro. Ron expressed appreciation for the service these men and women have given to our nation and to the Northern Lights Church.

Rev. Ben Crabtree asked the Executive Board to develop and adopt a plan that would facilitate missionaries coming home in an emergency situation. Rev. Herbert Waid informed the Association that Contingency funds are available and used for that purpose at the International Missions level.

Rev. Terry Tribble expressed gratitude for the unity that God has brought among Georgia Free Will Baptists. Rev. Tim Eaton dismissed the session in prayer.

FRIDAY EVENING WORSHIP SESSION

As a prelude to the evening worship session, a group called "Legacy Trio" ministered in song. Gilmore family cousins, the "Legacy Trio" are all members of the Sardis FWB Church in Eufaula, Alabama.

The worship service began at 7:00 pm with Rev. William Smith presiding and Rev. Donnie Burke directing the music. (Tim Horne, Todd Horne, and Ben Crabtree were the primary musicians. Monty McKenzie, with plenty of good help from the Albany First FWB Church, ran the sound and video equipment.)

After a radio clip of different world dialects, Rev. Donnie Burke led the choir in a song entitled "Agnus Dei". A member of the Albany church (with a very pronounced Australian accent) recited the Great Commission as the song "People Need the Lord" and visual images of the world's people groups played in the background. The choir followed with "Go Tell It On The Mountain".

With Rev. Wayne Miracle, Rev. Ben Crabtree and Bro. Daniel Snow on the "stringed instruments", the choir and congregation sang a bluegrass sounding version of "Send the Light". Rev. Donnie Burke and the choir followed with a song called "Each One, Reach One", and Rev. Nathan Snow inspired the congregation with a solo rendition of "Go Light Your World".

The Teen Choir of the Albany First FWB Church challenged the session with a soul-searching song entitled, "If We Are The Body". The session choir sang "Lord Most High", followed by a solo rendition of "Orphans of God" by Sister Donna Walker.

Rev. William Smith called the ushers forward to receive the 3rd Annual Damon C. Dodd Mission Offering, and introduced Rev. Paul Creech as the evening speaker. Rev. Rick Wilson asked God's blessing on the offering. The offering totaled \$1,036.00.

Rev. Paul Creech spoke to the congregation on the subject "The Master and His Mission", using Matthew 19:23 as his text. At the close of his message, Bro. Paul led us in an invitational hymn, "Jesus, I My Cross Have Taken".

A men's quartet consisting of Rev. Mark Kennedy, Rev. Wayne Miracle, Rev. Russell Horne, and Rev. Len Blanchard, harmonized beautifully together when they sang "Do You Know My Jesus?" The choir sang "Shout to the North" and was joined (possibly outdone) by the Kids Choir of Albany First, who also sang "The Coloring Song".

Brother Todd Horne, Rev. Tim Horne and Rev. Donnie Burke, accompanied by the choir, brought the congregation to their feet with "Days of Elijah". The choir and congregation joined together in singing "Jesus Saves" and "Lord Lay Some Soul Upon My Heart".

Rev. Rick Wilson called for a special prayer to be offered for Rev. Paul Creech, who is battling cancer, by the "laying on of hands". Rev. Len Blanchard led in this prayer.

"The Georgia Boys Quartet" (consisting of Tim and Todd Horne, Mark Walker, Donnie Burke) accompanied by the choir, implored the session through song to "Reach the World". Rev. Ben Crabtree then sang "Thank You" as background music to a video slide-show of FWB missionary servants who have gone to be with the Lord. It was a very moving tribute to this "great cloud of witnesses" that have gone before us.

Rev. William Smith thanked the Music Commission for their hard work in putting together the 5th Annual Georgia Praise Gathering and asked Rev. Eddie Hodges to pray the closing prayer.

Final Credentials Committee Report

Rev. Bobby Taylor gave the final report of the Credentials Committee and his final report as the Credentials Committee Chairman and thanked the Association for allowing him to serve. The final report is as follows: 70 standing delegates and 12 elected delegates for a total voting delegation of 82. There were also 68 visitors registered for a total registration of 150. The Friday evening attendance was 275. (Sister Donna Jewell and Sister Henrietta Brown also served on this year's Credentials Committee.)

With no other business, the congregation sang "We Will Stand" and the 72nd Annual Session of the Georgia Association of Free Will Baptists was adjourned.

Executive Secretary/Treasurer Report January 1, 2007 – December 31, 2007

Welcome to the Seventy-second annual session of the Georgia State Association of Free Will Baptists, Inc. We have gathered to conduct our state association business and receive reports from our state boards and national agencies. God richly blessed our state during 2007. We gather to rejoice as we look at the blessing of the past and we are challenged as we look at the possibilities for the future.

This digest contains reports from all the Georgia State Boards. The board reports and all financial reports cover the period of January 1, 2007 – December 31, 2007.

Thank you for your faithful support during 2007. Receipts through the State Office totaled \$1,197,178.82. Of this amount \$317,552.04 was Cooperative Receipts, \$210,421.74 was Georgia Acts 1:8 Receipts, and \$669,205.04 was Designated Receipts. We had slight decrease of \$957.46 in Cooperative Receipts and an increase of \$11,935.21 or 6% in Georgia Acts 1:8 Receipts. With the down turn in the national economy I am continually amazed at the faithfulness of our Georgia churches and their giving.

Your faithfulness to support the *Georgia Cooperative Plan* and the *Georgia Acts* 1:8 Plan makes it possible for the gospel to be shared in foreign countries, new churches to be planted in our state, Georgia students to attend Free Will Baptist Bible College and Georgia pastors to get their masters degree by attending the Georgia extension of the Hillsdale Free Will Baptist College. You also help fund ten sessions of youth camp, five retreats and the retirement program for Georgia pastors.

As we think about our future we see how God has positioned the State of Georgia to do great things when it comes to the great commission. We have a strong financial base to support our mission efforts both at home and on the foreign field. People from around our country and around our world are now moving to Georgia, giving us many opportunities to spread the gospel around the world without even leaving our state. We need to always remember "to whom much is given, much is also required".

Randall House Publications will be sponsoring a TEAM Church conference at the First Free Will Baptist Church in Albany, on August 16, 2008. Stan Toler will be the key note speaker and at least twenty sessions will be offered. These sessions will cover a variety of areas, such as dealing with the culture our teens live in today, how to get parents involved in the spiritual development of your students, how to incorporate missions into your lessons, effectively getting your lesson off to a good start, recruiting teachers, and hands on lesson materials.

I thank God for giving me the opportunity to serve Him in the **Great State of Georgia**. Thank you for your support and your continued prayers.

March 12, 2008, First FWB Church, Albany (prior to 72nd Annual Session)

From these meetings, the following items are presented for general information and/or approval at this 72nd Annual Session of the GAFWB.

2008 State Program

Featured speakers and subjects for the 72nd Annual Session were selected as follows: Wednesday evening, Rev. Grover Jewell, "Lifting Up Laymen"; Thursday morning Bible Conference, State Board Chairmen, "Vision Sharing"; Thursday evening, Rev. Keith Burden, "Celebrating the Ordinances"; Friday morning, Rev. Keith Horn, "Worthy Workmen"; and, Friday evening, Rev. Paul Creech, "The Master and His Mission".

Georgia State Budget Proposed

A 2008 calendar year budget of \$900,000.00 is proposed. A 2009 Georgia State *Cooperative Budget* of \$350,000.00 and a 2008 Acts 1:8 Budget of \$284,098.18 is included in the overall budget. You will find the approved 2009 *Cooperative Budget* included with this report on page 20..

2008 State Meeting Changes

Due to a conflict concerning the necessary hotel accommodations, the Board voted to move the 2008 State Meeting from the Liberty Bible Church in Gainesville to the First FWB Church in Albany.

A change to the By-Laws in last year's Annual Session called for future sessions to begin on the "Thursday following the third Sunday in March", which would have caused part of the 72nd Annual Session to be held on Good Friday. Because many of our churches have special functions on Good Friday, the Board voted to move the session back one week for the 72nd Annual Session.

The Board voted to begin the business session of the 72^{nd} Annual Session on Thursday afternoon from 2:00-4:00 p.m. instead of Thursday evening, in an effort to complete all business by Friday afternoon.

Sound Equipment Storage and Transportation

At the request of the Music Commission, the Board approved the purchase of an enclosed trailer to store and transport the GAFWB sound system and equipment at a cost not to exceed \$3,500.00. The equipment is being frequently used at State retreats and other functions and is under the care of the Music Commission.

Property Sales

The previously acquired properties in Tift and Lowndes counties were sold and the proceeds are being handled by the Mission Board.

State Office Personnel Evaluation

Granted a 5% increase in the salary of Executive Secretary William Smith.

Granted a 3% increase in the salary of State Office Secretary Rhonda Chandler.

Funds were utilized from the sale of the church property that we were given a couple of years back.

For me, the highlights of the year far exceed the acquisition of land. True success is measured by an eternal standard; it is the work in the hearts and lives of Georgians seeking the Savior. Our church planters invest their lives in others, offering leadership to the faithful, and rescue to those bound by sin. Dr. Bill & Loraine Crank and Dr. Bill & Ann Lewis are paying the price for His kingdom. God bless them.

Our board hired a third church planter to go west to Harris County. Rev. Jay and April Hollis, and their kids, have chosen Georgia to be home and church planting to be their ministry. I encourage you to meet them at this State Meeting, embrace them with your heart, and add them to your prayer list.

I admit, in a sense, this is an incomplete report. I have not included charts and statistics and the numbers we long to cling to. Here's my reasoning. Yes, those figures are important. But I am convinced you will remember them so much more if you hear Bro. Bill Crank tell you about the Sunday before Christmas when 117 people came to Cartersville Family Church. Ask him about the *Chief Baker*'s Dozen who were baptized a few weeks ago. Inquire of Bro. Bill Lewis about the solid core of believers who are striving to plant a church in the college climate of Lowndes County. Discover Harris County through the heartbeat of Bro. Jay Hollis. Get Bro. Ron Wallace to share heart-warming stories of God at work in the cold climate of Alaska

You see, I could only offer second hand testimony. They can give you the facts! They were there, and they want to testify of the goodness of God. He is working, and He offers the opportunity to join with Him in the task of the Great Commission. What a journey with Jesus and His ministers.

My heart overflows with the goodness of God this year as I reflect on the work of this Board of Missions. We enjoyed a sense of precious unified purpose and commitment. We placed the faith you entrusted to us in the hand of the Father, and we acted for the glory of God, the establishment of churches in Georgia, and the salvation of the lost.

CONSTITUTION AND BY-LAWS

GEORGIA STATE ASSOCIATION OF FREE WILL BAPTISTS. Inc.

PREAMBLE

We, the Free Will Baptist of the State of Georgia, do ordain this Constitution for the purpose of advocating, promoting and increasing all phases of the cause of Christ.

ARTICLE I

This assembly shall be known as the Georgia State Association of Free Will Baptists, Inc.

Article II

- **SECTION 1.** The officers of this association shall be Moderator, an Assistant Moderator, a Clerk, an Assistant Clerk, and an Executive Secretary/Treasurer.
- **SECTION 2.** The Executive Board shall be composed of the regular officers; the chairman of each of the standing boards; and the previous moderator, as an ex officio member for a period of two years following his term of office; and the moderator of the District Associations not represented shall serve as members at large.
- **SECTION 3.** This Association shall be composed of ordained Ministers, ordained Deacons, Missionaries, and Board Members who are members of affiliated bodies; one (1) delegate for every three hundred (300) members or fraction thereof from District Associations; one (1) delegate for every one hundred (100) members or fraction thereof from each local affiliated church.
- **SECTION 4.** All delegates from District Associations and local churches shall be elected from the laity of the body sending them.
- **SECTION 5.** Funds to meet current needs of this body shall be paid to the treasurer of this association. Each District Association will give a minimum of twenty-five dollars (\$25.00) per delegate authorized, and each local church will give twenty-five (\$25.00) per delegate.
- **SECTION 6.** In order to pay our Georgia State Association's annual representation fee to the National Association, each local association is to be responsible to promote, receive and forward the amount designated by the National Association per church per year to the State Office, along with their annual State Association representation fee, on or before our annual State Association session

ARTICLE III

- **SECTION 1.** It shall be the privilege of each affiliated District Association to recommend a member for each standing board. Terms of office on these boards shall be on a rotating basis which will necessitate the election by the State Association of five (5) members every two (2) years, thus giving each member a four (4) year term of office.
- **SECTION 2.** There shall be a **Board of Missions** composed of members who are noted for their missionary zeal.

- **A.** The Board of Missions shall employ missionaries as needed to establish Free Will Baptist mission/churches in the State of Georgia. These missionaries may be employed exclusively or jointly with other Free Will Baptist agencies.
- **B.** A mission/church sponsored by the Georgia State Association and their missionaries are under the authority of the State Association and the supervision of the Georgia State Board of Missions.
- **C.** A mission/church does not have autonomous church status. As long as the mission/church is unable to provide for its own business, it is in a dependent relationship to the State Association and its Board of Missions.
- **D.** When the mission/church is self-sustaining, self-governing, self-discipline, and self-propagating. It should be organized into an autonomous Free Will Baptist Church following the procedures adopted by the Georgia State Association.
- **E.** After proper procedures are satisfied and the church is duly organized into autonomous Free Will Baptist church it shall have all normal rights, privileges, and responsibilities of any other Free Will Baptist Church.
- **SECTION 3.** There shall be a **Board of Camping** whose duties shall be to schedule and arrange all camp sessions, and to appoint the Camp Director each year.
- **SECTION 4.** There shall be a **Board of Christian Education** whose duties shall be:
- **A.** To provide educational services for the members of the Georgia State Association of Free Will Baptists.
- **B.** To set policy and supervise the functions of the State Youth Committee. This Board shall appoint this Committee to carry out Board policy.
- **C.** To organize sponsor and promote educational and inspirational retreats for our members.
 - D. To organize, sponsor and promote Sunday School and Church Training seminars.
- **E.** To set policy and supervise the Historical Committee. This Board shall appoint the Historical Committee to gather and set forth for public knowledge and posterity the history of Georgia Free Will Baptists.
- **SECTION 5.** There shall be a **Board of Trustees** whose duties shall be; maintenance, upkeep and insuring of all State Association properties; the planning and supervision of all future developments and expansion of these properties as directed by the State Association except otherwise provided in this Constitution.
- **SECTION 6.** There shall be a **Credentials Committee**, which shall consist of three (3) members of three-year terms. And the term of one expiring each year thereafter according to seniority of service, who shall be in charge of the registration and examination of delegates and the receiving of all dues.
- **SECTION 7.** There shall be two members on the Board of Trustees of the Free Will Baptist Children's Home, Eldridge, Alabama, elected for terms of four (4) years. Election will take place on odd years and shall be staggered.
- **SECTION 8.** There shall be a **Georgia State Master's Men.** They shall select their own officers and conduct their own business.

SECTION 9. There shall be a **Georgia State Woman's Auxiliary Convention (GWAC)**. They shall elect their officers, conduct their business and maintain their treasury.

ARTICLE IV

- **SECTION 1.** All officers except board members and the Executive Secretary/Treasurer shall be elected to serve a term of two (2) years. The Executive Secretary/Treasurer shall be employed by the Executive Board of the Georgia State Association of Free Will Baptists, subject to the ratification of the Georgia State Association of Free Will Baptists at its next regular session, for an indefinite period, with an agreement of sixty (60) day notice of termination by either the Executive Secretary/Treasurer or the Executive Board.
- **SECTION 2.** Standing Boards of the State Association have no power of final authority to hire, full–time employees until the matter has been presented to and acted on by the State Association in session except where otherwise provided.
- **SECTION 3.** The Executive Board may fill vacancies on any of the boards or committees, which occur between regular sessions of this State Association, until the convening of the annual session of said association.
- **SECTION 4.** Election of all General Officers shall take place on the odd years of the calendar.
- **SECTION 5.** If a member of any board fails in the function of his or her duty without good and sufficient reasons, the board of which the delinquent is a member may declare that particular office vacant. Further, this body shall have and does reserve the right to deal with the officer or board member who does not conduct his or her office in a Christian, business like manner according to the rules of Christian conduct as set forth in the New Testament.

Any standing board of this State Association may appoint proxies to serve in lieu of the absent members.

At the pleasure of the boards, and subsequent to the meeting from which the regular member is absent, the boards have the right to deal with the delinquent member in the manner stated in this section.

SECTION 6. The Chairman or Vice-Chairman of said board, or by the Moderator or Assistant Moderator of the Georgia State Association of Free Will Baptists, upon the request of the majority of the members of said boards, may call boards into session.

SECTION 7. An auditing Committee shall consist of three (3) members elected for three (3) three year terms.

AMENDMENTS

This Constitution may be changed, altered, or amended by a two-thirds (2/3) vote of all delegates present and voting at any regular session of the State Association. Prior to a final vote on any amendment, change or alteration, said amendment, change or alteration shall be submitted in writing to the Clerk of this association and shall lie on the table from one (1) business meeting to the next during the same session, during which time it shall be read at least two (2) times in open session. Officers, standing boards, and/or standing committees may be added or deleted as the need arises.

BY-LAWS

SECTION 1:

- **A.** All real property, checking and savings account or any other assets of this Association shall be in the name of the *Georgia State Association of Free Will Baptists*. *Inc.*
- **B.** One or more of the corporate officers of the Association shall be the legal signers of all Georgia State Association of Free Will Baptists, Inc. business. These officers are: the Moderator as the corporate President; the Clerk as the corporate Vice-President; and the Executive Secretary/Treasurer as the Secretary/Treasurer.
- **C.** The State Office shall be responsible for the safekeeping of the corporate seal and all official documents of the State Association.
- **D.** No State Board may borrow money or financially obligated the State Association without the approval of the Executive Board.
- **E.** The fixed assets (building, land) of the Georgia State Association of Free Will Baptists shall not be liquidated except by a two-thirds (2/3) vote of the delegates present and voting at any regular session of the Association.
- The Executive Board shall have the authority to approve the sale of properties donated to any Board of the Georgia State Association of Free Will Baptists, Inc., upon recommendation of the Board to which the donation was made, with proceeds remaining under the authority of the recommending Board."
- **F.** The records of all financial transaction shall be open to all members of the Georgia State Association. The financial transactions of the State Office and State Boards shall be audited annually.
- **G.** Annual financial reports of the State Office and State Boards and the auditor's report shall be made to the State Association in session an be entered in the Annual State Minutes.
- **H.** The State Treasurer shall be bonded in amount stipulated by the State Executive Board
- I. This Association shall meet for its regular session annually on Thursday following the third Sunday in March.

SECTION 2.

- **A.** When the State Association is not in session, the State Executive Board shall be duly authorized to do business in the name of the State Association.
- **B.** The State Association has full authority to direct the State Executive Board in all business conducted on its behalf.
- **C.** The State Executive Board shall report to the State Association in session concerning the business conducted for the State Association since its last convening.
- **D.** The State Executive Board has the prerogative of deferring any matter to the State Association as a whole but is not under obligation to do so.
- **E.** The State Executive Board shall meet quarterly in the following months: March, June, September, and December. The March meeting shall be held just prior to the regular meeting of the State Association.

F. Any and all correspondence from any member of this State Association, (includes either individual, group, Board or District Association) directed to any Board, or Chairman of said Board, or any officer of this State Association, or any open letters to any or all District Associations of this State, that pertains to any business which is desired or required to be brought before this body at any scheduled or special called meeting, shall be properly sent directly to the Clerk of the Georgia State Association of Free Will Baptists, The clerk will be responsible for routing the correspondence to its proper designation. All correspondence as mentioned above, shall be required to be received by the Clerk of the State Association at least 30 days prior to any scheduled State Association Meeting if said correspondence contains business that is to be introduced and discussed at said meeting.

SECTION 3.

- **A.** The moderator shall preside at the Annual Session of the Georgia State Association of Free Will Baptists and the meetings of the Executive Board. The Moderator shall be the President of the Corporation known as the *Georgia State Association of Free Will Baptists, Inc.*
- **B.** The Assistant Moderator shall preside in the absence of the Moderator and/or when appointed by the Moderator as the need arises.
- **C.** The Clerk shall keep records of the proceedings of the Annual Associational meeting and of the Executive Board meetings. It shall also be his responsibility to have the minutes of these sessions printed and distributed. The Clerk shall be the Vice-President of the Corporation known as *Georgia State Association of Free Will Baptists, Inc.*
- **D.** The Assistant Clerk in the absence of the Clerk, shall fulfill the functions and duties of the Clerk as stated in paragraph C of this document.

SECTION 4.

- **A.** The Executive Secretary/Treasurer shall be responsible and accountable to the Executive Board in the fulfillment of the duties of his office as determined by the Executive Board.
- **B.** The Executive Secretary/Treasurer shall be allowed four (4) weeks vacation per year with pay.
- **C.** Funds received by the Executive Secretary/Treasurer for revivals, special speaking engagements and promotional meetings shall go into the Cooperative Fund. The exception to this regulation relates to remuneration received by the Executive Secretary during his four (4) weeks vacation, which shall be his personally and need not be accounted for to this State Association.
- **D.** Salary, mileage and operational expenses of the Executive Secretary/ Treasurer shall be determined by the Executive Board.
- **E.** The Executive Secretary/Treasurer shall be the Secretary/Treasurer of the Corporation known as the *Georgia State Association of Free Will Baptists, Inc.*
- **F. General Promotion.** He is to represent, or cause to be represented, the association at all affairs of interest to the association and he is to promote the work of the association in such a manner so as to unify the association as well as promote both the state and national works, missionaries, mission conferences, etc. Through personal communication he shall keep close contact with pastors, churches, and district association.

- **G. Administration.** He shall administer the affairs of the executive office and carry out the responsibilities delegated to him by the State Association and the Executive Board. He is to serve with all standing boards and committees of the association in an ex-official capacity. He is to report to the association during each annual session.
- **H. Stewardship.** He shall serve as treasurer of this association. An accurate and complete record of all funds received and disbursed shall be kept and a written report shall be included in his report to this association in its annual session. He shall receive, hold and disburse money as is made available by the State Association to the various boards. Disbursements to the various boards will be made available when requested.
- **I. Publication.** It shall be his duty to edit and publish the state paper. He shall direct the production of general promotional materials, pamphlets, audiovisuals, and books as approved by the Executive Board.
- **J. Arranging State Association.** He shall expedite the planning of the State Association program, enroll all ministers and delegates, print and distribute minutes, and investigate future sites for the annual session.

SECTION 5.

- **A.** The Executive Board shall serve as the Placement Committee for the State Association. In this capacity the board shall investigate places suitable for this meeting and make recommendations to said State Association. Meeting places shall be determined two (2) years in advance.
- **B.** The Executive Board shall plan the program for the annual meetings of the Georgia State Association of Free Will Baptists and the annual meetings shall follow the programs as closely as possible. Business sessions shall be conducted according to the commonly accepted rules of Parliamentary Procedure.
- **C.** The Executive Board shall formulate the budget for the State Association annually and recommend to the body in the session the allocations to be observed in the Cooperative Plan for Giving. This board shall, in addition to the above stated duties, also recommend a mileage rate for travel by the members of all standing boards in said association.

SECTION 6.

The Moderator shall appoint necessary committees unless otherwise provided for by the body.

SECTION 7.

These By-Laws may be altered, changed, or amended at any regular session of this association by a two-thirds (2/3) vote of delegates present and voting (Revised March 2005)

MINUTES

GWAC STATE MEETING

MARCH 13, 2008

ALBANY FIRST FREE WILL BAPTIST CHURCH

Christian Daniel from the host church welcomes everyone to the 2008 Session of the GWAC and gave general information about the church and local eateries. Rebecca Jackson led the congregation in "He Touched Me".

Marie Glover remembered those who have gone on to be with the Lord during 2007: Bessie Simmons from the Pleasant Hill Church in Vienna, and Carolyn Tully from the Colquitt FWB Church. Marie talked about "memories" and read the words to the hymn "I Will Not Forget Thee".

President Debra Van Pelt called the Session to order and welcomed everyone to the 2008 Session of the Georgia Women Active for Christ.

Sandra Jackson gave the credentials report. 8 out of 10 districts reported, representing 33 local churches, 362 members and 26 delegates. The standing and registered delegates which were present were then seated.

Debra recognized the missionaries who were present including Linda Snow from Japan, Lori Byers from Ohio, Janice Wallace from Alaska, the Hollis family, new missionaries to Harris County, and Faye Ogletree (Sandra Bishop's mother). We were also honored to have Mrs. Laura Thigpen in attendance. Dr. and Mrs. Thigpen now live in Byron and attend the White Oaks Church in Macon.

Henrietta Brown read the proposed Resolutions:

National Resolutions (these have already been passed by the National):

We recommend that scholarships be given from the Cleo Pursell Foreign Student Scholarship Fund as follows:

- 1. International Missions Scholarship (\$2,000.00) Panama: Four students will be enrolled in the new seminary which will open in 2008 under the leadership of Eddie Bowerman. We recommend that each student receive one fourth of the scholarship, which will amount to \$500.00.
- 2. Home Missions Scholarship (\$500.00): We recommend that a \$500.00 scholarship be awarded to a student(s) enrolled in the ministerial training program at the Gwen Hendrix Hispanic Seminary in Inman, South Carolina. This scholarship will help provide tuition, room and board.

GWAC Resolutions

We, the resolutions committee recommend the following:

- 1. In today's world of instant information, many of our members depend on information provided on the Internet to keep abreast of pertinent information. To that end we want to encourage the WNAC to continue providing up-to-date information on its web site. MSC to adopt.
- 2. Concern for declining membership in our local, state and national WAC has been a topic of discussion by our GWAC Executive Board as well as local and association groups. We urge every member to pray and promote the work of our State and National Association and encourage membership in our organization at every opportunity, and to contact a GWAC executive board member any time assistance or information is needed. After hearing this resolution, it was suggested that various groups share their ideas. Some of the ideas were asking those who have gone on mission trips to speak; light supper at each meeting; nursery workers on both the local and state levels; meet in ladies' homes for a more personal meeting; community outreach such as pregnancy crisis centers and local battered women's shelters; school supplies for needy children; luncheon for senior saints; state project auction open to the community; gift bags for local school teachers; timing of meetings is very important. MSC to adopt the Resolutions Report.

Lynda Blanchard gave the finance report. See report attached hereto. It was decided that the Lora Shutes State Project (Acts 1:8) will remain at \$7,500.00 and the amount needed per member to meet this goal for 2008 will be \$20.72. MSC to accept the finance report as read.

Kristen Crabtree gave the Credentials Report. 66 registered today, which represents 22 visitors, 34 delegates, 7 state officers and 3 missionaries. MSC to adopt report as read.

GEORGIA WOMEN ACTIVE FOR CHRIST Of the Georgia State Association of Free Will Baptists, Inc. Constitution and By-Laws

Article I

Name

This organization shall be known as Georgia Women Active for Christ a division of the Georgia Association of Free Will Baptists, Inc., commonly known by its initials, GWAC. Its members shall elect officers, conduct business and maintain a treasury.

Article II

Purpose

The purpose of this organization shall be to assist the various women composing the GWAC in providing opportunities to understand and fulfill the Great Commission through their responsibilities in the family, church, community, and around the world.

It shall bring the women of each district together for fellowship, sharing information, encouraging one another in the work of the Lord and furthering the purpose and goals of the Georgia State Association of Free Will Baptists.

Article III

Officers

- 1. The officers of this convention shall be president, vice president, secretary, treasurer, field worker, historian, and three members at large, all of which are elected by the convention. These officers shall serve as the State Executive Board. A minimum of five officers shall be a guorum for transacting business.
- 2. Any officer or elected board member of this convention must be an active member of a local Free Will Baptist Church and an active member of the GWAC group of a local church
- Executive Board members are required to attend all scheduled board meetings.
 Any officer missing three meetings is subject to review and removal by the Executive Board

Article IV

Membership

- 1. This convention shall be composed of: the officers of the convention, district presidents, district field workers, ten delegates (duly accredited by the credentials committee) from each district convention, four delegates and the president from each local GWAC in good standing with its district convention.
- 2. Local groups in an area where there is no district convention may be represented with five delegates by payment of their membership dues. All delegates, as well as officers of the convention, shall be in good standing with a church that is in good standing with the Georgia State Association of Free Will Baptists, and shall perform the duties as set forth for them in the present WNAC manual and this Constitution and By-Laws.

Article V

Meetings

- 1. The annual meeting shall be held each year the day before the Georgia State Association of Free Will Baptists convention in the same place or at such a time and place determined at the previous annual meeting or by the Executive Board.
- 2. A prayer retreat shall be held annually, time and place to be planned by the Executive Board.

Article VI

Amendments

This Constitution may be amended at any annual meeting of the convention by a two-thirds vote of the members present.

By-Laws

Article I

Duties of Officers

President – The president shall preside over all meetings, appoint such committees as may be needed; call the Executive Board together when necessary; be ex-officio member of all committees, except the nominating committee; see that reports are sent promptly to the WNAC secretary; and perform all duties pertaining to such an office. She should see that GWAC is represented in the State Promotional Bulletin. Articles should be sent to the state executive office by the 1st of each month. She may either write the articles or ask someone to write the articles for her.

Vice President – The vice president shall preside in the absence of the president or by her request and otherwise assist her in the oversight of the work in general. She shall serve as chairman of the credentials committee.

Secretary – The secretary shall keep an accurate record of all proceedings of the convention and Executive Board meetings; preserve all valuable papers and turn same over to her successor; make an annual report to the WNAC secretary on a form available from the WNAC office within 15 days after the State GWAC Convention; compile the districts' slate of officers and addresses immediately after the convention; send a slate of state officers to the WNAC secretary and to each state officer. She is responsible for getting the minutes prepared and to the state associational office in time to be included in the state minutes each year.

Treasurer – The treasurer shall have charge of all funds belonging to this convention and shall pay out same only when authorized by the convention. The treasurer shall keep an accurate account, and give a written report of all funds received and disbursed at each annual meeting of the convention. She is required to deposit all checks in her possession and disburse all designated funds by the 30th of each month. She shall be bonded through the state office and audited annually.

Field Worker – The field worker shall promote GWAC programs through personal contact and the distribution of literature and serve where needed as directed by the Executive Board.

Historian – The historian shall keep a historical record and have a display at all state meetings and serve where needed as directed by the Executive Board.

Members at Large - The members at large shall help promote the work in general, meet with the Executive Board, and serve where needed as directed by the Executive Board.

Article II

Elections

A nominating committee shall nominate the general officers and members at large. Following the nominating committee's report, opportunity shall be given for nominations from the floor. In case of more than one nominee for any particular office, a vote will be taken for each; otherwise they may be elected by acclamation. The officers shall be elected every two years on odd number years. Not more than one-half of the elected officers shall be changed in any regular election. All elections shall be held at the closing sessions of the annual convention.

Article III

Expenses

Estimated expenses for the state work shall be set by an annual budget approved by the convention. The Executive Board must approve all reimbursement.

Article IV

Boards and Committees

Executive Board – This Board shall be composed of six officers and three members at large elected by the convention. Five of these shall compose a quorum. They shall hold meetings for the transaction of business as often as necessary. It shall be the duty of the Executive Board to maintain an oversight of the work at large. The Board shall act for the convention when necessary. It shall prepare the program for the regular meetings and fill any vacancy between elections.

Resolutions Committee – A resolutions committee shall be appointed by the president. A member of the Executive Board shall chair this committee. This committee shall review all resolutions presented, having the prerogative of passing on to the convention those resolutions that are deemed proper and profitable. Resolutions should be properly worded, i.e. "Be it Resolved....."

Nominating Committee – The nominating committee shall be composed of one member from each district convention and shall be elected one year prior to making their report. The names of the members from each district shall be submitted with the convention annual report. The president shall appoint a chairperson from the members of the nominating committee.

Credentials Committee – The vice president shall be the chairman of the credentials committee and the president shall appoint two other members. This committee shall examine the reports of the represented women's groups to see if fees are paid and if reports are in order.

Finance Committee – The treasurer shall be chairman of the finance committee and the president may appoint four other members. This committee reviews the financial records for the year, reports on same to the convention, and makes recommendations of disbursements of funds to the convention.

Registration Committee – The president shall appoint members as needed to serve on this committee. This committee registers those in attendance and gives a report to the convention.

Article V

Dues and Reports

Active members shall pay dues yearly as required by the GWAC Convention for membership. These dues should come through the district treasurers by January 10th following the close of the previous year. District secretaries and treasurers annual reports should be filed with the state secretary and treasurer no later than February 1 following the close of the previous year. Beginning 2002 the dues are \$12.50 per member with Georgia retaining \$2.50 per member and WNAC receiving dues of \$10.00 per member.

Article VI

Gifts

Season of Prayer Offerings-

- **1. Pre-Easter Week of Prayer** offering is used for Foreign Missions in memory of Laura Bell Barnard, our first foreign missionary.
- **2. Pre-Thanksgiving Week of Prayer** offering is used for National Home Missions in memory of Mrs. Lizzie McAdams, a great writer of our literature and one of the first National officers.

- **3. The December Week of Prayer** offering is used for State Missions in memory of Mrs. Alice E. Lupton, our first National president.
- **Co-Laborer Offering** A financial plan of support for WNAC. Each local GWAC is encouraged to support the WNAC office with a monthly offering.
- **Provision Closet** This project helps missionaries as they return home to pick up household items, etc., from the closet at the National Office. Each local GWAC is encouraged to keep abreast of the items and supplies needed as they are periodically listed in the **Co-Laborer** magazine, and give to this project as needed.
- **WNAC Emphasis** A special offering to supplement the Co-Laborer Offerings for WNAC expenses of operation, literature, etc. This offering is received during August.
- **Remembrance Fund –** This is a fund established by WNAC and a distinct way to honor any occasion the donor wishes to note: Anniversaries, birthdays, or as a memorial gift at the time of death. A remembrance card notifying the family of the person being honored, and the donor, will be entered in the permanent Book of Remembrances in the WNAC office. These gifts will be used to advance the kingdom of God through WNAC. A Remembrance Service is to be conducted at our state GWAC convention each year.
- **Dr. Mary Ruth Wisehart Foreign Student Scholarship Fund** Any GWAC group who wishes may contribute to this special fund set up by WNAC to train Nationals from our foreign fields. February is designated as Foreign Student month.
- **Dot Harvey Loan Fund –** This revolving loan fund was established in honor of Miss Dot Harvey, a forerunner of youth work in Georgia, by the Georgia Women's Auxiliary Convention in 1954 to aid worthy Georgia students attending Free Will Baptist Bible College. Each local group is asked to donate monthly toward this project. A special offering is received in September to add to this fund.
- **Westfield Church Fund** –This fund is used to assist the church in Kotogiri, South India in memory of Miss Laura Bell Barnard. All groups are encouraged to give to this Georgia project monthly.
- **Other Gifts –** The state GWAC may decide on and promote other projects for funds at its own discretion.
- **Lora Shutes Mission Project –** This is a statewide project with the goal set each year at the annual convention. Funds are disbursed to missionaries through the State Acts 1:8 Program.
- **GWAC Emphasis** June is designated as GWAC Emphasis Month. Each group is asked to receive a special offering to supplement GWAC operational expenses.
