ARTICLES OF FAITH

1. **THE BIBLE**—The scriptures of the Old and New Testaments were given by inspiration of God, and are our infallable rules of Faith and Practice.

2. **GOD**—There is one living and true God, revealed in nature as the Creator of the universe; and in the Scriptures as Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, obey.

3. **CHRIST**— Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified. He is now risen and glorified, and is our ever present Saviour and Lord.

4. **THE HOLY SPIRIT**— The scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

5. **THE GOVERNMENT OF GOD**— God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

6. **THE SINFULNESS OF MAN**— Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherit a fallen nature of such tendencies that all who come to years of accountability sin and become guilty before God.

7. **THE WORK OF CHRIST**— The Son of God by His incarnation, life, sufferings, death and resurrection, effected for all a redemption from sin that is full and free and is the ground of salvation by faith.

8. **THE TERMS OF SALVATION**— The conditions of salvation are: 1. Repentance of sincere sorrow for sin and hearty renunciation of it. 2, Faith or the unswerved committal of one's self to Christ as Savior and Lord with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit freed from dominion of sin and become a child of God. 3, Continuance in faith and obedience until death.

9. **ELECTION**— God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ, men became His elect.

10. **FREEDOM OF WILL**— The human will is free and self-controlled, having power to yield to the influence of the truth and the spirit, or to resist them and perish.

11. **SALVATION FREE**— God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. **PRESERVERANCE**— All believers in Christ, who through grace preserve in holiness to the end of life, have promise of eternal salvation.

13. **GOSPEL ORDINANCES**— Baptism, or the immersion of believers in water, and the Lord's Supper are ordinances to be perpetuated under the Gospel; Feet washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.

14. **TITHING**— God commanded tithes and offerings in the Old Testament; Jesus Christ indorsed it in the Gospel (Matt. 23: 23) and

the Apostle Paul said "upon the first day of the week let every one of you lay by him in store as God hath prospered him." (1 Cor. 16:2).

15. THE CHRISTIAN SABBATH— The divine law requires that one day in seven be set apart for secular employments and amusements, for rest, worship, Holy works and activities, and for personal communion with God.

16 RESURRECTION, JUDGEMENT AND FINAL RETRIBUTION— The Scriptures teach the resurrection of all men of the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will go away into eternal punishment, but the righteous into eternal life.

CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things and to avoid all appearance of evil, to sustain from all sinful amusements and unholy conformity to the world from all sanction of the use and sale of intoxicating beverages and to "provide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scripture, secret prayer, family devotions, and social worship; and by self-denial, faith and good works, endeavor to "grow in grace and the knowledge our Lord and Savior, Jesus Christ.

We will not forget the assembling of ourselves together for church conferences; public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability for the support of the church, of its poor and all its benevolent work.

We agree to accept Christian admonition and reproof with meekness: and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, to be careful one another's happiness and reputation, and seek to strengthen the weak, encourage the afflicted, admonish the erring, and as far as we are able promote the success of the church and of the Gospel.

We will everywhere hold Christian principle sacred and Christian obligations and enterprises supreme: counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises; the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

BY-LAWS

- Article 1. Annual conferences shall be annually held.
- Art. 2. Every Elder, Minister and Preacher in good standing, and delegates shall duly attend.
- Art. 3. If any member in the judgement of the conference, shall show anger in his discussion on any subject, he shall forfeit his seat in the conference.
- Art. 4. No member of the Annual Conference shall be at liberty to withdraw without leave of the Moderator.
- Art. 5. The conference shall always adjourn by vote.
- Art. 6. There shall annually be a committee of finance chosen to settle with the treasurer and report to conference.
- Art. 7. The officers and standing committees shall be entitled to seats in the annual conference.
- Art. 8. No Elder, Minister, Preacher or delegate shall during the sitting of the annual conference, be at liberty to fill any place, as to preaching or hearing at the stage, only as liberty shall be granted by the conference.
- Art. 9. Conference shall always open and adjourn by prayer and praise of God.
- Art. 10. The Minutes of the conference shall be signed by the Moderator and Clerk.

CONSTITUTION**Preamble**

We, the Original Free Will Baptist of the State of Georgia, do ordain this Constitution for the purpose of advancing, promoting and increasing all phases of the cause of Christ.

Article I

SECTION 1. This assembly shall be known as the Georgia State Association of the Original Free Will Baptists.

Article II

SECTION 1. The officers of this Association shall be a Moderator, an assistant Moderator, a Secretary, an assistant Secretary and a Treasurer.

SECTION 2. All regular officers and the chairman of each standing board shall compose the Executive Board.

SECTION 3. This association shall be composed of all active Ministers who are members of an affiliated body, one delegate for every 500 members or fractions thereof of each affiliated association. One delegate for every 1000 members or fraction thereof of each affiliated Union meeting, and one delegate for every 100 members or a fraction thereof of every affiliated local Free Will Baptist church.

SECTION 4. All delegates from associations, union meetings and local churches shall be elected from the laity of the body sending them.

SECTION 5. Funds to meet the current and benevolent allocations shall be paid in on a voluntary basis to the treasurer of this association; However, it is suggested that each affiliated body contribute as a minimum in the following order: Each district association one half of one per cent per capita of their respective membership and \$5.00 in addition for the National Association dues, each Union meeting one fourth of one per cent per capita of their respective membership and each local church according to their ability.

Article III

SECTION 1. It shall be the privilege of each affiliated district Association to furnish a member for each standing board with the term of office being four years, approximately fifty percent of the boards being elected at each election. The number of each board shall not be less than five.

SECTION 2. There shall be a board of Missions composed of members who are noted for missionary zeal and they shall have the supervisions of all mission interest sponsored by this body both home and foreign. Undesignated funds sent to the general Treasurer shall be allocated by the body and undesignated mission funds shall be equally divided between home and foreign.

SECTION 3. There shall be a board of Christian Education whose duty it shall be to keep the body informed of all Christian education sponsored by the body and make such recommendations as they shall deem proper to the body from time to time.

SECTION 4. There shall be a board of superannuation whose duty it shall be to make plans and rules which shall be in harmony with the National Superannuation Board and shall be authorized to formulate plans whereby necessary funds for superannuation may be raised.

Article IV

SECTION 1. All officers except board members shall be elected to serve a term of two years.

SECTION 2. Any officers may be reelected as the body shall see fit.

SECTION 3. When vacancies occur for any cause they shall be filled by the Executive Board, or by any of the standing boards, subject to the approval of the Executive Board, until the time of the regular election of officers.

SECTION 4. Election years shall take place on the odd year of the calendar.

SECTION 5. Any member who fails in the function of his or her duties without reason, the board to which the delinquent member has been elected, shall the office vacate. Further, the body shall have and does reserve the right to deal with any officer or board member who does not conduct his or her office in a Christian and business-like manner according to the rules of Christian conduct laid down in the New Testament. Thus, the right to discipline in this body is confined to this body, but a charge against a member of this body and the member of a local church shall constitute a charge against said member in this body and the body shall abide accordingly.

SECTION 6. The duties of officers not defined shall be the same as those for any deliberative assembly.

SECTION 7. All board may be called in session only by the Chairman of the Executive Board and any standing board may be called in session only by the chairman of said board, unless said chairman becomes incapacitated in which case the assistant assumes the authority of said incapacitated chairman.

AMENDMENTS

This Constitution shall not be changed or altered except by a majority vote of all members present in regular session. All amendments shall lie on the table at least from the morning session until evening session or from evening session to morning session prior to adoption and shall during that time be read at least twice in open session. Additions of board or officers may be added as there is need.

RULES FOR ORDINATION OF MINISTERS

- (1) Applicant shall bear license for not less than one (1) year.
- (2) Be called to one (1) or more churches, except that evidence be shown where as the applicant can be useful in evangelistic work.
- (3) Applicant shall be examined by the Ordaining Council, who having been duly elected by the Association to which they hold membership.
- (4) Applicant shall meet the qualifications as laid down in the scriptures of the Old and New Testaments, measure up to the standards of the treatise of National Association of Free Will Baptist, of which have been adopted by this body.
- (5) These rules may be changed and re-written only by a two-thirds majority of those voting for a change by the Georgia Union Association while in session.

The above rules having been adopted by the executive board and the Quarterly Conference of the Georgia Union Association, the same shall be carried in the Minutes of the Georgia Union Association of Free Will Baptist.

RULES FOR LICENSING MINISTERS

A person having felt the calling of the ministry must be recommended by the church of which he is a member, to the Quarterly Conference or the Association while in session, there examined by the ordaining council and upon their approval be granted license of which shall carry the name of each council member and the seal of Georgia Union Association of Free Will Baptist.
