Over \$5,000.00 has been donated. Double Branches is on top in per capita giving followed by Mt. Ararat. New Ebenezer, Christian Hill, Pine Level are on the junior honor roll. Bro. Morris suggests that each church could support the Unified Program in several ways, but said the best way was by setting aside 10% or 20% of the regular offering.

Motion carried to accept resignation of Bro. W. W. Hobbs from Executive Board.

Nomination in order to replace him. Bro. Lewis Clark nominated and elected.

Motion carried to recommend Bro. E. J. Barker to Board of Trustees of Camp Mt. Bethel.

Bro. Charles Clark selected to preach introductory sermon at next session. Bro. Nick Rozar, alternate.

Motion carried for Sis. T.M. Sangster to replace Sis. Lucy Payne as Field Worker in organizing and working with Women's Auxiliary.

Motion carried to give Bro. Morris the stand for the preaching hour. Offering taken in amount of \$29.25.

Bro. Morris used Matt. 12:24-30 as a scripture lesson. He read the three words "while men slept", as a text. He reminded us of the sleep into which Fre Will Baptists have fallen. He tells us of the age of the Free Will Baptists in Georgia and North Carolina. One Association in North Carolina has celebrated its 210th session. Concerning the sleep, we have lost more churches and members than we have on the rolls today. The devil and his cohortes have sowed seed, none good, among Free Will Baptists. All of which tend to retard or hold back our movement, among them are indifference, discord, unsound doctrines, World-

liness. He pleads with us to wake up and learn and do the truth. Wake up, set up and light up.

#### ARTICLES OF FAITH

- 1. THE BIBLE—The scriptures of the Old and New Testaments were by inspiration of God, and are our infallable rules of Faith and Practice.
- 2. GOD—There is one living and true God, revealed in nature as the Creator of the universe; and in the Scriptures as Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore, obey.
- CHRIST—Christ is God manifest in the flesh; in His divine nature truly God, in his nature truly man. The mediator between God and man, one crucified. He is now risen and glorified, and is our present Savior and Lord.
- THE HOLY SPIRIT—The scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.
- 5. THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requirese.
- 6. THE SINFULNESS OF MAN—Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity therefore, inherit a fallen nature of such tendencies that all who come to years of accountability, sin, and become guilty before God.
- 7. THE WORK OF CHRIST—The Son of God by His incarnation, life, sufferings, death and resurrection, effected for all a redemption from sin that is full and free is the ground of salvation by faith.
- 8. THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance of sincere sorrow for sin and hearty renunciation of it. 2. Faith of the unswerved committal of one's self to Christ as Savior and Lord with purpose to love and obey His in all things. In the exercise of saving faith with the soul is renewed by the Holy Spirit freed from domination of sin and become a child of God. 3. Continuance in faith and obedience until death.
- ELECTION—God determined from the beginning to save all who should comply with the condition of salvation. Hence by faith in Christ, men became His elect.
- 10. FREEDOM OF WILL—The human will is free and self-controlled having power to yield to the influence of the truth and the spirit, or to resist them and perish.

SIXTY-THIRD ANNUAL SESSION

- 11. SALVATION FREE—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.
- PERSEVERANCE—All believers in Christ, who through grace preserve in holiness to the end of life, have promise of eternal salvation.
- 13. GOSPEL ORDINANCES—Baptism, or the immersion of believers in water, and the Lords Supper are ordinances to be perpetuated under the Gospel; Feet Washing, and ordinance teaching humility, of universal obligation, and to be administered to all true believers.
- 14. TITHINGS—God commanded tithes and offerings in the Old Testament; Jesus Christ endorses it in Gospel (Matt. 23:23) and the Apostle Paul said, "upon the first day of he week let every one of you lay by him in store as God hath prospered him" (I Cor. 16:2).
- 15. THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart for secular employments and amusements, for rest, worship, Holy works and activities, and for personal communion with God.
- 16. RESURRECTION, JUDGEMENT AND FINAL RETRIBUTION The Scriptures teach the resurrection of all men of the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will go away into eternal punishment, but the righteous into eternal life.

#### CHURCH COVENANT

Having given ourselves to God by faith in Christ, and adopted the word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things and to abstain from appearances of evil, to sustain from all sinful amusements and unholy conformity to the world from all sanction of the use and sale of intoxicating beverages and "t oprovide things honest in the sight of all men."

We agree faithfully to discharge our obligations in reference to the study of the Scripture, secret prayer, family devoions, and social worship; and by self-denial, faith and good works, endeavor to "grow in grace and the knowledge of our Lord and Savior, Jesus Christ."

We will not forsake the assembling of ourselves together for church conferences; public worship and the observance of the ordinances of the Gospel, nor fail to pay according to our ability fr the support of the church, of its poor and all its benevlent work.

We agree to accept Christian adominition and reproof with meekness; and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace, oo be careful of one another's happiness and reputation, and to seek to strengthen the weak, encourage the afflicted, admonish he erring, and so far as we are able promoe the success of the church and of the gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme: counting it our chief business in life to extend the influence of Christ in society; consantly praying and toiling that the Kingdom of God may come and his will be done on earth as it is in heaven.

To this end we agree to labor for the promotion of educational and denominational enterprises; the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

#### BY-LAWS

#### REVISED VERSION

- Article 1. Annual conferences shall be annually held.
- Article 2. Every Elder, Minister, Deacon and Board member in good standing and delegates shall duly attend.
- Article 3. If any member in the judgment of the conference shall show anger in his discussion on any subject, shall forfeit his seat in the conference.
- Article 4. No member of the annual conference shall be at liberty to withdraw without leave of the moderator.
- Article 5. The conference shall always adjourn by vote.
- Article 6. There shall annually be a committee of finance chosen to settle with the treasurer and report to the conference.
- Article 7. The officers and standing committees shall be entitled to seats in annual conference.
- Article

  8. No Elder, Minister, Deacon, Board member or delegate shall, during the sitting of the annual conference, be at liberty to fill any place, as to preaching or hearing at the stage, only as liberty shall be granted by the conference.
- Article 9. Conference shall always open and adjourn by Prayer and Praise of God.
- Article 10. The minutes of the conference shall be signed by the moderator and clerk.
- Article 11. The moderator shall read or have read the by-laws and the churcr covenant at the opening of business session annually.
- Article 12. All church clerks shall furnish moderator a list of delegates 15 days prior to convening of each annual session.

## CONSTITUTION REVISED VERSION

- Article

  1. This yearly meeting or association shall be called the Georgia Union Association and shall be composed of such regularly organized and disciplined Free Will Baptist churches and Quarterly meetings, conveniently located, as may embody themselves under this constitution.
- Article

  2. The conference of this body or association shall consist of Ministers,, Deacons and Board members in good standing and delegates from the several churches and the quarterly meetings of which it is composed, all of whom shall have voting power. Every quarterly meeting with 500 members or less shall be entitled to one delegate and quarterly meetings with more than 500 members shall be entitled to one delegate plus one delegate for each additional 500 members or fraction thereof. Every church with 50 members or less shall be entitled to three (3) delegates, and churches with more than 50 members shall be entitled to three (3) delegates, plus two (2) for each additional 50 members or fraction hereof.
- Article 3. The officers of this yearly meeting or association shall be a clerk and treasurer, moderator, vice moderator and a mission treasurer, who shall be chosen at the close of every session of the yearly meeting or association, and whose term of office shall begin immediately following adjournment of each annual session.
- Article 4. Any well organized and well regulated Free Will Baptist church or quarterly meeting as conform to the practices and adopt the doctrines of the Free Will Baptist denomination, as published in the Treatise of their faith, and in the minutes of the national association and one in favor of all benevolent enterprise of the denomination may at any time on application by two-thirds vote of this body, become a member thereof.
- Article

  5. This yearly meeting or association shall have power to disclipine the churches of which it is composed and to exclude them for disorderly work, if labor proves unsuccessful, but in no case to reverse their decision nor interfere with any of their internal regulations.

- Article
  6. The sessions of this yearly meeting or association shall be held on Thursday and Friday before the second Sunday in October, at which time it shall be the duty of the churches and quarterly meeting of which this yearly meeting or association is composed, to represent themselves by letter and delegates and report their standings, prospects and statistics, at which time the association shall act upon such questions and topics as may be referred to it by its respective churches and quarterly meetings and transact such other business not repunant to this constitution or to the practices of the denomination as in its judgment may promote the cause of Christ and the interests of the churches and quarterly conferences within the limits of this yearly meeting or association.
- Article 7. This yearly meeting or association shall have power to adopt any regulations or by-laws, not consistant with this constitution, which may be deemed essential to the further regulation of its session.
- Article 8. This constitution shall not be changed or altered except by two-thirds majority of all members present at a regular session. All proposed amendments shall be in writing and shall be read in open session during first day, then lie on table until second day, read for second time in open session prior to being considered.

# RULES FOR ORDINATION OF MINISTERS REVISED VERSION

- 1. Applicants shall bear license for not lessthan one (1) year.
- Be called to one (1) or more churches, except that evidence be shown whereas the applicant can be useful in evangelistic work.
- Applicant shall be examined by the ordaining council, who having been duly elected by the association to which they hold membership. Examination shall be held at a Quarterly meeting or the annual association while in session.
- Applicant shall meet the qualifications as laid down in the scriptures of the ol dand new testaments. Measure up to the standards of Free Will Baptists and our church covenant, of which have been adopted by this body.
- These rules may be changed and re-written only by a two-thirds majority of those voting for a change by the Georgia Union As-

sociation. The same shall be carried in the minutes of the Georgia Union Association of Free Will Baptists.

# RULES FOR LICENSING MINISTERS REVISED VERSION

- 1. Applicant must be recommended by the church he is a member.
- Applicant shall be examined at the quarterly meeting or annual association while in session by the ordaining council, who having been duly elected by the annual association.
- Approved license shall carry the names of all three council members and the seal of the Georgia Union Association of Free Will Baptists.
- 4. Applicant shall meet the qualifications as laid down in the scriptures of the old and new testaments, measure up to the standard of the Treaties of the National Association of Free Will Baptists and our church covenant, of which have been adpted by this body.
- These rules may be changed and re-written only by a two-thirds majority of those voting at a regular session of Georgia Union Association.
