# PROCEEDINGS

The sixty-eighth (68) annual session of the Georgia Union Association of the Original Free Will Baptists convened with New Ebenezer Church, Route three, Cochran Georgia, Friday October 11, 1963.

#### FRIDAY MORNING

The session was opened by singing "Victory in Jesus." Prayer was offered by Rev. Emmett McDuffie. Moderator, Rev. Charles Clark, used as a scripture lesson I Chor. 12:12-20.

Call to order by Moderator.

Called for corresponding letters from various churches.

Motioned, seconded, carried for chair to appoint letter readers. Moderator appointed Bro. E. J. Barker and Rev. E. E. Kelley.

The following churches responed: Christian Hill, White Oak, Beulah Springs, Pleasant Hill, Pine Level, Liberty Chapel, Bethlehem, Mt. Ararat, Bay Springs, Antioch, Double Branches, Little Bethel, New Ebenezer, and First (Eastman).

Motion, seconded, carried to receive letters and seat delegates. Called for petitionary letters. Received letters from: Quarterly Con-

ference, Youth for Christ, and League Convention.

Motion, seconded, carried to receive these letters for information.

Visitors invited to seats with us. Those responding were: Bro. Garrett, from the Missionary Baptist, Sister Smith, from the Church of God, Rev. Thomas Wiley, Sr., of the National Foreign Mission Department, Rev. Emmett McDuffie, Rev. Leonard Graham, Rev. Harvey Giddens, Bro. James Fowler from the South Georgia Association and Rev. Mance Cason from the State Promotional Department.

Motion, second, carried for Moderator to appoint Finance Committee. Those appointed were: Bro. Donald Moore, chairman, Bro. Fletcher Swearingen and Bro. B. I. Peacock.

Motion, second, carried for Moderator to appoint devotional Committee. Those appointed were: Bro. Ross Bennett, chairman; Bro. Thomas Bryant and Bro. Homer Shi.

Motion, second, carried to discontinue regular order of business and enter into worship hour.

After singing "At Calvary", prayer was offered by Bro. I. J. Blackwelder.

Rev. W. L. Amerson was in charge of the Worship Hour. He used as a scripture lesson Psalms 27:1-14 and places special emphasis on verse 14. Rev. Amerson savs "The biggest mistake of the world todav is being in such a hurry and living so fast we can not wait upon the Lord to direct us.

#### FRIDAY AFTERNOON

After a bountiful and very graciously prepared lunch, we met back in the church. After a song, prayer was offered by Bro. Donaid Moore.

Motion, second, carried to accept report and release committee.

Motion, second, carried to enter into Miscellaneous Business.

Rev. Eugene Ross read proposed changes in the constitution concerning abolishing the present Quarterly Conference and Combining same with the Georgia Union Association with one set of officers and to abolish the present Mission Board and elect a five (5) man Mission Board with the Mission Treasurer as one of those members.

Motion, second, carried to lay these recommendations on the table and take action at the proper time the next day.

Motion, second, carried to have 400 minutes printed.

Motion, second, carried for the Auxiliaries of the church have space in the Associational minutes with each auxiliary paying for its space.

Rev. Mance Cason introduced for the State Work. Bro. Cason commends the Association for a good job during the past year. Several churches received certificates for their achievement.

Motion, second, carried to accept report as information and commend Secretary.

Bro. Emmett Long ask for an offering to help Bro. and Sister Peacock complete the new church building at Mt. Ararat. \$32.50 was taken.

Rev. Hoyt Findley gave report on the State Mission Board. Report accepted as information.

Motion, second, carried to accept the report of the Resolutions Committee and release the committee. (See reports)

Motion, second, carried to adopt each item separately.

Motion, second, carried for Names, addresses and phone number of Pastors, Deacons, and church clerks to appear in the associational minutes.

Motion, second, carried that a Digest Committee be appointed to study the church letters and make a report to the Association.

Motion, second to adopt recommendation to appoint a Program Commi<sup>+</sup>tee to prepare a program and get advanced notices to the churches to outline the transactions of the association.

A very inspirational message was delivered by Rev. I. J. Blackwelder from the scripture lesson, Luke 15:17-24. Rev. Blackwelder brought out five (5) points in the conversion of the Prodigal Son: 1. His Awakening, 2. His Meditation, 3. His Decision, 4. His Confession, and 5. His Acception.

Session re-opened by singing "At Calvary". Prayer offered by Rev. Eugene Ross. After another song, "There Is Power In The Blood" the Moderator read as a scripture lesson I Thes. 5:1-10.

Motion, second, carried for chair to appoint the Nominating Committee. Those appointed were Sister Donald Moore, Bro. Joel Butler and Sister Hollis Smith.

Motion, second, carried for chair to appoint a Digest Committee. Those appointed were: Bro. Sherman Jones, Chairman; Bro. E. J. Barker and Bro. Ernest Collins.

Motion, second, carried to retain Bro. W. H. Nobles to the Executive Board.

Bro. Ross Bennett nominated to replace Bro. Sherman Jones on the Superannuation Board.

Motion, second, carried for nominations to cease and proceed to elect by acclamation.

Rev. Russell Horne nominated to replace Bro. H. E. Leonard on the Education Board.

Motion, second, carried that nominations cease and proceed to elect by acclamation.

Motion, second, carried to retain Rev. J. F. Smith on the Ordaining Council.

Rev. W. L. Amerson nominated to be recommended to the State Association to replace Rev. Charles Clark on the Christian Education Board.

Motion, second, carried that nominations cease and proceed to elect by acclamation.

Rev. E. E. Kelley nominated to replace Rev. Hoyt Findley on the State Mission Board.

Motion, second, carried that nominations cease and proceed to elect by acclamation.

Motion, second, carried to retain Bro. John Ross on the Superannuation Board of the State.

Motion, second, carried to retain Bro. T. B. Etheridge to the Camp Board.

Motion, second, carried to accept the report of the Christian Education committee and to release the committee. (See reports)

Motion, second, carried to adopt the report item by item.

Wiley used as a scripture lesson the 10th chapter of Luke to bring a very inspiring message on the subject: "They came, they looked, they saw and they left." The people of the body made a prresent of \$25.50 to Bro. Wiley. We were dismissed for the lunch hour by Rev. Howard Faircloth.

Motion, second, carried to remove the material from the table and act upon them item by item.


Motion, second, carried to adopt item 1 as read. (See recommendations)

#### CHRISTIAN EDUCATION COMMITTEE REPORT

Observing, as we must, the fact that wherever our people have been alerted in the field of Christian Education, whether it be in the local church, district, state or national associations, they have been able to step up the tempo in the development of our Lord's cause, We therefore recommend:

First, that our local churches be strongly encouraged to inaugurate Training Programs with a view to greater effeciency in spreading the Gospel of Christ, and, in building up the Faith of the Saints at the Local Church Level.

And, Finally, that all of our churches be urged to inaugurate educational programs, made possible through our familiar denominational organizations such as, the Sunday School, Free Will Baptist Leagues, Masters Men's chapters and Woman's Auxiliaries.

**ARTICLES OF FAITH**

4. THE HOLY SPIRIT—The scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.

5. THE GOVERNMENT OF GOD—God exercises a wise and benevolent providence over all beings and all things by maintaining the constitution and laws of nature. He also performs special arts of grace, not otherwise provided for, as the highest welfare of man requires.

6. THE SINFULNESS OF MAN—Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity therefore, inherit a fallen nature of such tendencies that all who come to years of accountability, sin, and become guilty before God.

7. THE WORK OF CHRIST—The Son of God by His incarnation, life, suffering, death and resurrection, effected for all a redemption from sin, that is full and free, is the ground of salvation by faith.

8. THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance of sincere sorrow for sin and hearty renunciation of it.

2. Faith of the unswerved commital of one's self to Christ as Saviour and Lord with purpose to love and oney Him in all things. In the exercise of saving faith with the soul renewed my the Holy Spirit freed from domination of sin and become a child of God. 3. Continuance in faith and obedience until death.

9. ELECTION—God determined from the beginning to save all who should comply with the condition of salvation. Hence by faith in Christ, men became His elect.

10. FREEDOM OF WILL—The human will is free and self-controlled having power to yield to the influence of the truth and the spirit, or to resist them and perish.

11. SALVATION FREE—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, whosoever will may come and take of the water of life freely.

12. PERSERVERANCE—All believers in Christ, who through grace preserves in holiness to the end of life, have promised of eternal salvation.

13. GOSPEL ORDINANCES—Baptism, or immersion of believers in water, and the Lord's Supper are ordinances to be perpetuated under the Gospel: Feet Washing, and ordinance teaching humility, of universal obilgation, and to be administered to all true believers.

14. TITHING— God commanded tithes and offerings in the Old Test-

ament; Jesus Christ endorses it in Gospel (Matt. 23.23) and the Apostle Paul said, "upon the first day of the week let every one of you lay by him in store as God hath prospered him." (I Cor. 16:2)

15. THE CHRISTIAN SABBATH—The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, Holy works and activities, and for personal communion with God.

16. RESURRECTION, JUDGMENT AND FINAL RETRIBUTION— The Scriptures teach the resurrection of all men on the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will go away into eternal punishment but the righteous into eternal life.

#### CHURCH COVENANT

Having given ourselves to God by faith in Christ and adopted the word of God as our rule of faith and practice, we now give ourselves to one another by the will of God in this solemn covenant.

We promise by His grace to love and obey Him in all things and to abstain from appearances of evil, to abstain from all sinful amusements and unholy conformity to the world from all sanction of the use and sale of intoxicating beverages and to "provide things honest in the sight of all men."

We agree to accept Christian admonition and reproof with meekness; and to watch over one another in love, endeavoring to "keep the unity of the Spirit" in the bonds of peace to be careful of one another's happiness and reputation, and to seek to strengthen the weak, encourage the afflicted, admonish the erring, and so far as we are able promote the success of the church and of the gospel.

We will everywhere hold Christian principles sacred and Christian obligations and enterprises supreme; counting it our chief business in life to extend the influence of Christ in society; constantly praying and toiling that the Kingdom of God may come and His will be done on earth as it is in heaven

To this end we agree to labor for the promotion of education and denominational enterprises; the support of missions, the success of Sunday

Schools; and evangelistic efforts for the salvation of the world. And may the God of Peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

#### **BY-LAWS**

#### **REVISED VERSION**

Article 1. Annual conference shall be annually held.

Article 2. Every Elder, Minister, Deacon and Board member in good standing and delegates shall duly attend.

Article 3. If any member in the judgment of the conference shall show anger in his discussion on any subject shall forfeit his seat in the conference.

Article 4. No member of the annual conference shall be at liberty to withdraw without leave of the Moderator.

Article 5. The conference shall always adjourn by vote.

Article 6. There shall anually be a committee of finance chosen to settle with the treasurer and report to the conference.

Article7. The officers and standing committee shall be entitled to seats in annual conference.

Article 8. No Elder, Minister, Deacon, Board Member or delegate shall, during the setting of the annual conference, be at liberty to fill any place, as to preaching or hearing at the stage, only as liberty shall be granted by the conference.

Article 9. Conference shall always open and adjourn by prayer and Praise of God.

Article 10. The minutes of the conference shall be signed by the Mod-

erator and Clerk.

Article 11. The Moderator shall read or have read the by-laws and the church covenant at the opening of business session annually.

Article 12. All church clerks shall furinsh moderator a list of delegates 15 days prior to convening of each annual session.

#### CONSTITUTION REVISED VERSION

Article 1. This yearly meeting or association shall be called the Georgia Umon Association and shall be composed of such regularly organized and disciplined Free Will Baptist Churches and Quarterly meetings, conveniently located, as may embody themselves under this constitution.

Ardele 2. The conference of this body or association shall consist of Ministers, Deacons, and Board Members in good standing, and delegates from the several churches and the quarterly meetings of which it is composed, all of whom shall have voting power. Every quarterly meeting with 500 members or less shall be entitled to one delegate and quarterly meetings with more than 500 members shall be entitled to one delegate plus one delegate for each additional 500 members or fraction thereof. Every church with 50 members or less shall be entitled to three (3) delegates, and churches with more than 50 members shall be entitled to three

(3) delegates, plus two (2) for each additional 50 members or fraction thereof.

Article 3. The officers of this yearly meeting or association shall be a clerk and treasurer, assistant clerk and assistant treasurer, moderator and Vice Moderator, who shall be chosen at the close of every session of the yearly meeting or association and whose term of office shall begin immediately following adjournment of each annual session.

Article 4. Any well organized and well regulated Free Will Baptist church or quarterly meeting as conform to the practice and adopt the doctrines of the Free Will denomination, as published in the Treatise of their faith and in the minutes of the national association and one in favor of all benevolent enterprise of the denomination may at any time on application by two-thirds vote of this body become a member thereof.

Article 5. This yearly meeting or association shall have power to discipline the churches of which it is composed and to exclude them for disorderly work, if labor proves unsuccessful but in no case to reverse their decision nor interfere with any of their internal regulations.

Article 6. The sessions of this yearly meeting or association shall be held on Friday and Saturday before the second Sunday in October at which time it shall be the duty of the churches and quarterly meeting of which this yearly meeting or association is composed, to represent themselves by letter and delegates and report their standings, prospects and statistics, at which time the association shall act upon such questions and topics as may be referred to it by its respective churches and quarterly



meetings and transact such other business not repugnant to this constitution or to the practices of the denomination as in its judgment may promote the cause of Christ and the interest of the churches and quarterly conferences within the limits of this yearly meeting or association.

Article 7. This yearly meeting or association shall have power to adopt any regulartions or by-laws, not consistant with this constitution, which may be deemed essential to the further regulation of its session.

Article 8. This constitution shall not be changed or altered except by two-thirds majority of all members present at a regular session. All proposed amendments shall be in wrtiing and shall be read in open session during the first day, then lie on the table until second day, read for second time in open session prior to being considered.

#### **RULES FOR ORDINATION OF MINISTERS**

#### Revised 1960

1. Applicant shall bear license for not less than one (1) year and shall be recommended to the quarterly conference or association by the church of which he is a member.

2. Be called to one (1) or more churches, except that evidence be shown whereas the applicant can be useful in evangelistic work.

3. Applicant shall be examined by the ordaining council, who having been duly elected by the association to which they hold membership. Examination shall be held at the Quarterly meeting or the annual association while in session.

4. Applicant shall meet the qualifications as laid down in the scripture of the Old and New Testaments. Measure up to the Standards of Free Will Baptists and our church covenant, of which have been adopted by this body.

5. These rules may be changed and re-written only by two-thirds (2-3) majority of those voting, for a change, by the Georgia Union Association. The same shall be carried in the minutes of the Georgia Union Association of Free Will Baptists.

#### **RULES FOR LICENSING OF MINISTERS** Revised 1960

1. Applicant must be a member of church recommending him, and if applicant is coming from another denomination or association, he shall be a member of church recommending him for not less than three (3) monthes from date receiving letter stating he in is good standing with church, denomination and association he is leaving.

2. Applicant shall be examined and asked the following questions at the quarterly meeting or annual association while in session, by the ordaining council duly elected by the association.

Q. 1. Do you believe and accept the Old and New Testaments as inspired word of God?

.

Q. 2. Do you believe in baptism by immersion in water?

Q. 3. Do you believe the ordinances of the Lord's Supper and washing of the saints feet?

Q. 4. Do you believe in tithing and offerings as given in the inspired word of God?

Q. 5. Do you believe in the sale of intoxicating beverages?

3. Approved license shall carry the names of the Pastor and Clerk of the church issuing the license.

4. Applicant shall meet the qualifications as laid down in the scripture of the Old and New Testament, measure up to standards of the treatise of the National Association of Free Will Baptists and our church covenant of which have been adopted by this body.

5. No applicant for license to the ministry will be elegible for license if he or she has more than one living husband or wife.

6. These rules may be changed and re-written only by two-thirds (2-3) majority of those voting at a regular session of the Georgia Union Association.
