# Suggested Substitute for Article III, Section I

We recommend that each Church pay two percent (2%) of its regular, undesignated income into the treasury of the Association to be used in the various phases of the denominational work at the discretion of the Association. (Compliance with this recommendation is not compulsory for affiliation, but the plan has proven successful in other areas.)

# Article III, Section I as it now stands:

In view of the need of finance to promote all phases of our work within this Association, as well as the State and National work, it shall be the duty of each church composing this body, to be represented at each quarterly meeting of the Association with a minimum of ten per cent (10%) of their regular undesignated tithes and offerings.
