

Feb. 7, 1987

The Green River Association of Free Will Baptists, met with the First Free Will Baptist Church in Glasgow, Ky. on Feb. 7, 1987 for the Annual meeting. The morning session was opened by singing, "To God be the Glory."

Comments were then given on the subject of using money in other funds to support bro. Bob White's work in Paducah. Bro. moderator read letter from bro. White concerning his needs also his efforts in trying to build a church. Much discussion was given. Bro. moderator called for a recess of 5 minutes for all board chairmens to meet concerning the Paducah church. Conference was then called back to order. Bro. Ed Winkler gave the recommendations as follows, to take \$559.00 from the student loan fund, \$500.00 from the Louisville mission fund and \$200.00 from the C.T.S. fund to go to Bob White to cancell out his diffict with the Home Mission Department.
