

### PROCEEDINGS

### THURSDAY AFTERNOON SESSION

The Association was called to order by the Clerk. Song by the congregation.

Prayer by Rev. Elias Matney.

The Moderator being absent, the Ass't. Moderator was called to the chair, Rev. A. M. Halford, after making a short talk, called for the introductory sermon. Rev. Jno. W. Silvey filled the stand who was to preach the introductory sermon, his text was taken from St. John 7:38.

Enrollment of ministers and deacons was called for. Committees on Credentials and Divine Service were appointed.

### CONSTITUTION

- 1. This Association shall be called the Harmony Association of Free Will Baptists.
  - 2. The object of this Association shall be for the bringing

together of the Free Will Baptists of the different churches of the Harmony Association in one great annual gathering so they can get better aquainted with each other, and for the upbuilding of the Free Will Baptist churches and for the salvation of souls.

- 3. This Association shall be composed of duly elected delegates, elected by the bodies holding membership in this body.
- 4. The officers of this Association shall be a moderator, an assistant moderator, a clerk who shall be treasurer and shall superintend the printing of the minutes, and shall hold their offices until their successors shall be elected; a Board of Trustees of five members whose term of office shall be as follows: One for one year, one for two years, one for three years, one for four years, and one for five years, and at the expiration of these terms, one is to be elected for a term of five years, and who shall hold their office until their successors are elected; and further, if any vacancy occurs between sessions of the Association, the Board shall fill such vacancy or vacancies until the next session of the Association, who shall perform the following duties: First, shall be the legal corporation of the Association with thte corporate name of the Board of Trustees of the Harmony Association of Free Will Baptists, to be a Board of Missions and Church Extension, to secure, hold, use and convey money, homes or lands for the propagation of the Gospel in connection with the Free Will Baptist denominat-Second, to receive, hold, manage, use, control or convey any property intrusted to the Association for and in accordance with the donor's purpose. Said Board of Trustees shall also ompose the Home Mission Board. They may be chosen from ministers.
- 5. This Association shall not usurp any authority over the Quarterly Meetings, and churches that shall be under its supervision, but shall be an advisory body to help them.
- 6. Seven or more ordained ministers or deacons from two or more bodies belonging to this Association shall constitute a quorum to transact business.
- 7. The clerk, or assistant clerk, and in their absence, the senior minister in age, shall call the Association to order for business, and call the moderator or his assistant to the chair, and if neither the moderator nor his assistant are present, then the senior minister in age shall act as moderator. On taking his chair, the moderator shall call for the reading of the letters from the different bodies composing this Association, and after the letters are read he shall seat the delegates. After the delegates are seated, the election of officers shall be in order.

- 8. Any organized Quarterly Meeting or Free Will Baptist church may unite with this body at any regular session through a letter or delegates by a two-thirds vote of all members present
- 9. Be it Resolved, That our ministers refrain from jealousy and self-opinionation.
- 10. This constitution may be added to, amended or changed at any regular session of this body by a two-thirds vote of all the members present, after written notice of the contemplated change has been published in the official paper three months precious to the session at which such change is to take place.

### BY-LAWS

- No. 1. The clerk or assistant clerk, or in their absence the senior minister in years shall call the Association into conference and if a quorum is present the moderator, or in his absence the assistant moderator shall take charge. If neither of them are present the senior minister in years shall act as moderator.
- No. 2. All persons declared by a Committee on Credentials to be duly entitled to a seat in this Association are hereby made and constituted members of this body, and are authorized to act in all respects according to the provisions of the Constitution and By-Laws under which this Association is organized.
- No. 3. It shall be the duty of every body belonging to this Association, to send a letter to every tri-ennial session of this Association, reporting in the same its spiritual condition, benevolent work, and its statistics. Any body belonging to this Association which shall fail to report itself for three successive session, may be dismissed from the Association by a two-thirds vote of all members present.
- No. 4. Each meeting shall be opened by reading a portion of the Bible and with prayer, and shall be closed with prayer.
- No. 5. By a two-thirds vote of all members present, a ruling of the Moderator can be over-ruled.
- No. 6. This Association may correspond by messenger, or otherwise, with other religious bodies.
- No. 7. This Association shall sit with open doors except when it shall go into a committee of the whole.
- No. 8. It shall be the duty of all members of this Association to be present at the time appointed for each meeting, and anyone wishing to retire shall first obtain leave of the moderator.
- No. 9. No member shall absent himself from the Association during its meetings without first obtaining permission from the moderator.

No. 10. No person shall be allowed to nominate more than one member of any committee; provided the person nominated be elected.

No. 11. The moderator shall not allow discussion when not carried on in a Christtian spirit, or when he thinks it will cause disorder or division.

No. 12. Anyone desiring to speak shall rise to his feet and address the moderator by the appellation, "Brother Moderator," but shall not speak further until recognized by the moderator.

No. 13. No member of this Association shall be allowed to speak more than ten minutes nor twice on the same subject without the permission of the moderator.

No. 14. It shall be the duty of the moderator to seat the delegates in a body in a designated section of the room at the beginning of each business session.

No. 15. These By-Laws may be altered or amended at any regular or adjourned sesson of this Assolation by a two-thirds vote of all members present.

### FREE WILL BAPTIST ARTICLES OF FAITH

- 1. THE BIBLE.— The Scriptures of the Old and New Testaments were given by inspiration of God, and are our infallible rule of faith and practice.
  - 2 Timothy 3:16.
- 2. GOD There is one living and true God, revealed in nature as the Creator. Preserver, and Righteous Governor of the universe, and in the Scriptures as the Father, Son and Holy Ghost, yet as one God, infinitely wise and good, whom all intelligent creatures are supremely to love, adore and obey.
  - 1 Cor. 8:6; Matt. 28:19.
- 3. CHRIST.—Christ is God manifest in the flesh; in His divine nature truly God, in His human nature truly man. The mediator between God and man, once crucified, He is now risen and glorified and is our ever present Savior and Lord.
  - St. John 1:1-12.
- 4. THE HOLY SPIRIT.—The Scriptures assign to the Holy Spirit all the attributes of God. He is the Reprover, Comforter, Guide and Sanctifier of men.
  - St. John 16:7-8; Acts 2:4; Eph. 4:46.
- 5. THE GOVERNMENT OF GOD.—God exercises a wise and benevolent providence over all beings and all things by main-

taining the constitution and laws of nature. He also performs special acts of grace, not otherwise provided for, as the highest welfare of man requires.

Psalm 22:28: 97:2.

6. THE SINFULNESS OF MAN.— Man was created innocent, but by disobedience fell into a state of sin and condemnation. His posterity, therefore, inherited a fallen nature of such tendencies that all who come to years of accountability sin, and become guilty before God.

Gen. 2:17; 3:19.

- 7. THE WORK OF CHRIST.—The Son of God, by His incarnation, life, sufferings, death and ressurrection affected for all a redemption from sin that is full and free and is the ground of salvation by faith.
  - 1 John 2:2.
- 8. THE TERMS OF SALVATION—The conditions of salvation are: 1. Repentance or sincere sorrow for sin and the hearty renunciation of it. 2. Faith or the unreserved committal of one's self to Christ as Savior and Lord, with purpose to love and obey Him in all things. In the exercise of saving faith the soul is renewed by the Holy Spirit, freed from the dominion of sin and becomes a child of God. 3. Continuance in faith and obedience until death.

- 9. ELECTION.—God determined from the beginning to save all who should comply with the conditions of salvation. Hence by faith in Christ men become His elect
  - 1 Tim. 2:4.
- 10. FREEDOM OF WILL.—The human will is free and self controlled, having power to yield to the influence of the truth and the Spirit and live, or to resist them and perish.

  Joshua 24:15.
- 11. SALVATION FREE.—God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of Life freely. Rev. 22:17.
- 12. PERSEVERANCE.—All believers in Christ, who through grace, persevere in holiness to the end of life, have the promise of eternal salvation.

- 13. GOSPEL ORDINANCES Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel: Feet Washing, an ordinance teaching humility, of universal obligation, and to be administered to all true believers.
