Church Covenant

Believing that the union of Christians in a visible church is sometimes by the teachings of Christ and the practice of the Apostles, that it is adopted to promote piety, and increase Christian influence.

To keep ourselves in vital communion with our Heavenly Father and commend to others our Lord, not only in word but by means of a devoted spirit, a holy example, always careful of each other's reputation and usefulness.

We will watch over each other in the spirit of true charity, seeking to bear each other's burdens, assist those in need, strengthen the weak, encourage the despondent, sympathize with the sorrowful, reprove the erring, win back the straying to duty and aid in maintaining wholesome discipline, receive Christian admonition and reproof in meekness, keep the unity of the heart in the bonds of peace, and cheerfully submit such regulations as the majority may approve. We will contribute according to our apility for the support of a faithful ministry, maintain secret congregationl prayer and aid by our presence and otherwise in sustaining public and social worship and in giving success to the various means of grace. We will give an active and conscientious support to the great cause that aims to promote morality and Christian influence, such as home culture, temperance, Sabbath Schools, education, and we will refuse all sanction to such worldly amusements and indulgence which tend to lessen true piety in ourselves or weaken Christian influence over others so that religion be not reproached on our account. We will ever hold Christian objects supreme, counting it our chief aim in life to spread the Gospel of our Lord Jesus Christ.

We, your committee on resolutions, recommend that each church pay \$5.00 for the expense of delegates to the Stat Association, and help pay for the State Minutes.—S. B. Rush, Chairman.

Constitution

We, the members of the Church of Christ, known as the Free Will Baptists, being regularly baptised upon a profession of our faith in Christ and convinced of the necessity of a combination or churches to perpetuate a union and communion among us, and to preserve and maintain a correspondence with each other, do therefore ordain this constitution for our government as an Association.

- 1—This Association shall be composed of all the ordained authority in its bounds assisted by the several church clerks and delegates chosen by each church, not to exceed three in number.
- 2—The letters from the different churches must be read: Number in fellowship, number by confession of faith, number by letter, number by recommendation, number dismissed, number excluded, number died since last Association.
- 3—The members thus chosen shall be known as the Hopewell Association of Free Will Baptists, composed of sundry churches in Oklahoma. The Association shall have no power to lord over God's heritage, or have any ecclesiastical power over the churches, but reserves the right to withdraw from any church that becomes disorderly.

4-The Association shall have a Moderator, Clerk and Treasurer,

who shall be chosen by the suffrage of the body.

5—Newly constituted churches may be admitted by petitionary letters, and if upon examination they are found to be orthodox and orderly, they be received and given the right hand of fellowship.

6—No question from any church shall come under the consideration of the Association unless it has been discussed in the church asking the question.

7—Every motion made and seconded shall come under the consideration of the Association unless it is withdrawn by the member who made it.

8—The Association is to endeavor to furnish the churches with the minutes of the Association in proportion to the membership of each church, the distribution being at the discretion of the Asso-

9—Each ordained Minister shall maintain membershin of some local church, and if he should have a letter and should hold same for a perioid of twelve months when conveniences and opportunities are afforded, then his name shall not appear on the "Roll of Ordained Ministers" in this Association.

10—Amendments to the Constitution may be made when necessary,

by a majority of the members present.

Articles of Faith

- 1—We believe in the true and living God, Son and Holy Ghost, and these three are equal in divine essence, power and glory. Rom. 1:20; John 1:1.
- 2—We believe the scriptures of the Old and New Testaments are the written Word of God, and the only infallible rule of faith and practice. II Tim. 3:16-17.
- 3—We believe God created man and gave him holy commandments whereby he should live holy, but man voluntarily disobeyed the commandments of God, transgressed the law and fell under the just condemnation of the same whereby all mankind are sinners, not

by constraint but by choice, being partakers of the sinful nature attained by the fall, and man is unable to save himself with his own person; but we see Jesus for the suffering of death crowned with. glory; that He, by the grace of God, tasted death for every man. Gen. 1:31 Heb. 3:9-12.

4-We believe that Christ by his suffering, death and resurrection purchased our pardon and offered it free to all on the principles of repentance toward God and faith in our Lord Jesus Christ. He commands men everywhere to repent. Therefore he saith: "Look unto me and be ye saved all the ends of the earth; for I am God and there is none other." Matt. 7:7; Isa. 45:22; Acts 20:21.

5-We believe that adult persons must be regenerated and born of the spirit if they inherit eternal life. John 3-5-6; Rom. 5:1, 13.

6—We believe that infants are saved upon the merits of the Son of God. Mark 10-13-16.

7—We believe that all Christians sould persevere in grace and be faithful to the end if they inehrit eternal life. "Blessed are they that do his commandments, that they may have a right to the Tree of Life and enter in through the gates to the city." Rev. 22:14.

8-We believe that God in his goodness displays the power of Grace in calling and qualifying His servants by the teachings of the Holy Ghost, and by His instruction of His blessed word, to go forth and proclaim life and salvation. I Cor. 12:8; Eph. 3:7.

9—We believe that baptism, the washing of saints' feet, the Lord's Supper, keeping the Lord's day holy, abstaining from worldly lusts and carnal cares and assembling ourselves together is an ornament which prepares and beautifies the soldier of the cross to march onward in the army of the Lord. Matt. 28:19-20.

10—We believe that immersion is the apostolic mode of baptism; that Christ, who is our life, showed this humble example to His followers and bids us walk therein. John 3:23; Matt. 3:16.

11—We believe that none have the right to baptism only those who have a living hope in our Lord Jesus Christ, and none have a right to administer the same only those who are called of God and come under the hands of the presbytery. Mark 16:16; I John 5:1.

12—We believe in the resurerction of the dead, both of the just and the unjust. The resurrection of the just to grory and immortality in the presence of God; the unjust to shame and banishment from the presence of God. Matt. 25:41-46; II Thes. 1:4-11; Rev. 20:10.

13—We believe we are saved by grace through faith. Eph. 2:8; John 1:7.

RULES OF ORDER

1-At every sitting business shall be opened and closed with prayer by the Moderator or whoever he may request.

2—Visiting members invited to seats may take part in discussion,

but are not to vote.

3-Those who speak shall arise and address the Moderator. Per-

sonal reflections shall be avoided in all debates.

4-When a motion has been made and seconded and a member opposes discussion, the Moderator shall put the question: "Shall it be discussed?" If negative, the question shall be dismissed.

5—If any proposition under debate contains two or more points, it shall be divided at the request of any member and a vote taken.

6-Motions made and lost shall not be recorded.

7-No one shall speak more than twice on any subject without the leave of the Moderator.

8-All questions shall be decided by a majority of all members

present.

9-No one shall absent himself without the leave of the Moderator. 10—Minutes shall be leisurely read and corrected, if necessary,

before the close of the Association.

11—In the sessions of the Association arrangements shall be made so as to have two or more sermons a day, or their equivalent de-votional services.

12—The rules of order shall be read from the chair immediately

after the organization of the Association.

13-Alterations may be made to these rules at any regular meeting of the Association.

Resolved, that we, your committee on Sunday Schools, insist that the Sunday School be considered an auxiliary of the Church and comes under the supervision of the Pastor, and we insist that he use every effort possible to further the same and to arouse an interest among the paernts is the thing most needed. The Scriptural charge to bring up the child in the nurture and admonition of the Lord, is to the parents, and we believe the best way to do this is to go with them instead of sending them to Sunday School. We offer the following evidence to prove the importance of the Sunday School: From 75 to 90 per cent of the present church membership comes from the Sunday School and that 85 to 90 per cent of those united with the church under the age of 17. We believe that knowledge of the Scripture is responsible for these conditions and that outside of the home, the Sunday School is the best means of imparting this knowledge.—L. A.
