Motion sustained that Ordination Credentials be issued to Brother Allen Taylor upon proper request of the East Central Quarterly, Meeting.

The Illinois State Home Mission Board gave the Executive Board custody of the deed and insurance papers of the Wil-Street Free Will Baptist Mission of Peoria, Illinois.

Motion sustained that the member churches of ----6

the State Association be notified that individuals are to bring a sack lunch of sandwiches and dessert to the meeting of the association; and that we pay the Illinois Women's Auxiliary the fee of \$25.00 per day for serving the noon meals and furnishing the tea and coffee.

The Foreign Missions Board, Christian Education Board, Superannuation Board, Laymen's Board and Illinois Home Missions Board gave a quarterly report.

Motion sustained that rather than granting the request made by the Home Missions Board to increase their allocation by 5% of the Co-operative monies, the Home Mission Board is to contact Brother Homer Willis, National Home Missions Director, and inquire on how the State and National boards can work together.

Motion sustained to receive the report of the State Promotional Secretary, Brother George Waggoner, and pay his mileage allowance of \$146.60.

Motion sustained that a letter of condolence be sent to Brother Clyde Gulley because of the death of his wife.

Motion sustained that the clerk make any necessary changes on the Quarterly Meeting report blanks and have 500 revised report blanks printed.

Motion sustained to receive the resignation of Brother George Waggoner as State Promotional Secretary effective 60 days from this date, and proceed to find a qualified full time man.

Motion sustained that the chair be empowered to appoint a committee of two to serve with himself to try to acquire a State Promotional Secretary.

The chair appointed Brothers Robert Laur and Bobby Carden to serve on this committee.

Motion sustained that the Executive Board go on record as endorsing the proposed constitutional changes.

Motion sustained to adjourn.

Motion sustained to lay the following Constitutional changes on the table:

following: "A. Standing delegates as follows

- 1. All ordained ministers having a current ministerial card of good standing from this Association.
- 2. All active deacons who hold membership in a local church that is a member of this State Association."

Item No. 2: To Article XII, Section 2, of the Con-stitution, add: "No minister may be issued a certificate of good standing without first being issued Exhorter's License, a Certificate of Ordination, or a Recognition of a Certificate of Ordination.

Item No. 3: Amend Article XII, Section 3, of the Constitution, by substituting the following for the entire section: "Section 3. Qualifications for Ministerial Cards of Good Standing.

> A. Each minister must make a report of the past church year's activities on a report blank furnished by this Association. He is responsible for getting his report signed by proper church, quarterly meeting, and district association or yearly meeting clerks, and delivering it to the State Association.

> B. In order to receive a card of good standing a minister must answer ALL questions on his report and

- 1. Must agree with and practice the terms of the Church Covenant as evidenced by the answer on his report:
- 2. Must agree with and teach all points in the Free Will Baptist Articles of Faith as evidenced by the answer of his report;
- 3. Must not take part in practices repugnant to the Free Will Baptist Doctrine such as: (a) Sanctification as a second definite work of grace; (b) Oneness rather than the Trinity; (c) Unknown tongues as commonly recognized; (d) Positional ethernal security rather

than provisional eternal security as taught by the Scripture and recognized by our Treatise;

- 4. Must attend, support, and participate in denominational programs and organizations:
- 5. Must be recommended by his church, quarterly meeting, and district association or yearly meeting as evidenced by proper signatures on his report."
- Item No. 4: Add Section 4 to Article VII as follows: "A minister who has ordination credentials from another Free Will Baptist body other than this State Association who joins a church that is a member of this Association will be issued a Recognition of Certificate of Ordination upon proper request by his church and his quarterly meeting and will be issued a card of good standing for the remainder of the associational vear."
- Item No. 5: Add Section 5 to Article XII as follows: "A minister who has been ordained in another denomination will, not less than one year after he has joined a church that is a member of this Association, be issued a Recognition of Certificate of Ordination upon proper request of his church. the quarterly meeting, and the district association or yearly meeting, and will be issued a card of good standing for the remainder of the associational year."

The Sunday School Alliance reports 29 Sunday Schools in attendance in the Fall, 1967, Meeting and 33 at the Spring, 1968, Meeting. This was the largest number in attendance yet.

The Board met 8 times during the year to conduct business. The Youth Camps have been staffed and programs are available. The programs will tell

you who the Camp personnel are. Youth Camp dates are as follows: Junior Camp, July 21-26 and Senior Camp, July 28-Aug. 2. Please note that the Senior Camp begins on Sunday afternoon, as does Junior Camp. If campers are brought prior to opening of either camp, provision for their supervision should be arranged for. Camp personnel will not be responsible for them prior to the beginning of each camp.

Camp fees have been raised to \$9 per week this year to enable us to pay each counselor the same amount the teachers are paid. We would encourage the churches to help us with the counselor situation, especially if you send campers. Counselors are difficult to find.

July 13 has been set as general camp clean up day. Please come and help if you possibly can. We need to get the camp spruced up for the summer activities.

In previous sessions the Sunday School Alliance voted to construct a  $36 \times 78$  foot tennis court to be used as a general play area. The proposed cost was to be about \$600. The Board has found that the cost will be in excess of twice that amount and believes the issue should be brought back before the Sunday School Alliance.

In the Spring Meeting it was voted to add more dorm space to the girls' dorm. Construction was delayed until after summer activities at the Camp Ground to avoid the mess and confusion an incompleted construction project might bring.

There were 123 Junior Campers and 103 Senior Campers in attendance in 1967.

These and other projects have been the business of your Sunday Schoel Alliance Board. They have labored hard and faithful and there has been a fine spirit of cooperation at each meeting.

### REPORT OF THE PROMOTIONAL SECRETARY MAY 1, 1967 TO APRIL 30, 1968

In several areas this has been our very best year, and we are pleased. An increase of \$30,395.14 was reported. This is a 29.3% increase over last year. Receipts in the Co-operative fund exceeded our goal with a  $13\frac{1}{2}\%$  increase and totaled \$17.541.61. Designated receipts were \$12.853.53, an increase of 60%. Reporting Sunday School attendance increased from 2560 to 2928, a 14.4% increase. Membership was up from 3294 to 3509, a  $6\frac{1}{2}\%$  increase. Number reported saved was 361 as compared to 360 last year. NEWSLETTER and Promotion Fund increased to \$1,596.69 or 18%.

NEWSLETTERS numbered 124 to 135 were distributed in a new format. These are well received among the churches and we hope this continues.

We drove 6188 miles and traveled to many services up north by train and plane. 79 promotion visits were made.

The mission at Peoria is doing well. One new church was organized at Gurnee and there is another mission near Joliet. Some other boards have not functioned as well as the Home Mission Board.

We see some difficulty in the year or years ahead over the basic philosophy of the place and work of the minister and the church in relation to such organizations as the National Association of Evangelicals and to such people as Billy Graham, etc. I hope the conflict will not split us.

Ordinary business transacted. The board decided to give 2 weeks vacation per year to Missionary, board to be notified a minimum of 20 days in advance, so the proper person could be chosen to fill in at church.

Talked to Rev. Dale Palmer in regard to Galesburg, Illinois.

Decided to place announcement in the local paper in regard to a Sunday School there. To date have received letters from two families.

In all it has been a great year. God has been very gracious, always leading the way.

The Mission hopes to organize in the near future and when they do the property will be transferred to their trustees. It is now in the name of Illinois Free Will Baptist Association.

The Mission held a Vacation Bible School which was highly successful.

We would like for the churches of the State to continue to support the cause of Home Missions, the 500 Club, the Co-op and through special offerings.

We close with thankful hearts for all who gave in the special drive last November and other gifts we — 32 — have received. We pray we have used God's money well and that many souls will be saved through works started by the Home Missions effort.
