ILLINOIS FOREIGN MISSION BOARD REPORT

The Foreign Mission Board challenged the churches in the State Association to pay Dr. Miley's rent and Utilities while in New York going to school. Dr. Miley was not receiving a salary and we felt he should be helped in some way.

Our goal was to send him \$300.00 a month from January to August of this year. In June of this year, Dr. Miley wrote to us and asked that we channel our giving to someone else, since

he was now getting his room and board free.

At this time, we are asking our churches to continue giving on a monthly basis as they have been nd give this money to the Fred Hersey account. The Hersey's need to be back in Japan by September 1 and are in need of our support.

We are also sponsoring a CALL-A-THON for the Herseys -

August 22 of this year.

Our churches responded greatly to the Miley need and we thank them for their response. We are looking ahead with great expectation in what we will receive for the Herseys.

REPORT NO. 4

Illinois State Association of Free Will Baptists SUNDAY SCHOOL BOARD

Yearly report to the State Executive Board meeting on June 8, 1976.

The State Sunday School Board met and organized during the State Association on June 20, 1975 with James O'Dell chairman, Guy Terry treasurer, and David Turner as board member.

The next meeting of the Sunday School Board was on August 20, 1975 to discuss plans for future activities. Such activities included at that time:

 The discontinuing of Enlargement Campaigns as in the past due to a lack of interest.

2. The setting up of Sunday School Revivals with Keith Kenemer as the Evangelist.

3. The planning of a Teachers & Officers Seminar in conjunction with the Sunday School Alliance.

The Sunday School Board met again on October 18, 1975 to discuss further the Sunday School Revival and the Teachers & Officers Seminar. At that meeting it was decided to mail notices of the Sunday School Revival to Sunday Schools throughout the State in order to create more interest. Also, the Teachers & Officers Seminar was discussed with the dates of 14-16 being set.

The Board met for the final time on January 22, 1976. Following are the results of that meeting:

1. The Sunday School Revival effort with Keith Kenemer was cancelled by Bro. Kenemer.

2. The Board decided to conduct a 'Year-Long' Sunday School Enlargement Campaign beginning on March 7, 1976 and ending February 27, 1977, with Quarterly Reports from the participating Sunday Schools being published in the Newsletter. The basis of the Campaign being the average attendance for March 2, 1975 through February 29, 1976. The Sunday School having the greatest percentage of increase will be the winner. The pastor of the winning church Sunday

School will be sponsored by the Sunday School Board on a

tour of the Holy Land sometime during 1977.

3. Due to the fact of this promotional campaign and because of the Laymans Board conducting 'Workers Conferences' it was decided to discontinue plans for a Teachers & Workers Seminar.

REPORT NO. 6

ANNUAL REPORT ILLINOIS HOME MISSION BOARD

June 8, 1976

This report concerns action taken and sponsored by your Home Missions Board. The board members are Larry Clyatt, chairman, Wallace Malone, Secretary & Treasurer, and members Wayne Martin, Jesse Heade, and Don Matthews. Bro. Don Matthews was appointed by the Executive Board in March 1976, to fill the vacancy of Gary Carstens.

Again this year our work has centered around missionary John Hollis and the mission in Kankakee, Illinois. We feel it is a blessing of God to have such a man with which to work, and we give thanks to God for the way he has used him during the

past year.

As I gather information to give you an over all picture of the progress in Kankakee, my heart thrilled within me. Look

with me at how God has blessed this past year.

This year has seen the need for faithful, knowledgeable works met. God provided by moving a brother of missionary Hollis from South Roxanna to Kankakee. Next, God moved a school mate of missionary Hollis from Detroit, Michigan to Kankakee. Both have been a real help to the work. I cannot doubt the work of God in these moves.

God's use of our state's people in the work is an item of praise. We remember the plea for rent funds that enabled the group to have its own facilities and proved to be a stepping stone to growth. About this time last year that fund was channeled toward the purchase and preparation of two vans. Now those vans are rolling and once more the funds have been designated to another cause. Now they are going into the building fund which totals nearly \$6000.00. This amount has been reached by a \$3400.00 gift from the state Woman's Auxiliary project and \$2600.00 raised by the mission itself including the continuing gifts from the people of the state.

Space to worship and teach more effectively has been provided. As an answer to prayer God moved on the heart of the rented building's owner and permission was given for the

people to use the entire building instead of only part.

Financially the work has been blessed. They have moved from the need of help to pay the rent to assuming its own responsibilities. These include rent, utilities, and the setting aside of a monthly amount to the building fund. In its efforts to become a self supporting church they have assumed a goodly amount of its pastor's salary, raising it three (3) times this year, while continuing to give to the Co-op and other causes such as missions. God has blessed them with increased income.

The greatest blessings have been spiritual. God has used them in the salvation of seventeen (17) souls this year. Of that number, eight (8) have followed the Lord in Baptism. As a result their attendance has nearly doubled since this time a year ago. We praise God with them.

During the year the board has also helped the First Church of Springfield and its pastor Bro. Dave McDaniel. We are helping in providing housing for Bro. McDaniel. This work also reports conversions, new members and increased giving.

It has been a good year.
