ANNUAL REPORT ILLINOIS HOME MISSION BOARD 1978

The members of your Illinois Home Mission Board are: Larry Clyatt, Chairman; Wallace Malone, Secretary Treasurer; Jesse Meade, Gene Norris and Galen Warren. We are grateful for the privilege to serve and yet mindful of the responsibility.

Again this year our chief concern has been centered around our two state missionaries and their missions: Rev. John Hollis in Kankakee, Ill.; and Rev. Jim Summerson in Milan. Ill. 1978 saw both of these works organized into regular Free Will Baptist churches.

The Milan, Ill. work was organized into Faith Free Will Baptist Church on February 26th. The Board was privileged to be present and to participate in the service. Thirty six (36) charter members were received. During 1978 the church reported twenty seven (27) conversions and twenty (20) baptisms.

September 10th was the date for the Kankakee, Ill. work to be organized into Unity Free Will Baptist Church. Again the Board was privileged to be present and to participate in the service. Unity received twenty five (25) charter members. Twelve (12) conversions and ten (10) baptisms were reported by the church during 1978.

In addition to their organization, the Faith Church purchased property through a bond issue, and the Unity Church did more remodeling to their building during the year. Both have lovely places in which to worship.

Another common denominator between our two missionaries in 1978 was that they both became the parents of sons. The Hollis's became parents on July 26th when Johnny Dow II was born. James Leslie joined two sisters in the Summerson family on October 31st. Congratulations.

In other activities during the year, the board served in an advisory capacity to a group seeking to start a church in Mounds, Ill. The group discontinued their efforts in the summer. The board also met with the congregation of the

First Church in Moline, Ill. in a similar capacity.

At times during the year finances faltered. However, God was faithful and used you, our Free Will Baptist people, to see us through. May God bless your faithfulness. Let's continue to start churches for Jesus through out our state.
