Our state quota for Foreign Missions as set by the National Association Foreign Missions Board for 1979 was \$80,000. The amount given by our churches and gifts from individuals was \$62,176.04. Our largest single contribution in 1979 was to the Dennis Owens Fund...this amounted to \$9,192.74.

The churches of the State of Illinois are to be commended for their giving to Foreign Missions.

Our State Quota for 1980 is \$73,000. With 42 churches recorded in our Denominational Minutes, we could reach this quota if each church gave \$1,738.10 in 1980...Or \$144.84 per month.

ILLINOIS STATE BOARD OF CHRISTIAN EDUCATION REPORT

The State Christian Education Board had proposed to sponsor Special Study Seminars during the 1979 calendar year. These seminars were to be designed with the local church and pastor in view. However, the Board received no

requests for the program during the past year.

The major functions of this Board at the present time concern the Student Loan Fund. (Attached is a financial statement.) This year some changes were made in the administration of this fund. A loan of \$500.00 is now possible for a first semester student, \$750.00 for a second semester student, and \$1,000 for a third semester or above student. In addition to these financial modifications, the maximum indebtedness allowed was increased to \$2,250.00. Information has been given to Free Will Baptist Bible College concerning this loan, and it will be listed in the upcoming catalog. These changes were deemed necessary due to the escalation in educational expenses.

As to future plans, the feasibility of a Bible Institute is being investigated. The type program, instructors, and the possible location will continue to be under consideration.
