REPORT NO. 2 REPORT OF THE EXECUTIVE BOARD OF THE ILLINOIS STATE ASSOCIATION OF FREE WILL BAPTISTS

ORGANIZATIONAL MEETING, MARCH 29, 1980:

The Executive Board was organized with John Hollis, chairman; David Burgess, vice-chairman; Ed Shrum, clerk; Larry Clyatt, Home Missions Board chairman; Ken Elkins representing the Northern District; Joey Murphy of the East Central District; Ivan Ryan of the South Central District; Everett Martin, West Central District; Ken Rogers, North Central District; David Shores, treasurer. There were not enough members of the C.T.S. Board, the Christian Education Board, the Layman's Board, and the Foreign Missions Board to properly organize so the chairman of each board could serve on the Executive Board. It was voted to meet at the First Free Will Baptist Church of Decatur on May 2, 1980 at 7:30 p.m.

Board concerning his actions. If his response is negative that he be removed from the C.T.S. Board. The moderator appointed Randal Steelman, co-ordinator, David Burgess, and Wallace Malone....Motion sustained that the mailing permit fee be paid out of the General Fund....Motion sustained that the Association purchase a typewriter for the editor of the Newsletter.... Motion sustained to sell old Olympia typewriter to Gene Norris for \$35.00....Motion sustained that the Executive Board recommend that each District elect their own representative to the Executive Board....Motion sustained to adjourn.

Report of the committee to investigate the feasibiliby of appointing the nominating committee and nominations being made prior to the State Associational meeting was given. Motion sustained that the Executive Board recommend that the following change be made to Article II (Committees) of the By Laws of the Illinois State Association of Free Will Baptists by adding, "Section 4. Nominating Committee. The Nominating Committee, consisting of three (3) members, shall be elected

Most of our work during 1980 has been related to fulfilling that part of our constitutional duties which states, "... and assist in keeping established churches open." In January 1980 we granted the request of the First Free Will Baptist Church in Granite City, Illinois, to help them secure and support a full time pastor. Since June 1980 we have been assisting said church and its pastor, Rev. Owen Ganey. Reports of progress are coming from that work.

1981 finds us ready to open another Free Will Baptist Church in Illinois. Contacts were begun in December 1980, but the details were not worked out until January 1981 concerning the appointment of veteran home missionary, Rev. John Hollis, to begin a church in Effingham, Illinois. Pray for this endeavor, and, if possible, have Bro. Hollis in your church. Services should begin in Effingham, Illinois, this spring.
