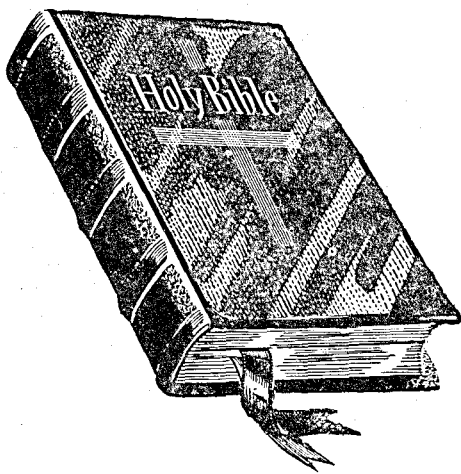

REPORT NO. 2

PARTIAL REPORT OF THE BUSINESS COMMITTEE

Motion was sustained to adopt the report and to consider item by item.

Item 1. We recommend a committee be formed to study the feasibility of having a presbytery to determine which ministers will receive a card of good standing and/or examine ministerial problems that may occur throughout the year.

Motion sustained to adopt Item 1.

Item 2. We recommend a rising vote of thanks be given to the Woman's Auxiliary of the First Free Will Baptist Church of Mt. Vernon who cheerfully served us a delicious lunch.

Motion sustained to adopt Item 2.

Item 3. We recommend that a \$100 be given to the Sunday School Alliance toward the cost of utilities.

Motion sustained to adopt Item 3.

Item 4. We recommend our moderator, Loyd Crain, receive an honorarium of \$100.

Motion sustained to adopt Item 4.

Item 5. We recommend an honorarium of \$50 be given to each one of our local scheduled speakers.

Item 6. We recommend this State Association give \$75 to each delegate toward his expenses to the National Association.

REPORT NO. 3

REPORT OF THE PROMOTIONAL SECRETARY

1984 opened with plans being made for a Free Will Baptist Bible College Day for our state. The day was set for March 25th and several churches participated and raised over \$6,000 for the college. It was a good project for the State Association and the churches reported good services in most cases.

There were 20 pastoral changes during the year. This problem seems to persist in spite of efforts to stabilize the situation. One of the things I have noticed this past year is a growing discouragement in our churches concerning the work of the pastor. Our people are disheartened because of the short terms and, in some cases, the immaturity of our pastoral leaders. We must produce a growing, stable, mature leadership role for our pastors or face even worse consequences in the very near future. This should be a matter of prayer throughout the State Association.

At the present time, there are eight churches seeking a pastor . . . and a list in my office lists about 60 pastors seeking churches. The problem? Many of our churches simply cannot pay the salary of a full-time pastor, and many of the men simply will not accept a church where they will have to supplement their income with other employment. As long as this situation exists, we will continue to feel the effects of discouragement.

The mission church at Effingham, Crossroads Church, is doing well . . . and the new church in Salem, Calvary Church, is off to a good start. The people of Illinois are to be commended for their generous support of both churches. It would be impossible to build new churches without this help. We are in the process of losing two churches to other denominations, but several of our churches have recorded gains in baptisms, membership and attendance. For this we are thankful.

Our total giving this year was highest in history. We received through the State Treasurer's Office a total of \$156,590.88 which is up over \$4,000.00 from last year. Our Co-Op giving was up another \$2,500.00 which brought it close to \$50,000.00. You will be able to get all the exact figures on the Treasurer's Report included in this report packet. In addition to the Bible College Day, other promotions included several Missionary Conferences, a tour of the Bible College Quartet, and taking up the cause to pay the medical expenses incurred by Brother Jerry Presley. As most of you realize, Brother Presley was left with his indebtedness after our medical insurance program underwriters defaulted. The people of Illinois responded with their hearts and that \$24,000.00 bill has been settled. Thank you!

Because of so many promotional fund raisers, the

Promotional Fund did not carry itself this past year. I did not turn in any mileage expenses, food expenses or hotel expenses last year and do not intend to, however I feel it is time to pay attention to the needs of this office. Churches should support the Co-Op Program of Illinois, and those who do not are missing out on a special ministry. The Co-Op Program allocations are set by the people of this Association. Churches who do not support this program are not giving one cent to all the work that goes on through this office, nor to the distribution of the Newsletter. Of the 46 churches affiliated with this State Association, only 27 support this work. Out of the Co-Op Program comes money for building new churches in Illinois, support of the Bible College Loan Fund, Newsletter, etc. All allocations are listed for your personal information in this report packet.

Co-operation is the key work for progress in the Lord's work in Illinois. We must get together on our pastoral outlook, our church programs, our missions outreach, our youth camp program, our financial program and in every other area of the work that is necessary to the building of the Kingdom of God. We are now in our 25th year as a State Association. It would be a shame if, after another 25 years, we have made no more progress than we have in the past. Let's get together and show the world, "how good and how pleasant it is for brethren to dwell together in unity." (Ps. 133:1)

In closing, let me thank all of you for the privilege to serve in this office. I attended 9 of the 12 quarterly meetings this year, visited and preached in some of the Free Will Baptist Churches not members of this State Association, and spent hours talking with pastors and church board members about their churches... and practically everyone I talked with wants to accomplish the same thing: build a church to the glory of God. This can be done if we will establish some attitudes for growth, then carry out the work that must be done.

REPORT NO. 7

REPORT OF THE STATE MISSIONS BOARD

The Board of Missions met 5 times during the past year (1984). The business of the board consisted mostly of working with the two mission projects now operating in Effingham and Salem, IL and checking on some of our older established churches that are having difficulties because of loss of membership and the economic situation in the areas, making it almost impossible for them to operate.

The Effingham mission under the leadership of missionary Hollis and family, was officially organized as a church May 20, 1984, adopting the name "Crossroads Free Will Baptist Church" electing their own Pastor and officers. They are still under the care of the Missions Board until some projects that were started

are completed.

Missionary Hollis, his family and people are to be commended for the establishing of this fine work in the city of Effingham. Missionary Hollis will speak to us further about this work during this association meeting.

The month of June marked the beginning of a new mission work in Salem, IL. Missionary Donoho and his family moved to Salem in May of 1984, and immediately began visiting and advertising the new mission church location. Services began in their home, but they were soon able to obtain a vacated church building in a very good location. This mission church is growing and Missionary Donoho will bring us up to date concerning the work at this association meeting.

The board is still helping the First of Moline, IL. Contacts have been made, and others will follow to determine what can be done to salvage this work, together with other work in this area.

Many thanks to our churches and people in our state, who so faithfully support our mission work, both home and foreign. Our churches and people have a vision of the future, and a mind to work. God is blessing their efforts.

The missions giving for 1984, from our churches and people could be called astronomical --!

To foreign missions -- \$69,232.96 -- an increase over last year of almost \$1,800.00

To home missions -- \$57,348.15 -- an increase over last year of almost \$10,750.00

We are hoping and praying that 1985, will be the greatest of all, if the Lord tarries, for missions giving from our churches and people.

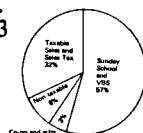
