# REPORT NO. 3

# **REPORT OF THE PROMOTIONAL SECRETARY**

My last year's report began with an introduction to the two major national projects: The Advance Celebration for Foreign Missions, and Project 90, a program of growth for the churches of our denomination. The Board of Missions will report on the progress of The Advance Celebration and how we are reaching our goal of \$45,000...and each one of us, both church and pastor, will report on our efforts in the Project 90. Each pastor and church must become aware that for the goal of 50,000 new Free Will Baptists by 1990 to be reached, ALL must show an increase! Information for this project is available to everyone who will contact me.

The Illinois Newsletter has a new look — and the new look has created renewed interest in the publication. We would like to share the news of all our churches, but each church must get a reporter to send the letters in each month. Photographs can now be used if you will send \$3.00 to cover the added cost of having it printed. Many of our churches are doing exciting things for the Lord, why not share it with the rest of us? Perhaps your excitement will cause others to want to increase their zeal.

We now have a computer on which we can list all our people who are receiving the Newsletter. In time past, the local high school has printed and furnished the mailing labels for us. Even though this is very much appreciated, it is our responsibility to do the work and absorb the cost. Your church can help in this area also. The cost of paper, printing and mailing each Newsletter is about 14¢, and now the cost of labels will add another penny — and that brings the annual cost for each Newsletter to about \$1.80. If each church could budget \$10.00 per month for this work, it would underwrite almost the entire expense of the promotional office.

Here are some things we need to work on: our giving is down from last year, we have had some churches to close during the year (The First Church of Niantic and People's Church of Justice are no longer in our State Association), only 50% of our churches support any phase of our state work, the change of pastors continues to plague us, and some of our smaller churches have problems of getting a pastor.

We can rejoice in the fact that people are still being saved and baptized in our churches, and young men are still being called to preach the gospel. This week, four young men contacted me about the availability of churches in our state — it is encouraging to me that men still want to serve in this ministry. This has been a good year for me to get better acquainted with pastors and churches of the Free Will Baptist faith who are not associated with our state work, men who also love the Lord, men I hope will soon join with us in state and national cooperation. The group of preachers within driving distance of the youth camp meet once a month for breakfast and fellowship. What a blessing it would be for all areas of our state to do the same.

Also included with my report is a 1987 Calendar of Events for the Illinois State Association and a copy of the results of the survey taken to study the Pastor's Tenure.

Let us pray for increased love, unity and cooperation as we serve the Lord locally and as a State Association.

#### -Report of the Pastor's Tenure Committeeto the Illinois State Executive Board

A questionaire was mailed or given to each church or pastor in our Illinois State Association with instructions to have it distributed among the members and the results were to be sent to the Committee to compile and report to the State Executive Board.

Of the 46 churches receiving the report, 50%, or 23, responded by sending their report to us.

We have done the best we can to determine the percentage of answers given on the 16 questions contained in the report.

Those answers receiving the highest percentage as listed...followed by those receiving lesser percentage points. As the questions were followed by a number of answers, we listed those in order of highest percentages.

Example: The answer to Question Number 1 was a 71% response that pastors should have an indefinite call at the church he serves. The other three answers were about equal in the response, so only the first answer is listed as being of any value as far as this survey is concerned.

We hope this survey will, in some way, be of help to both the churches and pastors of this State Association.

# PARTIAL REPORT OF THE BUSINESS COMMITTEE Item #1

March 27, 1987

I, Rev. Max Courtney, pastor of the Alexander Free Will Baptist Church of Thebes, Illinois, a member in good standing of the South Central Illinois Association of Free Will Baptists and of the Illinois State Association of Free Will Baptists, do hereby submit the following resolution for your consideration:

- Whereas; Article VII of The Constitution of the Illinois State Association of Free Will Baptists states: "This association shall be actively affiliated with 'The National Association of the Original Free Will Baptists of the United States,' and shall make no regulations repugnant to that body." [Emphasis mine]; and
- Whereas; Article V Section 1, A, 1 and all of Article XII of the Constitution of the Illinois State Association of Free Will Baptists do, in fact, conflict with the stated practices of said body; and
- Whereas; In the Treatise of the Faith and Practices of the Original Free Will Baptists in Part III under "The Practices of Free Will Baptists" Chapter II Section I Paragraph B it states: "Free Will Baptist Churches, in most areas, have traditionally *delegated* this authority to the associations in which they voluntarily unite themselves..." and in Paragraph E, 1 of that same Article it states: "He is examined by the local association's ordaining committee..." and in Paragraph E, 3 of that same Article it states: "His ordination credentials may then be 'ratified' by the association upon recommendation of the ordaining council"; and
- Whereas: In Part III of the Treatise of the Faith and Practices of the Original Free Will Baptists under 'The Practices of Free Will Baptists' Chapter II Section II Paragraphs A and B; "As in the case of ordination, the authority to discipline a minister has its source in the authority of the local church. Again, however, this is *delegated* to the association along with the authority to ordain. In most cases, any accusation against a minister that is offered concerning his conduct. character, profession, or doctrine (and which should be considered against his good standing), should be brought to the association by the local church. [Emphasis mine] The only exception that should be made arises when an offense involves a fellow minister (as object or witness) in asituation unknown to the local church. In this case, charges should be preferred by three ministers jointly, with the local church fully apprised of the fact." and Paragraph E. 3: "The association's discipline cannot deal with the minister's relationship to the local church, either as pastor or member. It can make recommendations concerning this to the local church, and the church's fellowship in the association might be endangered if those recommendations were not followed, but no force can be applied." and Paragraph G: "The minister who feels he has not been justly treated may, in union with at least one other

sustaining minister, appeal to the next broader organization of WHICH HIS DISTRICT ASSOCIATION IS A MEM-BER (such as the state association) [Emphasis mine] for a hearing among the sister associations. The nature of the broader organization's powers in such a case is described in Chapter Three: Associations of Churches'', all make it quite clear that the Licening, Ordaining, setting of qualifications for receiving, Licening and Ordaining as well as the disciplining of ministers is to be the duty of the Local or District Associations of a State Association; and

- Whereas; Article XII of the Constitution of the Illinois State Association of Free Will Baptists does not grant the District Associations which are members of the Illinois State Association the privileges granted them by the Treatise of the Faith and Practices of the Original Free Will Baptists as set forth in the foregoing Articles quoted; and
- Whereas; All the District Associations have set forth in their Constitutions and By-Laws their qualifications for receiving, licening, ordaining and disciplining of ministers; and
- Whereas; The Treatise of the Faith and Practices of the Original Free Will Baptists in Section II Paragraphs A through G of The Practices of Free Will Baptists grants the State Associations as well as District Associations, local Churches, and three ministers of any District or State Association belonging to the National Association the right to discipline a minister for violation of conduct, character, profession or doctrine;
- Be It Therefore Resolved; That we strike all the following from the Constitution of the Illinois State Association of Free Will Baptists to bring said Constitution into compliance with the Treatise of the Faith and Practices of the Original Free Will Baptists:
  - (1) The words: "...from this association." from Article V Section 1, A, 1; and
  - (2) All of Article XII.
- NOTE: This action will place the responsibility of setting the qualifications for and receiving, licening, ordaining and disciplining of ministers as well as the issuance of cards of good standing for ministers annually as prescribed in the hands of the District Associations that are members of the Illinois State Associations of Free Will Baptists as it is recommended by the Treatise of the Faith and Practices of the Original Free Will Baptists.
- FURTHER NOTE: Every State Association affiliated with the National Association of Free Will Baptists except the

Illinois State Association of Free Will Baptists now follow this procedure. Not only will this action place the Illinois State Association in compliance with the National Association Treatise but will align it with all other State Associations that are members of the National Association.

#### REPORT NO. 9 THE REPORT OF THE CAMP BOARD CAMP BOARD REPORT 1986

The Camp Board met seven times in 1986 to handle camp business. Some board members, due to the lack of a resident camp manager during the first part of the year, spent many hours at the camp doing maintenance work and preparation for youth camp. The following is a summary of the activities and improvements at Camp Hope:

#### I. Activities during 1986

- 1. **1986 Youth Camp:** Total attendance was approximately 330 (240 campers), 24 campers made first-time decisions for salvation. The entire camp staff is to be commended for the hard work and cooperation that resulted in a smoothly run camp.
- 2. Camp Reunion Retreat: September 26-27, 1986, about 100 attended services. Over \$300.00 was raised for Camp Development Project (see below).
- 3. Winter Youth Retreat: December 29-31, 1986, 55 teens from 12 churches attended. Jeff Stegall and Sarah Malone led the services.

# II. Improvements to the facility completed in 1986

- 1. Gravel walkways between buildings (1985-86 Development Project)
- 2. Playground equipment (swing sets and see-saws)\*
- 3. Maintenance and repairs to manager's house
- 4. Second study shelter built near auditorium\*
- 5. Brush cleared in area of campsites and dozer work done near lagoon\*
- 6. Miscellaneous repairs and minor improvements

Items marked with \* were done with individual contributions at no cost to the camp board.

III. Other Camp Board action in 1986

- 1. Camper Pads and Hookups: 8 trailer/RV pads with electrical connections and a dump station are planned to be constructed soon. The Camp Meeting Association (Adult Camp) donated \$1,000.00 for this project and the Camp Board has received approval from the state authorities (Springfield). Campsites will be located east of auditorium and girls' dorm under the trees next to ballfields.
- 2. Season of Hope: A quarterly camp newsletter began publication and is sent to pastors, campers, camp workers, and others interested in our camp.
- 3. 1986-87 Camp Development Project: The board set up a "Tractor Fund" as this year's development project. A special offering was received at the Youth Camp Reunion. Funds collected will go toward purchasing a good used tractor for use at the camp.
- 4. New Youth Camp Director: Larry Clyatt was selected by the camp board to serve as General Director of the 1987 Youth Camps. Board action also permanently made the Camp Director an ex officio member of the board.
- 5. New Camp Manager (Caretaker): Keith Fletcher assumed responsibilities October 1 as Camp Manager. As well as serving as caretaker, the manager has been taking on camp promotional roles such as publishing camp materials (newsletters, brochures, etc.).

#### Report No. 13

#### THE REPORT OF THE STATE MISSIONS BOARD

The Board of Missions met six times during the year.

This year of 1986 has been an enjoyable year for the Mission Board. We have seen great strides of improvement in our work at Salem, IL under the leadership of missionary Donoho. The mission church (Calvary) in consultation with the Mission Board purchased 13.6 acres of choice property located on Highway 37 South, known as the Cluster Drive-In Theater property, for \$32,500. The mission church raised the down payment of \$10,500 and are assuming the monthly payments on the balance.

Missionary Donoho, his family and congregation are to be commended for their unselfish labor in establishing this work, and the growth of their people both spiritually and numerically.

The work at Effingham (Crossroads Church) has been one of miracles. This work was started about five years ago by our missionary, John Hollis. The Free Will Baptist churches and people of this state are to be highly commended for their faithful support to missionary Hollis, his family and this work.

What a wonderful privilege we have to be holding this twenty-fifth annual meeting of the Illinois State Association of Free Will Baptists in these very lovely facilities.

The Board, in it's meeting, January 23, 1987, after much prayer and discussion, made definite plans to phase-out mission support for missionary Hollis beginning in April and concluding December 31, 1987. We would urge our churches and people to pray for and continue to support missionary Hollis throughout this year.

As the Board looks to future work, it agreed to give priority consideration to the Chicago, Urbana, Champaign and Bloomington areas for the establishing of mission work and that plans be implemeted as soon as feasible. We call upon our Free Will Baptist Churches and people of Illinois to give special prayer support to these future plans. Funds may be designated now to assure the success of this future venture.

Furthermore, since the State Association last year, ask the Board of Missions to help in sponsoring the Foreign Missions project "Advance Celebration" for the next three (3) years in an attempt to raise \$1,000,000.00 across the denomination, we, the Board, urge you to join us in making a commitment to give generously and sacrificially to this worthy program. Our State Association, in it's 1986 session, set a goal of \$45,000.00 to be raised by our churches and people over the next three (3) years. We plead with you to help us in getting every church and individual involved in this great task.

Our state missions giving for 1986 was somewhat less than last year, which seems to have been the trend nationally, in both Home and Foreign Mission Departments. To Foreign Missions...\$87,661.83. To Home Missions...\$39,555.68 making a total of \$127,217.51.

The Board includes in this report the set of guidelines it has adopted to guide it's work.

#### GUIDELINES FOR THE BOARD OF MISSIONS OF THE ILLINOIS STATE ASSOCIATION OF FREE WILL BAPTISTS

Name: This Board shall be known as the Board of Missions of the Illinois State Association of Free Will Baptists.

**Purpose:** It shall be the purpose of this board in cooperation with the Illinois State Association of Free Will Baptists to promote missions both Home and Foreign in the Free Will Baptist churches in the state of Illinois.

**Organization:** The Board of Missions shall operate under the direction of the Illinois State Association of Free Will Baptist. It shall be composed of persons elected in accordance to the constitution of said association. The board shall elect its own chairman and secretary/treasurer.

#### **Operation and Duties:**

1. Meetings of the Board-The Board shall meet twice yearly and at other times as is deemed necessary at the call of the chairman. Three members shall constitute a quorum, providing all members have been duly notified.

2. The chairman will provide an agenda for board meetings and preside over the board sessions.

3. The secretary/treasurer shall keep minutes of all board meetings and provide copies for board members. The treasurer shall receive all monies and disburse funds as directed by the board. Financial reports are to be given at each board meeting and an annual report prepared for the State Association.

4. The Board shall prepare a proposed annual budget to present to the State Association.

5. Official correspondence of the Board shall bear the signature of either the chairman or the secretary/treasurer. The Board shall authorize the chairman and secretary/treasurer to sign all legal documents.

6. The Board will sponsor missionary conferences in local churches, district associations, and arrange itineraries for both state and national missionaries. It shall also seek out locations

(areas) in our state in consultation with local pastors and other church leaders in the areas to establish mission work. it shall work with the National Home Mission Board in joint projects as it deems advisable to do so.

7. The Board will be responsible for employing persons who meet required qualifications as specified in questionaire and application form. The Board will provide personnel with job description and make contractural agreement with said parties.

8. The Board shall rent, lease or purchase properties and other equipment and supplies as necessary for the operation of mission work in a given area. The Board must use discretion in obligating itself. The Board shall hold title to all properties and equipment unless otherwise agreen upon, until the mission becomes self supporting.

9. The board will periodically review the ministry of the missionary and progress of the mission church. It will advise and help the missionary and the church in future planning.


