REPORT OF THE PROMOTIONAL SECRETARY

1991 was a good year for our State Association financially. We are in the second year of our aim to increase the work and giving in Illinois. Each board set a budget and goals they hope to reach by 1995. We'll have reports from each of the boards to see

It is an honor and great responsibility to serve on the Illinois Mission Board. We appreciate men who give of themselves (time, prayer, heart, concern) to serve on this board. We have had meetings in Effingham, Chicago, Springfield, Bloomington, Ewing, and Salem this year. We appreciate so very much the missionaries (Burgess', Potete's, Scott's) serving in Illinois.

We now have four projects, more than ever before. Many souls weigh in the balance. The four projects can be categorized as: "Project Near Complete" (Calvary - Salem); "Project Establish" (Bloomington - Normal); "Project Beginning" (Chicago); and "Project Rescue - Rebirth" (Springfield).

The "mission" aspect of the Calvary Mission - Church of Salem is nearing completion. With the missionary resignation and replacement, we faced a potential setback. Upon a request from the Calvary Mission - Church, a six month's extension of phase-out support has been approved. The target for self-support has been set for fall of 1992.

The Home Mission field of Bloomington - Normal is seeing long-awaited progress. We celebrate with Brother Burgess to see the seed take root and bear fruit. The beautiful facilities have been enhanced in appearance and function by pews. These pews have been provided by a loan from Brother Potete. The pews have been in storage (at Immanuel Free Will Baptist Church, Joliet) donated to Brother Potete by Hope Chapel Free Will Baptist Church. The Illinois Mission Board is so appreciative for the donation. We are grateful for the willingness of Brother Potete to allow the Bloomington - Normal Mission to use this fine furniture.

The "Beginning Project" is in Chicago (Brother Potete). This Mission - Church (Northwest Free Will Baptist Church) is meeting in the missionary's home. Disappointment came after expectations were very high, thinking we had secured a meeting place for the infant church. This is a major need and concern.

The "Rescue - Rebirth Project" is in our State Capital. The four remaining members voted to turn the ministry and facilities of the First Free Will Baptist Church over to the Illinois Mission Board. The spirit and intent was and is that a progressive, growing, soul-winning Free Will Baptist Church be established in Springfield. We want to utilize the facilities (debt free) to revive the Free Will Baptist witness of Christ in our Capital City. This is a great task, challenge, and opportunity for this board and for Illinois Free Will Baptists. This board is determined not to surrender this ground to the forces opposed to a Biblepreaching, teaching, living Free Will Baptist Church. Help us keep the Free Will Baptist fire buring in this needy city. Accept the challenge to pray, work, give, care, so that the Free Will Baptist Church doors are not closed in Springfield. Beloved, do not turn your backs and accept defeat! Satan envisions a deserted, decaying effort in Springfield. Let us have a mind to work. Let us revive the work and rebuild "walls"!

At the time of writing this report, the Teagues account was \$5400.00 in the red (down from \$8000.00) and the Owens account reflected a \$700.00 negative balance (had some \$15,000.00 come into account in December). We ask you to pray. We encourage special offerings for these missionaries. For the long term we need individuals and churches to add and/or increase regular financial support for these faithful Illinois Free Will Baptist missionaries. Share in the helping and the harvest of these mission fields.

Pray for your Illinois Mission Board to be led by God. We need great wisdom. Your support and God's direction and blessing is imperative. Whether they realize it or not, a multitude of souls are depending on Illinois Free Will Baptists to reach them with the gospel. We have a great responsibility and opportunity to establish and maintain vibrant fundamental churches in this great state. We have the message. 2. S.A.M. Program The Summer Assistance Ministry program provided two FWBBC students to work during each week of camp and to complete some maintenance projects during open weeks. The Camp Board funded first-aid and lifeguard courses for them. Each student was given a \$1,000 scholarship toward their college tuition.

3. Winter Youth Retreat Our December retreat was directed by Brother Randy Fosse. A total of 85 campers registered with

19 workers. Illinois youth were utilized as speakers.

II. MAINTENANCE AND IMPROVEMENTS TO THE FACILITY

1. New Bed Construction - Steel has been purchased and frames welded to construct new dorm beds. 8 bunks were assembled during Senior High Camp due to the crowd, but lack of finances and volunteer labor have hindered the completion of the planned 30 new bunks.

2. Girls' shower room renovation - The showers in the girls' dorm had to be remodeled to provide better drains, include

privacy dressing booths, and correct a leakage problem.

Matress replacement - We acquired many new mattresses to replace the old cloth-covered dormitory mattresses.

4. New apartment beds - Thanks to special donations from the Woman's Auxiliary, the board purchased new beds and bedding for two bedrooms of the missionary apartment. A fund

was also started to replace furniture in the living room.

5. Renovations to Manager's dwelling - The Camp Board received \$2,500 from the State General Fund to assist in remodeling the camp manager's house. Guttering and a new porch/deck at the back door were needed on the outside. New floor coverings, some sub-floor replacement, remodeling in the utility room, and complete painting were necessary inside.

6. Purchased answering machine - An answering machine was

purchased for the camp's business line.

III. BUSINESS TRANSACTED BY THE BOARD

1. Manager's Job Description - A complete job description for the camp manager was drawn up and adopted with a new compensation package.
