**MINUTES OF THE THIRTY-FIFTH ANNUAL  
MEETING OF THE ILLINOIS STATE ASSOCIATION  
OF FREE WILL BAPTISTS**

**MARCH 17, 1995  
FRIDAY MORNING SESSION**

The 1995 State Association meeting was hosted by the Immanuel Free Will Baptist Church of Joliet. ### REPORT OF THE PROMOTIONAL SECRETARY

The past two years my report has contained an outline of the new stewardship program, "The Together Way". This plan, which is now in its second year, incorporates both methods of giving used by our Illinois churches: cooperative giving and designated giving. Included in this plan are four annual special offerings, designated to the various National Departments:

April: Foreign Missions Month

September: Rest of the Family Month

November: Home Missions Month

December: Free Will Baptist Bible College Month

Churches and pastors should continue to become more informed about this new program. Success depends on an informed denomination. Materials are available from our National Offices in Antioch, Tennessee.

Our Co-Op giving was up this year by almost \$13,000.00 (\$93,358.73 in 1994 as compared to \$80,968.62 in 1993). The churches are to be commended for their faithful giving. Some areas of Illinois have been "economically hindered" this past year, so we are very appreciative of your support. Also, our thanks go to those who responded to the times we asked for a special offering: SAM workers, Team '94, new stove for Camp Hope, etc. Thanks for everything.

One of our churches, which had not functioned for several years, sold its building and gave over \$11,000.00 to Camp Hope. Our thanks to the members of the Friendship FWB Church of Mt. Vernon who were so generous. Another church, located in the Chicago area, has contacted the State Association concerning transferring title of property to this body. This building has not been used as a Free Will Baptist Church for several years. We hope to receive some benefit from this transaction.

Also, included in this report is a Newsletter Supplement listing news which was not printed in the February/March issue. A note concerning the Brotherhood Mutual Insurance Company is also available, plus an informational sheet from "Life Line", a long distance carrier for your telephone service. This office is not to be an endorser for services or products, but due to recent inquiries this information is available.

This year we have had several changes in churches and pastors. Recently, Brother Ivan Ryan, Brother Roger Bennett, Brother Ed Hollis, Brother James Barlow, and Brother Dan Martin resigned their pastorates. Pray for guidance as the Calvary Church, First Church of Decatur, the Moline Church, and Waltonville Church seek a pastor. We welcome Brother Carl Miller (Bakerville Church), Brother Tracy Kerr (Mascoutah Church), Brother William Crank (Bethel Church) and Brother Ron Jones (Rock Springs Church) to Illinois. Brother Rodney Mellott (Salem Church) and Brother Jim Walker (Camp Hope) began in their new positions this year.

In closing, let me encourage you and your church to help young people from our state who are involved in one of the missions projects. Team '95 will be traveling to France and Mexico, summer missionaries will be going to other countries, still others will be involved in such activities as those sponsored by ELIC. Let's help these young people as they seek direction in their lives.

Thank you again for allowing me to serve in this position. It is both a privilege and an honor to be part of the Free Will Baptist Family of Illinois.

The Board met two times during 1994. The meetings were held at Hazel Dell Church.

We made six student loans totalling \$4,750.00. This is a decrease from the eleven loans in 1993. We also reimbursed students \$1,390.50 for 1st semester books compared to \$2,083.98 in 1993. We praise the Lord for the supplying of funds to do so.

Loan payments increased in 1994. We received \$8,887.50 in 1994 compared to \$6,086.06 in 1993 and \$2,916.40 in 1992. There were four loans paid in full. We thank the Lord for those who made payments on their loans during 1994. Because of their response, we are still able to help other students go to Bible College to seek

God's will for their lives. The CEB voted to donate the \$5,000 in bonds, held by the State Associations Treasury, to help the Camp Board pay for the re-roofing of the multipurpose building at Camp Hope.

The defaulted loan amount has slightly decreased (even with 2 more loans being moved into this category) from \$14,492 to \$13,882. Of the \$13,882 in the defaulted category, \$2,958 in loans are currently being paid on. The remainder of the defaulted loans are listed as follows: A \$1,270 loan holder has declared bankruptcy. A \$1,152 loan holder cannot be located. Two other loan holders, who borrowed a total of \$5,654 (eighteen years ago) are currently not making payments and have made no attempts to make steady, if any, payments even after personal contact by CEB members.

Student loans have decreased during the past year. The good standing loans amount has increased dramatically. This is due to the new loan rules and interest rates.

Randy Corn resigned from the board this year after leaving the state.

Jason Scott received a scholarship payment from the CEB this past year. We have three students presently at the Bible College with a pastoral/ministerial major. Applications will be mailed to these three students to see if they qualify for a scholarship. We are thankful for the increase in pastoral/ministerial majors from Illinois.

The Camp Board met seven times during 1994 to oversee camp programs and to care for the maintenance and development of the campground property. The following is a summary of the board's actions and activities throughout 1994.

**I. PROGRAMS IMPLEMENTED AT CAMP HOPE.**

1. 1994 YOUTH CAMPS - Registration figures for each week are shown below:

Leadership Camp .....	23
Primary (3rd-4th) Camp .....	59
Freshman-Sophomore Camp .....	50
Northern Illinois Camp .....	45
Junior (5th-6th) Camp .....	87
Junior High (7th-8th) Camp .....	68

We praise God for the 40 recorded first-time decisions during these camps, over 160 other decisions recorded and the 15 baptisms that the Northern Illinois Camp witnessed. Pre-registered campers received free commemorative t-shirts and were eligible for the family plan discount. Our youth camps gave to our missionaries' accounts and the Master's Men Department. We were thankful for our many dedicated workers and supporting churches.

2. SAM Program: The Summer Assistance Ministry again provided two FWBBC students to work during our youth camps. We hired Cliff McReynolds and Stephanie Utley to work for 10 weeks through the summer, giving each a \$1,350 scholarship for fall semester along with other benefits.

## II. MAINTENANCE AND IMPROVEMENTS TO THE FACILITY.

1. **ROOFED MULTI-PURPOSE BUILDING** - A phenomenal task was undertaken in April by over 40 workers to strip and replace the roofing on the gym. The job was completed in 3 days with a cost of \$6,213.17. The estimated cost to have the job done was \$12,000. Special donations from the SS & CE and Missions Board helped this project. Other clean-up and clearing jobs were also done that week.

2. **NEW KITCHEN FLOOR COVERING** - A Torginol surface was applied to the kitchen floor for cleaning ease and future upkeep.

3. **NEW DECK ON HOUSE** - The final completion of a remodeling project on the caretaker's house included a new deck across the back.

4. **PURCHASED GROUNDSKEEPING EQUIPMENT** - The old Cub Cadet was sold and a new push mower, finish mower for the tractor, and a drag blade were purchased from our Equipment Fund.

5. **NEW KITCHEN RANGE** - Thanks to special donations, a new kitchen range with double ovens and griddle was purchased. Pans, a kitchen cart, and oven racks were also purchased.
