

#### REPORT NO. 2 REPORT OF THE STATE PROMOTIONAL SECRETARY

I want to begin my report by giving special thanks to the Illinois Disaster Response Unit and their Coordinator, Tim Hayes. A very strong storm stuck the Mt. Vernon area in July and destroyed hundreds of trees and damaged many homes. The Mt. Vernon Church was not damaged but every tree on the property had to be cut. The unit came to the city and worked several days clearing the litter that covered the streets. They worked hard, conducted themselves in a very professional manner and made a good impression on the people they served. The Mt. Vernon community thanks you.

Secondly, I want to thank all of you for your prayers, visits, calls and cards during the time of my wife's surgery and recuperation. She did not have to have chemotherapy, radiation or any other treatment.

Although I did not have the opportunity to visit in the northern quarterlies I did attend nine quarterly sessions this past year and attended several meetings of our various state boards. Last year I served as host pastor for the State Meeting, the FWBBC College Choir tour and two sessions of the Camp Meeting. Our church has held camp meeting planning sessions, WNAC meetings for officers and is always open for board meetings, committee meetings and other gatherings for the people of our state.

Our association received another dividend check from the Brotherhood Mutual Insurance Company. Over half of our churches participate in this co-operative insurance program through the Gearhart and Associates of Carbondale. Terrance Mohr is the agent for our group in the southern area and Brother Tom Slammans handles the northern Illinois area. Any year we have a three year ratio loss of less than 45% qualifies us to receive a yearly dividend from the company. In 2004 our return was \$7,646.00, in 2005 we received \$8,319.00 and for this past year of 2006 we received \$9,173.00 which is a full 10% of all premiums paid by our churches. The total received and deposited into our state treasury for the past three years totals \$25,138.00.

The information network in our state still needs some upgrading. Once in a while we simply do not get the news out quickly enough. The state website is helpful and the net pals network is helpful and everyone interested in the activities of our state are very cooperative so I applaud the young men who are good at using the modern methods of communication to get the word out.

We have held the cost down in publishing the Illinois Newsletter but postage continues to rise. This little paper goes into about 750 homes each month and contains news of interest for the Free Will Baptist people in Illinois. We would love to have news from your congregation. Thanks to the reporters who send in items for publication. Most are sending in the news by e-mail which is a tremendous help as far as time is concerned. Let me remind everyone to think ahead when announcing upcoming events in your church.

For example, if your revival is scheduled for April 20<sup>th</sup>, your news should be at the state office by March 15 in order to get into the April issue. Sometimes such announcements are submitted too late for the readers to be aware of the event. One other note to the reporter and pastors: please keep your article down to about 500 words which is about one column on a three column page.

At the time of this report, the updates on pastors and churches are as follows. Pastor Russell Wolfe resigned the Bakerville Church and they are seeking a pastor. The Heritage Church of Springfield has Brother Karel Smith serving as Interim Pastor, the Nason Church and Rescue Church are in need of a pastor. Thanks to Brother Kent Dunford for serving as Interim Pastor at Rescue Church during this transition period.

We welcome four new pastors to our association: Brother Roger Odum is serving at the Freedom Church, Brother Craig Smith is now serving as Pastor at Oak Valley Church; Brother Brian Bennett is serving the Salem Church; and from south Georgia, Brother David Womack is now pastor at Tanner Trail Church in Aurora. The Tanner Trail Church was formerly called Butterfield Church and since they are no longer on Butterfield Road but are on Tanner Trail, they have a new name. The People's Church of Chicago also has a new building and address and has relocated to Hoopeston.

Brother Stephen Gray and his family have relocated to Collinsville where they will plant the new Discovery Family Church. The Board of Missions will have more information concerning Brother Gray. Finally, the word has been received that two churches of our association located in Iowa have decided to withdraw and organize an Iowa District Association with hopes of attracting attention to building new churches in their state. We bid them well on this new endeavor.

The CTS Board began to have more frequent telephone conferences and using email to communicate more effectively with one another. In August 2006, the Illinois CTS Board had a meeting to discuss:

- 1. Re-organizing the board.
- 2. State Competition 2007
  - Calendar
  - Notification to churches
  - Rule changes (national and state level)

- Competition schedule
- Judges and scoring
- 3. CTS Promotion in the state of Illinois
  - Phone calls to churches (increased and more personal communication)
  - Utilizing Illinois Free Will Baptist Website

The following was decided by the Illinois CTS Board during the course of the August 2006 meeting regarding the aforementioned:

- 1. Steve Futrell stepped down as Secretary, and Liz Kohn was nominated and accepted by the Board to fill the position of Secretary, effective immediately.
- 2. A packet of information regarding the 2007 State Competition along with a current NYC rule book, would be sent out to all Illinois Free Will Baptist Churches (that are members of the Illinois State Association) in the month of October. Along with general rules and competition information, the packet addresses the issues of a new earlier registration deadline and the changes to state level rules of competition (i.e. allowance of multiple competitors from the same church who are the same age category competing in the same event). This packet of information was sent out to all churches the last week of October. (23)

On these issues we also discussed the possibility of sending the scheduling, scoring, and registration out-of-state to be completed for the national level of competition, but voted on keeping these matters in state this year.

3. We, as members of the Illinois CTS Board, divided up the Illinois churches and were instructed to call and regularly correspond with our list of churches regarding Illinois CTS competition. This was done in an attempt to communicate more effectively with Illinois churches regarding competition issues, and therefore, avoid a repeat of some past problems that have arisen out of poor communication and misunderstanding.

We also discussed utilizing the Illinois Website and other forms of mass-communication to further aid in the efficiency of this Board in getting information to and from Illinois churches and their coaches and competitors.

We had a phone conference a week or so after this meeting to affirm and further nail down what was finally decided and discussed during the August meeting. A follow-up letter to Illinois churches was sent by Liz Kohn in February as a reminder of the March 1, 2007 registration deadline. No registration information has been received by Elizabeth Kohn as of this date.
