

REPORT NO. 7 REPORT OF THE PROMOTIONAL SECRETARY Report of the Promotional Secretary

The Illinois State Association was formed in 1960 in an effort to bring all our churches into one organization so we could more effectively fulfill the Great Commission. It was intended to get our churches more organized, have a closer communication and share greater responsibilities. We had suffered great loses when Free Will Baptists merged with the Northern Baptist Association in 1911.

Although we struggled to continue with the remnant of the churches that remained, we had various conferences and quarterly meetings that held us together, and we also had a vision and continued to build on it. One of the organizations that came into existence in 1950 was called the Sunday School Alliance which received land to build a Youth Camp. It was that group that eventually became a part of the State Association and we now call it Camp Hope. It has been a great factor in the continuing growth of our churches and in influencing young people to various ministries around the world.

Today, we face challenges that were not faced by our predecessors. The teachings which were readily accepted in that first camp are questioned and ridiculed in today's society. Thank God we still share a vision and have boards in place to handle the various functions of our state business, and I thank the Lord for those who volunteer to serve in their positions, you will be hearing from each board during the meeting. 2018 Annual Report of the Christian Education Board

The Christian Education Board met three times in person and once via conference call since the last state meeting. Our annual seminar prior to the state meeting last year was well received and attended. Dr. Robert Picirilli enlightened seminar attendees with "Free Will Revisited" and delivered two great messages during the worship services. Gary Portell was elected to serve on our board, and we have appreciated his input.

Once again, we have provided scholarships for Illinois students attending Welch College. In 2018, we paid \$4,400 in scholarships divided evenly among students from Illinois and \$1,500 in ministerial student scholarships. In the current semester (Spring 2019), we will award 10 Welch College students \$220 each and 2 ministerial students \$500 each.

Last year, to encourage our pastors, we gave each a copy of Robert J. Morgan's book *Reclaiming the Lost Art of Biblical Meditation: Find True Peace in Jesus.* We also encouraged pastors and leaders to attend a free workshop on pastoral health presented by Brother Jim Mullen at Calvary Church in Salem last March. We donated \$300 to Calvary to help with the expenses of this workshop.

We attempted to schedule a Sunday school and Christian education workers training session in the spring of 2019, but schedule conflicts prevented presenters from Randall House from coming at that time. We are currently finalizing a fall date for this event and hope to publicize it at the state meeting. Hopefully, we will also be able to announce the topic and speaker for the 2020 Christian education seminar as well.

We voted to transfer \$2,500 from our general fund into the scholarship fund to add to the principle in the mutual fund to boost annual dividends and capital gains so scholarships will increase as well.

REPORT NO. 14 PARTIAL REPORT OF THE BUSINESS COMMITTEE

We recommend the Constitutional revisions concerning marriage in Article XII(12) and Article XVII(17) of our constitution be adopted.

The committee recommended the revision of Article XII, Section 2, Part B, Item 3 and Article XVII of the Illinois State Association of Free Will Baptist. As follows:

Illinois State Association of Free Will Baptist Constitution 2018 Edition:

Article XII Section 2 Part B Item 3 (Page 8)

Presently reads: "He may not engage in activities or practices which are inconsistent with prevailing Free Will Baptist beliefs and attitudes, such as the use of tobacco and illegal drugs, or involvement in a homosexual lifestyle.

Would be changed to read: "He may not engage in activities or practices which are inconsistent with Free Will Baptist beliefs and attitudes, such as the use of intoxicating beverages, tobacco, and abuse of drugs, or involvement in a lifestyle repugnant to the Biblical standard of one man (being male as naturally born) and one woman (being female as naturally born) relationship and marriage.

Article XVII (page 9) Marriage •

As it now reads

Article XVII Marriage

The Illinois State Association shall take the following actions concerning Same Sex Marriages based on the action taken by the National Association in 2008 when they added the following appendix to the Constitution: Both Scripture and nature as designed by God affirm the lifelong covenantal union of one man, being male as created by God, and one woman, being female as created by God, in a one-flesh relationship. This one-flesh relationship is emblematic of the union of Christ and His church. It is the sole and beautiful context of the divine plan for the marital relationship of man and woman as image-bearers of God, as well as the foundation for the family as the basic, divinely ordained unit of human society. Violations of this one-flesh union, whether heterosexual or homosexual, premarital or extramarital, contravene the divine plan for the family and for the conception and rearing of children, bringing spiritual despair, guilt, and death to individuals and cultures.

Section 1. That all properties of the Illinois State Association of Free Will Baptist including Camp Hope and any other properties obtained in the future will not be used in any way to support the homosexual movement or the performance of same sex marriages.

Section 2. No personnel of the State Association of Free Will Baptist will be involved with the promotion of the homosexual movement or the performance of same sex marriages.

Section 3. That all personnel or volunteers that participate in any state function or activity must not be involved in a homosexual lifestyle. This would pertain especially to all who work at Camp Hope or Church Training Service activities.

Article XVII would be changed to read:

"The Illinois State Association shall take the following actions concerning Same Sex Marriages based on the action taken by the National Association in 2008.

Both Scriptures and nature as designed by God affirm the lifelong covenantal union of one man, being male as naturally born and one woman, being female as naturally born, in a one-flesh relationship. This one-flesh relationship is emblematic of the union of Christ and His church. It is the sole and beautiful context of the divine plan for the martial relationship of man and woman as image-bearers of God, as well as the foundation for the family as the basic, divinely ordained unit of human society. Amen. 26 For this cause God gave them up unto vile affections: for even their women did change the natural use into that which is against nature: 27 And likewise also the natural use of the woman, burned in their lust one toward another*; men with men working that which is unseemly, and receiving in themselves that recompense of their error which was meet. 28 And even as they did not like to retain God in their knowledge, God gave them over to a reprobate mind, to do those things which are not convenient; 29 Being filled with all unrighteousness, fornication, wickedness, covetousness, maliciousness; full of envy, murder, debate, deceit, malignity; whisperers, 30 Backbiters, haters of God, despiteful, proud, boasters, inventors of evil things, disobedient to parents, 31 Without understanding, covenant-breakers, without natural affection, implacable, unmerciful: 32 Who knowing the judgment of God, that they which commit such things are worthy of death, not only do the same, but have pleasure in them that do them.

1 Cor. 7:1-5 1 Now concerning the things whereof ye wrote unto me: It is good for a man not to touch a woman. 2 Nevertheless*, to avoid fornication, let every man have his own wife, and let every woman have her own husband. 3 Let the husband render unto the wifedue benevolence: and likewise also the wife unto the husband. 4 The wife hath not power of her own body, but the husband: and likewise also the husband hath not power of his own body, but the wife. 5 Defraud ye not one the other, except it be with consent for a time, that ye may give yourselves to fasting and prayer; and come together* again, that Satan tempt you not for your incontinency.

Ephesians 5:21-33 21 Submitting yourselves one to another in the fear of God. 22 Wives, submit yourselves unto your own husbands, as unto the Lord. 23 For the husband is the head of the wife, even as Christ is the head of the church: and he is the savior of the body. 24 Therefore as the church is subject unto Christ, so let the wives be to their own husbands in every thing. 25 Husbands, love your wives, even as Christ also loved the church, and gave himself for it; 26 That he might sanctify and cleanse it with the washing of water by the word, 27 That he might present it to himself a glorious church, not having spot, or wrinkle, or any such thing; but that it should be holy and without blemish. 28 So ought men to love their wives as their own bodies. He that loveth his wife loveth himself. 29 For no man ever yet hated his own flesh; but nourisheth and cherisheth it, even as the Lord the church: 30 For we are members of His body, of His flesh, and of His bones. 31 For this cause shall a man leave his father and mother, and shall be joined unto his wife, and they two shall be one flesh. 32 This is a great mystery: but I speak concerning Christ and the church. 33 Nevertheless let every one of you in particular so love his wife even as himself; and the wife see that she reverence her husband.

Hebrews 13:4 Marriage is honourable in all, and the bed undefiled: but whoremongers and adulterers God will judge "All Scripture References are in the King James Version".

Section 1 That all properties of the Illinois State Association of Free Will Baptist including Camp Hope and any other properties obtained in the future will be used to support only Biblical heterosexual lifestyle. Only Biblical heterosexual marriages of one man (male as naturally born) and one woman (female as naturally born) will be sanctified, celebrated, or performed on Illinois State Association of Free Will Baptist property.

Section 2 The personnel of the State Association of Free Will Baptist will be involved in only the promotion of the Biblical heterosexual movement and the performance of such marriages.

Section 3 That all personnel or volunteers that participate in any state function or activity must be supportive of, and practice Biblical heterosexual lifestyle. This would pertain especially to all who work at Camp Hope or Church Training Service activities.

Plus the addition of Section 4 to Article XVII

Section 4 No local Free Will Baptist Church associated with the Illinois State Association of Free Will Baptist shall accept any official member into their church that does not agree with the National Association of Free Will Baptist and the Illinois State Association of Free Will Baptist position on the support of heterosexual lifestyle and marriage.

Note 1:All Scripture references would be fully written out in King James Version

Note 2: DEFINITION:

The word HETEROSEXUAL is defined by Webster's Collegiate Dictionary as follows: "of, relating to, or characterized by a tendency to direct sexual desire toward the opposite sex".
