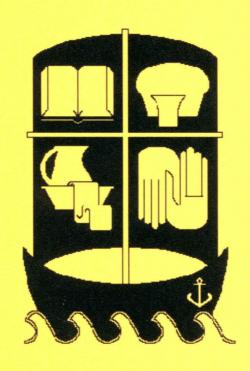

A motion was sustained to approve the 2019 Treasurer's Report and to adopt the budgets for both the General Fund and Promotional Fund for 2020.

Report of the Promotional Secretary 2019

Back in July, 1953, the National Association of Free Will Baptists met in Mount Vernon, Illinois using the Emmerson Hotel as the headquarters of the convention. The business meetings were held at the high school auditorium, and many visitors and delegates roomed with local church members. Although our state had ties with our national body, the Bible College and the Sunday School publishing department, seven years later, a small group of churches in Illinois gathered together to become a part of the national association. The purpose of this was to have a greater representation in the national association.

It is difficult to believe that 60 years have passed since that day in June, 1960 when Free Will Baptist churches in Illinois sent their pastors, deacons and delegates to organize a State Association. They met at the Free Will Baptist Youth Camp in Benton, Illinois to discuss, debate and decide how to adopt a constitution, set up quarterly and district meetings, elect officers and listen to the challenges of becoming part of the National Association of Free Will Baptists.

The main concern was to better equip the churches to reach the world with the gospel. It was exciting to be part of the church organization which would send missionaries into all the world! The group suffered a major setback less than two years later when two of the quarterly meetings voted to withdraw from the new fellowship.

Our State Association is among the smaller groups which make up the National Association. However, we have several things that are very important that we contribute to the overall functioning of the national. We have a great spirit of cooperation among our standing boards and among the members of those boards that is expressed when we meet and evaluate the work in the state. Because all boards are funded through the Together Way Plan and we have to set up the allocations of those funds and make a recommendation to the delegates at this meeting to approve them. Every member of the Executive Board shares a concern for every board to be funded so they can function throughout the year. I am thankful for those on the board for their cooperative attitude. Please remember, all our boards are funded through this program. Encourage your church to give.

Another blessing is our wonderful camp facilities and the great youth camps which meet there every summer. Camp Hope seems to bind us together and keep us in touch with the past, present and future. In addition to the young people attending camp, they are doing many things for the work of God: serving in various countries with E-Team, working stateside with Truth and Peace, participating in CTS activities, and serving in their own churches. Those who work with the youth in these areas are to be commended! We need to help our young men and women and pray for them, prepare them for the leadership role they will assume in the coming years. They will face challenges we never had to face.

The third thing I want to mention is the dedicated work of the people who serve on our state boards. They spend many hours and drive a lot of miles to take care of the business of our association. You will be hearing reports from these boards during this convention as they share what they have done and the goals set for this coming year. Thank you board members for serving well!

We have a new National Executive Secretary, Dr. Eddie Moody who will be leading us and he is a great communicator. You will be hearing from him as he shares a fresh vision for our denomination. He is introducing some new programs that are available to all our churches and leaders. These new resources should make us "Better Together." Meanwhile we will continue to publish the Illinois Newsletter and Ross Bunton will keep the Illinois FWB website updated for your information.

Here are some updates on pastors and churches: Brother Carl Hawkins retired this year as pastor of the Solid Rock Church, Brother Larry Cook retired after serving the Bear Point Church for 36 years, and Brother Larry Clyatt retired as pastor of the Hazel Dell Church, Brother Harrell Hungate resigned the Waltonville Church and has been replaced by Brother Mark Wells.

Hazel Dell Church has called Brother Curtis Smith and Brother Bruce Thurman has been called to serve the Harmony Church. Bear Point Church now has Brother Gowdy Cannon as pastor, Brother David Heath is pastor at Oak Grove Church, and the New Hope Church is searching for a pastor. Former Illinois pastor, Brother Howard Flota, passed away right after the beginning of this year. He had a lengthy ministry and was active up until his 99th birthday last July. Brother Robert Helms who had served in Illinois several years ago went to be with the Lord in February. Rescue Church is in the process of building a new church and the congregation plans to move into the new facility soon.

We felt we had a focused responsibility to the board to simply give a recommendation as to what to do with the funds, whether to stay the course and keep them locked in promotional funds for future hiring or to release the funds for other ministerial needs. We did not fully research out and discuss the job description and salary aspects of this position, and therefore have no recommendations to make to that end. We simply attacked the task of what to do about the funds, to release them or stay the course.

We therefore recommend to the executive board that these funds be used as supplementary income for a part time promotional person acting with more responsibilities and likewise an income to match than what is currently being asked of by the executive board. We also recommend if there is no desire to pursue actionable acts towards this endeavor in 2020 that the funds then be released to other ministries as so directed by the executive board in 2021. Then a motion was sustained to recommend the following Together Way allocations for consideration at the 2020 State Meeting.:
