The meeting opened with the congregation singing *The Old Account Was Settled* led by Randy Jackson, with Diana Bryant at the piano. Announcements were made concerning Marie Hanna's death, and the death of Eugene Waddell's father.

Russell Mccoy led in prayer. The morning devotion was given by Paul Bryant on what it takes to be a success in God's work, that is, relying on God's wisdom and power. Scripture was read from I Cor. 2:1-12.

Delagates were seated by Moderator Randy Bryant, with a MSC to seat delegates from Titusville as their letter had not yet been received.

The Moderator appointed the Statistical Committee: Ham, Jean Adelmeyer, Lassie Allen Shirley

MSC to approve the minutes as printed.

MSC to approve Treasurer's Report with the note that Okeechobee is mentioned twice on the report.

Women Active for Christ reports were heard from Auburndale, Cocoa, Ryanwood, Scottsmoor, Okeechobee,

A Master's Men report was heard from Melbourne.

MSC to receive the Mission Board report given orally by Treasurer Jim Christian in absence of a Mission Board Chairman. He mentioned that the Board would meet today to elect a chairman.

A question was raised about the sale of the Palm Bay property, and ti was disclosed that the sale was in progress, with paperwork to be done with the Church Extension Loan Fund at the National Offices in Antioch, TN. The proceeds from this sale will be used by the Mission Board to complete the building in Palm Bay.

There was no report from the Ordaining Board.

Chairman Robert Griffith gave the Christian Education Board Report.

C.T.S. Director Mike Taggart gave a report concerning C.T.S. Competition and winners as well as a report on the activities of the Y.E.T. A Financial Report of the Y.E.T. was also given.

MSC to receive the reports.

The Y.E.T. was introduced and a rising vote of appreciation and encouragement was given by the body.

A presentation was given by the Y.E.T. consisting of a skit entitled "Church Improvement", and a solo.

Pastor McClung from the Faith Church stood and pledged \$50.00 toward the expenses of the Y.E.T. and challanged each Pastor present to do the same.

The Finance Committee Report was given stating that today's offering go to the Youth Evangelistic Team. MSC to approve this report.

The offering was received with Diana Bryant playing *He Leadeth Me* on the piano.

As a matter of information, a camp report was given by Camp Director, Randy Bryant. He mentioned the need for workers. A seminar for camp workers will be held the last Saturday of June.

MSC to remove from the table an item concerning Article 4, Section 3 of the Constitution.

The change was read.

MSC to change Article 4, Section 3 to read as follows:

The Christian Education Board shall be composed of three members whose terms of office be three (3) years and whose terms shall be staggered so that only one member shall be replaced or re-elected each year. Board shall also consist of the two (2) trustees of the Camp Sonshine Youth Board, representing and elected by this association and who terms shall run concurrent with the Camp Sonshine Board.

The District CTS Director shall be an ex-officio member of this Board, and shall be responsible for District Youth Competition, promotion of CTS programs within our churches, and oversight of the Youth Evangelistic Team (YET) ministry. The CTS Director shall be elected annually by the association at it's annual meeting.

The District YET Director will be an ex-officio member of the CE Board and report to the CTS Director. The YET Director will be appointed by the CE Board.

Functions of this board shall be to support and promote the education of our churches through Sunday School, CTS and other educational ministries and to act on behalf of the association in reference to the Camp Sonshine Board and the operation of the youth camp.

MSC to approve the Executive Committee Report.

The meeting was recessed for 20 minutes.



When business reconvened, the Statistical Committee Report was given by Jean Adlemeyer. MSC to approve.

The Financial Committee report was given by Randy Jackson. MSC to receive the report.

The Nominating Committee report was given by Chairman Henry Beard. MSC to receive the report and accept the slate of speakers for the next meeting.

MSC to adjourn the business portion of the meeting and enter into a time of worship.

The Congregation sang *I'm Redeemed* and *Victory in Jesus* led by Randy Jackson with Diana Bryant at the piano.

The YET Team sang Awesome God by request.

The morning message was delivered by Jim Christian asking the question, "How can we be Christians that attract the world?" He used Acts 4:1 - 22 as his text. He noted that what the disciples did was quickly seen, and it got results. We need to let the world see that we have been with Jesus and strive to be like Him.

The meeting was adjourned after a few announcements from the churches.

# **INDIAN RIVER ASSOCIATION CONSTITUTION AND BY-LAWS**

## Preamble

We, the Indian River Association of Original Free Will Baptists of the state of Florida, do ordain this constitution for the purposes of advancing, promoting, and increasing all phases of the causes of Christ.

## Constitution

## **ARTICLE ONE: NAME**

This organization shall be known as the Indian River Association of Original Free Will Baptists of the State of Florida.

## **ARTICLE TWO: MEMBERSHIP**

This association shall be composed of such Free Will Baptist Churches as shall adq this compact and agree to this constitution. One may obtain associate membership statement of Christian faith.

#### **ARTICLE THREE: DELEGATION**

#### Section 1

The standing delegation of this association shall consist of all ordained ministers, ordained deacons, association clerks, and church clerks of this association in good standing with this association.

#### Section 2

Voting privileges shall be extended to all standing delegates and to those duly elect or appointed delegates representing the churches of this association in good standing. with this association.

#### Section 3

Each church shall be entitled to two (2) delegates plus one (1) delegate for each twenty-five (25) members (or fraction thereof), not to exceed a total of six elected a appointed delegates.

## **ARTICLE FOUR: OFFICERS AND BOARDS**

#### Section 1

The general officers of this association shall be moderator, the assistant moderator, the clerk-treasurer, and the assistant clerk-treasurer. These officers shall be elected on odd years for the term of two years.

## Section 2

There shall be a General Board, composed of the officers of the association and the chairmen of the various boards, which shall serve as the association out of session. Section 3

The standing Boards of this Association shall be the Mission Board, the Ordaining Board, and the Christian Education Board.

Section 4

Each of these standing boards shall after the annual association meeting, elect a chairman. The responsibilities of the chairman are to oversee their respective boards' operation and to attend all General Board Meetings personally or by proxy of another board member. Failure to attend or be represented at two consecutive General Board Meetings shall constitute reason for dismissal from the General Board.

## **ARTICLE FIVE: MEETINGS**

The meetings of this association shall be on the last Saturday of January, April, July, and October.

## **ARTICLE SIX: AMENDMENTS**

This constitution may be amended or altered at any regular session of the association by a two-thirds majority vote of the delegates present, providing the proposed amendment of alteration is presented in writing during one session, placed on the table and voted upon in the next session.

# **BY-LAWS**

## **ARTICLE ONE: MEMBERSHIP**

## Section 1

All churches affilated directly with this association shall be required to adopt the Treatise of the Faith and Practice of the Original Free Will Baptists as adopted by the National Association of Original Free Will Baptists. Application for membership must contain a statement to this effect.

## Section 2

Churches desiring to affiliate themselves with this body must make application by letter and representation to this association.

## Section 3

Any Christian or church desiring to affiliate themselves with this body as an associate member may do so by signing a statement of Christian faith and by paying annual dues designated by the association. Associate members DO NOT have voting privileges.

# **ARTICLE TWO: FINANCE**

#### Section 1

The manner of financial support for this association shall be by dues of each member church according to the amount designated by the association. These dues shall be retained in the General Fund for the administration of the association.

#### Section 2

The Mission Board and Christian Education board shall be financed by retaining a percentage (to be designated by the association) of the Cooperative Plan before sending it to the State Treasurer. The percentage that is retained in the Association and its disbursement will be recommended by the Finance Committee at each annua meeting. A two-thirds majority of the association will rule.

#### Section 3

It will be the responsibility of the Mission Board and the Christian Education Board to disburse the funds and present a written report at each Association Meeting. Section 4

The books of the clerk-treasurer and each board shall be audited each year by the Executive Board at the planning meeting before the Annual meeting of the association.

#### Section 5

All elected boards, officers & committees will be paid 21 cents a mile for transportation expenses, lodging and meals, if required when traveling on Associativ business.

# **ARTICLE THREE: FUNCTION OF THE OFFICERS**

#### Section 1

The duties of the moderator shall be to preside at all the meetings of the association. He shall be empowered with the authority to appoint any committees not otherwise provided for in the constitution. The Moderator shall serve as ex-officio member of all boards and committees.

#### Section 2

The duties of the vice-moderator shall be to preside at the request of or in the absent of the moderator and assist him in such ways as are necessary and advisable. Section 3

The duties of the clerk-treasurer shall be to keep accurate minutes of the association meetings, to compile the minutes and reports of the boards and auxiliaries and to prepare and publish them. It shall be his further duty to take care of necessary correspondence. The clerk-treasusrer shall receive all associational monies and disburse them as directed by the association. He shall be an ex-officio member of the Finance Committee, as well as serve in the position of chairman of this committee.

#### Section 4

The duties of the assistant clerk-treasurer shall be to function at the request of or in the absence of the clerk-treasurer and to assist him in any way necessary.

# **ARTICLE FOUR: FUNCTION OF THE BOARDS**

#### Section 1

The Mission Board shall be composed of five (5) members whose terms of office shall be five (5) years and whose terms shall be staggered so that only one member shall be replaced each year. The Board shall be composed of two (2) ministers, two (2) deacons and one (1) layman.

### The function of this Board shall be:

- a. To supervise any and all missions' programs of this association and to coordinate their efforts with our state and national agencies.
- b. To be vested with the power of trusteeship; to hold and convey titles of any property coming under the jurisdiction of the Missions Board through this association or as dealing with any or all property requiring trustees of the Indian River Association.
  - To formulate and promote a live missionary program by the aiding of weak churches, the establishment of new churches and by an earnest effort to keep a spirit of revival present in the association.

It shall not be the function of this board to hold joint ownership of any church or church properties.

# Section 2

The Ordaining Board shall be composed of three (3) ministers and two (2) deacons who are members of this association in good standing. Board members shall be elected to staggering terms of five (5) years with one member being replaced or re-elected each year.

# n's The functions of this board shall be:

- To examine all applicants for ordination and all previously ordained ministers and deacons seeking membership in the association.
- b. To ordain or assist in the ordination of deacons and ministers when requested to do so by the church of the candidate.
  - To consider the following in carrying out the duties of the office:



- (1) That all ministers and deacons wishing to become members of this association shall be recommended from the church of which they are members.
- (2) That all examinees shall be called upon to present their credentials for examination and answer satisfactorily such questions as may be asked of them.
- (3) That all applications must be made prior to the association meeting to the chairman of the Ordaining Board.
- (4) That a person presented for ordination to the ministry, or to be recognized a a minister in good standing, must be pastoring; be in a state of retirement due to age or health; be engaged full-time in the art of Christian work; or have justifiable cause preventing his pastoring.
- (5) That ministers desiring to be ordained must have been licensed for a period of one year and have pastored for at least six months prior to ordination.
- (6) The licensed minister must come before his local church after one (1) year for re-licensing or ordination.
- (7) For a person to be presented for ordination as a deacon or recognition of ordination as a deacon, he must have served one year. If he has served as a deacon in this association previously and still holds his credentials, the this period of service would be waived. If he is coming from another association, it would be waived provided he actively holds valid credentials from a Free Will Baptist Church or Association.
- (8) That all ordination services be conducted at the time and place recommended by the candidate's church.
- (9) That a licensed minister who turns in his license to the Ordaining Board must go through all required processes previously needed for licensing.
- (10) That all applicants for ordination abstain from the use of tobacco in any form.

#### Section 3

The Christian Education Board shall be composed of three members whose terms of office shall be three (3) years and whose terms shall be staggered so that only one member shall be replaced or re-elected each year. The board shall also consist of the two (2) trustees of the <u>Sonshine</u> Youth Camp Board, representing and elected by this



association and whose terms shall run concurrent with Camp <u>Sonshine</u> Board. The district CTS Director shall be an ex-officio member of this board.

The District CTS Director shall be elected annually by the Association at its annual meeting. Functions of this board shall be:

- a. Appoint youth camp director.
- b. To organize and supervise a camping program.
- c. To act as trustees and to hold title to any properties deeded to this association for the purpose of camping.
- d. To be responsible for all monies received for or related to the camping program of this association.
- e. To support and promote the education of our youth and Christian leaders.
- f. To be responsible for coordinating all CTS programs of his association.

# **ARTICLE FIVE: COMMITTEES**

#### Section 1

The nominating committee shall be composed of three (3) members to be elected at the annual session and who shall serve for a period of one (1) year.

### Section 2

The finance committee shall be composed of three (3) members to be elected at the annual session. The members shall serve in a rotating sequence of three (3) year terms. The duly elected clerk-treasurer shall be an ex-officio member of the committee.

## Section 3

All committees not provided for by either the constitution or its by-laws may be appointed by the moderator as deemed necessary.

# **ARTICLE SIX: REPORTING**

## Section 1

Each church is requested to mail its report to the clerk fifteen (15) days prior to the association session.

## Section 2

Each Woman's Auxiliary of the association shall give a report at the sessions.

## Section 3

The District Woman's Auxiliary shall give a report at the annual meeting.

# **ARTICLE SEVEN: MISCELLANEOUS**

## Section 1

Each minister and deacon who is a member of the Indian River Association shall be expected to attend or report to all association meetings unless providentially hindered.

#### Section 2

The name, date of birth, age, and church affiliation of any member overtaken by death each year shall be included in that year's minutes and such information shall be given to the clerk-treasurer by the clerks of the churches.

#### Section 3

At the death of a minister, a page in the following year's minutes (draped in black a a memorial to the deceased) shall provide all pertinent information concerning him and his ministry.

#### Section 4

The constitution and by-laws, with any amendments and alterations, shall be printed in the annual minutes each year.

#### Section 5

Robert's Rules of Order shall be parliamentary guide for all meetings of the association or its auxiliaries, boards or committees.

#### Section 6

A Quorum shall consist of a majority of any board or committee.

# **ARTICLE EIGHT: AMENDMENTS**

The by-laws may be amended or altered at any regular session of the association by two-thirds majority vote of the proper voting representation present, providing that the proposed amendment or alteration is presented in writing during one session, placed upon the table and voted upon in the next session.
