Minutes of the Indian River Association Meeting Meeting in First Free Will Baptist Church, Titusville

April 28, 2001

The meeting opened with the congregation singing "Love Lifted Me" led by Randy Jackson with Sandra Jackson at the piano. Prayer was offered by Jerry Scott. Assistant Moderator Randy Jackson welcomed the body and introduced Bill Swartz for the morning devotion. He used Psalm 1 as his text. Jim Foster led the congregation in singing "Zion'sHill" in remembrance of Melvin Sanford.

Delegates were seated. Local church delegates were read and seated, followed by standing delegates. A Statistical Committee was appointed consisting of Margaret Welsh, Mary Paul and Lassie Allen.

MSC to accept minutes as printed. The Treasurer's report was read and there was aMSC to accept it. Reports were heard from the following Auxiliaries: Scootsmoor, Faith, New Hope, and Melbourne. A few announcements were made and the body was dismissed.

Auxiliary Reports:

<u>Melbourne</u>: We meet once a week with an average attendance of 17. This monthour study toipic is about growing aspiritually. We support the Donald Legg Evangelistic Minsitry, supply food for the needy, we have given \$400 love offerings to three different peopel, and we are raising funds by selling cookbooks. We gave Bibles to the Children's Church and had lunch on the Cocoa Belle this past quarter.

<u>Scottsmoor</u>: We continue to meet monthly, using the CoLaborer for our programs. Our average attendance this quarter was 6, we are happy to report that we now have 9 members enrolled.

During the quarter, we continued supporting the following: Florida Shares, Florida State Auxiliary, Indian River District Benevolent Fund, and the Indian River District Scholarship Fund. We sent a donation to Paul Bryant, a student at FWBBC. We gave money for repair work on the Church Van.. We have also given money to the Church to help with the expense of our Soul Winning Conference beginning April 29 - May 4.

In March we passed out "Tax Forms" to raise money for Foreign Missions. Tax money is still coming in. We are planning a spaghetti dinner to raise money to help send our youth to Camp. At the present time we are gathering items for the Provision Closet

which will be delivered at the State Association meeting in Deland next month.

<u>New Hope Fellowship</u>: We continue to meet once a month at the church after the monthly fellowship dinners which are held on the first Wednesday after the first Sunday of the month at 7:00 pm. Our average attendance has jumped dramatically during this quarter from 14 to about 20. We give God the glory for the things He is doing not only in our Women's Auxiliary Program, but also in our church as a whole. Through the faithfulness of our congregation, our pastor, and our Lord, New Hope Fellowship is beginning to thrive tremendously.

The ladies in the WNAC take turns volunteering to present the monthly program in the CoLaborer. This quarter we were honored to host the District Women's Auxiliary.

Every month, our WNAC puts together various "cheer" baskets for our shut-ins. We set a theme, and every member signs up to bring an item to make the basket complete. Our shut-ins love these baskets, and they are a huge success. It is amazing how the Lord can take such a small gesture and touch somebody's life in such a meaningful way.

Once again during the Easter season, we decided to make and sell chocolate Easter eggs. We wanted to beat our record from last year which was 810 eggs sold, and the Lord blessed us by helping us to sell 926 eggs this year. But better than raising money from this venture, and even better than eating some of our eggs, is the fellowship that we had while making them. Monthly we support the Shares Program by giving four shares each month. We also support the Sate Budget, the Alabama Children's Home, and our pastor's retirement.

On a sadder note, our church clerk, Ms. Ruby McClain, has decided to retire. Ruby has put in more than 20 years of dedicated work to not only New Hope Fellowship, but also to the Lord. She

has kept our church together better than any concrete or cement ever could, and she has been more structurally sound than the wood which our church is built around. We will miss her tremendously. "Well done, thy good and faithful servant". Christian Kinney will now be our church clerk.

We give all of our praise and thanks to the Lord who is so faithful to His flock even when we stray away from Him. Have faith in the Lord and He will lift you up every time.

<u>Faith</u>: The Ladies of Faith met in March and elected officers: President - Liddie McCoy, Vice President - Jewel Jordan, Secretary/Treasurer - Marjorie McClung, and Fund Raiser Organizer - Naomi Marcum. There were 6 in attendance, and the group will meet on the third Saturday of each month.

The Ladies of Faith had an Easter Egg hunt, they put together yard sales, breakfast sales, sales of angel plates, and raised over \$3000 to purchase new carpeting for the Sanctuary.

Master's Men Reports

<u>Melbourne</u>: Melbourne has 16 active members. This past quarter they hosted a Spaghetti Dinner and Pie Auction and raised \$850.00. They planted shrubery, took the widows out to Sunday Dinner, bought carpet for the choir loft, gave monthly donations to missions, supported Victory Ministries and the Don Legg Evangelistic Effort. The meet once a month for Bible Study.

Mission Board Report

The Indian River Mission Board met on April 4, 2001 at New Hope Fellowship Church in Coaoa, Florida. Those in attendance were Jim Christian, Tim Tillotson, MikeWelsh and Don Ingram. Absent wa sRussell McCoy. Tim Tillotson opened in prayer.

A discussion was held concerning the attending of Mission Board Meeting by all Board Members. In our meeting on July 29, 2000, it was decided that this was a necessary requirement and failure to do so would result in dismissal from the Board.

Items of Business Discussed:

The <u>Newsletter</u> is still in the planning and information gathering stage. An update of the membership role is being obtained, and development of the news letter is expected in the third quarter of this year. <u>Promotion of Florida mission shares</u>- banners will be obtained from Scott Printing in Cocoa. The cost has not yet been determined and the design is under development. The banners will be displayed in churches on "Mission Sundays" and then taken down until the next "Mission Sunday".

A display table with a "changeable" folding banner is being looked into. This will be suggested for all churches. Mission giving envelopes will be obtained for placement in church pews. It is the intent of the Mission Board to "make it easy" for everyone to give to missions.

Banners and material will be offered to every church to helpthem fulfill their obligation to support the Florida Mission Shares Program.

INDIAN RIVER ASSOCIATION CONSTITUTION AND BY-LAWS

<u>Preamble</u>

We, the Indian River Association of Original Free Will Baptists of the state of Florida, do ordain this constitution for the purposes of advancing, promoting, and increasing all phases of the causes of Christ.

Constitution

ARTICLE ONE: NAME

This organization shall be known as the Indian River Association of Original Free Will Baptists of the State of Florida.

ARTICLE TWO: MEMBERSHIP

This association shall be composed of such Free Will Baptist Churches as shall adopt this compact and agree to this constitution. One may obtain associate membership by statement of Christian faith.

ARTICLE THREE: DELEGATION

Section 1

The standing delegation of this association shall consist of all ordained ministers, ordained deacons, association clerks, and church clerks of this association in good standing with this association.

Section 2

Voting privileges shall be extended to all standing delegates and to those duly elected or appointed delegates representing the churches of this association in good standing with this association.

Section 3

Each church shall be entitled to two (2) delegates plus one (1) delegate for each twenty-five (25) members (or fraction thereof), not to exceed a total of six elected or appointed delegates.

ARTICLE FOUR: OFFICERS AND BOARDS

Section 1

The general officers of this association shall be moderator, the assistant moderator, the clerk-treasurer, and the assistant clerk-treasurer. These officers shall be elected on odd years for the term of two years.

Section 2

There shall be a General Board, composed of the officers of the association and the chairmen of the various boards, which shall serve as the association out of session.

Section 3

The standing Boards of this Association shall be the Mission Board, the Ordaining Board, and the Christian Education Board.

Section 4

Each of these standing boards shall after the annual association meeting, elect a chairman. The responsibilities of the chairman are to oversee their respective boards' operation and to attend all General Board Meetings personally or by proxy of another board member. Failure to attend or be represented at two consecutive General Board Meetings shall constitute reason for dismissal from the General Board.

ARTICLE FIVE:MEETINGS

The meetings of this association shall be on the last Saturday of January, April, July, and October.

ARTICLE SIX: AMENDMENTS

This constitution may be amended or altered at any regular session of the association by a two-thirds majority vote of the delegates present, providing the proposed amendment of alteration is presented in writing during one session, placed on the table and voted upon in the next session.

BY-LAWS

ARTICLE ONE: MEMBERSHIP

Section 1

All churches affilated directly with this association shall be required to adopt the Treatise of the Faith and Practice of the Original Free Will Baptists as adopted by the National Association of Original Free Will Baptists. Application for membership must contain a statement to this effect.

Section 2

Churches desiring to affiliate themselves with this body must make application by letter and representation to this association.

Section 3

Any Christian or church desiring to affiliate themselves with this body as an associate member may do so by signing a statement of Christian faith and by paying annual dues designated by the association. Associate members DO NOT have voting privileges.

ARTICLE TWO: FINANCE

Section 1

The manner of financial support for this association shall be by dues of each member church according to the amount designated by the association. These dues shall be retained in the General Fund for the administration of the association. S

Section 2

The Mission Board and Christian Education board shall be financed by retaining a percentage (to be designated by the association) of the Cooperative Plan before sending it to the State Treasurer. The percentage that is retained in the Association and its disbursement will be recommended by the Executive Committee at each annual meeting. A two-thirds majority of the association will rule.

Section 3

It will be the responsibility of the Mission Board and the Christian Education Board to disburse the funds and present a written report at each Association Meeting. Section 4

The books of the clerk-treasurer and each board shall be audited each year by the Executive Board at the planning meeting before the Annual meeting of the association.

Section 5

All elected boards, officers & committees will be paid 21 cents a mile for transportation expenses, lodging and meals, if required when traveling on Association business.

ARTICLE THREE: FUNCTION OF THE OFFICERS

Section 1

The duties of the moderator shall be to preside at all the meetings of the association. He shall be empowered with the authority to appoint any committees not otherwise provided for in the constitution. The Moderator shall serve as ex-officio member of all boards and committees.

Section 2

The duties of the vice-moderator shall be to preside at the request of or in the absence of the moderator and assist him in such ways as are necessary and advisable.

Section 3

The duties of the clerk-treasurer shall be to keep accurate minutes of the association's meetings, to compile the minutes and reports of the boards and auxiliaries and to prepare and publish them. It shall be his further duty to take care of necessary correspondence. The clerk-treasusrer shall receive all associational monies and disburse them as directed by the association. He shall be an ex-officio member of the Finance Committee, as well as serve in the position of chairman of this committee.



Section 4

The duties of the assistant clerk-treasurer shall be to function at the request of or in the absence of the clerk-treasurer and to assist him in any way necessary.

ARTICLE FOUR: FUNCTION OF THE BOARDS

Section 1

The Mission Board shall be composed of five (5) members whose terms of office shall be five (5) years and whose terms shall be staggered so that only one member shall be replaced each year. The Board shall be composed of two (2) ministers, two (2) deacons and one (1) layman.

The function of this Board shall be:

- To supervise any and all missions' programs of this association and to a. coordinate their efforts with our state and national agencies.
- b. To be vested with the power of trusteeship; to hold and convey titles of any property coming under the jurisdiction of the Missions Board through this association or as dealing with any or all property requiring trustees of the Indian River Association.

To formulate and promote a live missionary program by the aiding of weak C. churches, the establishment of new churches and by an earnest effort to keep a spirit of revival present in the association.

It shall not be the function of this board to hold joint ownership of any church or church properties.

Section 2

The Ordaining Board shall be composed of three (3) ministers and two (2) deacons who are members of this association in good standing. Board members shall be elected to staggering terms of five (5) years with one member being replaced or re-elected each year.

The functions of this board shall be:

- To examine all applicants for ordination and all previously ordained a. ministers and deacons seeking membership in the association.
- To ordain or assist in the ordination of deacons and ministers when b. requested to do so by the church of the candidate.
- To consider the following in carrying out the duties of the office: C.



- (1) That all ministers and deacons wishing to become members of this association shall be recommended from the church of which they are members.
- (2) That all examinees shall be called upon to present their credentials for examination and answer satisfactorily such questions as may be asked of them.
- (3) That all applications must be made prior to the association meeting to the chairman of the Ordaining Board.
- (4) That a person presented for ordination to the ministry, or to be recognized as a minister in good standing, must be pastoring; be in a state of retirement due to age or health; be engaged full-time in the art of Christian work; or have justifiable cause preventing his pastoring.
- (5) That ministers desiring to be ordained must have been licensed for a period of one year and have pastored for at least six months prior to ordination.
- (6) The licensed minister must come before his local church after one (1) year for re-licensing or ordination.
- (7) For a person to be presented for ordination as a deacon or recognition of ordination as a deacon, he must have served one year. If he has served as a deacon in this association previously and still holds his credentials, the this period of service would be waived. If he is coming from another association, it would be waived provided he actively holds valid credentials from a Free Will Baptist Church or Association.
- (8) That all ordination services be conducted at the time and place recommended by the candidate's church.
- (9) That a licensed minister who turns in his license to the Ordaining Board must go through all required processes previously needed for licensing.
- (10) That all applicants for ordination abstain from the use of tobacco in any form.

Section 3

The Christian Education Board shall be composed of three members whose terms of office shall be three (3) years and whose terms shall be staggered so that only one member shall be replaced or re-elected each year. The board shall also consist of the two (2) trustees of the <u>Sonshine</u> Youth Camp Board, representing and elected by this



association and whose terms shall run concurrent with Camp <u>Sonshine</u> Board. The district CTS Director shall be an ex-officio member of this board.

The District CTS Director shall be elected annually by the Association at its annual meeting. Functions of this board shall be:

- a. Appoint youth camp director.
- b. To organize and supervise a camping program.
- c. To act as trustees and to hold title to any properties deeded to this association for the purpose of camping.
- d. To be responsible for all monies received for or related to the camping program of this association.
- e. To support and promote the education of our youth and Christian leaders.
- f. To be responsible for coordinating all CTS programs of his association.

ARTICLE FIVE: COMMITTEES

Section 1

The nominating committee shall be composed of three (3) members to be elected at the annual session and who shall serve for a period of one (1) year.

Section 3

All committees not provided for by either the constitution or its by-laws may be appointed by the moderator as deemed necessary.

ARTICLE SIX: REPORTING

Section 1

Each church is requested to mail its report to the clerk fifteen (15) days prior to the association session.

Section 2

Each Woman's Auxiliary of the association shall give a report at the sessions. Section 3

The District Woman's Auxiliary shall give a report at the annual meeting.



ARTICLE SEVEN:MISCELLANEOUS

Section 1

Each minister and deacon who is a member of the Indian River Association shall be expected to attend or report to all association meetings unless providentially hindered.

Section 2

The name, date of birth, age, and church affiliation of any member overtaken by death each year shall be included in that year's minutes and such information shall be given to the clerk-treasurer by the clerks of the churches.

Section 3

At the death of a minister, a page in the following year's minutes (draped in black as a memorial to the deceased) shall provide all pertinent information concerning him and his ministry.

Section 4

The constitution and by-laws, with any amendments and alterations, shall be printed in the annual minutes each year.

Section 5

Robert's Rules of Order shall be parliamentary guide for all meetings of the association or its auxiliaries, boards or committees.

Section 6

A Quorum shall consist of a majority of any board or committee.

ARTICLE EIGHT: AMENDMENTS

The by-laws may be amended or altered at any regular session of the association by a two-thirds majority vote of the proper voting representation present, providing that the proposed amendment or alteration is presented in writing during one session, placed upon the table and voted upon in the next session.
