

The morning session was opened with the hymn "When We All Get to Heaven." Brother Archie Ratliff, pastor of Peace Free Will Baptist Church of Indianapolis, led us in prayer. Our moderator, Brother Ed Hargis, welcomed everyone to the meeting and our visitors were recognized and introduced.

The delegates to this 17th session were seated representing these three associations: Kosciusko, Wabash and White River.

Resolutions were then presented to be acted upon in the afternoon business session. Only one resolution was presented coming from the executive committee. The resolution reads as follows:

> The moderator shall appoint the nominating committee, who presents the nominations for the Indiana State Association Officers, in the March executive committee meeting with the appointees being chosen from the Indiana State Association Executive Board.

This would change regulation number 6 in the "rules and regulations" of our constitution and by-laws.

The moderator then appointed the nominating committee. Those appointed were Rev. Donald Arms, Mr. Kenneth Cade, Rev. Greg Hanson, Mr. J.T. Stargill and Rev. Donald Trogdon.

With the appointment of committees completed the time of worship began.

The congregation was led in singing "Sunlight". Brother Steve Ashby sang a solo using the great hymn "Saved, Saved". Brother Henry Patterson was the appointed messenger and preached from the text II Timothy 3:1, a message entitled "Time to Quit."

The congregation then blended their voices in song. Following the singing, the second speaker for the morning session was called on to preach The speaker, Brother Robert Helms preached from the text Galatians 5:13-16

These messages from God's men were used of God to speak to the hearts

of those in the congregation.

Lunch was served by the host church and enjoyed by all.

The afternoon session was begun with another fine solo by Brother Steve Ashby. Rev. Donald Arms gave a devotional thought from the Word of God.

A discussion followed the reports concerning a visit to the camp ground property in Southern Indiana. The date September 10, 1977 was set for all pastors and others who were interested to visit the camp property.

The resolution introduced in the morning session was then called for and presented to the body for their consideration. The resolution was discussed and passed Rule number 6 in our constitution and by-laws under "rules and regulations" reads as changed:

> "The moderator shall appoint the nominating committee, who presents the nominations for the Indiana State Association officers and committees, in the March executive committee meeting with the appointees being chosen from the Indiana State Association executive board. The body may place nominations from the floor for each office. All nominees must be voted on and approved by the body."

The budget for the fiscal year June 1977 to June 1978 was presented and accepted by the body.

The moderator was then given the responsibility of appointing the delegates to the National Association of Free Will Baptist convened in July 1977. Those appointed were:

> Kenneth Cade, Imogene Patterson, Steve Ashby Charles Eldridge and Carol Eldridge

The Indiana representative to the National Association of Free Will Baptist General Board was elected for a two year term. Rev. Henry Patterson was chosen.
