Report of Committee on Sabbath Observance

Whereas the general public, including many of our church members, are habitual Sabbath-breakers and thereby transgress God's law, robbing Him of the day that He reserved to Himself by sanctifying it as a holy day of rest and worship;

Therefore we urge our pastors and church officials to warn our people to "Remember the Sabbath day to keep it holy." Many make the Sabbath a holiday instead of a holy day. They go visiting, auto riding, go on picnics, and some keep their stores open to sell goods, others go in to buy, and in almost every conceivable way break the Sabbath, so much so that we advise the strict enforcement of discipline.

We protest against any and all laws that will license people to trade, play, hunt or fish, or in any other way break the Sabbath of

the Lord God Almighty.

CHURCH COVENANT

- 1. Having given ourselves to the Lord through Jesus Christ we agree to adopt the Free Will Baptist Articles of Faith. We give ourselves to each other by the help of God.
- 2. We solemnly covenant before God that we will carefully observe commands implied in a profession of faith, and in the spirit of meekness rebuke and admonish those who have gone astray and watch over each other's reputations, and use our influence to the upbuilding of the church and for the advancement of the cause of Christ, endeavoring to seek the unity of the spirit in the bonds of peace and to confess our faults one to another and to strengthen those who are weak.
- 3. We promise by the help of God that we will faithfully practice the family and secret prayer, and strive to cultivate the doctrine of God's revealed word in the minds of those under our care.
- 4. We also agree to use our influence for the support of the gospel and to contribute liberally to aid in the ministry according to our several abilities. Also, we agree to be liberal with those who are afflicted and needy, and especially those of "The Household of Faith."
- 5. We also agree to attend the monthly meetings regularly if not providentially hindered, and to submit to all ordinances implied in a profession of faith.
- 6. We also agree to abstain from all sinful and vain amusements.
- 7. We also agree to abstain from all intoxicating liquors, not to use it as a bevarage, nor to aid or assist in the manufacture of such, nor to furnish it to others.
- 8. We also agree to encourage home and foreign missions, education, Sabbath school, good morals, and everything that is for the glory of God and to the welfare of men, and may the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ that we may be happily admitted into the kingdom of God, where we can ascribe honor unto the Lamb foreyer. Amen.

RULES OF DECORUM

Article 1. The association shall be opened and closed with prayer.

- 2. There shall be no conversation by the members one with another so as to interrupt business while in session.
- 3. Every member wishing to speak shall first rise and address the Moderator.
 - 4. No member shall interrupt another while speaking.
- 5. We shall admit no other title while in session but that of brother.
- 6. Every member speaking shall attend to the subject under consideration.
 - 7. No member shall speak more than twice on any one subject.
- 8. Every motion made and seconded shall be attended to unless withdrawn by the person who made it.
- 9. No member shall absent himself from the body without leave of the Moderator.
- 10. On all motions made where the vote of the body is taken, a majority shall prevail.
- 11. The Moderator shall have the same privilege to speak as any other member, provided the chair is filled.
- 12. Any member transgressing the above rules shall be admonished by the Moderator.
 - 13. Not less than nine members shall constitute a quorum.

ARTICLES OF FAITH

- 1. God—We believe that there is one, and only one, true and living God who is personally the Father, Son and Holy Ghost, equal and harmonious in every divine perfection. There is one God and one Mediator between God and man, the Man Christ Jesus, who gave Himself a ransom for all to be testified in due time.—I Tim. 2:5.
- 2. The Holy Scripture—We believe that God is the author of the Holy Bible and its teachings constitute the only infallible doctrine for the government of His church. All Scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, instruction in righteousness.
- 3. Original Apostacy—We believe that Adam was created holy; but by voluntary transgression fell into depravity and consequently involved his posterity in sin. And when the woman saw that the tree was good for food and that it was pleasant to the eye, and a tree to be desired to make one wise she took of the fruit thereof and did eat and gave unto her husband with her and he did eat.—Gen. 3:6.
- 4. Free Grace—We believe the grace of God comprehends all spiritual blessings, that the Gospel is the power of God unto salvation, that the Holy Spirit not only reproves the world of sin but is the means whereby sinners are converted and made wise unto salvation. For there is no difference between the Jews and the Greeks, for the same Lord over all is rich unto all that call upon Him.—Rom. 10:12.
- 5. Christian Faith—We believe that Christian faith is the belief in the Lord Jesus Christ as the Son of God and Redeemer of

the world and in the divinity of the Holy Scripture, that faith comes by hearing and hearing by the Word of God. He that believeth on the Son hath everlasting life, and he that believeth not on the Son shall not see life, but the wrath of God abideth on him.—John 3:36.

- 6. Repentance—We believe that repentance is sorrow for sin, and the kind of sorrow which produces Godly repentance must be preceded by effectual conviction of sin. Now I rejoice, not that ye were made sorrow, but that ye sorrowed to repentance; that ye might receive damage by us in nothing. For Godly sorrow worketh repentance to salvation not to be repented of but sorrow of thte world worketh death.—II Cor. 7:8-10.
- 7 Free Agency—We believe that the human will is free, and that men have the ability to accept or reject the conditions of salvation as they are revealed in the Holy Scripture. He hath showed thee, O man, what is good; and what doth the Lord require of thee, but to do justly, and to love mercy, and to walk humbly with thy God.—Mich. 6:8.
- 8. Perseverance—We do not believe under Gospel dispensation any soul is elected to eternal life unconditionally, but those who by faith persevere to the end will be saved; that it is possible for men who have been converted to make shipwreck of their faith, turn again to sin and be finally lost. And Jesus said unto him: No man having put his hand to the plow and looked back is fit for the Kingdom of God.—Luke 9:62.
- 9. Good Works—We believe that good works are the results of faith and not necessity; that those who have faith will do works of righteousness, while those who have not faith, cannot do anything pleasing or acceptable unto God. Every tree that bringeth not forth good fruit is hewn down and cast into the fire. Wherefore by their fruits ye shall know them.—Matt. 7:19-20.
- 10. Christian Baptism—We believe that Christian baptism is the immersion of a believer in water in the name of the Father, Son and Holy Ghost; that baptism cannot be scripturally administered without faith in the subject who receives it. Therefore we are buried with him by baptism into death; that like as Christ was raised up from the dead by the glory of the Father, even so we should walk in newness of life.—Rom. 2:4.
- 11. The Lord's Supper—We believe the supper was instituted by our Saviour as a commemorative ordinance; that it was instituted for Christians, and that all Christians should unite in sacred services regardless of name or denominational distinction. But let a man examine himself and so let him eat of that bread and drink of that cup. "For he that eateth and drinketh unworthy, eateth and drinketh damnation unto himself, not discerning the Lord's body."—I Cor. 11:28-29.
- 12. Feet Washing—We believe that washing the saints' feet a command of our Saviour, and that His followers ought to practice the same. We urge the pastors of all our churches to encourage the practical obedience of this command, especially among the members of their churches. "If I then your Lord and Master have washed your feet, ye also ought to wash one another's feet."—St. John 13:14.
- 13. The Gospel—We believe it to be the duty of all churches to support the Gospel. Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel.—I Cor. 9:14.
