COMMITTEE REPORTS

Each of the following reports were received, discussed and adopted individually.

SUNDAY SCHOOLS

What is the Sunday School? First of all, it is or should be a means of reaching and saving souls for whom Christ died. Leading them to make a definite decision for Christ through his word. Then instructing them "more perfectly in the way of the Lord," training them to be better fitted for His service. In order to accomplish this end, there must be Godly, separated, Spirit-filled leaders in charge. This can only come through much believing prayer and waiting on the Lord. We earnestly and prayerfully urge all our churches to be given more fully to prayer concerning these matters. If the Sunday School fails in its mission of saving souls, it has completely failed in its established purpose.

TEMPERANCE

Too often we allow ourselves to think of temperance in relation to the use of alcoholic beverages. Truly this is a devise of Satan, the adversary of the souls of men and we must bend every force against this evil. However, let us think of the term in a wider scope which involves every thought and act of man, for He would have us temperate in "all things." He has spoken—"Be not drunk—but be filled with the Spirit." Here we have a double command, "Be not drunk," and "Be ye filled." Being filled with the Spirit produces temperance in "all things." God is Holy and demands Holiness. No person can enjoy God's favor, or a truly happy life, unless his character and conduct are pure. "Keep thy heart with all diligence, for out of it are the issues of life." We are commanded and expected as believers to live and to teach a Spirit-filled life, to be filled, not with wine, the fruit of the vine of earth, but with the new wine of the Kingdom, the fruit of the "True Vine."

May we as a body press, both in word and example, Temperance in "all things" for this is "the will of God in Christ Jesus concerning You."

ORPHANAGE

We ask that we adopt the same report of last year. The orphanage truck will come the same time this year to receive commodities from the churches. Each church is asked to gather these commodities on the first Monday in October, take them to Windom not later than Tuesday following. The orphanage truck will receive them there on Wednesday. May we not forget that these are our children, and that the Lord Jesus said, "Inasmuch as ye did it not unto one of the least of these, ye did it not unto me." May we also feel the responsibility for the teaching of these children "Train up a child in the way it should go and when it is old it will not depart from it". Prov. 22:6.

GOVERNMENTAL DOCUMENTS

-OF-

JACK'S CREEK FREE WILL BAPTISTS CONSTITUTION OF JACK'S CREEK F. W. B.

ASSOCIATION

1. This Association shall be composed of delegates chosen and

sent from each church.

2. The delegates chosen and sent shall be recommended in a letter from the church to which they belong and include the minister and some of the ablest members belonging to the church

3. The Association shall elect annually a moderator and clerk. 4. The Rules of Decorum shall be read immediately after the

body is organized

1. The Association will encourage a sound ministry; such as present Christ as an all-sufficient Savior; having made salvation possible for every human being on the terms of the gospel, which is freely offered to all

6. Any minister in good standing, whether a delegate or not, may be invited to a seat and take part in the deliberations, and

have his name enrolled in our minutes.

7. The Association may appoint such committees as may be necessary to the expedition of business, and every committee appointed to any particular business shall report their proceedings in writing to the Association while in session, and all reports made be adopted or rejected by the body.

8. The Association shall have a book in which shall be kept

an accurate account of all its proceedings.

9 Any church may become a member of the Association by making application by letter or by delegate and adopting our adticles of faith and church covenant.

10 The Association may withdraw from any church that be-

comes disorderly or refuses to be represented

11. There shall be an associational fund for defraying expenses and charges that may accrue, and for replenishing such. and each church may contribute at pleasure.

12. There shall be a treasurer appointed by the Association, whose duty it shall be to have care of and account for the money

committed to his charge.

11. The Association shall use the Free Will Baptist Treatise in full

14. Each church shall be allowed one vote for every ten members or fraction thereof

15. The Association advises all its churches to commemorate the

death and suffering of our Lord at least twice a year.

16. The Association shall pay its clerk at least \$5.00 for his services per annum.

ARTICLES OF FAITH

Article 1—The True God. We believe that there is one and only one living and true God who is in personality the Father, Son and Holy Ghost, equal and harmonious in every divine perfection.—
"There is one God and one mediator between God and men, the man Christ Jesus, who gave himself a ransom for all to be testified in due times."—I Tim. 2:6.

Art. 2.—Hely Scriptures. We believe that God is the author of the Holy Bible, and its teachings constitute the only infallible doctrine for reproof, for correction, for instruction in righteousness.

II Tim. 1:16.

Art 3.—Original Apostasy. We believe that Adam was created holy, but by voluntary transgression fell into depravity and consequently involved his posterity in sin.—And when the woman saw that the tree was good for food and that it was pleasant to the eye, and a tree to be desired to make one wise, she took of the fruit

thereof and did eat. Gen. 3-6.

Art. 4.—Free Grace. We believe that the grace of God comprehends all spiritual blessings; that the Gospel is the power of God unto salvation; that the Holy Spirit net only reproves the world of sin, but is the means whereby sinners are converted and made wise unto salvation—For there is no difference between the Jew and the Greek, for the same Lord is rich unto all that call upon him. Rom. 10:12.

Art.—Christian Faith. We believe that Christian faith is belief in Jesus Christ as the Son of God and Redeemer of the world and in the divinity of the Holy Scriptures, that faith comes by hearing the word of God.—He that believeth in the Son hath everlasting life, but he that believeth not the Son shall not see life; but the

wrath of God abideth on him. John 3:36.

Art 6.—Repentance. We believe that repentance is sorrow for sin, and the kind of sorrow which produces Godly repentance must be effectual conviction of sin.—Now I rejoice not that ye were made sorrow, but that ye sorrowed to repentance: for ye were made sorrow after a godly manner, that ye might receive damage by us in nothing. For Godly sorrow worketh repentance to salvation not to be repented of: but the sorrow of the world worketh death. III Cor. 7:9-10

Art. 7.—Free Agency. We believe that human will is free, and that men have the ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures. He hath showed thee, O man, what is good; and what doth the Lord require of thee, but to do justly, and love mercy, and to walk humbly with thy God?

Micah 6:8

Art. 8.—Perseverance. We do not believe, under the Gospel dispensation, any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men, who have been converted, to make shipwreck of the faith, turn again to sin and be lost. And Jesus said unto him: No man having put his hands to the plough, and looking back, is fit for the kingdom of God. Luke 9:62.

Art 9 -Good Works. We believe that good works are the result of faith, and not of necessity; that those who have faith will do works of righteousness, while those who have not faith cannot do anything pleasing or acceptable to God.—Every tree that bringeth not forth good fruit is hewn down, and cast into the fire: wherefore, by their fruits ye shall know them. Matthew 7:19-20.

Art. 10.—Christian Baptism. We believe that Christian Baptism is the immersion of a believer in water, in the name of the Father, Son and Holy Ghost; that baptism cannot be scripturally administered without faith in the subject who receives it. Therefore we are buried with him by baptism into death; that like as Christ raised from the dead by the glory of the Father, even so we also should walk in newness of life. Romans 6:4.

Art. 11.—The Lord's Supper. We believe that the supper was instituted by our Saviour as a commemorative ordinance; that the bread and wine represent His body and blood; that it was instituted for Christians and that all Christians should unite in service regardless of name or denominational distinction.—But let a man examine himself, and so let him eat of that bread, and drink of that cup. For he that eateth and drinketh unworthily, eateth and drinketh damnation to himself, not discerning the Lord's body. I Cor. 11:28-29.

Art. 12.—Feet Washing. We believe that washing the saint's feet is a command of our Saviour, and that his followers ought to practice the same.-If I then, your Lord and Master, have washed your feet, ye ought to wash one another's feet. John 13:14.

Art, 13.—The Gospel. We believe it is the duty of all churches to support the Gospel -Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel I Cor 9:14.

RULES OF DECORUM

Article 1. This Association shall be opened and closed with prayer.

Art. 2. There shall be no conversation by members, one with another so as to interrupt business, while in session.

Every member wishing to speak shall first rise to his feet and address the moderator.

Art. 4. No member shall interrupt another while speaking

Art. 5. We will admit of no other title but that of Brother, while in session.

Art. 6 Every member speaking shall attend to the subject under consideration

No member shall speak more than three times on one subject.

Every motion made and seconded shall be attended to, unless withdrawn by those who made it

Art 9. No member shall absent himself from the body while in session without leave of the Moderator.

Art. 10. On all motions when the vote of the body is taken, a majority shall prevail.

Art. 11. The Moderator shall have the same privilege to speak

as any other member, provided the chair is filled

Art 12. Any member transgressing the above rules shall be admonished by the Moderator.

CHURCH COVENANT

1. Having given ourselves to the Lord through Jesus Christ, we agree to adopt the Free Will Baptist faith, we now give our-

selves to each other by the help of God.

2. We solemnly covenant before God that we will carefully observe the commandments implied by a confession of faith, and in the spirit of meekness rebuke and admonish those who have gone astray, and watch over each other, being careful of each other's reputation, and use our influence to the upbuilding of the church and for the advancement of the cause of Christ, endeavoring to seek the unity of the Spirit in the bonds of peace, and to confess our faults one to another, and to strengthen those that are weak.

3. We promise that by the help of God we will faithfully practice family and secret prayer, and strive to cultivate the doctrine of

God's revealed word in the minds of those under our care.

4. We also agree to use our influence for the support of the Gospel and to contribute liberally to aid the ministry according to our several abilities. Also we agree to be liberal with those that are afflicted and needy, and especially those of the household of faith

We also agree to attend the monthly meetings regularly if not providentially hindered, and submit to all ordinances implied in a

Profession of Faith.

6. We also agree to abstain from all sinful and vain amusements.

7. We also agree to abstain from all intoxicating liquors and not to use it as a beverage, nor to aid or assist in the manufacture

of such nor furnish it to others.

8. We also agree to encourage home and foreign missions, education, Sabbath schools, good morals, and everything that is to the glory of God and to the welfare of men. And may the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ, that we may be happily admitted into the Kingdom of God, where we may ascribe honor unto the Lamb forever. Amen.

CONSTITUTION OF JACKS CREEK F. W. B. ASSOCIATION MINISTERS' CONFERENCE

ART. (1) THIS Body shall be known as the Ministers Conference of the Jacks-Creek, Association of Free-Will Baptists; and shall be composed of all Licensed and Ordained Ministers of said "Association"

ART. (2) THIS Conference may Receive any Christian Minister, as a Visiting Member and when thus received, He may Enjoy all Rights, and Privileges of the Regular Members not in conflict with ART. (3).

ART (3) THIS Body shall Elect Annually, a President or Moderator, and a Clerk, both Ordained Ministers, of One (1) Year or more of Membership in this Conference after His Ordination.

ART. (4) EACH Church may send Two (2) of it's Members as Delegates to this Conference. One (1) to be the Steward of His Church; and when thus sent, they are Entitled to a Seat in the Conference with all the privileges of Visiting Brethren, as Provided by ART. (2).

ART. (5). THE Conference shall Meet on Friday, before Each Fifth (5th). Sunday, with some Church in the Association, previously agreed upon, or at the call of the President, provided that more than One (1) Session, may not be Held with any Church dur-

ing the same Conference Year.

ART (6). THE President is Empowered, and it is His duty, to call an Extra Session of the Conference, upon the petition of the Members of this Conference, provided however, that said Petition, is properly signed, by Seven (7) Members, Three (3) of whom, shall

be Ordained Ministers

ART (7). THE Conference, upon being Organized Each Year: shall proceed to Elect an Ordaining Council, composed of Three (3) Regular Ordained Ministers; all having been Ordained at least Two (2) Years; and One or more shall have Served One or more Years on Ordaining Council, and One of the Senior Members shall be the Chairman of Council thus Constituted.

ART (8) THE Ordaining Council, when properly Organized, shall have charge of all Examinations, and Ordinations, of Candidates for the Ministry, who have been Ordered before it by the

Conference.

ART (9). ALL Applicants for License to Preach, shall be Recommended by the Pastor and Deacons, of His Church, and if the Conference after Due Inquiry and prayerful consideration, and after Examination by the Ordaining Council, as to Gifts, Qualifications, and the Divine Call: said Applicant shall be Granted a License to Preach the Gospel, for the period of One (1) Year, provided however, He may have said License, renewed at the Expiration of the

Year, from Time to Time

ART, (10), ALL Licensed Preachers are required to Preach Twenty-Four (24) Sermons Each Year; and at least, Fifty Sermons before He can Succeed to Ordination, provided however, He can not be Ordained, until He has proved Him-Self faithful and Successful, in the Gospel Ministry, for a period of at least, One (1) Year; all Ordained Ministers are Required to Preach, Forty-Eight (48) Sermons a Year; and if any shall fail to do so, because of negligence. He shall be Entitled to a Seat in the Conference only as a Visiting Minister, as in ART. (2) provided however, the above Requirements shall not apply to Ministers who have past Sixty (60) Years in Age, or to any Minister who is rendered unable to conform to the above Rules by Disease, or continued Sickness of Himself, or Family.

ART (11) ANY Minister being absent from Two (2) Sessions of Conference, in Succession; shall stand charged with Delinquency, and shall be deprived of His Vote on any Question until His Disability is removed by a Vote of the Conference. However, if the Delinquent Brother offer satisfactory Excuse for His absence. His Disability may be removed by a majority Vote of the Conference.

ART. (12). ALL Applicants for Ordination shall present to the Conference a Letter of Recommendation from His Church, properly

Signed by both Pastor and Clerk.

ART. (13). THE Conference may withdraw Fellowship from any

Member who becomes Disorderly.

ART. (14). NO Session of Conference will be considered Legal, if Three (3) or more Ordained Ministers are not Present.

ART. (15). THIS Constitution and BY-LAWS, or any ART. thereof, may be Suspended, or Amended, ba a two-thirds vote of the Conference.

ART. (16). THE President or Moderator may have Power to appoint any and all Committees to carry on the Work of the Conference.

ART (17). A Session of Conference, shall be Held in connec-

tion with the Yearly Association.
