It was also moved that this Committee be elected permanently.

A move was then presented to the body and voted to make no withdrawals from the fund until we have the amount of \$500.00. Voted to meet present needs with free will offerings.

Pledges from the churches were then received in the amount of \$440.00. (This is shown in the table of the Church reports.)

SECTION II

COMMITTEE REPORTS

The following reports were discussed and adopted by the body and are given here in the order of their discussion for the convenience of the reader.

ARRANGEMENTS

All committee reports shall be called for in their order and not more than 15 minutes shall be given to discussion of any one report unless voted by the body.

Report on our Orphanage work. Report on our Mission work.

Ministers reports. Hereafter all Ministers are expected to give a

report of their work.

The morning session of this association shall begin at 9:00 A. M., Evening session at 2:00 P. M. There shall be preaching at 11:00 A. M. and 7:30 P. M.

We recommend that this committee act as pulpit committee

after this association.

TEMPERANCE

We, your committee on Temperance, report that we have to be partakers of a thing before we can be temperate in that thing. We urge, and the Bible demands that our people abstain from all alcoholic drinks and the Lord wants us to be filled with His spirit. If we are filled with the spirit of the Lord, we will be temperate in all things.

ORPHANAGE

We, your committee on Orphanage, ask that we adopt the same report as last year, as follows: Each Church is asked to gather the commodities for the orphanage on the first Monday in October, take them to Windom not later than Tuesday and the truck will receive them there on Wednesday. Also each Church should send along some money to help pay the expenses of the truck. May we not forget that these are our children, and that the Lord Jesus said, "Inasmuch as ye did it not unto one of the least of these, ye did it not unto me"

EDUCATION

We present the following recommendations:

First, that we go on record as favoring Christian education. Realizing that the Bible commands to "study to show thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." This makes plain to us the Bible teaching regarding education

We recommend further that the church give its full support to those that the Lord has led to further educate themselves for his work. Realizing that the Lord gives different gifts unto man—educated and uneducated—yet these are for the same purpose, the

editying of the body of Christ.

RESOLUTIONS

Resolved, that we urge our pastors and deacons to see that each church hold at least two Communion services a year. We find in many of our churches reporting their activities to this association, that they haven't held any Communion services this year and many churches report fair or poor spiritual condition. We believe that if

we do the things that the Lord has commanded, as christians and as a church, that we will be more alive spiritually. Jesus said, "if ye know these things, happy are ye if you do them." Therefore when we do his will we can claim his blessing.

Also, we believe that the different churches of this association should show their love for and their fellowship with each other as much as possible "So we, being many, are one body in Christ, and every one members of another." Romans 12:5.

Resolved, that we convey, through our moderator of this association, our thanks to this church for the kind and hospitable manner in which they have cared for this association.

CHURCHES AND PASTORS

First to the pastors: "Take heed therefore unto yourselves and to all the flock, over which the Holy Ghost hath made you overseers, to feed the Church of God, which he hath purchased with his own blood." Acts 20:28.

Second, to the church: "Not a hearer of the word is justified, but doer of the word Let your light so shine that others may see your good works and glorify your Father which is in heaven."

MISSIONS

First, we find that the mission of Christ was to seek and to save that which was lost. He called unto him twelve apostles and his first commission was to them was, "But go ye to the lost sheep of the house of Israel." As ye go preach, saying the kingdom of heaven is at hand. Heal the sick, cleanse the lepers, raise the dead, cast out devils, freely ye have received, freely give. The second commission was given just before he went away, "Go ye into all the world and preach the gospel to every creature."

The mission of the church today is to support the work of the Ministry, care for the sick, and every good cause that will promote the kingdom of Christ

Acts 6:2—Then the twelve called the multitude of the disciples unto them and said, "It is not reason that we should leave the word of God and serve tables. Wherefore brethren, look ye out among you seven men, full of the Holy Ghost, whom you may appoint over this business. But we will give ourselves continually to prayer and the ministry of the word."

SUNDAY SCHOOLS

We, your committee on Sunday Schools recommend that we readopt the report that we have in the minute, as follows:

What is the Sunday School? First of all, it is or should be a means of reaching and saving souls for whom Christ died, leading them to make a definite decision for Christ through his word. Then instructing them "more perfectly in the way of the Lord," training them to be better fitted for his service. In order to accomplish this end, there must be Godly, separated, spirit filled leaders in charge. We earnestly and prayerfully urge our churches to be given more fully to prayer concerning these matters. If the Sunday School fails in its mission of saving souls, it has completely failed to its established purpose.

INVESTIGATION

We, the committee on investigation, advise that instead of drawing from the funds that we now have on hand, that we supply those in need at present with free will offerings.

OLD AGED MINISTERS FUND

The committee on Old Aged Ministers Funds ask that the churches take more interest, asking that the pastors of the churches present it to the churches often with much stress. We also feel that more money should be given to this cause

GOVERNMENTAL DOCUMENTS

JACKS CREEK FREE WILL BAPTISTS

CONSTITUTION OF JACKS CREEK F. W. B. ASSOCIATION

- 1. This Association shall be composed of delegates chosen and sent from each church.
- 2. The delegates chosen and sent shall be recommended in a letter from the church to which they belong and shall include the minister and some of the ablest members belonging to the church.
 - 3. The Association shall elect annually a moderator and clerk.
- 4. The Rules of Decorum shall be read immediately after the body is organized.
- 5. The Association will encourage a sound ministry; such as present Christ as an all-sufficient Savior; having made salvation possible for every human being on the terms of the gospel, which is freely offered to all.
- 6. Any minister in good standing, whether a delegate or not, may be invited to a seat and take part in the deliberations, and have his name enrolled in our minutes.
- 7. The Association may appoint such committees as may be necessary to the expedition of business, and every committee appointed to any particular business shall report their proceedings in writing to the Association while in session, and all reports made be adopted or rejected by the body.

- 8. The Association shall have a book in which shall be kept an accurate account of all its proceedings.
- 9. Any church may become a member of the Association by making application by letter or by delegate and adopting our articles of faith and church convenant.
- The Association may withdraw from any church that becomes disorderly or refuses to be represented.
- 11. There shall be an associational fund for defraying expenses and charges that may accrue, and for replenishing such; each church may contribute at pleasure.
- 12. There shall be a treasuer appointed by the Association. whose duty it shall be to have care of and account for the money committed to his charge.
- 13. The Association shall use the Free Will Baptist Treatise in full.
- 14. Each church shall be allowed one vote for every ten members or fraction thereof.
- The Association advises all its churches to commemorate the death and suffering of our Lord at least twice a year.
- 16. The Association shall pay its clerk at least \$5.00 for his services per annum.

ARTICLES OF FAITH

Article 1-The True God. We believe that there is one and only one living and true God who is in personality the Father, Son and Holy Ghost, equal and harmonious in every divine perfection. -"There is one God and one mediator between God and men, the man Christ Jesus, who gave himself a ransom for all to be testified in due time."-1 Tim. 2:6.

- Art. 2.-Holy Scriptures. We believe that God is the author of the Holy Bible, and its teachings constitute the only infallible doctrine for reproof, for correction, for instruction in righteousness. LI Tim. 3:16.
- Art. 3.—Original Apostasy We believe that Adam was created holy, but by voluntary transgression fell into depravity and consequently involved his posterity in sin.-And when the woman saw that the tree was good for food and that it was pleosant to the eye, and a tree to be desired to make one wise, she took of the fruit thereof and did eat. Gen. 3:6.
- Art. 4.—Free Grace. We believe that the grace of God comprehends all spiritual blessings; that the Gospel is the power of God unto salvation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted and made wise unto salvation For there is no difference between the Jew and the Greek, for the same Lord is rich unto all that call upon Him. Rom. 10:12.

Art. 5.....Christian Faith. We believe that Christian faith is belief in Jesus Christ as the Son of God and Redeemer of the world and in the divinity of the Holy Scriptures, that faith comes by hearing the word of God.—He that believeth in the Son hath everlasting life, but he that believeth not the Son shall not see life; but the wrath of God abideth on him. John 3:36.

Art. 6.—Repentance. We believe that repentance is serrow for sin, and the kind of sorrow which produces Godly repentance must be effectual conviction of sin.—Now I rejoice not that ye were made sorry, but that ye sorrowed to repentance: for ye were made sorrow after a godly manner, that ye might receive damage by us in nothing. For Godly sorrow worketh repentance to salvation not to be repented of: but the sorrow of the world worketh death. III Cor. 7:9-10.

Art. 7.—Free Agency. We believe that the human will is free, and that men have the ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures. He hath showed thee, O man, what is good; and what doth the Lord require of thee, but to do justly, and love mercy, and to walk humbly with thy God? Micah 6:8.

Art. 8.—Perseverance. We do not believe, under the Gospel dispensation, any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men, who have been converted, to make shipwreck of the faith, turn again to sin and be lost. And Jesus said unto him: No man having put his hands to the plough, and looking back, is fit for the kingdom of God. Luke 9:62.

Art. 9.—Good Works. We believe that good works are the result of faith, and not of necessity; that those who have faith will do works of righteousness, while those who have not faith cannot do anything pleasing or acceptable to God—Every tree that bringeth not forth good fruit is hewn down, and cast into the fire: wherefore, by their fruits ye shall know them. Matthew 7:19-20.

Art. 10.—Christian Baptism. We believe that Christian Baptism is the immersion of a believer in water, in the name of the Father. Son and Holy Chost: that baptism cannot be scripturally administered without faith in the subject who receives it. Therefore we are buried with him by baptism unto death: that like as Christ was raised from the det of by the glory of the Father, even so also we should walk in newn so of life. Romans 6:4.

Art. 11.—The Lord's Supper. We believe that the supper was instituted by our Saviour as a commemorative ordinance: that the bread and wine represent His body and blood; that it was instituted for Christians and that all Christians should unite in service regardless of name or denominational distinction.—But let a man examine himself, and so let him eat of that bread, and drink of that cur. For me that eateth and drinketh unworthily, eateth and drinketh damnation to himself, not discerning the Lord's body: I Cor. 11:28-29.

Art. 12.—Feet Washing. We believe that washing the saint's feet is a command of our Saviour, and that his followers ought to practice the same.—If I then, your Lord and Master, have washed your feet; ye ought to wash one another's feet. John 13:14.

Art. 13.—The Gospel. We believe it is the duty of all churches to support the Gospel.—Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel. I Cor. 9:14.

RULES OF DECORUM.

- Article 1. This Association shall be opened and closed with prayer.
- Art. 2. There shall be no conversation by members, one with another so as to interrupt business, while in session.
- Art. 3. Every member wishing to speak shall first rise to his feet and address the moderator.
 - Art. 4. No member shall interrupt another while speaking.
- Art. 5. We will admit of no other title but that of Brother, while in session.
 - Art.. 6. Every member speaking shall attend to the subject under consideration.
- Art. 7. No member shall speak more than three times on one subject.
- Art. 8. Every motion made and seconded shall be attended to, unless withdrawn by those who made it.
- Art. 9. No member shall absent himself from the body while in session without leave of the Moderator.
- Art. 10. On all motions when the vote of the body is taken, a majority shall prevail.
- Art. 11. The Moderator shall have the same privilege to speak as any other member, provided the chair is filled.
- Art. 12. Any member transgressing the above rules shall be admonished by the Moderator

CHURCH COVENANT.

- 1. Having given ourselves to the Lord through Jesus Christ, we agree to adopt the Free Will Baptist faith, we now give ourselves to each other by the help of God.
- 2. We solemnly covenant before God that we will carefully observe the commandments implied by a confession of faith, and in the spirit of meekness rebuke and admonish those who have gone astray, and watch over each other, being careful of each other's reputation, and use our influence to the upbuilding of the church and for the advancement of the cause of Christ, endeavoring to seek the unity of the Spirit in the bonds of peace, and to confess our faults one to another, and to strengthen those that are weak.
- 3. We promise that by the help of God we will faithfully practice family and secret prayer, and strive to cultivate the doctrine of God's revealed word in the minds of those under our care.

- 4. We also agree to use our influence for the support of the Gospel and to contribute liberally to aid the ministry according to our several abilities. Also we agree to be liberal with those that are afflicted and needy, and especially those of the household of faith,
- 5. We also agree to attend the monthly meetings regularly if not providentially hindered, and submit to all ordinances implied in a Profession of Faith.
- 6. We also agree to abstain from all sinful and vain amusements. of such nor furnish it to others.
- 7. We also agree to abstain from all intoxicating liquors and not to use it as a beverage, nor to aid or assist in the manufacture
- We also agree to encourage home and foreign education, Sabbath schools, good morals, and everything that is to the glory of God and to the welfare of men. And may the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ, that we may be happily admitted into the Kingdom of God, where we may ascribe honor unto the Lamb forever. Amen.

CONSTITUTION OF JACKS CREEK F. W. B. ASSOCIATION MINISTER'S CONFERENCE

- ART. (1) THIS Body shall be known as the Ministers Conference of the Jacks-Creek Association of Free-Will Baptists; shall be composed of all Licensed and Ordained Ministers of "Association."
- ART. (2). THIS Conference may Receive any Christian Minister, as a Visiting Member and when thus received, He may Enjoy all Rights, and Privileges of the Regular Members not in conflict with ART. (3)

ART (3(. THIS Body shall Elect Annually, a President or Mod-

- erator, and a Clerk, both Ordained Ministers, of One (1) Year or more of Membership in this Conference after His Ordination.

 ART. (4). EACH Church may send Two (2) of it's Members as Delegates to this Conference One (1) to be the Steward of His Church; and when thus sent, they are Entitled to a Seat in the Conference with all the privileges of Visiting Brethren, as Frovided by ART. (2).
- ART. (5). THE Conference shall Meet on Friday, before Each Fifth (5th), Sunday, with some Church in the Association, previously agreed upon, or at the call of the President, provided that more than One (1) Session, may not be Held with any Church during the same Conference Year.
- ART (6). THE President is Empowered, and it is His duty, to call an Extra Session fof the Conference, upon the petition of the Members of this Conference, provided however, that said Petition, is properly signed, by Seven (7) Members, Three (3) of whom, shall be Ordained Ministers.
- ART (7) THE Conference, upon being Organized Each Year, shall proceed to Elect an Ordaining Council, composed of Three (3) Regular Ordained Ministers; all having been Ordained at least Two

- (2) Years; and one or more shall have Served One or more Years on Ordaining Council, and One of the Senior Members shall be the Chairman of Council thus Constituted.
- ART (8). THE Ordaining Council, when properly Organized, shall have charge of all Examinations, and Ordinations, of Candidates for the Ministry, who have been Ordained by the Conference
- ART 9). ALL Aplicants for License to Preach, shall be Recommended by the Pastor and Deacons, of His Church, and if the Conference after Due inquiry and prayerful consideration, and after Examination by the Ordaining Council, as to Gifts, Qualifications, and the Divine Call; said Applicant shall be Granted a License to Preach the Gospel, for the period of One (1) Year, provided however, He may have said License, renewed at the Expiration of the Year, from Time to Time.
- ART (10) ALL Licensed Preachers are required to Preach Twenty-Four (24) Sermons Each Year; and at least Fifty (50) Sermons before He can Succeed to Ordination, provided however, He can not be Ordained, until He has proved Him-Self faithful and Successful, in the Gospel Ministry, for a period of at least, One (1) Year; all Ordained Ministers are Required to Preach, Forty-Eight (48) Sermons a Year; and if any shall fail to do so, because of negligence, He shall be Entitled to a Seat in the Conference only as a Visiting Minister, as in ART. (2) provided however, the above Requirements shall not apply to Ministers who have past Sixty (60) Years in Age, or to any Minister who is rendered unable to conform to the above Rules by Disease, or continued Sickness of Himself, or Family.
- ART. (11) ANY Minister being absent from Two (2) Sessions of Conference, in Succession; shall stand charged with Delinquency, and shall be deprived of His Vote on any Question until His Disability is removed by a Vote of the Conference. However, if the Delinquent Brother offer satisfactory Excuse for His absence. His Disability may be removed by a majority Vote of the Conference.
- ART (12) ALL Applicants for Ordination shall present to the Conference a Letter of Recommendation from His Church, properly Signed by both Pastor and Clerk.
- ART (13). THE Conference may withdraw Fellowship from any Member who becomes Disorderly.
- ART (14). NO Session of Conference will be considered Legal, if Three (3) or more Ordained Ministers are not Present.
- ART. (15) THIS Constitution and BY.LAWS, or any ART. thereof, may be Suspended, or Amended, by a two-thirds vote of the Conference.
- ART. (1). THE President or Moderator may have Power to appoint any and all Committees to carry on the Work of the Conference.
- ART (17). A Session of Conference, shall be Held in connection with the Yearly Association.
