Upon presentation of their letter and delegation, they were presented to the committee of investigation. The session then adjourned to meet at 9:00 a. m. Friday with preaching tonight at 7:30. Sister Josephine Mumpower Stevens to give a program at 7:00 for the children. Dismissed in prayer by Bro. T. E. Woody.

WORSHIP SERVICE THURSDAY NIGHT

The congregation came together at 7:00. Bro and Sister Stevens. who are to be sent as Missionaries to Africa, took charge of the service. Everyone was asked to help sing together, "When The Roll Is Called Up Yonder." We were then led in prayer by Bro. Stevens. Through the use of the Flannel-Board, Sister Stevens illustrated the manner of life of those who live in the jungles of Africa This was very interesting to the young as well as the old.

The Choir then sang, "What A Friend Is He," We were then led in prayer by Bro. Quince Miller. After prayer a song, "Holy Light, Keep Shining Upon Me." After which, Bro. Jimmie Arrowood was

introduced and took charge of the service.

For a Scripture lesson he read Philippians 1, 1-26, using as a text the 15th verse, "Some Indeed Freach Christ Even Of Envy and Strife; And Some Also of Good Will" We were given a wonderful message, especially to the Ministry. The service closed with singing We were dismissed by Bro. Ebb Wheeler.

FRIDAY MORNING SESSION

Came together at 9:00 A. M. according to appointment, singing. "Heavenly Sunlight" The devotional service was conducted by Bro. Shelby Beaver, reading 1 Corinthians 13th chapter. The opening prayer was offered by Bro. Arrowood. The minute of Thursday's session was read and adopted. A call was then extended for any Churches present who had not already reported. It was then voted to give the clerk \$1500 and the moderator \$10,00 for their services. An offering was amount of \$15.22 to build up our minute funds. then taken in the

The report of the committee on Missions was called for and read before the body as follows:

MISSIONS

The Apostolic Church recognized as its greatest privilege and duty the work of spreading the Gospel-(that which we call missions) especially to those who had never heard it before. This was true because their vision of Calvary was fresh, and the words of the Saviour—"Go ye into all the world and preach my Gospel" were still like flames of fire in their hearts. With that spirit they progressed, and "The Lord added to the church daily such as should be saved" Without that spirit, we here in this gathering today, would have never heard the Gospel. Our churches, our Christian heritage here in America, are the results of missionary zeal imparted to other hearts by the Holy Spirit.

We, your committee on missions, do therefore submit the fol-

lewing recommendations:

First, as to home missions, that every christian consider himself a missionary, and set about to win those about him to Christ This is not a work intrusted only to those specially called to the ministry; it is the privilege and duty of every Christian to win souls. and the Christian who fails to do so is certainly short of the Lord's perfect will.

Second, as to foreign missions, it has pleased our Master to call one of our sisters, Mrs. Josephine Mumpower Stevens, to go with her husband to the field of Zululand, South Africa, to carry the glad tidings of Jesus. Our sister association, the French Broad, recently voted while in session to contribute at least \$60.00 of the \$90.00 required monthly for her support. A member of your committee who was present, and upon whose heart the Lord had laid the burden of this work; believing that the lord wanted to give us a part in this work, promised to raise the other \$30.00 per month, either by pledges from the churches or individuals in this Association

We, your committee, do therefore recommend, (1) That we ask for pledges from the churches or individual members of our body in whatever amount the Lord may direct each to give until the required

amount of \$30.00 per month is pledyed.

(2) That a committee of one be appointed in our Association to receive these donations and to forward them each month to the State Foreign Mission Board of Free Will Baptists, who will forward them to Sister Stevens. And may the Holy Spirit of God impress our hearts with this great privilege and confirm his will in our body, leading us to deny ourselves, that those in heathen darkness may see His glorious light and be saved.

The service was then dismissed for preaching by Bro. Wheeler.

WORSHIP SERVICE 11:90 A. M.

The congregation came together at 11:00 A M. for preaching by Bro Wheeler. Bro. Jimmie Arrowood sang, "Won't It Be a Happy Time" and "Jesus Is Coming Soon." We were then taken to the Lord in prayer by Bro W. M. Howell. Bro. Wheeler read from James 3 and Proverbs 18-21, which he used for a subject, "Death and Life are in the power of the tongue: and they that love it shall eat the fruit thereof." We were given a wonderful message showing that every beast and animal had been tamed by man but only the Spirit and Love of God could control the tongue of man, that whatsoever is in man's heart, the tongue speaketh. The service was closed with singing and Christian handshake. Dismissed by Bro. Miller until 2:00 P. M.

FRIDAY AFTERNOON SESSION

The body came together at 2:00 P. M. according to appointment. Singing by the choir of "Standing on The Promises" and "I'll Be A Friend To Jesus." The Devotional service was conducted by Bro Clyde Fender who read from Psalms 91. After reading we were led in prayer by Bro. T. E. Woody. The body was called to order by the Moderator. Sister Stanley was present children from the orphanage at Greenville, Tenn The service was then given to her to conduct as she saw fit. The children sang the following songs, "Thy Word Have I Hid In My Heart, The Light Of The World Is Jesus and I'm Gonna Let My Light Shine" The two smallest of the group then sang, I'll Be Somewhere Working For My Lord." The songs were enjoyed by all present. Sister Stanley then extended an invitation unto one and all to visit the Orphanage at Greenville. An offering was then taken with the suggestion that it be divided between the Tennessee and North Carolina orphanage since most of our churches represented at the Association are from North Carolina. The amount received was \$62.26. \$31.13 Sister Stanley, receipt of same in possession of the clerk,

The report on Education was read and adopted as follows:

EDUCATION

Whereas, our young people of our churches have been neglected in the past, in Christian education and our churches have failed to have Bible Schools. Since our children and Young people haven't had the proper Christian training, therefore, we recommend that this association go on record as favoring better training for our young people. We also recommend that each church, through it's pastor, begin this educational training this year with established christians as leaders. And that we encourage those who are engaged in this work rather than discourage them.

The report of the committee on Sunday Schools was received Discussed by Bro. Velmer Bailey and adopted as follows:

SUNDAY SCHOOLS

We, your committee on Sunday Schools, recommend that our churches take a great interest in the work of the Sunday School and encourage its attendance, because it furnishes a certain portion of our christian education and helps to hold up the spiritual condition of our churches. It also prepares our children for the acceptance of Salvation. The church never grows or prospers where there is no Sunday School

The report of the committee on Temperance was received and adopted as follows:

TEMPERANCE

We, your committee on Temperance, report that we have to be a partaker of a thing before we can be temperate in that thing. We urge, and the Bible demands, that our people abstain from all alcoholic drinks and the Lord wants us to be filled with his Spirit. If we are filled with the Spirit of the Lord, we will be temperate in all things.

The report of the committee on Deeper Devotion was read, discussed by Bros. E. P. Blevins, Casie Thomas, Lee Metcalf, Stanley Parkey and Sister Frances Radford, and adopted as follows:

DEEPER DEVOTION

Devotion, in its fullest sense, is self consecration. It is not only an act of worship but an attitude. It is possible for a person to be in full time work, yet not be consecrated. We feel that God's plan for our lives is that we should not only be legally safe but Spiritually and Morally sound. Before a person is regenerated, he must first be convicted of his sins. First, conviction, then regeneration. We must distinguish between willingness to consecrate and consecration itself, for consecration must be an accomplished fact Jesus said in John 4-14, "But the water that I give him shall be in him a well, springing up into everlasting life." We come to the association from time to time and get our vessels filled up. After a time What we need perhaps is "sinking a well of they leak out our own." Altho we may differ somewhat as to when and the result of consecration and use various terms to describe it, we come together and say be honest with God, seek the leadership of the Spirit and he will reveal the Father's will for your life. Soon the clay will be hardened and we will only be that that we allowed God to make.

The congregation assembled at 3:30 for worship service. Singing by the choir of "When I See The Blood and We'll Understand It Better By And By." Prayer by Bro. E. J. Billings opened the service Bro. W. M. Howell then took charge of the service reading from Isaiah 57-15. "For thus saith the high and lofty. One that inhabiteth eternity, whose name is Holy; I dwell in the high and holy place, with him also that is of a contrite and humble spirit, to revive the spirit of the humble, and to revive the heart of the contrite ones. Bro. Howell gave a great message from this scripture, showing that God, in His greatness, His Holiness, reached down through the love and atoning death of Christ, picked up man out of his degredation and sin, cleansed him by his blood and brought man to the place where he could live with God in the spirit in this life and live with Him after this life is over.

WORSHIP SERVICE 7:30

A very large congregation assembled for the 7:30 service. Singing by the choir, "When He Spoke Peace To Me, I'm On The Upward Way and What A Friend Is He." We then had some special singing by the Trinety Quartet of Erwin. They sang, "Down Deep In My Soul and I'm A Debtor I Know." after which we were led in prayer by Bro Loss McCourry. Bro Horace D Poole then read for a Scripture lesson from St. John 3, using for a text the 16th verse, "For God So Loved The World, That He Gave His Only Begotten Son, That Whosoever Believeth In Him Should Not Perish, But Have Everlasting Life." We were then privileged to



listen to a great message on the "Love of God." We were shown that, though man had fallen deep in sin, deep in shame and despair. God loved the man that he had made, in His own Image and Likeness, to such an extent that He was willing to give all that he had, the very brightness of heaven, to save everyone that believe on and accept Christ. Following the message, Quartet of Canton, N. C. came forward and sang several songs which were enjoyed by everyone present, and inspired us to lift our voices in praise unto Him who hath redeemed us by His blood

SATURDAY MORNING SESSION

Song, "I Want To Love Him More" after which a devotional service was conducted by Bro. Coy Davis. The opening prayer was given by Bro, Clyde Fender. After calling the body to order for business, the minutes of Friday's session were read and adopted.

The report of the committee on orphanage was read and discussed by Sisters Julia Boone and Gladys Riddle, Bros. C. J Higgins and Troy McCourry, after which Bro. Fender made some report of his work this past year as field representative for the orphanage. The report was adopted as follows:

ORPHANAGE

Secing that so many children need orphanage care, but for the lack of room we are not able to receive them, we urge our churches to give freely to the support of this great cause. While these children may not be brought up as we would bring them up in our own homes, they are a challenge to us as to citizenship and christian training. We recommend that all our churches set aside one Sunday in each month for an offering for the support of our orphanage Also, lets do not forget for each church to gather the commodities for the orphanage on the first Monday in October, take them to Windom not later than Tuesday evening. The truck will receive them there on Wednesday.

In the discussion of the orphanage work, your clerk, Rev. Troy McCourry stated that while visiting the orphanage in July, that he was asked by the Social Director of the orphanage. Miss Edgeton. to try to raise \$100.00 from our people for the re-furnishing of the girl's dormitory. It was then suggested that we raise the amount. An offering was taken in the amount of \$79.87 to be added to the \$31.13 raised vesterday making a total of \$111.00, (Which been forwarded to the orphanage by your clerk.)

The report of the committee of investigation was received and

read as follows:

REPORT OF COMMITTEE OF INVESTIGATION

We wish to report that we have found the condition and doctrine of the Glen Alpine Free Will Baptist Church to be sound as to the requirements of this association.

as follows:

SESSIONS

JACKS CREEK FREE WILL BAPTISTS

CONSTITUTION OF JACKS CREEK F. W. B. ASSOCIATION

1. This Association shall be composed of delegates chosen and sent from each church.

The delegates chosen and sent shall be recommended in a letter from the church to which they belong and shall include the minister and some of the ablest members belonging to the church.

The Association shall elect annually a moderator and clerk. 3.

The Rules of Decorum shall be read immediately after the

body is organized.

5. The Association will encourage a sound ministry; such as present Christ as an all-sufficient Savior; having made salvation possible for every human being on the terms of the gospel, which is freely offered to all.

6. Any minister in good standing, whether a delegate or not, may be invited to a seat and take part in the deliberations, and have

his name enrolled in our minutes.

7. The Association may appoint such committees as may be necessary to the expedition of business, and every committee appointed to any particular business shall report their proceedings in writing to the Association while in session, and all reports made be adopted or rejected by the body.

8. The Association shall have a book in which shall be kept

an accurate account of all its proceedings.

9. Any church may become a member of the Association by making application by letter or by delegate and adopting our articles of faith and church convenant.

10. The Association may withdraw from any church that

becomes disorderly or refuses to be represented.

11. There shall be an associational fund for defraying expenses and charges that may accrue, and for replenishing such; each church may contribute at pleasure.

- 12. There shall be a treasuer appointed by the Association. whose duty it shall be to have care of and account for the money committed to his charge.
- 13. The Association shall use the Free Will Baptist Treatise in full.
- 14. Each church shall be allowed one vote for every ten members or fraction thereof.
- 15. The Association advises all its churches to commemorate the death and suffering of our Lord at least twice a year.
- 16. The Association shall pay its clerk at least \$5.00 for his services per annum.

ARTICLES OF FAITH

Article 1—The True God. We believe that there is one and only one living and true God who is in personality the Father, Son and Holy Ghost, equal and harmonious in every divine perfection.—"There is one God and one mediator between God and men, the man Christ Jesus, who gave himself a ransom for all to be testified in due time."—1 Tim. 2:6.

- Art. 2.—Holy Scriptures. We believe that God is the author of the Holy Bible, and its teachings constitute the only intallible doctrine for reproof, for correction, for instruction in righteousness. II Tim. 3:16.
- Art. 3.—Original Apostasy We believe that Adam was created holy, but by voluntary transgression fell into depravity and consequently involved his posterity in sin.—And when the woman saw that the tree was good for food and that it was pleasant to the eye, and a tree to be desired to make one wise, sho took of the fruit thereof and did eat. Gen. 3:6.
- Art. 4.—Free Grace. We believe that the grace of God comprehends all spiritual blessings; that the Gospel is the power of God unto salvation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted and made wise unto salvation.....For there is no difference between the Jew and the Greek, for the same Lord is rich unto all that call upon Him. Rom. 10:12.
- Art. 5.....Christian Faith. We believe that Christian faith is belief in Jesus Christ as the Son of God and Redeemer of the world and in the divinity of the Holy Scriptures, that faith comes by hearing the word of God.—He that believeth in the Son hath everlasting life, but he that believeth not the Son shall not see life; but the wrath of God abideth on him. John 3:36.
- Art. 6.—Repentance. We believe that repentance is serrow for sin, and the kind of sorrow which produces Godly repentance must be effectual conviction of sin.—Now I rejoice not that ye were made sorry, but that ye sorrowed to repentance: for ye were made sorrow after a godly manner, that we might receive damage by us in nothing. For Godly sorrow worketh repentance to salvation not to be repented of: but the sorrow of the world worketh death. III Cor. 7:9-10.
- Art. 7.—Free Agency. We believe that the human will is free, and that men have the ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures. He hath showed thee, O man, what is good; and what doth the Lord require of thee, but to do justly, and love mercy, and to walk humbly with thy God? Micah 6:8.

Art. 8.—Perseverance. We do not believe, under the Gospel dispensation, any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men, who have been converted, to make shipwreck of the faith, turn again to sin and be lost. And Jesus said unto him: No man having put his hands to the plough, and looking back, is fit for the kengdom of God. Luke 9:62.

Art. 9.—Good Works.We believe that good works are the result of faith, and not of necessity; that those who have faith will do works of righteousness, while those who have not faith cannot do anything pleasing or acceptable to God.—Every tree that bringeth not forth good fruit is hewn down, and cast into the fire: wherefore, by their fruits ye shall know them. Matthew 7:19-20.

Art. 10.—Christian Baptism. We believe that Christian Baptism.

Art. 10.—Christian Baptism. We believe that Christian Baptism is the immersion of a believer in water, in the name of the Father, Son and Holy Ghost; that baptism cannot be scripturally administered without faith in the subject who receives it. Therefore we are buried with him by baptism unto death: that like as Christ was raised from the dea by the glory of the Father, even so also we should walk in news, so of life. Romans 6:4.

Art. 11.—The Lord's Supper. We believe that the supper was instituted by our Saviour as a commemorative ordinance; that the bread and wine represent His body and blood; that it was instituted for Christians and that all Christians should unite in service regardless of name or denominational distinction.—But let a man examine himself, and so let him eat of that bread, and drink of that cup For me that eateth and drinketh unworthily, eateth and drinketh damnation to himself, not discerning the Lord's body. I Cor. 11:28-29.

Art. 12.—Feet Washing. We believe that washing the saint's feet is a command of our Saviour, and that his followers ought to practice the same.—If I then, your Lord and Master, have washed your feet; ye ought to wash one another's feet. John 13:14.

Art. 13.—The Gospel. We believe it is the duty of all churches to support the Gospel.—Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel. I Cor. 9:14.

RULES OF DECORUM.

Article 1. This Association shall be opened and closed with prayer.

Art. 2. There shall be no conversation by members, one with another so as to interrupt business, while in session.

Art. 3. Every member wishing to speak shall first rise to his feet and address the moderator.

Art. 4. No member shall interrupt another while speaking.

Art. 5. We will admit of no other title but that of Brother, while in session.

Art. 6. Every member speaking shall attend to the subject under consideration.

Art. 7. No member shall speak more than three times on one subject.

Art. 8. Every motion made and seconded shall be attended to, unless withdrawn by those who made it.

Art. 9. No member shall absent himself from the body while in session without leave of the Moderator.

Art. 10. On all motions when the vote of the body is taken, a majority shall prevail.

Art. 11. The Moderator shall have the same privilege to speak as any other member, provided the chair is filled.

Art. 12. Any member transgressing the above rules shall be admonished by the Moderator

CHURCH COVENANT.

1. Maylor given curselves to the Lord through Jesus Christ, we agree to adopt the Free Will Baptist faith, we now give ourselves

to each other by the help of God.

2. We solemnly covenant before God that we will carefully observe the commandments implied by a confession of faith, and in the spirit of meekness rebuke and admonish those who have gone astray, and watch over each other, being careful of each other's reputation, and use our influence to the upbuilding of the church and for the advancement of the cause of Christ, endeavoring to seek the unity of the Spirit in the bonds of peace, and to confess our faults one to another, and to strengthen those that are weak.

3. We promise that by the help of God we will faithfully practice family and secret prayer, and strive to cultivate the doctrine of

God's revealed word in the minds of those under our care.

4. We also agree to use our influence for the support of the Gospel and to contribute liberally to aid the ministry according to our several abilities. Also we agree to be liberal with those that are afflicted and needy, and especially those of the household of faith.

5. We also agree to attend the monthly meetings regularly if not providentially hindered, and submit to all ordinances implied

in a Profession of Faith.

6. We also agree to abstain from all sinful and vain amusements.7. We also agree to abstain from all intoxicating liquors and

not to use it as a beverage, nor to aid or assist in the manufacture of such nor furnish it to others.

8. We also agree to encourage home and foreign missions, education, Sabbath schools, good morals, and everything that is to the glory of God and to the welfare of men. And may the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ, that we may be happily admitted into the Kingdom of God, where we may ascribe honor unto the Lamb fore er Amen.

CONSTITUTION OF JACKS CREEK F. W. B. ASSOCIATION MINISTER'S CONFERENCE

ART. (1). THIS Body shall be known as the Ministers Conference of the Jacks-Creek Association of Free Will Baptists; and shall be composed of all Licensed and Ordained Ministers of said "Association."

ART. (2) THIS Conference may Receive any Christian Minister, as a Visiting Member and when thus received, He may Enjoy all Rights, and Privileges of the Regular Members not in conflict with ART. (3).

ART. (3) THIS Body shall Elect Annually, a President or Moderator, and a Clerk, both Ordamed Ministers, One (1) Year or

more of Membership in this Conference after His Ordination.

ARI. (4) EACH Church may send Two (2) of it's Members as Delegates to this Conference. One (1) to be the Steward of His Church; and when thus sent, they are Entitled to a Seat in the Conference with all the privileges of Visiting Brethren, as Provided by ART (2).

ART (5). THE Conference shall Meet on Friday, before Each Fifth (5th), Sunday, with some Church in the Association, previously agreed upon, or at the call of the President, provided that more than One (1) Session, may not be Held with any Church during the

same Conference Year.

ART. (6) THE President is Empowered, and it is His duty, to call an Extra Session of the Conference, upon the petition of the Members of this Conference, provided however, that said Petition, is

properly signed, by Seven (7) Members, Three (3) of whom, shall

be Ordained Ministers.

ART. (7) THE Conference, upon being Organized Each Year, shall proceed to Elect an Ordaining Council, composed of Three (3) Regular Ordained Ministers; all having been Ordained at least Two (2) Years; and one or more shall have Served One or more Years on Ordaining Council, and One of the Senior Members shall be the Chairman of Council thus Constituted.

ART. (8). THE Ordaining Council, when properly Organized shall have charge of all Examinations, and Ordinations, of Candidates for the Ministry, who have been Ordained before it by the

Conference.

ART. (9) ALL Aplicants for License to Preach, shall be Recemmended by the Pastor and Deacons, of His Church, and if the Conference after Due inquiry and prayerful consideration, and after Examination by the Ordaining Council, as to Gifts, Qualifications, and the Divine Call; said Applicant shall be Granted a License to Preach the Gospel, for the period of One (1) Year, provided however, He may have said License, renewed at the Expiration of the

Year, from Time to Time.

ART (10). ALL Licensed Preachers are required to Preach Twenty-Four (24) Sermons Each Year; and at least Fifty (50) Sermons before He can Succeed to Ordination, provided however, He can not be Ordained, until He has proved Him-Self faithful and Successful, in the Gospel Ministry, for a period of at least One (1) Year; all Ordained Ministers are Required to Preach, Forty-Eight (48) Sermons a Year; and if any shall fail to do so, because of negligence, He shall be Entitled to a Seat in the Conference only as a Visiting Minister, as in ART. (2) provided however, the above Requirements shall not apply to Ministers who have past Sixty (60) Years in Age, or to any Minister who is rendered unable to conform to the above Rules by Disease, or continued Sickness of Himself, or Family.

ART. (11). ANY Minister being absent from Two (2) Sessions of Conference, in Succession; shall stand charged with Delinquency, and shall be deprived of His Vote on any Question until His Disability is removed by a Vote of the Conference. However, if the Delinquent Brother offer satisfactory Excuse for His absence, His Disability may be removed by a majority Vote of the Conference.

ART. (12) ALL Applicants for Ordination shall present to the Conference a Letter of Recommendation from His Church, properly

Signed by both Pastor and Clerk.

ART. (13). THE Conference may withdraw Fellowship from any Member who becomes Disorderly

ART. (14). NO Session of Conference will be considered Legal,

if Three (3) or more Ordained Ministers are not Present.
ART. (15). THIS Constitution and BY-LAWS, or any ART.

thereof, may be Suspended, or amended, by a two-thirds vote of the Conference

ART (16). THE President or Moderator may have Power to appoint any and all Committees to carry on the Work of the Conference.

ART. (17). A Session of Conference, shall be Held in connection

with the Yearly Association.
