In Loving Memory Reverend Theodore Fleenor Sept. 4, 1914 - Sept. 24, 2013

Reverend Fleenor was born in Big Stone Gap, VA to the late Alonza and Myrtle Watts Fleenor. He lived most of his life in Johnson City when he was called home to Glory.

He was a Free Will Baptist Minister for more than 60 years and was currently a member of the Jack's Creek Free Will Baptist Ministers' Conference and a member of Rich Acres Free Will Baptist Church. Through the years, he had been the pastor of First Free Will Baptist Church in Pennington Gap, VA, and West Fairview Free Will Baptist Church in Elizabethton, TN. He had the privilege to preach at more than 45 churches and was still called upon to preach when he was able.

He was a member of the International Brotherhood of Teamsters Retiree's Chapter of Local 549, a member of the Arcana Lodge #489 F&AM, and he was a Shriner.

He was preceded in death by his wife, Gladys Black Fleenor, a daughter, Barbara Bradford, a grandson, six sisters, and one brother. He is survived by one daughter, Kathleen Hill and husband, Kenneth; one son, Richard Fleenor and wife, Pat; one brother, Hershel Fleenor and wife Irene; four grandchildren, thirteen great-grandchildren, and six great-great-grandchildren.

He was a great man of God and will be missed by his family and friends.

PROCEEDINGS July 24, 2014, 10:30 AM

The Jack's Creek Association met for its 119th session with the New Hope Freewill Baptist Church July 24, 2013 at 10:30 AM. A welcome was given by their pastor, Rev. Norman Loveless, who made the necessary announcements. The congregation sang "Heavens Jubilee" which was followed by the opening prayer.

Rev. Stanley McMahan was introduced as the preacher for the opening message. He read passages from II Chronicles 18 and 19. His topic was "Be Not Deceived". He preached about the condition of our

Nation; what it once was and what it is now. In the scheme of things today, we as Free Will Baptist are not important except in the Realm of Heaven. We are recognized and known in the Throne Room of the Lord. God has not changed, but man has changed for the worse. He admonished us to love one another from the heart.

The Ministers' Roll Call was read and the ministers were seated. A call was made for visiting church delegations (none responded) and for visiting ministers. Revs. Verlin Anderson, Frank Woods, and Ted Lewis were welcomed. A call was made for any churches seeking membership in this body (none responded). The election of the Association Officers was made, a list of which is on page 2 of these minutes. Rev. Jonas Revis resigned the position he has held as Disabled Ministers Treasurer for forty years because of his failing health. Rev. Stanley McMahan also resigned. The Board of Directors was asked to appoint someone they felt qualified to fill these positions. The Topic Committees were appointed, and the names of the committee members appear with their submissions later in these minutes.

Rev. Verlin Anderson was given an opportunity to speak and share with us some of his plans regarding his mission work in the Ivory Coast. Since he is no longer with the Free Will Baptist International Missions, we had voted earlier to withdraw our support for him. There was no move to renew his support, therefore, he requested the following letter be included in these minutes.

"We thank you for having faithfully stood with us through trials and tribulations in Cote d'Ivoire over sixteen years. We see the sick healed, the lame walk, sexual and drug addicts freed, and the hungry and malnourished fed as people learn to obey the Lord. We see churches planted as they trust Him directly rather than men who they understand as sent of God to meet their needs. The people God calls to Himself there suffer because they lack knowledge of God's law, just as the people in Hosea's time. Where there is no vision, people perish. Jesus died so that the works of the law that bless us can be accomplished by those who walk in the Spirit, and not by their own personal resources. We work with Ivorians who discover that God's provision is sufficient to meet their needs. We join with them to grow the gifts God has given.

Please be assured we hold you in love and support your decisions made by assembly to be considered as being led of the Lord. We encourage your liberty to continue to assist us and Free Will Baptist International Missions (FWBIM), or not. We will still witness of Christ among Free Will Baptist and other believers. Each is called to liberty to do right. No one's conscience should bear offense when ministering, otherwise zeal lags and we become lukewarm. Our confidence is in the same Lord, not human supporters, whom He provides as needed by His Spirit.

The separation of service that came between the Andersons and FWBIM happened because of honest disagreement between administrative personnel and us as to what it means to plant Free Will Baptist churches in

Cote d'Ivoire, help the poor, and attribute properties. The divide spans more than eight years and was unresolved although both sides made many efforts.

FWBIM administration and we led the Board to evade pronouncing a verdict either way. We, the Andersons, had no fear of the decision for ourselves concerning the precise point upon which the conflict teetered. Two sides, even three, can be distinguished in the debate among Free Will Baptist missionaries who have served there. We did not separate of our own will, but under the duress of a Macedonian call reflected in the lives of others. To force our staying with FWBIM, and openly fight to reverse what led to that called board meeting, would unnecessarily harm FWBIM, which is our common denominational effort to expand FWB witness. Although we offered to be seconded to another organization, it was preferred that we tender our resignation. To stay would have also closed a door of opportunity that has opened to us to touch the entire nation for Christ within our lifetime, village by village. Instead, we chose to separate and multiply the efforts for Christ's Kingdom. Praise God that He has a specific role for each of us in his harvest! May we all be found faithful to obey His commands.

May God bless you, one and all, in the name of Jesus, Rev. Verlin Anderson, RN, and Debbie Anderson"

Bro. Frank Woods from Free Will Baptist Family Ministries gave his report on many of the facets of their ministry. He thanked us for the prayers and support we had rendered. Details of this report are found in the Topic Committee Reports under the Freewill Baptist Children's Ministries.

This session was dismissed in prayer by Rev. Henry Berry.

Thursday Night Session, July 24, 2014

Rev. Norman Loveless opened the service by taking prayer requests. Rev. Charlie Trivette led the altar prayer. Rev. Rickey Hollifield sang "When He Put a Little Sunshine In". Bro. Calvin Edwards sang "Built For Glory" and "This Man Jesus". The service was turned over to Rev. Clyde Thomason and he read Job 2:1-2 and I Peter 5:8. The subject of the message was "The Roaring Lion". Satan is on the move devouring any soul that he can. People are ignoring him, and he is destroying them. Many of our elders who warned us and prepared us to resist him have finished their labors. It seems that there are fewer and fewer who were taught these things taking the necessary stand against Satan now. Who is paying attention to the "roaring of the lion" and taking the immediate action to get to safety? There seems to be so little concern about what is happening by those who are attending church. It is time that professing Christians get back to a holy way of living according to the principles of God's Word. Church leaders should be those that qualify according to the Word; saved by the Grace of God, dedicated in their lives, experienced in walking with the Lord, and battle tested.

Are we obedient unto the Lord? We were saved to do good works in this world. The Word of God should motivate, inspire, and nourish us so that we get excited about doing the great ministry of the Lord. If we draw nigh to God, He will draw nigh to us. Wonderful message!

Note: Sadly there were very few in attendance for this service! We urge each one who reads these minutes to consider attending the Association. There are many wonderful services and great fellowship.

FRIDAY MORNING SESSION, JULY 25, 2014

Rev. Norman Loveless welcomed all to the second day of the Association. We sang a congregational song, "I Love to Tell the Story". Rev. Rickey Hollifield gave the devotional reading Ezk. 36:27 and Rom. 8:9. His topic was the Holy Spirit dwelling in believers. The world does not see the need, but we have the Holy Spirit in us and with us. Without the Holy Spirit we are none of His! He gave much encouragement along with his personal testimony. Prayer was led by Rev. Paul Bennett. The Moderator, Rev. Marvin Hensley, called the meeting to order and read the Rules of Decorum. The Minutes of Thursday's sessions were read and approved. The moderator called for churches that did not report Thursday. The letter from New Hope Free Will Baptist Church was read. The Ministers roll call was made. A call for visiting church delegations was made and none responded. A call for visiting ministers was made and Rev. Verlin Anderson and Rev. Gerald Fender were recognized.

New business was called for and the Rules Committee made a

recommendation that the dates for the Ministers' Conference be changed to the last Saturday in the months of October, January, and April each year. After an opportunity for discussion was made, the vote was taken and the measure was approved. Article 5 of the Constitution and By-laws of the Ministers Conference will be changed to reflect this modification.

Rev. Frank Cable spoke to us about the posters for the Association Revival. He also spoke to us about the need in today's world of incorporating with the State our churches and association. This will protect the members of the church from being included in any law-suit brought against the church. He has some information about this if you would like to know more.

The moderator called for Topic Committees to make their reports. Some of these reports were given before the session was suspended for the 11:00 AM preaching service.

11:00 AM WORSHIP SERVICE

The service began with the congregation singing "Victory in Jesus". Rev. Terry Richardson preached using the verses Col. 4:3 and Eccl. 4. His topic was "Redeeming the Time". The world around us is changing, and we are experiencing changes in our own lives. God has not changed, and we must be aware that this is our time to stand for the Lord. There is a time to be broken; we must be broken in order for God to save and heal us. There is a time for everything under the sun. Hezekiah reached a time to die. There is a time to live. Visit a cemetery, and read the tombstones. We see the time of birth and the time of death, but what about that time that is between represented by only a dash mark?

We want it like it was in the church years ago, so what has changed? Preachers, preach what your people need, not what they want. It's a time to preach to the lost souls all around us. The Lord desires to save the lost because he has no pleasure in the death of the wicked. It's about going Home time. Are you getting ready for your departure from this world?

There is a time to tear down and a time to build up. The Gospel tears down the life of the self-righteous and builds up a life of holiness. It's a time to sow the good seed. When it comes up, it will reveal what was planted. Redeem the time, for our opportunities are few and will soon

pass away.

The service closed with a song and fellowship which was a great blessing. Dismissal prayer and thanksgiving for the food was led by Rev. Stanley McMahan.

1:15 BUSINESS SESSION

The afternoon business session began with Rev. Henry Berry having devotions. He read Ps. 133:1, "Behold, how good and how pleasant it is for brethren to dwell together in unity!" He told us how we need to be careful about injuring our brothers and sisters reputation, but to work to build up each other in the Lord. In the eyes of the Lord, we are all the same. Let us strive to work together in unity. Rev. John Stockton led us in prayer.

Bro. Mike Allison of Free Will Baptist Family Ministries was given the opportunity to speak. He encouraged us to keep our eyes on the Lord. He expressed thanks to all the churches for the support that we have given the Ministry over the years. He reported that ten young boys were saved in a meeting this week. Over 1400 children have made professions of faith in the last 14 years of the ministry. In the past year, 114 babies have been born through the support of the Hope Center. He closed with a song "Serving the Lord"; the theme of which was "Lord, when the world sees me, may they see You".

The treasurer of the Family Ministries Fund gave his report on the monies received at this Association.

Rev. Charlie Trivette presented the nominations for the Disabled Ministers Fund treasurer and his assistant that the Board Of Directors had agreed upon; Rev. Marvin Hensley to serve as treasurer and Rev. Kevin Laws as his assistant. The nominations were approved by a majority vote of the Association. Rev. Marvin Hensley resigned as treasurer of the International Missions Fund, and Rev. Blaine Whitson was elected to serve as the new treasurer.

The moderator resumed calling for the topic committee reports which are printed at the conclusion of the minutes of the Association. The various treasurer reports were called for and they are also printed at the end of these minutes.

There was much discussion about helping Rev. Jonas Revis

financially since he has had many health problems over the last year, and he is still facing many issues. A special offering was received, and it was approved to receive a special offering each night of the Revival to help him out. The Disabled Ministers Investigating Committee will see if there is any further help needed.

The moderator expressed appreciation for New Hope FWB Church hosting this Association. The church did a wonderful job.

The business part of the Association was completed, and the closing prayer was led by Rev. Ronnie Peterson. Worship service will be at 7:00 PM, and the Ministers Conference will meet at 9:30 Saturday morning.

7:00 PM WORSHIP SERVICE

Rev. Norman Loveless opened the service by extending a welcome to all and calling for special prayer requests. Rev. Stephen Miller led the prayer.

Several people came from Sunset Free Will Baptist Church, and their choir sang many beautiful songs. There were other singers there who also sang. Most of all, the presence of the Holy Spirit was manifested, and there was great rejoicing in the Lord. There were some special needs which we took before the Lord in prayer.

We had a wonderful time in the Lord, and we wish all of you could have been there with us. What a wonderful celebration is going to take place in Glory when all the saints from all the ages are united and praising Jesus for making it possible for us to be partakers of that blessed Place He is preparing!!

ASSOCIATION TOPIC COMMITTEES

Churches, pastors, and deacons: We your committee recommend the following: churches should develop a renewed zeal for winning the lost and evangelizing the world. The early churches were greatly concerned for the lost, and souls were saved in great numbers. (Acts 2:4 and Acts 4:4)

We believe that pastors are called by God, not by men to lead the churches of God, and their calling is to preach the Word (II Tim. 4-2). We

encourage the members of our churches to support their pastors with prayer, adequate pay, benefits, and love as they strive to fulfill their calling.

We believe that the position of deacon was ordained by God in the church at Jerusalem. The job of the deacon is a vital one in the church. Disabled Ministers' Fund: Romans 10:14-15 says "How then shall they call on him in whom they have not believed? and how shall they believe in him of whom they have not heard? and how shall they hear without a preacher? And how shall they preach, except they be sent? As it is written How beautiful are the feet of them that preach the gospel of peace and bring glad tidings of good things!" Thank God for his men that carry the Gospel. I truly believe the purpose of the Disabled Ministers' Fund is to take care of the men of God. Just like the Shunammite woman took care of Elisha and sustained him, is the same way we need to take care of our preachers. You be good to God's man, and God will be good to you.

Education: The principle of Christian Education requires two vital components, a teacher and a learner, as is the case with all education. Jesus was the greatest teacher ever, and throughout Acts we find the Apostles' teaching. This entails an expository explanation of the Bible,

principle upon principle, precept upon precept. II Timothy 2:24 instructs us to be "apt to teach", that means not only available and willing, but also prepared and equipped to do so. Thus, we are further instructed in II Timothy 2:15 the following: "Study to shew thyself approved unto God, a workman that needeth not to be ashamed, rightly dividing the word of truth." Thus, in order to advance Christian education, teachers must be informed. This comes only from a dedicated study of the Word. The Scriptures would not tell us to "rightly divide" the Word of Truth if it were not possible to "wrongly divide" it. This is the reason for so much misunderstanding of doctrine, God's servants have not prepared themselves through a study of the Word. Hebrews 5:12 tells us: "For when for the time ye ought to be teachers, ye have need that one teach you again which be the first principles of the oracles of God; and are become such as have need of milk, and not of strong meat." Christians must be willing to instruct others. It is true, we are to be lifelong learners, but we are specifically called to guide others in the ways of the Scriptures. It is a certainty that without deep consideration and prayers, along with a dedicated study of the Word, we will be unable to teach others. Can you answer your child when they ask if something is a sin? Adults, can you explain why? Do you really know what sin is? It's not a list of do's and don'ts. Outward sinful behavior is evidence of inward corruption.

Study, be a student, all your life! Transfer your knowledge and experience to the next generation; someone did it for you! It takes time; take the time to TALK! To your children, your family, your friends! God

tells us to in his Word. Texting is not talking, it's the avoidance of real personal communication. Is our prayer to God like a text message? Short as possible, impersonal, sent while multi-tasking at other things?

Do you have time to be educated by the Spirit? Do you pray for Wisdom? All the knowledge of man taught to a person without the wisdom of the Spirit indwelling simply makes for smarter criminals and politicians. Matthew 10:16 instructs us to be wise as serpents and harmless as doves, for we are sent forth as sheep among wolves!

Articles of Faith

Article 1 - **The True God** - We believe that there is one and only one living and true God who is in personality the Father, Son, and Holy Ghost, equal and harmonious in every divine perfection. "For there is one God, and one mediator between God and men, the man Christ Jesus; who gave himself a ransom for all to be testified in due time." I Timothy 2: 5-6

Article 2 - Holy Scriptures - We believe that God is the author of the Holy Bible, and its teachings constitute the only infallible doctrine "All scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness." II Timothy 3:16

Article 3 - **Original Apostasy** - We believe that Adam was created holy, but by voluntary transgression fell into depravity and consequently involved his posterity in sin. "And when the woman saw that the tree was good for food and that it was pleasant to the eyes, and a tree to be desired to make one wise, she took of the fruit thereof and did eat..." Genesis 3: 6

Article 4 - Free Grace - We believe that the grace of God comprehends all spiritual blessings; that the Gospel is the power of God unto salvation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted and made wise unto salvation. "For there is no difference between the Jew and the Greek: for the same Lord over all is rich unto all that call upon him." Romans 10: 12

Article 5 - **Christian Faith** - We believe that Christian faith is belief in Jesus Christ as the Son of God and Redeemer of the world and in the divinity of the Holy Scriptures; that faith comes by hearing the Word of God. "He that believeth on the Son hath everlasting life, and he that believeth not the Son shall not see life; but the wrath of God abideth on him." John 3: 36

Article 6 - **Repentance** - We believe that repentance is sorrow for sin, and the kind of sorrow which produces Godly repentance must be effectual conviction of sin. "Now I rejoice, not that ye were made sorry, but that ye sorrowed to repentance: for ye were made sorry after a godly manner, that ye might receive damage by us in nothing. For Godly sorrow worketh repentance to salvation not to be repented of: but the sorrow of the world worketh death." II Corinthians 7: 9-10

Article 7 - **Free Agency** - We believe that the human will is free, and that men have the ability to accept or reject the conditions of salvation, "...what is good; and what doth the Lord require of thee, but to do justly, and to love mercy, and to walk humbly with thy God?" Micah 6: 8

Article 8 - **Perseverance** - We do not believe, under the Gospel dispensation, any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men, who have been converted, to make shipwreck of the faith, turn again to sin, and be lost. "And Jesus said unto him, No man, having put his hand to the plough, and looking back, is fit for the kingdom of God." Luke 9: 62

Article 9 - **Good Works** - We believe that good works are the result of faith and not of necessity; that those who have faith will do works of righteousness, while those who have not faith cannot do anything pleasing or acceptable to God. "Every tree that bringeth not forth good fruit is hewn down, and cast into the fire. Wherefore by their fruits ye shall know them." Matthew 7: 19-20

Article 10 - **Christian Baptism** - We believe that Christian baptism is the immersion of a believer in water, in the name of the Father, Son, and Holy Ghost; that baptism cannot be Scripturally administered without faith in the subject who receives it. "Therefore we are buried with him by baptism into death: that like as Christ was raised up from the dead by the glory of the Father, even so we also should walk in newness of life." Romans 6: 4

Article 11 - The Lord's Supper - We believe that the supper was instituted by our Savior as a commemorative ordinance; that the bread and fruit of the vine represent His body and blood; that it was instituted for Christians, and that all Christians should unite in service regardless of name of denominational distinction. "But let a man examine himself, and so let him eat of that bread, and drink of that cup. For he that eateth and drinketh unworthily, eateth and drinketh damnation to himself, not discerning the Lord's body." I Corinthians 11: 28-29

Article 12 - **Feet Washing** - We believe that washing the saints' feet is a command of our Savior, and that his followers ought to practice the same. "If I then, your Lord and Master, have washed your feet; ye also ought to wash one another's feet." John 13: 14

Article 13 - **The Gospel** - We believe it is the duty of all churches to support the Gospel. "Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel." I Corinthians 9: 14

Article 14 - Judgment Day - We believe in one general Judgment Day. Hebrews 9: 27. "Because He hath appointed a day, in the which He will judge the world in righteousness by that man whom he hath ordained..." Acts 17: 31. "When the Son of Man shall come in his glory, and all the holy angels with him, then shall he sit upon the throne of his glory: And before him shall be gathered all nations: and he shall separate them one from another, as a shepherd divideth his sheep from the goats." Matthew 25: 31-32. We believe that the tribulation precedes the Judgment of both righteous and sinners. Matthew 24: 21-31, II Peter 2: 10-13, II Thessalonians 2: 6-9, Revelations 21: 1-6, Revelations 19: 6-9

Church Covenant

1. Having given ourselves to God by faith in Jesus Christ and adopted the Word of God according to the original Free Will Baptist doctrine as our rule of faith and practice, we now give ourselves to each other by the help of God.

2. We solemnly covenant before God that we will carefully observe the commandments implied by a confession of faith, and in the spirit of meekness, rebuke and admonish those who have gone astray, and watch over each other's reputation and use our influence to the up-building of the church and for the advancement of the cause of Christ, endeavoring to seek the unity of the Spirit in the bonds of peace, and to confess our faults one to another, and to strengthen those that are weak.

3. We promise that by the help of God we will faithfully practice family and secret prayer, and strive to cultivate the doctrine of God's revealed Word in the minds of those under our care.

4. We also agree to use our influence for the support of the Gospel and to contribute liberally to aid the ministry according to our several abilities. Also, we agree to be liberal with those that are afflicted and needy, and especially those of the household of faith.

5. We also agree to attend all regular meetings regularly if not providentially hindered and submit to all ordinances implied in a Profession of Faith.

6. We also agree to abstain from all sinful and vain amusements.

7. We also agree to abstain from all intoxicating liquors and not to use it as a beverage, nor to aid or assist in the manufacture of such nor to furnish it to others.

8. We also agree to encourage home and foreign missions, education, Sabbath schools, good morals, and everything that is to the glory of God and to the welfare of men. May the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ, that we may be happily admitted into the Kingdom of God, may ascribe honor unto the Lamb forever. Amen.

Constitution of Jack's Creek Free Will Baptist Association

1. This Association shall be composed of delegates chosen and sent from each church.

2. The delegates chosen and sent shall be recommended in a letter from the church to which they belong and shall include the minister and some of the ablest members belonging to the church.

3. The Association shall elect annually a moderator and a clerk. The moderator shall not serve more than four (4) consecutive terms at one time. Amended August 9, 1986

4. The Rules of Decorum shall be read immediately after the body is organized.

5. The Association will encourage a sound ministry; such as present Christ as an all-sufficient Saviour; having made salvation possible for every human being on the terms of the Gospel, which is freely offered to all.

6. Any minister in good standing, whether a delegate or not, may be invited to a seat and take part in the deliberation, and have his name enrolled in our Minutes.

7. The Association may appoint such committees as may be necessary to the expedition of business, and every committee appointed to any particular business shall report their proceedings in writing to the Association while in session, and all reports may be adopted or rejected by the body.

8. The Association shall have a book in which shall be kept an accurate account of all its proceedings.

9. Any church may become a member of the Association by making application by letter or by delegate and adopting our Articles of Faith and Church Covenant.

10. The Association may withdraw from any church that becomes disorderly or refuses to be represented.

11. There shall be an Association Fund for defraying expenses and charges that may accrue and for replenishing such. Each church may contribute at pleasure.

12. There shall be a treasurer appointed by the Association, whose duty it shall be to have care of and account for the money committed to his charge.

13. The Association shall use the Freewill Baptist Treatise in full.

14. Each church shall be allowed one vote for every ten members or fraction thereof.

15. The Association advises all its churches to commemorate the death and suffering of our Lord at least twice a year.

16. The Association shall pay its clerk at least \$5.00 for his services per annum.

Constitution And By-Laws Jack's Creek Free Will Baptist Ministers' Conference

Article 1. This body shall be known as The Ministers' Conference of the Jack's Creek Association of Free Will Baptist and shall be composed of all licensed and ordained ministers of said Association.

Article 2. This Conference may receive any Christian minister, as a visiting minister. He may take part in any Biblical discussion. He may not vote or take part in the transaction of business matters.

Article 3. This body shall elect a moderator quarterly, and a clerk annually, both ordained ministers of one year or more membership in this Conference after his ordination. Amended August 1, 2009

Article 4. Each church may send two of its members as delegates to this Conference with all privileges of visiting brethren, as provided by Article 2.

Article 5. This Conference shall meet on the last Saturday of October, January, April, and the Saturday of the yearly Association with some church in the Association previously agreed upon or at the call of the moderator, provided that more than one session may not be held with any church during the same Conference year. Amended July 25, 2014

Article 6. The moderator is empowered and it is his duty to call an extra session of the Conference upon the petition of the members of this Conference; provided, however, that said petition is properly signed by seven members, three of whom shall be ordained ministers.

Article 7. The Conference, upon being organized each year, shall proceed to elect an Ordaining Council composed of five regularly ordained ministers; all having been ordained at least two years, and one or more shall have served one or more years on the Ordaining Council, and one of the senior members shall be the chairman of the Council thus constituted. It shall be their duty to examine candidates, grant licenses, and conduct ordinations.

Article 8. The Ordaining Council, when properly organized, shall have charge of all examinations and ordinations of candidates for the ministry who have been ordered before it by the Conference.

Article 9. All men applying to this Conference for a license to preach, for ordination, or for membership, shall present a letter of recommendation from the Free Will Baptist Church of which he is a member. This letter shall be dated and signed by the pastor, the deacons, and the clerk. Upon the majority approval of this Conference, the applicant will be received under our watchcare. The applicant shall sign a waiver permitting our Investigating Committee to check on his personal life. The Committee should submit their report at the next scheduled conference. If the Committee recommends the applicant and the majority of the Conference approves, the applicant and his wife (if married) will be questioned by the Ordaining Council as to his divine calling, his qualifications, and his doctrinal beliefs. Upon the approval of the Ordaining Council and the majority approval of the Conference, the applicant will be licensed, ordained, or accepted as member of this Conference. No member shall meddle with the work of another or injure his reputation for usefulness, but watch over each other in love, and thus promote harmony and love among the membership.

Article 10. Revised by a unanimous vote March 9, 2003. All applicants licensed by this Conference will be licensed to preach for one year. Upon the majority approval of the Conference, the license may be renewed annually. This license does not permit the licensed preacher to officiate at a marriage. A licensed

preacher may baptize converts and administer the Communion and Feet Washing service under the direct supervision of an ordained Free Will Baptist minister. Licensed preachers are expected to preach at least twenty-four sermons a year. If any preacher neglects to do so, (unless providentially hindered) he will be entitled to a seat in this Conference only as a visiting minister. All new licensed preachers will be assigned to one of our most able pastors for the period of two (2) years. Only pastors that are willing to accept the responsibility to work with the licensed preachers will be asked to participate. The licensed preachers in this program are with the pastor to observe and learn and are not to interfere or hinder the work of that pastor. The licensed preacher will not be considered to be an associate pastor. The senior pastor that he has served under will, at the end of the two (2) years, present a complete report to the Ministers' Conference in a written letter. Any new applicants on or after this date, March 29, 2003, will be required to go through this program. The new applicants are asked to attend the senior pastor's church when he is not preaching somewhere. The licensed preacher at the end of this program, providing a good report was received from the senior pastor, may request to be ordained . Amended August 1, 2009

Article 11. Each member is urged and expected to attend all regular meetings of the Conference. Any minister being absent from two sessions of the Conference in succession shall stand charged with delinquency and shall be deprived of his vote on any question until he offers a satisfactory reason for his absence. His delinquency charge may be removed by a majority vote of the Conference. Any minister who does not report to the Conference in any fashion for one year shall be dropped from the roll and his credentials called for.

The above requirements shall not apply to any minister who is rendered unable to attend by reason of a continued disability of himself or his family. The minister or his family may report such circumstances in a letter to the Conference or by phone call or e-mail to the clerk or assistant clerk.

Article 12. Ordained ministers (men) from sister Associations seeking membership with this Conference shall present a letter of recommendation from their Conference, dated and signed by the Moderator and Clerk, in addition to the requirements of Article 9. If the Applicant is accepted by this Conference, a new Certificate of Ordination will be issued with the name of his original Conference and the names of the Ordaining Council on the margin.

Article 13. The Conference may withdraw fellowship from any member who becomes disorderly. Any person presenting a charge against a minister must sign his name to the charge or it will be null and void.

All charges against a minister will be brought to the Conference and a recommendation made before proceeding farther. Amended August 10, 1996

Article 14. To constitute a quorum, at least half of the members on the roll must be present in order for the meeting to be called to order and business conducted. No session of Conference will be considered legal if fifteen or more ordained ministers are not present. Amended August 1, 2009

Article 15. No member shall serve as a pastor of a church which does not enforce discipline, care for its pastor, and contribute to other benevolent enterprises according to its ability.

Article 16. The moderator shall have the power to appoint any or all committees to carry on the work of the Conference.

Article 17. Necessary expenses of this organization shall be met by voluntary contributions or by assessment of the members.

Article 18. This Constitution and By-Laws, or any article thereof, may be suspended or amended, by a two-thirds vote of the Conference.

Article 19. Membership in this body shall be proof of good standing in the ministry.

Article 20. This Conference will only allow its members to preach, teach, and use the King James Version (KJV) of the Bible as we believe it is the infallible Word of God. Added August 1, 2009

The above Constitution and By-Laws was duly adopted by Conference in regular session at North Bend Free Will Baptist Church, June, 1919. Re-adopted in Conference, September, 1944. Revised and re-adopted at Locust Gap Free Will Baptist, Mountain City, TN, August 9, 1975. Amended March 28, 2003

Resolutions and Rules - Adopted Since 1948

53rd Session 1948 - When committees are chosen for the Association, they are to have a minister as chairman. The remainder of the committee is to be chosen from the delegates.

60th Session 1955 - A motion was passed not to license any woman to preach.

63rd Session 1958 - Any person teaching or holding a church office is to be a member of the Free Will Baptist denomination.

76th Session 1971 - Any person writing a letter to the investigating committee must sign the letter or the letter will be considered null and void.

80th Session 1975 - Jack's Creek Ministers' Conference is opposed to the so called Millennium or Millenial Doctrine as preached today. Any of our ministers found to be preaching or teaching this said doctrine, shall have their license called for and their names dropped from the ministers roll.

83rd Session 1978 - The Jack's Creek Free Will Baptist Association does not condone, or allow homosexuality among its people, that it is deemed to be a deadly sin. Leviticus 20: 13, Romans 1: 26-32. Also we are opposed to abortion in any form. "Thou shalt not kill," the fifth Commandment, Exodus 20:13. (Amended by Association July 29,2011)

84th Session 1979 - No minister will be allowed to serve on more than one committee of investigation or ordaining council.

Jack's Creek Ministers' Conference does not condone our ministers performing a wedding, and joining together in Holy Matrimony anyone who has been previously married and divorced.

The following rules and motions that govern our body have been adopted since the above list was prepared.

August 13, 1983 - Ministers' Conference - Concerning ministers marrying people that have been divorced: "If they have separated, divorced but not re-married, and get back together (and choose) to remarry, a minister may marry them."

"We, your Ordaining Council, recommend to the Conference that a By-Law be passed that any preacher, who leaves his church and starts a New Work within (10) ten miles, consisting of members of the Old Church, be dealt with by the Conference by calling for his credentials.

89th Session 1984 - Resolutions Committee Report: We make a motion that the following resolution be accepted, "This committee will be known as the rules Committee. It shall consist of five men: three deacons and two pastors. None on this committee shall belong to or attend the same church. All motions to make new, or change existing rules or bylaws, shall be given to said committee in writing and signed. The committee will consider the motion, then upon its decision, bring the motion to the floor for explanation in detail. This body shall then vote on the motion as they may choose. However, if the committee cannot agree that the motion should be presented to the body, the motion will then be dead."

August 12, 1994 - Rules Committee Report: "We also make the following

motion: No one is to be nominated for any office or committee unless present at the meeting in which the nomination occurs, unless the nominee has been informed and agrees prior to the nomination to accept the position if elected."

August 8, 1997 - Rules Committee Report: "The Treasurer and Assistant Treasurer of the Jack's Creek F. W. B. Disabled Ministers' Fund will be elected by the Jack's Creek F.W.B. Association for an indefinite period of time. A new Treasurer and/or Assistant Treasurer may be elected at the request of the current treasurer, at the decease or withdrawal from the Association by the treasurer, or by a majority vote of this Association."

August 7, 1998 - Bro. Charlie Trivette presented the church flag and a certificate to be given to all ministers' wives or next of kin at the close of a minister's funeral. The idea was accepted and agreed to be paid for out of the Home Missions fund, motion being approved by the Association.

November 28, 1998 - A motion was passed that anyone bringing a charge against a minister in the Conference would be subject to being investigated by the same Investigating Committee as the minister, before the charge would be brought before the Conference.

July 30, 1999 - 1 p.m. Business Session: A motion was passed to reprint and use the Treatise that was written by the Committee appointed in 1985.

October 28, 2000 - Ministers' Conference - Bro. Charlie Trivette spoke on the flags to be presented at funerals of deceased ministers. Bro. Trivette made a motion that the presiding minister call in advance to find out the wishes of the family. The motion was approved.

September 29, 2001 - Ministers' Conference - A decision was made that when a Conference was called (postponed) after inclement weather, it would be a standing rule that it would convene the next Saturday.

January 29, 2005 - Ministers' Conference - A motion was passed stating, "If the Investigating Committee got a signed letter requesting an investigation of a preacher ten days or sooner before the next Conference they have the authority to go ahead with the investigation. If it was within the ten days before the next conference, they will wait for the Conference Approval."

By- Laws Jack's Creek Free Will Baptist Disabled Ministers' Fund

1. This organization shall be known as the Jack's Creek Free Will Baptist Disabled Ministers' Fund. Therefore, it is not to be considered as a retirement program.

2. The purpose of this fund shall be to render financial aid to any member in good standing. However, the need must be due to a physical disability.

3. This fund shall be managed by a board of directors consisting of five men, three of these will be ordained ministers and two church laymen. Board members will be appointed by the Association and will serve for a five year term. Each member's term will expire in a rotating manner that will require one new member to be appointed each year. Each member will serve his last year on the board in the position of board chairman. It will be the responsibility of the board to manage this fund in such a way to provide the most return possible for the money we may have to invest. It will also be the responsibility of the board to budget the amount of money available to pay out each year. The amount to be used each year will be the amount of interest earned on the money invested.

4. Funding of this organization shall be done by requesting each member of the Conference to voluntarily take at least five dollars per week from his regular church contributions, or whatever amount God may direct him to give on a regular basis. This may be accomplished either by allowing the church the minister is pastoring to deduct the amount each week from his salary, and writing a check to the quarterly Conference for the amount deducted, or the ministers may bring their contributions to the conference. Anyone contributing to this fund will receive a receipt for their contribution. Churches are to be encouraged to take part in the support of this program as they feel God would have them to do. The funding of this program is never to be considered as dues to be paid, or a tax to be levied on the ministers or churches.

5. Qualification for financial help shall not be established at any given age, due to age alone. Financial help shall be given when properly applied for after the investigating committee has made a fair and impartial investigation. If the application is approved, the investigating committee has the authority to request help for the applicant up to the amount of three hundred dollars (\$300.00) without consulting the board of directors, providing an application has been completed for a record to be reviewed by the board of directors. Otherwise the board of directors will be consulted and said board will determine the amount and method of financial help to be given. The board may direct the amount to be paid in lump sum or monthly for the duration of the need. (Amended August 12, 1977)

6. A standard form application will be furnished by the organization. This application is to be properly completed by the investigating committee while the investigation is being conducted. Application for financial help may be requested by the individual in need, or by the church to which he belongs or may be pastoring.

Burial Fund

Article 1. This fund shall be known as the Jack's Creek Free Will Baptist Ministers' Burial Fund.

Article 2. This fund has two levels of benefits to choose from: (A) For an annual premium of \$15.00, a member will receive \$500.00 of death benefits. (B) For an annual premium of \$30.00, a member will receive \$1,000.00 of death benefits.

Article 3. Participation in this program is completely voluntary.

Article 4. Any minister, who is in good standing and a member of the Jack's Creek Ministers' Conference, has the option to participate in this program, provided he makes that election within one year of the date he becomes a member of this Ministers' Conference. His wife has the option to participate in this same program for the same benefits and the same annual premium. Her premiums will be in addition to his premiums.

Article 5. A membership application must be completed, signed, dated, and the first annual premium paid to be enrolled in this program.

Article 6. Annual premiums are due and payable in advance at the Ministers' Conference held in conjunction with the Jack's Creek Free Will Baptist Association each year. On October 29, 1983, a motion was passed to give a 90 day grace period (for paying annual premium) on Burial Fund.

Article 7. Any minister, who fails to pay his annual premium, who withdraws from the Ministers' Conference, or who is dismissed from the Ministers' Conference, forfeits his rights to the benefits of this program. He is not entitled to a refund of any of the premiums paid into this Fund. If his wife is a member of this program, she forfeits her benefits and will not receive any refund of premiums paid.

Article 8. If the minister precedes his wife in death, she has the option to continue in this program as long as she conducts herself as a Christian, remains unmarried, and pays her annual premiums.

This program was established August 12, 1978. The second benefit level (B) was added August 8, 1980.


