# **Rules of Decorum**

- **Article 10.** On all motions, when the vote of the body is taken, a majority shall prevail.
- **Article 11.** The Moderator shall have the same privilege to speak as another member providing the Chair is filled.
- **Article 12.** Any member transgressing the above rules shall be admonished by the Moderator.

# **PROCEEDINGS**

The 124<sup>th</sup> Jack's Creek F.W.B. Association met at Sunset F.W.B, Church, Roan Mountain, Tennessee at 10:30 AM. The pastor, Rev. Terry Richardson, welcomed the assembly and took care of the administrative duties. Prayer was lead by Rev. Rick Wood. The Sunset choir then sang "I Just Want To Thank You Lord.," "It Will Be Worth It After While," "I Keep Praying," "It's Shouting Time In Heaven", and "I Want To Stroll Over Heaven With You." Several testimonies were then given. Rev. Rick Wood gave his testimony and praise report from his accident.

The opening message was given by Rev. Norman Loveless, reading from Acts 16:16. He began by thanking the churches for prayer through his sickness. He preached why and how Paul and Silas were placed in prison. He then talked about the woman "diviner" and the harm she was causing. She had become a slave to demons. He then said that we as church members should be a slave and servant to Christ and his church.

He pointed out that we have a job to do in working in the church. He spoke about the condition of our church and said that a lot of members need to repent and talked about the woman as a fortune teller and how the demon was cast out by Paul, then the crowd rose up against Paul and Silas. They beat them and cast them into prison where at midnight they sang and prayed. Then an earthquake loosed their bonds and opened the prison doors. The jailer was so convicted he said "What must I do to be saved?" That night he and all his house were saved! He encouraged the church to keep fighting for lost people in our communities! He preached an inspiring message.

Prayer was given by Rev. Bernie Jones who also blessed the food for lunch.

#### **Afternoon Business Session**

The afternoon session began with Pastor Terry Richardson welcoming the Association back. Rev. Ralph Hedrick gave the devotion from Hebrews 2. He spoke on our growth in the word as a Christian and how important it is that we indeed grow! We cannot grow with out the anointing of the Spirit on the Word. It becomes food for our soul. We have strength in His Work to help us grow! It was a great devotional. Brother Ronnie Peterson led in prayer.

The Moderator, Rev. Marvin Hensley, then read the Rules of Decorum and called the business session to order. He then proceeded to the election of officers for the Association for the coming year. Rev. Marvin Hensley will serve as Moderator with the assistant to be Rev. Charlie Trivette.

The minister roll call was given and the ministers were seated. There were no visiting churches and no churches were seeking membership. There were no visiting ministers.

Officers of the Association were elected as recorded in the opening pages of this minute report.

The Sessions Committee was elected. The members are Rev. Terry Richardson, Brother Carson Jones, and Brother Jody Cox.

Brother Mike Allison from Free Will Baptist Ministries spoke regarding the new COO (Chief Operating Officer) Jim Robinette as of August 1<sup>st</sup>.2019 and gave background information about him. He announced and invited all to the 80<sup>th</sup> Homecoming Celebration October 26<sup>th</sup>, 2019 beginning at 10:30. He then reviewed the progress and successes of the ministry. (A report in full follows from Rev. Jim McComas, new Executive Director/CEO from Saturday's session).

The Sustainability Committee Chairman Rev. Scott Jenkins presented proposed changes to the Disabled Ministers Fund Rules. The proposals were tabled until Friday's session.

The Moderator called for the Association Committee Reports:

Time having expired for the daily business, the Moderator called for closing prayer. Brother Jim Ayers was anointed with much fervor of pray. The Moderator led the anointing service.

# 7:00 PM Worship Service

Pastor Terry Richardson welcomed the congregation. He asked for prayer requests, which were many for the lost, the sick, the military, and the nation. An altar of prayer followed. The Sunset choir sang "I Believe He's Coming Back," "My Hope Is In The Blood," "Lord, You Are the Best Thing That Ever Happened To Me," "I'm Going Home," "Consider The Lilies," and "Saved To The Uttermost." It was Spirit filled singing!

Rev. Henry Berry brought the message reading Psalms 116:15 "Precious in the sight of the Lord is the death of his saints." He said that we are to step out in faith and do the will of God to love one another without dissimulation. He encouraged us to call the lost to repentance, not shame them in church, but gently entreat them as a shepherd calls his sheep. He proclaimed that there will be joy in that heavenly land for all the precious saints of the Lord! He did a wonderful work for the Lord.

Sister Kay Richards testified of a faithful father and his love for his Bible. He had read it through more than 39 times and stopped counting. A deep Christian Heritage is a precious and priceless gift!

Pastor Richardson commented and closed the meeting with prayer led by Rev. John Stockton.

# Friday Morning Session, July 26, 2019, 9:30 A.M.

The service began with Pastor Terry Richardson welcoming everyone. The congregation sang "Oh, How I Love Jesus", led by Bro. Danny Cox of Sunset. Rev. B.F. McKinney Jr. led devotions by reading I Peter 5:1-4. The world is not "Home" he declared. There is reason for no Spiritual Power and our condition today: pastors don't feed the flock! We must make sure that the Spiritual food is CLEAN. It takes the pure anointed Word of God to feed the flock! He gave an encouraging devotional.

The session was called to order by the Moderator, Rev. Marvin Hensley, who read the Rules of Decorum. The clerk read the minutes from Thursday's sessions and they were accepted with one modification. An additional church letter was read from Crabtree FWB Church and their delegates seated. Rev. Charlie Trivette suggested that we contact delinquent churches. Rev. Marvin Hensley commented on delinquency and the fact of individual church independence. Rev. Blaine Whitson reported that we had sent letters last year to said churches with no response. Rev. Terry Richardson encouraged churches that they have responsibility on their own. Rev. Rodney Deyton encouraged individuals in the Association to contact acquaintances from the delinquent churches and encourage them to participate.

The minister roll call was taken and ministers were seated.

There were no visiting churches and no churches asking for membership. There were no visiting ministers.

The Moderator then called for committee reports.

The Moderator then dismissed business for intermission until preaching services.

"Divine Providence" to be read in the afternoon session.

# 11:00 AM Worship Service

The pastor, Rev. Terry Richardson, welcomed the association back.

The church sang "Power In The Blood." Sister Vanessa Cox testified and sang "Why Should I Worry?" and sister Gena Bagby sang "Sweet Beulah Land." Rev. Frank Cable gave the message reading from II Peter 1:1-7. He opened the message praising God for his many blessings though his health challenges this year, throughout life, and the hope of eternal life. His desire was to "encourage the Association and Conference." He requested that each individual open their heart and receive what God wants them to receive, accordingly, we will be blessed. More exists in life than what we see naturally. There is a depth of spirituality beyond the surface. 1st Corinthians declares that there is a foundation no other can lay: Jesus Christ. We can build on that foundation and it would be wise to build with precious materials. There is also another existence beyond this life according to scripture. At the end of this world there is a judgment of what we have built on this Foundation, "revealed by fire!" Peter advised us to build by adding "to your faith..." The body of the church is us, the individuals, "the bride." Can we find a "virtuous woman?" Do Christians who profess Christ display Him in our lives? He noted a list of qualities among which are fidelity, loyalty, faithfulness, and honesty, which we should practice. How great a work God did to create us unto good works and purge our conscience unto good works by His Blood. He encouraged us to search our hearts and fulfill the mission of Christ to our own benefit. He closed the message by leading the congregation in "What A Day That Will Be" and fellowship. He preached a very uplifting message. Rev. Stanley McMahan closed with prayer and a blessing upon the food.

#### 1:30 PM Business Session

The session began with the pastor welcoming everyone back. The congregation sang "Where Could I Go But To The Lord." Devotion was given by Rev. Rickey Hollifield reading from 1 Cor. 4:2 "Moreover it is required in stewards, that a man be found faithful." His topic was "Accountability." Glorify God, take your faith with you always, and be accountable. 1Cor 6:20- you are bought with a price. Matt. 12:36- shall give account of every idle word. Luke 12:48- of whom much is given, much is required. Rom. 14:12- give account of himself to God. We are to show ourselves approved. Prayer was led by Rev. Ralph Hedrick.

The Moderator called the session back to order and requested that the Home Missions report be read.

**Home Missions:** Young's Chapel, (read by clerk) Topic: Ye Are The Light Of The World (There is a day of accountability) [Full report included in "Committee Reports" section]. Due to "Divine Providence"

the report timely reaffirmed the opening devotion of Rev. Hollifield. It was Spirit anointed with power and read with tears! Praise God!

Rev. Marvin Hensley gave an interim report of the finances of the Disabled Ministers Fund. A complete report will follow in the printed minutes.

The Sessions Committee reported on their progress. (See Sessions on inside front cover for report details).

Rev. Ralph Hedrick requested prayer for sister Gail Duncan (wife of Rev. Jeff Duncan) who is at this moment undergoing serious surgery. The congregation stood in a prayer of intervention and petition.

Rev. Blaine Whitson was nominated and seconded for the position of Sustainability Committee member replacing Rev. Scott Jenkins. The motion was passed.

Rev. Adam Miller addressed the Association about the tabled Sustainability Committee submission from yesterday. He reported that after a conference with the Board of Directors of the Disabled Ministers Fund and the Sustainability Committee to review previous regulations of the fund, it was decided to table any changes until a further meeting and complete review of by-laws in order to have proposals of change that would concur with all requirements of the rules. A meeting will be scheduled when the members confer at the conclusion of the morning session.

He stated the reality that we acknowledge that the Association appears to be "dying". Several churches have left and minister numbers have declined from more than 70 to 45. He suggested that (1) ministers discuss this with their congregations and explain the ramifications to follow, (2) Preachers need to give in support of the Disabled Ministers Fund, (3) Special offerings need to be announced in advance of conference meetings in order for better preparation to give since a lot of people use electronic cash instead of currency. The Moderator spoke encouraging contribution to the fund.

A Home Mission interim finance report was given by Rev. Adam Miller (final report to be in minutes).

The Annual Jack's Creek Conference Revival will be held September 16, 2019 at Mt. Calvary FWB Church at 7:00 P.M. nightly. Speakers will be appointed by drawing at tomorrow's conference.

The Moderator praised Sunset FWB Church for their hosting of the Association. Pastor Terry Richardson praised the Lord for all his blessings at Sunset. Closing prayer was given by Rev. Bobby Revis.

# 7:00 PM Worship Service

The evening service began with Pastor Terry Richardson welcoming everyone. He complimented church member Danny Cox who delivered a wonderful committee report today (Amen!) He encouraged the church to endure and be faithful for the Lord is coming! He received many prayer requests from the congregation. Prayer was led by Rev. Charlie Trivette. The Sunset youth choir sang "Brother We Have Gathered," "He Set Me Free," "Tis That Old Time Religion." Gabe Gouge and Vanessa Cox sang "Beulah Land." Brother Gouge, a youth member, spoke boldly of the blessings and the plan of the Lord for each of us. McKenzie Buckles sang "He Knows My Name." The choir sang "Are You Washed In The Blood?" and "I'd Rather Be An Old Timed Christian." Another duet of girls sang "It's Under The Blood." The choir sang "There Ain't Nothing Gonna Steal My Joy." # ASSOCIATION TOPIC COMMITTEE REPORTS Church Operations:

Churches, Pastors, and Deacons: North Bend FWB Church

The local church is a group of believers in Christ who have covenanted together to spread the Gospel, to grow in the knowledge of Christ, and to give Him praise and honor. The head of the church is Christ. He takes each member, as a spiritual stone, and unites them with other believers into a holy temple (Ephesians 2:21). The church works together to fulfill our Great Commission of spreading the Gospel of Jesus Christ (Matthew 28:18-20).

There are many parts of a building in the natural world. Each part has its role to play in making the structure strong and long lasting. We, as spiritual stones, have our duties and obligations. Two of these stones are the pastor and deacon. These are the servant leaders of the church. Christ has placed some to lead and others to follow. As the pastor and deacons follow Christ, so is the church to follow them.

The church must always remember Christ has given qualifications for men who will fulfill these duties (I Timothy 3 and Titus 1). These qualifications are not recommendations. They were placed in the Bible to be followed. If a man does not meet these qualifications, he should not be placed into either of these positions. As we follow Christ as our Savior, we must also follow his direction in all facets of our lives. This is very important as the church places men into these leadership positions. Let us never leave the Master's plan when building the church.

The pastor serves the church by feeding the congregation through the preaching of the Word of God. He is to reprove, rebuke and exhort. He is to do this with long suffering or patience. He is to do this through Biblica instruction (I Timothy 4: 1-2). The pulpit is not a place for wives fables and traditions. It is a place to preach the Word and the Word alone. The preaching of the Word will bring repentance. It will be conviction to the lost. It will bring healing to the sick and afflicted. Preaching will feed the flock and lead to growth and spiritual maturity.

The deacons serve the church by tending to the physical needs of the congregation. The position of a deacon first started in the early church to care for the needs of the widows (Acts 6). These men were to make sure no widows were overlooked. Stephen was one of the first seven deacons. He fulfilled his duties and proclaimed the Gospel, and he eventually was a martyr for the faith.

Deacons, pastors and the entire church are to be united in our love for Christ. As God the Father, the Son and the Holy Spirit was united, we are also to be working together as one body. These three sections of the body are not to be working against each other. We are to be working together to bring honor and glory to our Savior. Remember, Christ is the head and we are parts of the body. Each role in the body is important. Our prayer is that each church will be united to spread the Gospel of Jesus Christ.

# Free Will Baptist Family Ministries: Rev. Jim McComas

(Excerpted from FY19 Executive Summary Report)

God has been good to Free Will Family Ministries, allowing us to serve for over seventy-nine years. As we approach our eightieth birthday it is evident that God has used the ministry to win countless souls to Christ. If "but one" enters the kingdom because of our efforts, everything we have done will have been truly worth it. Today, almost one hundred children are actively in care with Family Ministries. This number continues to grow, as we maintain our focus on serving the fatherless and motherless in Arkansas and Tennessee.

In the early 2000's, Family Ministries expanded to include another group of vulnerable and often uncared-for people. Our programs in Virginia and Tennessee that minister to the elderly have grown over the past twenty years to include almost one hundred individuals in care as well. We have also expanded to care for pregnant young women who are in helpless situations, including care for their newborn babies. Every day, when the sun rises, Family Ministries' caregivers work with over three hundred children, pregnant girls, and elderly. We are beyond thankful for the ministry opportunities God has provided as we continue forward into our eightieth year of service.

2018-2019 has been a year characterized by change for the ministry. The Board, under the leadership of Noah Taylor, selected Jim McComas as the next chief executive officer of Free Will Baptist Family Ministries. (Replacing retiring Rev. Frank Woods.) He pastored Canaan Free Will Baptist Church of Creston, Ohio, for twenty-one years. Jim was very involved in the community as well as denominational leadership, serving on the board of directors of both the Wayne County Pregnancy Care Center and the Ohio State Association of Free Will Baptists.

For the past nearly five years, Jim has worked for the denomination as director of church revitalization for Free Will Baptists North American Ministries. In this position he traveled from state to state singing, teaching, and preaching, in hundreds of Free Will Baptist Churches.

Family Ministries is at a turning point in the development of its activities. During FY19, the organization took a giant step forward, eliminating \$1.5M in overspend. Operationally, the business lost around \$500K in FY19. Organizationally, the ministry made major advancements in the past ten months projecting a break-even budget for the year.

The Skilled-nursing facility was closed, converting John Reed to an assisted-living facility. It now has twenty-two residents.

Cost cutting measures were applied to Governor's Bend and a new executive director was selected for the facility. The facility is now full, including a waiting list. It serves over sixty residents.

The Hope Center continues to fund raise the dollars needed to finish the new maternity home. The project is fully underway this fiscal year. More funds are needed to complete the facility.

The Laurels in Virginia continues to be a vibrant part of our ministry with over forty filled beds.

Conclusion: Current census numbers include sixty-three children in foster care in TN, four in independent care, twenty in the TN residential program, sixty rooms occupied at Governor's Bend, forty-three rooms occupied at the Laurels, twenty-two rooms occupied at John Reed, over one hundred girls in care the Hope Center, twenty-five at Maggie House, twelve in the Florence Crittenton Home, and twenty-eight in the Young Home. God has blessed our ministry in serving hundreds of children, over one hundred seniors, and hundreds of expectant young women this past year. The love of Christ was manifest through our 200+ employees, and the ministry has seen over one hundred professions of faith in Jesus Christ. The mission of Family Ministries has remained true to the purpose for which the organization was founded!

# 2018 - 2019 Ministers Conferences

Covy Rock F. W. B. Church Oct. 27, 2018

The Jacks Creek FWB Ministers' Conference met with Covy Rock FWB Church in Green Mtn., N.C. at 9:30 A.M. The session began with Pastor Marvin Hensley welcoming the conference and making the necessary announcements. The congregation sang, "I Want to Know More About My Lord." Due to neither of the devotion appointees being able to attend, several people gave their personal testimonies. Rev. Dean Murphy told how he was so blessed because of how his parents raised him. It was a spirit-filled time. Prayer was given by Rev. Keith Miller.

The session was called to order by the Moderator, Bro. Adam Miller, who read the Rules of Decorum. The minutes of the last session were read with one correction. The Minister's roll call was made with all ministers standing in full fellowship. There were no visiting ministers and no visiting churches. There were no ministers seeking license or ordination.

Independent Living for foster care children helping them find jobs and become independent. He also reported that almost 4500 campers had accessed the Oak Center where several young people had been saved this summer. Next year FWB Family Ministries will celebrate 80 years of operation.

Alvin Murphy then spoke about our missionary, Josh Provow. He and his family have been moved to a different area of Bulgaria and face many new challenges, especially with the government there. Josh is trying to build bridges from the old to the new, taking people from Islam to Christ. He is very interested in Operation Christmas Child with Samaritans Purse so that these boxes can be given to show our love for the people there. This will also be about getting Bibles written in their native language, to be given in the next few months. Bro. Murphy asked that each church in our association take up money to help with purchase of these Bibles. Rev. Scott Jenkins offered a motion that each pastor go back to their church and start a fund to help Bro. Provow with his request. His motion was seconded and passed. The money will be, taken up at the next conference in January. Bro. Eddie Tipton, who is with Gideons International, said that his organization would help with the project and asked the preachers to invite the Gideons to their churches to give a presentation.

In other business, Rev. Scott Jenkins informed the conference about progress being made with the Sustainability Committee. They met with preachers, deacons and church members at Young's Chapel in September and heard great ideas on how to improve things in our Association. They are planning another meeting in Tennessee on Nov. 12. An announcement will be made as to where. He also spoke about finding a new place for our revival, maybe even down in McDowell County. Rev. Jenkins also spoke about the phone service that we are now using to get messages and announcements out to churches and pastors. He stated that we could expand this service. #### **Articles of Faith**

- Article 1 **The True God** We believe that there is one and only one living and true God who is in personality the Father, Son, and Holy Ghost, equal and harmonious in every divine perfection. "For there is one God, and one mediator between God and men, the man Christ Jesus; who gave himself a ransom for all to be testified in due time." I Timothy 2: 5-6
- Article 2 **Holy Scriptures** We believe that God is the author of the Holy Bible, and its teachings constitute the only infallible doctrine "All scripture is given by inspiration of God, and is profitable for doctrine, for reproof, for correction, for instruction in righteousness." II Timothy 3:16
- Article 3 **Original Apostasy** We believe that Adam was created holy, but by voluntary transgression fell into depravity and consequently involved his posterity in sin. "And when the woman saw that the tree was good for food and that it was pleasant to the eyes, and a tree to be desired to make one wise, she took of the fruit thereof and did eat..." Genesis 3: 6
- Article 4 **Free Grace** We believe that the grace of God comprehends all spiritual blessings; that the Gospel is the power of God unto salvation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted and made wise unto salvation. "For there is no difference between the Jew and the Greek: for the same Lord over all is rich unto all that call upon him." Romans 10: 12
- Article 5 Christian Faith We believe that Christian faith is belief in Jesus Christ as the Son of God and Redeemer of the world and in the divinity of the Holy Scriptures; that faith comes by hearing the Word of God. "He that believeth on the Son hath everlasting life, and he that believeth not the Son shall not see life; but the wrath of God abideth on him." John 3: 36
- Article 6 **Repentance** We believe that repentance is sorrow for sin, and the kind of sorrow which produces Godly repentance must be effectual conviction of sin. "Now I rejoice, not that ye were made sorry, but that ye sorrowed to repentance: for ye were made sorry after a godly manner, that ye might receive damage by us in nothing. For Godly sorrow worketh repentance to salvation not to be repented of: but the sorrow of the world worketh death." II Corinthians 7: 9-10
- Article 7 **Free Agency** We believe that the human will is free, and that men have the ability to accept or reject the conditions of salvation, "...what is good; and what doth the Lord require of thee, but to do justly, and to love mercy, and to walk humbly with thy God?" Micah 6: 8

Article 8 - Perseverance - We do not believe, under the Gospel

dispensation, any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men, who have been converted, to make shipwreck of the faith, turn again to sin, and be lost. "And Jesus said unto him, No man, having put his hand to the plough, and looking back, is fit for the kingdom of God." Luke 9: 62

Article 9 - **Good Works** - We believe that good works are the result of faith and not of necessity; that those who have faith will do works of righteousness, while those who have not faith cannot do anything pleasing or acceptable to God. "Every tree that bringeth not forth good fruit is hewn down, and cast into the fire. Wherefore by their fruits ye shall know them." Matthew 7: 19-20

Article 10 - Christian Baptism - We believe that Christian baptism is the immersion of a believer in water, in the name of the Father, Son, and Holy Ghost; that baptism cannot be Scripturally administered without faith in the subject who receives it. "Therefore we are buried with him by baptism into death: that like as Christ was raised up from the dead by the glory of the Father, even so we also should walk in newness of life." Romans 6: 4

Article 11 - **The Lord's Supper** - We believe that the supper was instituted by our Savior as a commemorative ordinance; that the bread and fruit of the vine represent His body and blood; that it was instituted for Christians, and that all Christians should unite in service regardless of name of denominational distinction. "But let a man examine himself, and so let him eat of that bread, and drink of that cup. For he that eateth and drinketh unworthily, eateth and drinketh damnation to himself, not discerning the Lord's body." I Corinthians 11: 28-29

Article 12 - **Feet Washing** - We believe that washing the saints' feet is a command of our Savior, and that his followers ought to practice the same. "If I then, your Lord and Master, have washed your feet; ye also ought to wash one another's feet." John 13: 14

Article 13 - **The Gospel** - We believe it is the duty of all churches to support the Gospel. "Even so hath the Lord ordained that they which preach the Gospel should live of the Gospel." I Corinthians 9: 14

Article 14 - **Judgment Day** - We believe in one general Judgment Day. Hebrews 9: 27. "Because He hath appointed a day, in the which He will judge the world in righteousness by that man whom he hath ordained..." Acts 17: 31. "When the Son of Man shall come in his glory, and all the holy angels with him, then shall he sit upon the throne of his glory: And before him shall be gathered all nations: and he shall separate

them one from another, as a shepherd divideth his sheep from the goats." Matthew 25: 31-32. We believe that the tribulation precedes the Judgment of both righteous and sinners. Matthew 24: 21-31, II Peter 2: 10-13, II Thessalonians 2: 6-9, Revelations 21: 1-6, Revelations 19: 6-9

#### **Church Covenant**

- 1. Having given ourselves to God by faith in Jesus Christ and adopted the Word of God according to the original Free Will Baptist doctrine as our rule of faith and practice, we now give ourselves to each other by the help of God.
- 2. We solemnly covenant before God that we will carefully observe the commandments implied by a confession of faith, and in the spirit of meekness, rebuke and admonish those who have gone astray, and watch over each other's reputation and use our influence to the up-building of the church and for the advancement of the cause of Christ, endeavoring to seek the unity of the Spirit in the bonds of peace, and to confess our faults one to another, and to strengthen those that are weak.
- 3. We promise that by the help of God we will faithfully practice family and secret prayer, and strive to cultivate the doctrine of God's revealed Word in the minds of those under our care.
- 4. We also agree to use our influence for the support of the Gospel and to contribute liberally to aid the ministry according to our several abilities. Also, we agree to be liberal with those that are afflicted and needy, and especially those of the household of faith.
- 5. We also agree to attend all regular meetings regularly if not providentially hindered and submit to all ordinances implied in a Profession of Faith.
  - 6. We also agree to abstain from all sinful and vain amusements.
- 7. We also agree to abstain from all intoxicating liquors and not to use it as a beverage, nor to aid or assist in the manufacture of such nor to furnish it to others.
- 8. We also agree to encourage home and foreign missions, education, Sabbath schools, good morals, and everything that is to the glory of God and to the welfare of men. May the God of peace sanctify us wholly and preserve us blameless until the coming of our Lord Jesus Christ, that we may be happily admitted into the Kingdom of God, may ascribe honor unto the Lamb forever. Amen.

#### Constitution of Jack's Creek Free Will Baptist Association

- 1. This Association shall be composed of delegates chosen and sent from each church.
- 2. The delegates chosen and sent shall be recommended in a letter from the church to which they belong and shall include the minister and some of the ablest members belonging to the church.
- 3. The Association shall elect annually a moderator and a clerk. The moderator shall not serve more than four (4) consecutive terms at one time. Amended August 9, 1986
- 4. The Rules of Decorum shall be read immediately after the body is organized.
- 5. The Association will encourage a sound ministry; such as present Christ as an all-sufficient Savior; having made salvation possible for every human being on the terms of the Gospel, which is freely offered to all.
- 6. Any minister in good standing, whether a delegate or not, may be invited to a seat and take part in the deliberation, and have his name enrolled in our Minutes.
- 7. The Association may appoint such committees as may be necessary to the expedition of business, and every committee appointed to any particular business shall report their proceedings in writing to the Association while in session, and all reports may be adopted or rejected by the body.
- 8. The Association shall have a book in which shall be kept an accurate account of all its proceedings.
- 9. Any church may become a member of the Association by making application by letter or by delegate and adopting our Articles of Faith and Church Covenant.
- 10. The Association may withdraw from any church that becomes disorderly or refuses to be represented.
- 11. There shall be an Association Fund for defraying expenses and charges that may accrue and for replenishing such. Each church may contribute at pleasure.
- 12. There shall be a treasurer appointed by the Association, whose duty it shall be to have care of and account for the money committed to his charge.
  - 13. The Association shall use the Freewill Baptist Treatise in full.
- 14. Each church shall be allowed one vote for every ten members or fraction thereof.

- 15. The Association advises all its churches to commemorate the death and suffering of our Lord at least twice a year.
  - 16. The Association shall pay its clerk at least \$5.00 for his services per annum

# Constitution and By-Laws Jack's Creek Free Will Baptist Ministers Conference

- **Article 1.** This body shall be known as The Ministers Conference of the Jack's Creek Association of Free Will Baptist and shall be composed of all licensed and ordained ministers of said Association.
- **Article 2.** This Conference may receive any Christian minister, as a visiting minister. He may take part in any Biblical discussion. He may not vote or take part in the transaction of business matters.
- **Article 3.** This body shall elect a moderator quarterly, and a clerk annually, both ordained ministers of one year or more membership in this Conference after his ordination. Amended August 1, 2009
- **Article 4.** Each church may send two of its members as delegates to this Conference with all privileges of visiting brethren, as provided by Article 2.
- Article 5. This Conference shall meet on the last Saturday of October, January, April, and the Saturday of the yearly Association with some church in the Association previously agreed upon or at the call of the moderator, provided that more than one session may not be held with any church during the same Conference year. Amended July 25, 2014
- **Article 6.** The moderator is empowered and it is his duty to call an extra session of the Conference upon the petition of the members of this Conference; provided, however, that said petition is properly signed by seven members, three of whom shall be ordained ministers.
- **Article 7.** The Conference, upon being organized each year, shall proceed to elect an Ordaining Council composed of five regularly ordained ministers; all having been ordained at least two years, and one or more shall have served one or more
- years on the Ordaining Council, and one of the senior members shall be the chairman of the Council thus constituted. It shall be their duty to examine candidates, grant licenses, and conduct ordinations.
- **Article 8.** The Ordaining Council, when properly organized, shall have charge of all examinations and ordinations of candidates for the ministry who have been ordered before it by the Conference.
- **Article 9.** All men applying to this Conference for a license to preach, for ordination, or for membership, shall present a letter of recommendation from the Free Will Baptist Church of which he is a member. This letter shall be dated and signed by the pastor, the deacons, and the clerk. Upon the majority approval of this

Conference, the applicant will be received under our watch care. The applicant shall sign a waiver permitting our Investigating Committee to check on his personal life. The Committee should submit their report at the next scheduled conference. If the Committee recommends the applicant and the majority of the Conference approves, the applicant and his wife (if married) will be questioned by the Ordaining Council as to his divine calling, his qualifications, and his doctrinal beliefs. Upon the approval of the Ordaining Council and the majority approval of the Conference, the applicant will be licensed, ordained, or accepted as member of this Conference. No member shall meddle with the work of another or injure his reputation for usefulness, but watch over each other in love, and thus promote harmony and love among the membership.

Article 10. Revised by a unanimous vote March 9, 2003. All applicants licensed by this Conference will be licensed to preach for one year. Upon the majority approval of the Conference, the license may be renewed annually. This license does not permit the licensed preacher to officiate at a marriage. A licensed preacher may baptize converts and administer the Communion and Feet Washing service under the direct supervision of an ordained Free Will Baptist minister. Licensed preachers are expected to preach at least twenty-four sermons a year. If any preacher neglects to do so, (unless providentially hindered) he will be entitled to a seat in this Conference only as a visiting minister. All new licensed preachers will be assigned to one of our most able pastors for the period of two (2) years. Only pastors that are willing to accept the responsibility to work with the licensed preachers will be asked to participate. The licensed preachers in this program are with the pastor to observe and learn and are not to interfere or hinder the work of that pastor. The licensed preacher will not be considered to be an associate pastor. The senior pastor that he has served under will, at the end of the two (2) years, present a complete report to the Ministers Conference in a written letter. Any new applicants on or after this date, March 29, 2003, will be required to go through this program. The new applicants are asked to attend the senior pastor's church when he is not preaching somewhere. The licensed preacher at the end of this program, providing a good report was received from the senior pastor, may request to be ordained. Amended August 1, 2009

**Article 11.** Each member is urged and expected to attend all regular meetings of the Conference. Any minister being absent from two sessions of the Conference in succession shall stand charged with delinquency and shall be deprived of his vote on any question until he offers a satisfactory reason for his absence. His delinquency charge may be removed by a majority vote of the Conference. Any minister who does not report to the Conference in any fashion for one year shall be dropped from the roll and his credentials called for.

The above requirements shall not apply to any minister who is rendered unable

to attend by reason of a continued disability of himself or his family. The minister or his family may report such circumstances in a letter to the Conference or by phone call or e-mail to the clerk or assistant clerk.

**Article 12.** Ordained ministers (men) from sister Associations seeking membership with this Conference shall present a letter of recommendation from their Conference, dated and signed by the Moderator and Clerk, in addition to the requirements of Article 9. If the Applicant is accepted by this Conference, a new Certificate of Ordination will be issued with the name of his original Conference and the names of the Ordaining Council on the margin.

**Article 13.** The Conference may withdraw fellowship from any member who becomes disorderly. Any person presenting a charge against a minister must sign his name to the charge or it will be null and void.

All charges against a minister will be brought to the Conference and a recommendation made before proceeding farther. Amended August 10, 1996

**Article 14.** To constitute a quorum, at least half of the members on the roll must be present in order for the meeting to be called to order and business conducted. No session of Conference will be considered legal if fifteen or more ordained ministers are not present. Amended August 1, 2009

**Article 15.** No member shall serve as a pastor of a church which does not enforce discipline, care for its pastor, and contribute to other benevolent enterprises according to its ability.

**Article 16.** The moderator shall have the power to appoint any or all committees to carry on the work of the Conference.

**Article 17.** Necessary expenses of this organization shall be met by voluntary contributions or by assessment of the members.

**Article 18.** This Constitution and By-Laws, or any article thereof, may be suspended or amended, by a two-thirds vote of the Conference.

**Article 19.** Membership in this body shall be proof of good standing in the ministry.

**Article 20.** This Conference will only allow its members to preach, teach, and use the King James Version (KJV) of the Bible as we believe it is the infallible Word of God. Added - August 1, 2009

The above Constitution and By-Laws was duly adopted by Conference in regular session at North Bend Free Will Baptist Church, June, 1919. Re-adopted in Conference, September, 1944. Revised and re-adopted at Locust Gap Free Will Baptist, Mountain City, TN, August 9, 1975. Amended March 28, 2003

53<sup>rd</sup> Session 1948 - When committees are chosen for the Association, they are to have a minister as chairman. The remainder of the committee is to be chosen from the delegates.

60<sup>th</sup> Session 1955 - A motion was passed not to license any woman to preach.

63<sup>rd</sup> Session 1958 - Any person teaching or holding a church office is to be a member of the Free Will Baptist denomination.

**76th Session 1971** - Any person writing a letter to the investigating committee must sign the letter or the letter will be considered null and void.

**80**<sup>th</sup> Session 1975 - Jack's Creek Ministers Conference is opposed to the so called Millennium or Millennial Doctrine as preached today. Any of our ministers found to be preaching or teaching this said doctrine, shall have their license called for and their names dropped from the ministers roll.

83<sup>rd</sup> Session 1978 - The Jack's Creek Free Will Baptist Association does not condone, or allow homosexuality among its people, that it is deemed to be a deadly sin. Leviticus 20: 13, Romans 1: 26-32. Also we are opposed to abortion in any form. "Thou shalt not kill," the fifth Commandment, Exodus 20:13. (Amended by Association July 29,2011)

**84th Session 1979** - No minister will be allowed to serve on more than one committee of investigation or ordaining council.

Jack's Creek Ministers Conference does not condone our ministers performing a wedding, and joining together in Holy Matrimony anyone who has been previously married and divorced.

Respectfully submitted by Reverends Blaine Whitson, Stanley McMahan, and Ronnie Peterson. August, 1984.

(Note: Two of these resolutions have been omitted since our Constitution was amended to incorporate the resolutions.)

The following rules and motions that govern our body have been adopted since the above list was prepared.

August 13, 1983 - Ministers Conference - Concerning ministers marrying people that have been divorced: "If they have separated, divorced but not remarried,

and get back together (and choose) to remarry, a minister may marry them."

"We, your Ordaining Council, recommend to the Conference that a By-Law be passed that any preacher, who leaves his church and starts a New Work within (10) ten miles, consisting of members of the Old Church, be dealt with by the Conference by calling for his credentials.

89<sup>th</sup> Session 1984 - Resolutions Committee Report: We make a motion that the following resolution be accepted, "This committee will be known as the rules Committee. It shall consist of five men: three deacons and two pastors. None on this committee shall belong to or attend the same church. All motions to make new,

or change existing rules or bylaws, shall be given to said committee in writing and signed. The committee will consider the motion, then upon its decision, bring the motion to the floor for explanation in detail. This body shall then vote on the motion as they may choose. However, if the committee cannot agree that the motion should be presented to the body, the motion will then be dead."

August 12, 1994 - Rules Committee Report: "We also make the following motion: No one is to be nominated for any office or committee unless present at the meeting in which the nomination occurs, unless the nominee has been informed and agrees prior to the nomination to accept the position if elected."

August 8, 1997 - Rules Committee Report: "The Treasurer and Assistant Treasurer of the Jack's Creek F. W. B. Disabled Ministers Fund will be elected by the Jack's Creek F.W.B. Association for an indefinite period of time. A new Treasurer and/or Assistant Treasurer may be elected at the request of the current treasurer, at the decease or withdrawal from the Association by the treasurer, or by a majority vote of this Association."

**August 7, 1998** - Rev. Charlie Trivette presented the church flag and a certificate to be given to all ministers' wives or next of kin at the close of a minister's funeral. The idea was accepted and agreed to be paid for out of the Home Missions fund, motion being approved by the Association.

**November 28**, **1998** - A motion was passed that anyone bringing a charge against a minister in the Conference would be subject to being investigated by the same Investigating Committee as the minister, before the charge would be brought before the Conference.

**July 30, 1999** - 1 PM Business Session: A motion was passed to reprint and use the Treatise that was written by the Committee appointed in 1985.

October 28, 2000 - Ministers Conference - Rev. Charlie Trivette spoke on the flags to be presented at funerals of deceased ministers. Rev. Trivette made a motion that the presiding minister call in advance to find out the wishes of the family. The motion was approved.

**September 29, 2001** - Ministers Conference - A decision was made that when a Conference was called (postponed) after inclement weather, it would be a standing rule that it would convene the next Saturday.

**January 29, 2005 -** Ministers Conference - A motion was passed stating, "If the Investigating Committee got a signed letter requesting an investigation of a preacher ten days or sooner before the next Conference they have the authority to go ahead with the investigation. If it was within the ten days before the next conference, they will wait for the Conference Approval."

**July 27, 2018**-Association- A motion was made, seconded, and approved to accept the following recommendations from the Sustainability Committee .(Committee was originally appointed by the Moderator on July 28, 2017 to study

surveys collected regarding possible changes of operation)

- 1) The Association's Moderator shall contact the pastor of member churches in regards to specific committee assignments for the upcoming Association at the third minister's conference. This will allow the members ample opportunity to meet and plan for a presentation. Each church contacted will be responsible for a committee.
- 2) The assigned committed will choose one spokesperson to present their report during the Association. Each report shall not exceed five minutes in length.
- 3) The Rules and Resolution Committees shall be combined to create the Rules/Resolution Committee.
- 4) The Churches, Pastors, and Deacons, Sunday School, Church Training Services, Ladies Auxiliary, and Educations Committees shall be combined into one group called the "Church Operations Committee. This multi-sectioned committee will be given five minutes per report if necessary with the committee choosing one spokesperson for each section.
- 5) Proposed minutes of each meeting shall be published and distributed to all member churches and preachers quarterly within one month after the conclusion of the meeting.
- 6) The Sustainability Committee shall become a standing committee designed to field questions, make recommendations and report to the association and conference. The Committee will present any recommendations to the Rules/Resolutions committee prior to the association. Into addition, the Committee will schedule times, during the next year, to meet with member churches for special sessions for conversations regarding how the conference might become more effective and efficient.
- 7) The monies of the Home Missions fund shall be expanded to include offerings, possible fees and other assorted expenses. Postage expenses for mailing the quarterly reports shall be included in these funds.
- 8) This new formed Sustainability Committee will be composed of five members with the chairman being replaced each year, the next member in line will become the chairman, and a new member will be elected which will serve for five years.
- July 28, 2018 Conference-A motion was made, seconded and approved to adopt the following Sustainability Committee recommendations: 1) The Conference's Moderator is to be elected for a period of one year. 2) The Moderator is to create an agenda for each meeting, contacting members, if necessary to finalize the agenda. 3) Members wishing to have items placed on the agenda shall notify the Moderator at least one week prior to the quarterly meeting. 4) The Moderator will present at each meeting the agenda to be followed. 5) No additions will be made unless the Moderator deems it necessary in case of unforeseen circumstances.

## By-Laws Jack's Creek Free Will Baptist Disabled Ministers Fund

- 1. This organization shall be known as the Jack's Creek Free Will Baptist Disabled Ministers Fund. Therefore, it is not to be considered as a retirement program.
- 2. The purpose of this fund shall be to render financial aid to any member in good standing. However, the need must be due to a physical disability.
- 3. This fund shall be managed by a board of directors consisting of five men, three of these will be ordained ministers and two church laymen. Board members will be appointed by the Association and will serve for a five year term. Each member's term will expire in a rotating manner that will require one new member to be appointed each year. Each member will serve his last year on the board in the position of board chairman. It will be the responsibility of the board to manage this fund in such a way to provide the most return possible for the money we may have to invest. It will also be the responsibility of the board to budget the amount of money available to pay out each year. The amount to be used each year will be the amount of interest earned on the money invested.
- 4. Funding of this organization shall be done by requesting each member of the Conference to voluntarily take at least five dollars per week from his regular church contributions, or whatever amount God may direct him to give on a regular basis. This may be accomplished either by allowing the church the minister is pastoring to deduct the amount each week from his salary, and writing a check to the quarterly Conference for the amount deducted, or the ministers may bring their contributions to the conference. Anyone contributing to this fund will receive a receipt for their contribution. Churches are to be encouraged to take part in the support of this program as they feel God would have them to do. The funding of this program is never to be considered as dues to be paid, or a tax to be levied on the ministers or churches.
- 5. Qualification for financial help shall not be established at any given age, due to age alone. Financial help shall be given when properly applied for after the investigating committee has made a fair and impartial investigation. If the application is approved, the investigating committee has the authority to request help for the applicant up to the amount of three hundred dollars (\$300.00) without consulting the board of directors, providing an application has been completed for a record to be reviewed by the board of directors. Otherwise the board of directors be consulted and said board will determine the amount and method of financial help to be given. The board may direct the amount to be paid in lump sum or monthly for the duration of the need. (Amended August 12, 1977)
- 6. A standard form application will be furnished by the organization. This application is to be properly completed by the investigating committee while the investigation is being conducted. Application for financial help may be requested

by the individual in need, or by the church to which he belongs or pastors.

## Burial Fund (Est. August 12, 1978) [Level 2: August 8, 1980]

Article 1. This fund shall be known as the Jack's Creek Free Will Baptist Ministers Burial Fund.

Article 2. This fund has two levels of benefits to choose from: (A) For an annual premium of \$15.00, a member will receive \$500.00 of death benefits. (B) For an annual premium of \$30.00, a member will receive \$1,000.00 of death benefits.

Article 3. Participation in this program is completely voluntary.

Article 4. Any minister, who is in good standing and a member of the Jack's Creek Ministers Conference, has the option to participate in this program, provided he makes that election within one year of the date he becomes a member of this Ministers Conference. His wife has the option to participate in this same program for the same benefits and the same annual premium. Her premiums will be in addition to his premiums.

**Article 5.** A membership application must be completed, signed, dated, and the first annual premium paid to be enrolled in this program.

**Article 6.** Annual premiums are due and payable in advance at the Ministers Conference held in conjunction with the Jack's Creek Free Will Baptist Association each year. On October 29, 1983, a motion was passed to give a 90-day grace period (for paying annual premium) on Burial Fund.


**Article 7.** Any minister, who fails to pay his annual premium, who withdraws from the Ministers Conference, or who is dismissed from the Ministers Conference, forfeits his rights to the benefits of this program. He is not entitled to a refund of any of the premiums paid into this Fund. If his wife is a member of this program, she forfeits her benefits and will not receive any refund of premiums paid.

**Article 8.** If the minister precedes his wife in death, she has the option to continue in this program as long as she conducts herself as a Christian, remains unmarried, and pays her annual premiums.

Article 9. When a minister or his wife has paid into this fund the full amount of their coverage, they do not have to pay any more premiums to have full coverage at their death. Amendment added July 31, 2015. If a minister or his wife wants to extend their coverage to \$2000.00, they can continue to pay \$30.00 per year. The same rules as listed above will still apply. Amendment added July 29, 2016.
