PROCEEDINGS.

The 14th annual session of the Jasper Freewill Baptist Assocociation convened with Mount Olive Church, Marion county, Alabama October 6th, 8th and 9th, 1900. The introductory sermon was preached by Rev. James J. Wesley. The text used was Acts 1ts chapter, 8th verse.

After preaching, an intermission of one hour was taken for rest and refreshments. After which the ministers and delegates were requested to meet in the house, organize and proceed to business.

AFTERNOON SESSION.

The Association met pursuant to adjournment. Singing by the congregation, prayer by Rev. W. A. Nelson. The Moderator of the former session, Rev. J. R. Holladay, being absent, while the Clerk, Bro. Robert Franks, was present, Bro. Franks called the house to order, and appointed Rev. W. A. Nelson Moderator pro tem; and business was transacted as follows, viz:

1. Letters from the churches are called for, handed in and read, and contents noted as per statistical table.

2. Called for petitionary letters and opened the door for the reception of new churches into the body. Received a letter from Horse Creek Church. The letter was read and after careful examination, it was found that the petitionary church was organized on our Articles of Faith. That it is sound in doctrine, and we recommend that it be received into the Association.

On motion, Horse Creek Church is unanimously reeived and its name ordered to be enrolled in the minutes.

3. It was then agreed to permanently organize the body which was done by electing Rev. W. A. Nelson, Moderator; Bro. Robert Franks, Clerk; and Rev. M. R. Martin, Corresponding Secretary.

4. Called for correspondents from sister Associations, and received the following:

From the Cullman Association, Revs. J. W. Moore, J. W. Riggs, W. Freeman and J. J. Morris.

From the Vernon Association, Rev. R. C. Flippo, and brethren G. C. Crews and F. S. Kuykendall.

These brethren were cordially received and welcomed to seats among us.

On motion, it is agreed that the Moderator appoint all the committees; whereupon the following are appointed, viz:

ON DECEASED MINISTERS AND MEMBERS-Revs. George C. Elliott, W. Freeman and Rev. M. R. Martin. ON FINANCE-Brethren H. T. Warren, J. D. Crawford and Joseph Atkins.

Reports of committees are called for, and the following is presented: That Rev. R. A. Nix preach to-morrow, at 9 o'clock; Rov. J. W. Riggs preach at 11 o'clock; Rev. G. B. Haney, alternate Rov. W. Freeman preach at night, Rev. J. W. Moore, alternate. Rev. J. W. Moore preach Monday at 11 o'clock. Respectfully submitted,

D. Z. GRIFFIN, Chairman. On motion, the report is adopted, and com. discharged.

Sunday morning 9 o'clock, Rev. R. A. Nix preached an able sermon to a large and attentive congregation. He used for his text Matthew 23 chapter, and 37th verse. At 11 o'clock, Rev. J. W. Riggs of the Culman Associa-

tion, preached an able sermon to a large and attentive congregation. He was followed by Rev. G B. Haney of the Bear Creek Association. His text was St. Mark 16th chapter and 15th verse.

After preaching, the Lord's Supper was administered and Christians of the different denominations partook with us. It was a free communion service, and was a practical demonstration of the liberal doctrine we preach.

ON PREACHING-Brethren D Z. Griffin, W. T. Keeton, and L. M. Raburn, with the Deacons of this church.

ON DOCUMENTS AND ORDER OF BUSINESS-Revs. James J. Wesley, R. A. Nix and S. B. Ramsey, with the Moderator and Clerk.

ON SABBATH SCHOOLS-Rev. T. M. Canup, and brethren J. L. Eades and J. A. Beazley.

ON DENOMINATIONAL LITERATURE-Brethren P. C. Pike, J A. Nelson and L. G. Green.

ON ASSOCIATIONAL FUNDS-Brethren R. L. Owens, J. A. Carns and W. B. Patterson.

On motion, the Association adjourned to meet Monday morning at 8 o'clock. Prayer by Rev. J. W. Moore of the Culman Association. Benediction by the Moderator.

Saturday night, Rev. S. B. Ramsey preached. Text not known.

At night, Rev. W. Freeman preached to a large and well behaved audience. His text was 3rd chapter of Revelation, and the last verse. He was followed by Rev. J. W. Moore, which closed our Sabbath service.

The Association met pursuant to adjournment. The opening service was conducted by the Moderator, and prayer was offered by Rev. G. B. Haney. The Moderator called the body to order. The Clerk called the roll and the ministers and delegates answer to their names.

On motion, the proceedings of yesterday were read and adopted.

On motion, visiting brethren are invited to take seats with us. None present.

Reports of committees are called for, and presented in the following order:

ON DOCUMENTS AND ORDER OF BUSINESS.

We your committee on Documents and Order of Business report: We find one petitionary letter for the next Association, and we recommend that Gum Springs have the mext Association. We furter recommend that Rev. J. R. Holladay preach the introductory sermon at our next session, and that it be a doctrinal discourse. And we further recommend that Rev. W. A. Nelson write a Circular Letter to be appended to our next minutes for 1901, choosing his own subject. We also recommend that the Clerk superintend the printing of the minutes, and that the work be done at the Baptist Review Job Office, Goldsboro, N. C. Also that the Clerk have five dollars for his services. We your committee find that some of our churches in their letters are reported to be in a cold and lukewarm condition, and we recommend that a committee of investigation be appointed so as to ascertain whether they have regular preaching or not; and report the cause. And we further recommend the union of all Free-Respectfully submitted, will Baptists.

ON DENOMINATIONAL LITERATURE.

We your committee on Denominational Literature report: We recommend the prayerful reading and study of the Bible for it is the book of God and the safe guide to heaven. For our church paper, we recommend the BAPTIST REVIEW. As for our hymn book, we leave that for the consideration of the Association.

We recommend that pastors and leading members of the various churches take hold of this great and important work, and do all in their power to improve it in the bounds of this Association, that it may be a help to the church in bringing many souls to Christ. We further recommend that the pastors of the various churches appoint Sabbath School Superintendants. And we further recommend that each church make a report of their Sabbath Schools in their letters to this Association.

After thorough investigation, we find the trouble in Freewater Church is for the lack of pastorial care; and also disorderly walk of the members.

MISCELLANEOUS BUSINESS.

Resolved that any minister of this Association who is found guilty of circulating false reports by pen or otherwise on a brother minister, which is liable to injure his usefulness and destroy his influence, shall be guilty of a disciplinary offense, and after discipline has been used, if he does not show signs of true penitence and reformation, he shall be excommunicated from this Association, and published in our denominational paper.

On motion, it is agreed to adopt a financial system as we see the great need of such; and we recommend that each male member that belongs to the Jasper Association pay annually twenty-five cents, and that those of the females that wish to pay any thing can do so. This is in connection with the minute funds. And it is further understood that at our next Association we elect a regular Treasurer, to keep a true record of all the funds that is paid in; and also, how the same is paid out. These funds are to be disposed of by the Association through the Moderator and Clerk, being empowered by the body. Said money is to be used for no other purpose than for the building up of the Jasper Freewill Baptist Association. Such as aiding destitute and disabled ministers, poor widows and orphans.

On motion, the Association adjourned for preaching and refreshments, and to meet at 2 o'clock, p. m. Prayer by Rev. L. M. Black.

The Association met pursuant to adjournment. Singing by the congregation. Prayer by Rev. M. R. Martin. The Moderator called the body to order. The Clerk called the roll and the ministers and delegates answer to their names.

On motion, it was agreed that each minister report annually the amount of money he receives, the number of miles traveled, the number of sermons preached, the number of prayers offered, the number of marriage ceremonies performed, the number of visits made to the sick and burial services attended during the associational year.

On motion, it is agreed that the Moderator appoint a Treasurer to fill the office; whereupon Bro. Walter W. Nelson is appointed Treasurer.

On motion, it is agreed that in lieu of the standing committee on ministerial character, that the Deacons of the various churches look after the preachers and report in their church letters to the Association their standing.

On motion, it is agreed that a collection be taken up for the benefit of Rev. J. W. Riggs of the Culman Association whose eye sight is very dim. The Association contributed liberally and the same was highly appreciated by the dear old brother.

On motion, it was agreed that members leaving any of our churches without letters of dismission, that we withdraw the hand of church fellowship from them.

At 11 o'clock, a. m., Rev. J. W. Moore, of the Cullman Association preached an able sermon. His text was St. John 11th chapter, 21st verse.

On motion, the Association adjourns to meet Tuesday morning 8 o'clock. Prayer by Bro. D. Z. Griffin.

CONSTITUTION.

ARTCLE 1. This Association shall be known as the Jasper Freewill Baptist Association, of Ala., and being composed of delegates from the different churches forming the same, each church being entitled to three delegates.

2. This body shall be considered an advisory counsel, but having no authority over the affairs of the churches.

3. Each church in this Association shall be considered an advisory body, and shall control its own internal affairs in matters of discipline, &c It may however in extreme cases call aid from sister churches

4. All questions of doctrine and matters of general interest shall be settled by a two thirds vote of the Association, and the decision shall be final.

5. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be chosen at each session by a majority of votes.

6. This Association shall meet annually at such time and place as may be agreed upon by a previous annual session, and shall not adjourn finally until all the business is transacted.

7. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.

8. We agree as churches of this Association to use our best influence to promote the interest of all moral and benevolent institutions, such as the Tempeance Cause, Sabbath School, Missionary Work, &c.

9. No member of this Association shall be eligible to the office of Moderator more than two successive sessions, unless no other member be competent to act in that capacity.

10. Any church of this Association failing to be represented for two years in succession, its name shall be dropped from our minutes.

RULES OF DECORUM.

ARTICLE 1. The Association shall be called to order by the Moderator who presided at the last session. Former Clerk also officiating until the body is fully organized.

2. The Association shall be opened and closed with singing and prayer.

3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

4. The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.

5. A majority of delegates shall rule in all cases, except in the reception of churches, then it shall be unanimous.

6. The Moderator shall not be entitled to vote, except in cases of a tie; and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, providing he appoints some one to the chair while he is speaking.

7. Only one person shall speak at the same time, and he shall arise and address the Moderator; and after recognition by the Moderator, proceed.

8. No brother shall be interrupted while speaking, unless he depart from the subject under discussion, or use words of personal reflection.

9. No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than fifteen minutes at a time.

10. No member shall laugh or talk during the time the debates are going on.

11. No member shall absent himself from the Association without leave of the Moderator.

CIRCULAR LETTER.

DEAR BRETHREN—Composing the Jasper Association, Greeting: As I was re-elected to write your next Circular letter, I will attempt to do so, God being my helper. I don't know of any thing that would be more suitable than to call your attention to your duty to man and to God. where are you my dear brother ministers? In your duty. Do you make your duty a study? Consult the 12th chapter of Mark, and 17th verse. Rento Caesar the things that are Caesars, and to God the things that are God's.

The Pharisees were watching the Saviour and seeking the advantage, constantly trying to ensnare Him in some way; but were defeated. In our text they had artfully laid a plan and it was artfully conducted, but in vain did human craftiness attempt to circumvent Divine wisdom. Instead of directly replying to the question our Savior called for a piece of money and asked "Whose image and superscription is this?" and they said unto him Cesars. He then said "Render to Cesar the things that are Cesar's, and to God the things that are God's." The spirit of the passage requires 14

us to regard the rights of all as sacred and to give them all that is theirs. This is a plain practical truth. We now propose to consider and in doing this we will show what is due to God first, and what is due to man second.

What, is due to God or what are those things which are due to God is the property of God which our Savior here requires us to render to Him. The question may be answered very briefly in one word, and that word is all. For it is very easy to show that all things are in the most perfect way the property of God. The earth is the Lord's and he claims us as His. Of course, we and all we possess are God's property, and more particularly our souls with all their faculties are the property of God. He is the father of our spirits who gave them all their faculties and endowed rhem with immortaiity.

In giving our souls to God we should employ all their faculties in His service in performing the work He has assigned us, where our understandings are dilligently employed in discovering His will, when our memories retain it, our hearts love it, our wills submits to it, and the whole inner man obeys it. Our bodies are the property of God. He also, formed our bodies; hence, we should glorify God with our bodies which are His, and this is done when we employ our memories as instruments of righteousness unto holiness.

Our time is God's property. Every moment of our existence is His; therefore, every moment of our time should be consecrated to His service, All our knowledge and literary attainments are God's property. They are acquired by us in the use of that time, of those faculties which are His. He justly claims as His own. In the parable of the sum of money entrusted by a master to servants, and in the parable of the tallents He shows us what will be the doom of those who do not cultivate their faculties or do not consecrate to Him the fruits of that eultivation. Our temporal possessions are God's property. We are not owners but merely stewards to whose care the Lord of all things has entrusted a portion of His property to be employed agreeable to His directions. We should employ them in supplying our own wants as is necessary to our support and happiness consistent w'th the rules of temperance and benevolence.

Our influence is God's property. All our influence over others results either from our natural faculties, or knowledge, or wealth, all of which has been shown to be the proprty of God. To withhold those or any part of those does not comply with the precept in the text Now I have plainly shown that we are not our own. We cannot afford to use these great gifts other than in the service of God. He requires it of us, expects it, looks for it, waits patientiently for it. Then brethren let us rally all our forces to fight against the common foe, and we will be more than conquerors in the end.

Now let us consider what things are due to man. Our duty to man is, a right founded in God's revealed will, hence, all men, without exception, have a right to our love that we should love them as ourselves, that we

There are somethings we owe to our families and connections, as husbands and wives, as parents, as heads of families, for he who neglects his own house-hold has denied the faith, and is worse than an infidel. How great, how inconceivable is the debt which we have contracted both to God and to men. Well may God accuse us of robbing Him. Though we forget God's rights, he will not. He knows how to claim and now to receive what is His. We may learn our need of our interest in the Savior; and the impossibility of being saved without Him. We cannot discharge . our past debts. He has death ready to arrest us. He has an eternal prison from whence there is no escape.

In Christ, there is help. He becomes surety for all who believe on Him, He takes upon himself the debt which they can never discharge, and this sets their souls at liberty. This is the only way of salvation and does not reason Revelation all concur in urging us to accept the offers of the divine Benefactor, and being constrained by His love to live, henceforth, to Him and not to ourselves.

should do unto them as we should wish them do unto us. our enemies not, excepted; and if we die failing to do all in our power, we die in debt to the world or its Creator. And to all who are our superiors we owe obedience, submission and respect, as subjects we are bound to obey, honor and ' pray for as ourselves. Children should honor and obey their parents, servants are required to obey their masters with reverence. And they especially have a right to respect.

We owe kindness, gentleness, and condescention to our inferiors, the poor and afflicted have special claims upon our sympathy and pecuniary relief. Those of us who are members of Christ's visible Church, owe to each other the performance of all the duties which result from our connec. tion and fellowship with it. We are bound to watch over our professing, brethren, to admonish, if necessary, and in all things seek the peace and welfare of the church, to do good to all men, especially those who are of the hsoue-hold of faith.

Brethren, I have written this hurriedly and at intervils when called from labor to refreshments. I would press a little time and write, and when called from refreshments to labor, I would study. Now brethren in conclusion, I will say: We owe a great debt to our old and honored publisher, at Goldsbord, N. C. I want him to have all our printing; and I also, insist that we get up a larger subscription for the BAPTIST REVIEW for 1901, than we ever have; and I further insist, that we all write interesting letters and send to our paper for publication, and in so doing we can all keep posted, and our paper will become more and more interesting. ARTICLES OF FAITH.

OF GOOD WORK -ART 9. We believe that good work is the result of Faith and not of necessity. That those who have Faith will do works of righteousness: while those who have no Faith, cannot do anything pleasing or acceptable unto God

OF CHRISTIAN BAPTISM.—ART. 10. We believe that Christian Baptism is the immersion in water of a believer in the names of the Father, Son and Holy Ghost. That Baptism cannot be Scripturally administered without Faith in the subject who receives it.

OF THE LORD'S SUPPER,—ART. 11. We believe the Supper was instituted by our Saviour as a commemorative ordinance. That the bread and wine represent His body and blood.
