PROCEEDINGS

of 27th. Annual Session of the Jasper Freewill Baptist Association convened with Mt. Pleasant Church, Marion County, Ala., Oct. 4—6th. 1913.

After singing Hymns, Prayer was offered by Rev. J. L. Conner. Rev. E. C. Thomas preached the introductory sermon-Text John 15—5. Rev. J. L. Conner concluded after which. Prayer was offered by Rev. J. W. Moore: 1-hour. intermission for dinner.

AFTERNOON SESSION.

At 1:30 p. m. after singing and prayer by Rev. M. R. Martin, the former Moderator and Clerk being present, taken seats and the Association was called to order and announced ready for business which was transacted as follows.

- 1. The Moderator appointed Rev. E. C. Thomas and Rev. W. D. Martain reading Clerks.
- 2. Called for letters from the various Churches and they were read and contents noted as per statistical table.
- Called for Petitionary letters and opened the door for the reception of new Churches into the body and received the following towit: New Bethleham and Bethel, these churches being organized on our Articles of Faith, they were unanimously received and the right hand of fellowship extended to the Delegates and welcomed to seats with us.
- 4. On motion it was agreed to permanently organize the body which was done by electing Rev. G. W. Flippo Moderator, J. W. Roberson Clerk and J. A. Nelson Treasurer, for the ensuing Associational year.
- 5. The Moderator appointed Bros. A. J. Ingle, J. T. Tharp and J. J. Erwin with the Deacons of this Church as a committee on preaching.
- 6. Called for correspondence from sister Associations and received Rev. J. W. Moore from the Morning Star and Rev. J. W. Porter from the Vernon, and by a motion these brethren were seated with us.

At 7 p. m. services was opened by song by the Choir and Rev. W. D. Martin preached a very interesting sermon to a large and well behaved audience. Text Luke 19—10.

SUNDAY PROCEEDINGS.

At 9 a. m. the congregation was called together by song and prayer by Rev. J. W. Porter who preached a most interesting and instructive sermon. Text 2nd. Cor. 5 & last. At the close of which prayer was offered by Rev. J. L. Conner and 10 minutes given for refreshment. At 11 a. m. the great concourse of people was called together by song by the Choir and prayer by Rev. M. R. Martin, after which Rev. J. W. Moore preached a very feeling and enthusiastic sermon, Text 1st. Cor. 15—49 at the close of which there was a great love feast and a harty Christian hand shake amid much tears and joy. Prayer by

MONDAY MORNING Oct. 6 1913.

The Association met persuant to adjournment, the congregation sang a hymn after which prayer was offered by Bro. E. D. Flurry. The Moderator called the body to order, the Clerk called the roll and the Ministers and Delegates answered to their names and the Moderator announced a quorum present and the Association ready for business which was transacted as follows;

- 1. By a motion all ministers of this Association present hand in their names to the Clerk that they may be enrolled as present.
 - 2. On motion Saturdays Proceeding were read and adopted.
- 3. On motion the names of the standing Delegates recorded as present as follows, A. J. Ingle, W. T. Keeton, G. W. Moore and J. A. Beasley.
- 4. Invited Ministers of other denominations to seats with us. Rev. A. C. Bowin of the Missionary Baptist order was present.
- 5. The Committee on preaching report Rev. J. W. Porter to preach at 11 a. m.
- 6. On motion we adjourn 1-hr, for preaching, song and benediction by Rev. J. W. Moore, Rev. J. W. Porter preached a most convincing sermon on Free communion, at the close of which the Lords Supper was administered, and Christians of different Denominations partook with us. The Association adjourned 1-hr. for dinner.

AFTERNOON.

The Association was called together by song and prayer by Bro. J. J. Erwin, after which the Moderator called for reports of the committies as follows:

1. On Documents and order of business.

We your committee beg to report as follows: We find four petitionary letters asking for the next session of the Association and recommend that the body of Delegates decide on the place of holding the same. We recommend that the clerk superintend the printing of the minutes and have \$7.50 for his services and that the Moderator have \$6.00 for his services out of the Associational funds.

We recommend that the Association discuss the wisdom of putting an Evangelist to work in the bounds of this Association for the next Associational year. We recommend that the Treasurer have \$5.00 for his service and that he loan the money at 8 per cent interest on notes with good security. We recommend the holding of 3 fifth Sunday meetings as follows: March 29 1914, Pocahontas, May 31 Pearces Chapel, August 30th. Pleasant Ridge, Miss.

MISCELLANEOUS BUSINESS.

- 1. Resolved. That any Minister of this Association who is found guilty of circulating false reports, by pen or other-wise, on a brother Minister which is liable to impair his usefulness and destroy his influence shall be deemed guilty of a disciplinary offence, and after discipline has been used if he does not show signs of penitence and reformation he shall be excommunicated from the Association and published in our denominational literature.
- 2. It is agreed to retain a financial system, as we see the great need of such, and we recommend that each member of this Association pay, annually, 50 cents in connection with the minute funds, and ask all our ministers to use their best efforts in collecting of these funds; and it is further understood. That our Treasurer keep a true record of all funds paid in, and how the same are paid out: such funds to be disposed of through the Moderator and Clerk being authorized by the Association; said funds to be used for no other purpose than the upbuilding of the Jasper Free-Will Baptist Association, i. e., 'aiding' distressed and disabled Ministers and poor widows and orphans.
- 3. Be it resolved. That members shall not hold their membership out of the Church over one year after date, and they are under the jurisdiction of the Church to which they belong.
- 4. Be it resolved. That any Minister of the Jasper Freewill Baptist Association who desires to set forth the full functions of the Gospel the same shall be made known to the Annual Association by a recommendation from the Church or

Churches to which they belong, and if on examination, they shall be found worthy, the Association may ordain them; but all ordinations must be done at the Annual Association.

5. On motion, each Minister report annually the amount of money he has secured, the number of miles traveled, number of sermons preached, number of public prayers, number of marriages, number of visits to the sick, and number of burial services attended during the associational year.

6. On motion the Moderator appoint corresponding Delegates to sister Associations towit: To Bear Creek, A. H. Lay, R. S. Mullins and W. A. Smith. To Little Browns Creek, W. T. Keeton, J. T. Tharp and B. N. Roberts. To State Line, Rev. J. R. Ford, J. H. Federick and J. E. Kenedy. To Morning Star, Rev. W. D. Martin and A. J. Ingle. To Vernon, J. A. Nelson, E. R. Franks, and Rev. M. R. Martin.

7. On motion Rev. E. C. Thomas preach introductory sermon at 5th. Sunday meeting at Pocahontas, Rev. J. L. Conner alternate. Rev. M. R. Martin preach introductory sermon at Pearce's Chapel, Rev. G. W. Flippo alternate. Rev. J. L. Conner preach introductory sermon at Pleasant Ridge, Rev. G. W. Flippo, alternate.

8. On motion Rev. W. D. Martin, read his circular letter and same is adopted and ordered apended to our minutes.

9. By a majority vote the next session of this Association be held with Union Chapel 2 miles North of Glen Allen, on the Frisco Rail Road in Marion Co., Ala., the same to convene on Saturday before the 1st. Sunday in Oct. 1914.

10. On motion Rev. J. L. Conner preach the introductory sermon, Rev. W. D. Martin alternate.

11. On motion the Treasurer is authorized to loan the money in the Treas., at 8 per cent interest on note with good security. And the Treasurer be allowed 5.00 for his service.

12. On motion the Clerk is to superintend the printing of our minutes and that he have \$7.50 for his service.

13. On motion it is ordered that our Articles of Faith and Rules of Decorum be appended to our Minutes.

14. On motion the following resolution was adopted as follows; Whereas since the organization of the Jasper Free-Will

Baptist Association in 1887, upto and including the 26th. Annual Session of the same, we are without a History of its acts and progress. Therefore be it Resolved that the Association have a complete History of all our work, setting fourth all of our work the same to be put in one book well bound, striking out the Riles of Decoran, Articles of Faith and Constitution except the 1st. and 26th. Annual Sessions.

Rules of Decorum.

- Art. 1. The Association shall be called to order by the moderator who presided at the last session; former Clerk also officiating until the body is fully organized.
- Art. 2 The Association shall be opened and closed with singing and prayer.
- Art. 3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.
- Art. 4. The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.
- Art. 5. A majority of delegates present shall rule in all cases except the reception of members, then it shall be unanimous.
- Art. 6. The Moderator shall not be entitled to vote, except in case of a tie and then he shall give the deciding vote. He shall also speak on any question after others have spoken, provided he appoint some one to the chair while he is speaking.
- Art. 7. Only one person shall speak at the same time, and he shall arise and address the Moderator, and after recognition by the Moderator, proceed.
- Art. 8. No brother shall be interrupted while speaking, un-

less he depart from the subject under discussion, or use words of personal reflection,

- Art, 9. No person shall be allowed to speak more than twice on the same subject without leave of the Association, nor more than fifteen minutes at a time.
- art. 10. No person shall laugh or talk during the time the debates are going on.
- Art. 11. No member shall absent himself from the Association without leave of the Moderator.

Constitution

- Art. 1. This Association shall be known as the Jasper Free-Will Baptist Association of Alabama, and being composed of ministers and delegates from the different churches forming the same, each church being entitled to three delegates.
 - Art. 2. This body shall be considered an advisory council.
- Art. 8. All questions of doctrine and matters of general interest shall be decided by a two-third vote of the Association, and the decision shall be final.
- Art. 4. The officers of this Association shall be a Moderator, Clerk and Treasurer, which shall be chosen by a majority vote at each session of the Association.
- Art. 5. The Association shall meet annually at such time and place as may be agreed upon by a previous annual session and shall not adjourn finally, until all the business is transacted.
- Art. 6. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.
- Art. 7. We agree as churches of this Association to use our best influence to promote the interest of all moral and benevolent institutions, such as the Temperance Cause, Sunday School, Missionary Work etc.
- Art. 8. No member of this Association shall be eligible to the office of Moderator more than two successive sessions, unless no other member be competent to act in that capacity.
- Art. 9. Any church of this Association failing to be represented for two years in succession, the same shall be dropped from our minutes.

Articles of Faith.

Of God-Art. 1. We believe there is one, and but one living and true God. Who is in personality, the Father, the son and Holy Ghost: Equal and harmonious in every Divine perfection.

Of the Holy Scriptures—art. 2. We believe that God is the author of the Holy Bible, and that its teachings constitute the only infallible doctrine for the government of his church.

Of Original Apostasy—art 3. We believe that adam was created holy: but by voluntary transgression fell into depravity, and consequently involved his posterity in sin.

Of Free Grace—art. 4. We believe that the Grace of God comprehends all spiritual blessings. That the Gospel is the power of God unto salvation. That the Holy spirit not only reproves the world of sin, but is the means whereby sinners are converted, regenerated and saved.

Of Christian Faith—art. 5. We believe that Christian Faith is belief in Jesus Christ as the Son of God and Redeemer of the world, and we believe in the inspiration of the Holy Scriptures. That "Faith comes by hearing and hearing by the Word of God."

Of Repentance—Art. 6. We believe that Repentance is sorrow for sin, and the kind of sorrow which constitutes Godly repentance must be preceded by effectual conviction for sin.

Of Free Agency—Art. 7. We believe that the human will is free, and that men have ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures.

Of Perseverance—art. 8. We do not believe under the Gospel dispensation that any soul is elected to eternal life unconditionally; but those who by faith persevere to the end will be saved. That it is possible for men who have been converted, to "Make-shipwreck of the Faith," turn again to sin and be finally lost.

Of Good Work—art. 9. We believe that good work is the result of Faith, and not of necessity. That those who have Faith will do works of righteousness; while those who have no Faith can not do anything pleasing or acceptable unto God.

Of Christian Baptism—art. 10. We believe that Christian Baptism is the immersion in water of a believer in the names of

the Father, Son and Holy Ghost. That baptism cannot be Scripturally administered without Faith in the subject who receives it.

Of The Lord's Supper-Art. 11. We believe the Supper was instituted by our Savior as a commemmorative ordinance. That the bread and wine represent his body and blood. That it was instituted for Christians and that all Christians should unite in observing that sacred service, regardless of names or denominational distinctions.

Of The Soul—Art. 12. We believe that man is a living soul. That the body will die, but that the soul is immortal. That death is the seperation of the mortal and immortal parts of human beings.

Of The Resurrection—Art. 13. We believe in the Resurrection of the dead. When the resurrection shall take place the soul and body will reunite and form and immortal being. That the righteous will be received into a state of everlasting happiness, to reign with God forever and ever. But the wicked will be bound hand and foot and be cast into outer darkness. "The wicked are driven away in their wickedness, but the righteous have hope in their death."

Circular Letter.

Text Rev. 1-3. "Blessed is he that readeth, and they that hear the words of the prophesy of this book, and keep the things which are written therein: for the time is near."

Some people say that the book of Revelation cannot be understood. The Lord did intend for this book to be understood, or he would not have revealed it to John, and it would not have been written. Some people have miserable handled it Hence others are afraid to touch it, and while they desire to know all things else, reject only the knowledge of those which God hath shown. They inquire after anything rather than this; as if it were written, "Blessed is he that doth not read the prophesy of this book." But nay, "Blessed is he that readeth, and they that understandeth the words of the prophesy of this book, and they that keep the things that are written therein." In this book our Lord has comprised what

was wanting in those prophesies touching the time which followed his assention and the end of the Jewish polity. Accordingly, it reaches from the old Jerusalem, to the new, reducing all things into one realm in the exact order, and with a near resemblance to ancient prophets, the introduction and conclusion agree with Daniel; the description of the man-child, with Isaiah, the Judgement of Babylon, Jeremiah again, the determination of times, with Daniel the Architecture of the holy city, with Ezekiel, the emblem of the horses, candle sticks: and the beast or four living creatures. Many things described by the prophets are repeated in this book; frequently in the same words. Who would dare before the Almighty, to say it is obscure, dark and beyond comprehension? Some people read a newspaper more than the word of God. That is one reason they do not understand the word of God as revealed in this book, It is the man that reads this book that is blessed: not he that spends all his time in reading something almost of no value. The first part of the book of Revelation is noticed first, John introduces after he has asked the blessing of the Lord on those that read, or hear the prophesies of this book, by saying, "John to the seven churches of Aisa: Grace be unto you, and peace, from him which is, and which was, and which is to come; and from the seven Spirits which are before the throne, and from Jesus Christ, who is the faithful witness, and the first begotton of the dead, and the prince of the kings of the earth Unto him that loved us and washed us from our sins in his own blood and bath made us kings and priests unto God and his Father, to him be glory and dominion forever and ever, Amen. Behold, he cometh with clouds; and every eye shall see him: and all kindreds of the earth shall wail because of him. Even so, Amen." This is plain my brother. This chapter is asking the blessings of God to rest on them, and. says Jesus will come again, and every eye shall see him. He is sure to visit this earth again, this was stated by the two men who stood by the diciples and people who saw Jesus ascend on high. These two men that were dressed in white apparel, said to the men of Galilee, "Why stand ye gazing up

into heaven? This same Jesus, which is taken up from you into heaven, shall so come in like manner as ye have seen him go into heaven." The great like in the world to day is that peo ple do not acknowledge the right of Jesus of Nazarath to rule in all the nations of earth John declared over eighteen hundred years ago, that Jesus was the prince of the kings of earth "The most high rules in the kingdoms of men, and gives them to whom soever he will." Nebuchadnzzar in his own estimative thought he was the monarch of the whole earth: but while he had this in his heart, he was informed better when he heard the voice from heaven saying that his kingdom .had departed from him, and he was driven from men, and placed with the beast of the field, to eat grass as the ox. There are people to day that have the heart of a beast, but when their understanding comes to them they will proclaim that Jesus is the rightful ruler.
