## **PROCEEDINGS**

The Thirty-Fourth Session of the Jasper Free Will Baptist Association convened with Pleasant Ridge church, Itawamba county, Miss., October 2, 3, 4, 1920. The introductory sermon was preached by Rev. M. R. Martin. Text: Tim. 4:5. After preaching an intermission of one hour was taken for refreshments.

#### SATURDAY EVENING.

The moderator, Rev. J. L. Connor requested the ministers and delegates to come into the house after dinner.

They organized and proceeded to business as follows: Devotional exercises by the moderator, after which, the moderator called the house to order.

- 3. Called for petitionary letters. Holly Springs and Mount Hope presented their letters, asking admittance into the Association, and they were received.

On motion the association adjourn in regular order by singing, prayer and the benediction, until Monday oct. 4, 1920.

Saturday night Rev. C. L. Pounders preached to a good sized congregation of people.

Sunday, October 3, at about 9 o'clock, Rev. W. D. Martin preached to a large congregation for the hour. After a few minutes intermission, Rev. J. L. Connor preached on the subject of Communion. Immediately after this the communion was administered, and many partook of the emblems. Sunday night Rev. P. T. Keeton preached to a good sized congregation. This closed the order of service for Sunday.

#### MONDAY MORNING, OCTOBER 4, 1920.

The Assoication was called to order in its regular order by the moderator. Saturday proceedings were read and adopted. The clerk called the roll and the ministers and delegates answered to their names.

The moderator announced a quorum present and business was trans acted as follows:

Committee on Documents and Order of Business report:

- Sec. 1. We find three petitionary letters for the next association. We recommend that the body decide the place.
- Sec. 2. We recommend that the clerk superintend the printing of the reinutes and that he have it done at once and that he be allowed \$7.50 for his services paid from the minute funds.
- Sec. 3. That the treasurer have \$6.00 for his services paid from the associational funds.
- Sec. 4. That we pay the balance due the Guinn people without interest on church and lot.
- Sec. 5. We recommend that each male member of this association send one dollar to the Thirty Fifth Annual Session and each year thereafter.
- Sec. 6. We recommend that we hold four union meetings this year.
- Sec. 7. We recommend that the moderator visit each church during the year.

#### Report of Committee on Sabbath Schools,

We, your committee on Sabbath Schools beg leave to submit the following: By investigation we find five churches that have Sunday Schools to-wit: Olive, Union Hill, Free Waters, Liberty, Pleasant Hill, Shady

Grove, and Mount Hope. We find that the interest for Sunday Schools is not what it should be. We recommend that our ministers who are pastors of churches earnestly urge the cause of Sunday Schools in our churches, and that they preach one or more sermons on the importance of Sunday Schools each year.

We recommend that each church organize a Sunday School and that each pastor aid and assist that the same be done. We further recommend that the work of the Sunday Schools be reported in the form of a Statistical table and printed in the minutes of the association.

#### Miscellaneous Business.

Resolved 1. That any minister of this association that is found guilty of circulating false reports by pen or otherwise on a brother minister, which is liable to impair or destroy his influence, shall be deemed guilty of a disciplinary offence, and after discipline has been used, if he does not show signs of penitence, he shall be excommunicated from the association and published in our denominational papers.

2. It is agreed to retain a financial system, as we see the great need of such. We recommend that each male member of this association pay to the thirty-fifth annual session of this association and each year thereafter the sum of one dollar.

Motion that a standing financial committee of seven men be appointed by the moderator of this association to see that the associational funds, go for a worthy cause and that the money be paid out of the treasury by the treasurer, and that the committee receipt the treasurer for the same, and that the treasurer make a complete report of all money paid through this committee and for what purpose at each session of the association. Report of Committee on Locating Union Meetings.

Be it Resolved, That any minister of the Jasper Association who desires to set forth full functions of the Jospel, the same shall be made known to the annual association by a recommendation from the church or churches to which they belong; and if on examination they be found worthy, the association shall ordain them, but all ordinations must be done at the associations.
- 7. Be it Resolved, That each minister report annually the amount of money that he has received, the number of miles traveled, the number of sermons preached, the number of public prayers offered, the number of marriage ceremonies he has performed, the number of visits to the sick, and burial services held during the associational year.
- 8. It was agreed that the moderator appoint corresponding delegates to the sister associations. He appointed the following:

- 11. It is agreed that the Articles of Faith, Constitution, and Rules of Decorum of the Jasper Free Will Baptist Association be appended to our minutes.

On motion it is resolved that this the Jasper Free Will Baptist Association, at Pleasant Ridge church, Itawamba county, Miss., do hereby tender our sincere thanks to the officers and delegates of this august body and to the good sisters and the community at large our deepest love and respect for their kindness and friendship toward us. We will long remember you all, and may the blessings of our Master be with you all.

13. On motion the association adjourn to meet at the time and place

#### RULES OF DECORUM.

Article 1. The Association shall be called to order by the Moderator who presided at the last session; former Clerk also officiating until the body is fully organized.

Art. 2. The Association shall be opened and closed with singing and prayer.

Art. 3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

Art. 4. The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.

Art. 5. A majority of delegates present shall rule in all cases except the reception of members, then it shall be unanimous.

Art. 6. The Moderator shall not be entitled to vote, except in case of a tie, and then he shall give the deciding vote. He shall also speak on any question after others have spoken, provided he appoint some one to the chair while he is speaking.

Art. 7. Only one person shall speak at the same time, and he shall rise and address the Moderator, and after recognition by the Moderator, proceed.

Art. 8. No brother shall be interrupted while speaking, unless he depart from the subject under discussion, or use words of personal reflection.

Art. 9. No person shall be allowed to speak more than twice on the same subject witout leave of the Association, nor more than fifteen min-

Art. 10. No person shall laugh or talk during the time the debates are utes at a time.

Art. 11. No member shall absent himself from the Association withgoing on. out leave of the Moderator.

## CONSTITUTION.

Article 1. This Association shall be known as the Jasper Free Will Baptist Association of Alabama, and being composed of ministers and delegates from the different churches forming the same, and each church being entitled to three delegates.

Art. 2. This body shall be considered an advisory council.

Art. 3. All questions of doctrine and matters of general interest shall he decided by a two-thirds vote of the Association, and the decision shall

Art. 4. The officers of this Association shall be a Moderator, Clerk be final. and Treasurer, which shall be chosen by a majority vote at each session of the Association.

Art. 5. The Association shall meet annually at such time and place as may be agreed upon by a previous annual session and shall not adjourn finally, until all the business is transacted.

Art. 6. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.

Art. 7. We agree as churches of this Association to use our best influence to promote the interest of all moral and benevolent institutions,, such as the Temperance Cause, Sunday Schools, Missionary Work, etc.

Art. 8. No member of this Association shall be eligible to the office of Moderator more than two successive sessions, unless no other member be competent to act in that capacity.

Art. 9. Any church of this Association, failing to be represented for two years in succession, the same shall be dropped from our minutes.

### ARTICLES OF FAITH.

Article 1. We believe that there is one and only one living and true God, who is in personality the Father, Son and Holy Ghost, equal and harmonious in every divine perfection.

Art. 2. THE HOLY SCRIPTURE .- We believe that God is the anthor of the Holy Bible, and its teachings constitute the only infallible doctrine for the government of his church.

Art. 3. ORIGINAL APOSTACY.-We believe that Adam was creat ed holy, but by voluntary transgression fell into depravity and consequently involved his posterity in sin.

Art. 4. FREE GRACE .- We believe that the grace of God comprehends all spiritual blessings; that the gospel is the power of God unto sal-

vation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted, regenerated and saved.

Art. 5. CHRISTIAN FAITH.—We believe that Christian Faith is belief in Jesus Christ as the Son oof God and Redeemer of the world and we believe in the inspiration of the Holy Scripture. That "faith comes by hearing and hearing by the Word of God."

Art. 6. REPENTANCE.—We believe that repentance is sorrow for sin, and the kind of sorrow which produces Godly repentance must be preceded by effectual conviction of sin.

Art. 7. FREE AGENCY.—We believe that the human will is free, and that men have the ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures.

Art. 8. PERSEVERENCE.—We do not believe under the Gospel dispensation any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; but it is possible for men who have been converted to make shipwreck of the faith, turn again to sin and be finally lost.

Art, 9. GOOD WORK.—We believe that good works are the result of faith, and not of necessity; that those who have faith will do the works of righteousness, while those who have not faith cannot do anything pleasing or acceptable to God.

Art. 10. CHRISTIAN BAPTISM.—We believe that Christian Baptism is the immersion of a believer in water, in the name of Father, Son and Holy Ghost; that baptism cannot be scripturally administered without faith in the subject who receives it.

Art. 11. THE LORD'S SUPPER.—We believe the supper was instituted by our Savior as a commemorative ordinance; that the bread and wine represent his body and blood; that it was instituted for Christians, and that all Christians should unite in observing that sacred service regardless oof name or denomination distinction.

Art. 12. THE SOUL.—We believe that man is a living soul. That the body will die, but that the soul is immortal. That death is the separation of the mortal and immortal parts of human beings.

Art. 13. THE RESURRECTION.—We believe in the Resurrection of the dead. When the resurrection shall take place thhe soul and the body will reunite and form an immortal being. That the righteous will be received into a state of everlasting happiness, to reign with God forever and ever. But the wicked will be bound hand and foot and cast into outer darkness. "The wicked are driven away in their wickedness, but the righteous have hope in their death."
