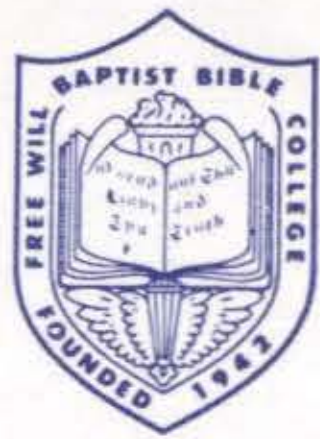

PROCEEDINGS

—0—

Of the thirty-ninth session of the Jasper Free Will Baptist Association which convened with Free Water Church, Marion County, Alabama. Oct. 3, 4, 5, 1925.

The Introductory sermon was preached by Rev. Jesse R. Ford. Text; James 1st, chapter 26, 27, verses. A very large audience present, and give un-divided attention. After which one hour was taken for refreshments, and a most luscious dinner was served, after which the ministers and delegates came to-gether by song and prayer, by Rev. J. R. Ford.

AFTER NOON SESSION

The former moderator, Rev. J. L. Conner and clerk, R. Franks being present, took their seats. The moderator called the body to order and business transacted as follows:

1st. Rev. Joe S. Frederick and B. M. Atkins was appointed reading clerks. Called for letters from churches, were handed in, and read—and contents noted as per statistical table.

2nd. Called for petitionary letters, for reseption of new churches into the body and received the following, to wit: Bear Creek, Union Valley, New Oak Grove and Bulah [Pocahontis].

3rd. The delegates from all the new churches came forward and the right hand of fellowship was extended to them, and they were seated.

4th. By motion, we permanently organize the body by electing Moderator, Clerk and Treasurer for the ensuing year, which resulted as follows:—Rev. B. M. Atkins Moderator, Bro. J. M. Roberson Clerk and W. J. Underwood Treasurer.

5th. Called for correspondence from sister associations and the following was represented; from the Congregational Church, Rev. G. W. Wates, from the State Line Bro. C. M. Stivens and E. L. Watson, from the Vernon—Rev. M. L. Hollis, H. D. Shelnut and Charlie Guin

6th. Called for visiting Ministers of other denominations to seats with us. Received none

7th. By a motion, the moderator was authorized to appoint all committees, as follows:

On Preaching—A. J. Ingle, R. E. Kenedy, J. A. Keeton, with the Deacons of this Church.

On Document and Order of Business—Revs J. L. Conner, W. D. Martin, C. L. Ponders, with the Moderator and Clerk.

On Sabbath Schools—Revs J. H. Potts, H. Howell and Joe S. Frederick

On Literature—Rev. James Godsey, Bro. Ira Nix and Rev. Jesse R. Ford.

On Deceased Members—Rev. P. T. Keeton, Bro. Joseph Atkins and W. S. Flippo.

On Finance—Bros. Joseph Halcomb, J. T. White and Foster Holcomb.

On Resolutions—Bros P. C. Pike, J. A. Pratt, J. J. Graves and Lee A. Nix.

8th. The committee on Preaching reported as follows: We, your committee on preaching report that Rev. Joe S. Frederick preach to night, Rev. P. T. Keeton at nine o'clock Sunday, Rev. B. M. Atkins at 11 o'clock a. m. Rev. A. L. Warren Sunday night, and Rev. W. D. Martin Monday at 11 a. m.

9th. By motion the association adjourned to meet Monday morning at 8 o'clock, song by choir, prayer by Rev. J. L. Conner.

SATURDAY NIGHT—Rev. Joe S. Frederick preached an eloquent sermon to a large audience, Text, St. Luke 16 chapter and 5 verse.

SUNDAY'S PROCEEDINGS

(Out in grove) At 9 o'clock, Rev. P. T. Keeton preached a most interesting and instructive sermon to a very large and attentive audience Text, St. John 5th. chapter and 6th. verse. "Wilt thou be made whole?"

At 11 o'clock, Rev. B. M. Atkins preached a noble

sermon to a vast congregation with the best of order, and great interest manifested, text used "Let not your heart fail because of him." after which the Lord's Supper served and all Christians invited to partake, and Christians of different denominations communed with us, Benediction by Rev. Swindle.

Sunday night at 7:30 Rev. A. L. Warren preached to a large audience with good attention and nice order. Text, not given.

MONDAY MORNING Oct. 5th, 1925.

The Association met pursuant to adjournment; song by the choir, prayer by Rev. W. D. Martin, after which the moderator ordered the roll of Ministers and Delegates called; a quorum being present, the association went into business as follows:

1st. The Minutes of Saturday's proceedings, read and adopted.

2nd. On motion, Rev. M. L. Hollois of Vernon, entertain the audience while the committees get ready to report.

3rd. Invited Ministers of other Denominations to seats with us. Rev. Bro. Swindle of the Methodist Church was seated.

4th. Reports of committees were called for in regular order and presented as follows:

ON DOCUMENT AND ORDER OF BUSINESS

1st. We find two petitionary letters asking for the next Association, and we recommend that the body decide, the same, to convene on Saturday before the first Sunday in October, 1926.

2nd. We recommend the Ordination of Rev. Grady Williams, of Guin.

3rd. We recommend that our minutes be printed at Vernon, Ala., and that the Clerk receive \$7.00 for his service, out of minute funds.

4th. We recommend that this Association represent

In the State Conference, which is to convene at Townley, Ala., on Friday night before the 2nd. Sunday in November, 1925

5th. We recommend that the Moderator and Treasurer receive \$5.00 each for their service, out of the Associational funds

6th. We recommend that a Ministers and Deacons meeting convene with Pearces Chapel Church, on Thursday before the 5th. Sunday in August, 1926.

We urge the Ministers and members of this association to organize more Sabbath schools as we deem it necessary, and that they are means whereby many souls are lead to Christ. We recommend that Free Will Baptist Literature be used in connection with the Holy Bible. Respectfully submitted,

The Association met pursuant to adjournment, song by choir, prayer by Bro. Joseph Atkins. By a motion the Associational funds be turned over to the Treasurer, and the minute funds to the Clerk. By a motion the Treasurer was ordered to pay a balance of \$5.00 due Bro. Hollis on minutes of 1924.

Rev. G. T. Williams was Ordained by a Presbatry composed of Revs. G. W. Flippo, P. T. Keeton and J. R. Ford, who recommended that he be set to the full functions of the Gospel.

MISCELLANEOUS BUSINESS

1. Resolved; That any Minister of this Association who is found guilty of circulating false reports, by pen or otherwise, on a brother minister which is liable to impair and destroy his influence shall be deemed guilty of a disciplinary offence, and after discipline has been used if he does not show signs of penitence he shall be excommunicated from the Association, and published in our denominational literature.

2. It is agreed to retain a financial system, as we see the great need of such, and we recommend that each member of this Association, pay, annually, 50 cents in connection with the minute funds, and ask all our ministers to use their best efforts in collecting these funds; and it is further understood that our Treasurer keep a true record of all funds paid in, and how the same are paid out; such funds to be disposed of through the Moderator

and Clerk being authorised by the Association; said funds to be used to no other purpose than the up-building of the Jasper Free Will Baptist Association, i.e., aiding distressed and disabled Ministers and poor widows and orphans.

3. Be it Resolved; That, members shall not hold their membership out of the Church over one year after date, and they are under Jurisdiction of the Church to which they belong.

4. Be it Resolved; That, any Minister of the Jasper Free Will Baptist Association who desires to set forth the full functions of the Gospel, the same shall be made known to the Annual Association by recommendation from the Church or Churches to which they belong, and if, on examination, they are found worthy, the association may ordain them; but all ordinations must be done at the Annual Association.

5. Be it Resolved; That we will not accept the Baptism of any un-ordained minister.

(On motion section 1,2,3,4 and 5 of last years minute be re-printed as printed there-in.)

6. By motion the Moderator appointed corresponding delegates to our sister Associations, whereupon the following were appointed, to-wit: Little Brown Creek—Rev. P. T. Keeton and Bro. J. T. Tharp. Vernon—Rev. W. D. Martin. Rev. E. R. Franks and Rev. J. H. Potts. To State Line—Revs. J. J. Wesley, Joe S. Frederick and J. L. Conner. To Bear Creek—Revs. J. R. Ford, J. A. Godsey and Bro. J. T. Lankston. To Mt. Moriah—Revs. W. D. Martin, A. L. Warren and B. M. Atkins.

7. Be it resolved: That there be one Ministers and Deacons Meeting this year, and that the same convene with Pearce Chaple Church, on Thursday before the 5th Sunday in August, 1926. Rev. J. A. Godsey, to preach the Introductory sermon.

8. By motion it was agreed to hold the next session of this Association with Gum Springs Church, 3 miles north east of Brilliant, Ala., the same to convene on Saturday before the 1st. Sunday in Oct. 1926. Rev. W. D. Martin was elected to preach the Introductory sermon.

9. On motion the moderator appointed delegates to the State Conference as follows: Bros. J. M. Weeks, A. J. Ingle and G. W. Burleson.

10. On motion the Ministers of the various Churches ask the members to consider the matter of changing the 9th. Article of Faith, or strike the word "NOT" from said Article, and report at next Association.

11. On motion the Articles of Faith, Rules of Decorum and Constitution be appended to this minute.

12. On motion the proceedings of the Ministers and Deacons meeting of July, 1925, be appended to our minutes.

13. Be it Resolved; that this Association tender our sincere thanks to the officers and delegates of this august body, and to the good women in the community at large, for their love and hospitality to us while here, and we shall long remember the same. Respectfully submitted,

AFTER-NOON SESSION

1st. At 2 o'clock the congregation was called together by a song, by the choir, prayer by Rev. G. W. Flippo.

2nd. The body was organized by electing Rev. G. W. Flippo, Moderator and W. S. Flippo, Clerk

3rd Called names of Churches, Ministers and delegates, to-wit: Mt. Olive—Revs. J. H. Potts, J. L. Conner and Bro. H. L. Franks. Mt. Pleasant—Rev. M. R. Martin and W. A. Smith. Union Hill—Rev. Joe S. Frederick. Free Water—Revs. G. W. Flippo, E. R. Franks and W. H. Morris. Liberty—Rev. W. D. Martin and J. E. Smith. Brilliant Chapel—Rev. A. L. Warren. Bethlehem—Rev. J. A. Flippo.

4th. Move carried, that the moderator appoint all committees. On preaching—Bros. Lee Franks, J. F. Burleson and J. G. Markham. On Documents and Order of Business—Revs. W. D. Martin, J. H. Potts, A. L. Warren Bros. R. E. Kened, K. M. Pollard and J. M. Underwood.

5th. The committee on preaching made the following report: Rev. J. H. Potts preach to-night; Rev. Joe S. Frederick preach Friday at 11 o'clock, a. m. Rev. A. L. Warren preach Friday night. The report received and the committee discharged.

6th. Adjournment to meet Friday a. m., at 8 o'clock. Song by choir, prayer by Rev. A. L. Warren.

FRIDAY MORNING SESSION

Friday, morning at 8 o'clock the body was called together by song, by the choir, prayer by Rev. G. W. Flippo; next, the moderator declared a quorum present, and called for the reading of Thursday's work, which was approved. Next, called for reading of the Resolution as drawn, after which the Articles of our Faith were discussed. Next, a resolution was drawn, to be presented to the Association, to know if our financial system was equal with our articles of faith. Next, adjourned for preaching, song and prayer by sister Potts.

At 11 o'clock Rev. Joe S. Frederick preached, Text, or subject, "No room in the Inn." After preaching the body was recessed until 1 o'clock.

AFTER-NOON SESSION

At the appointed time the body was called together by a song, by the choir, prayer by Rev. J. H. Potts, the

Moderator declared the body ready for business. Our Articles of Faith were ably discussed by the body and also the Resolution that had been drawn up by the committee, after which a song by the choir, prayer by Rev. G. W. Flippo, dismissed to meet Saturday at 8 o'clock a. m.

Friday night, Rev. A. L. Warren preached an able discourse. Text, Jonah 1:6.

SATURDAY'S SESSION

At 8 o'clock a. m. the congregation came together by song and prayer, by Rev. J. L. Conner, after which there was a general discussion on our financial system and Articles of Faith; song and prayer by Rev. J. A. Flippo, adjourned 1 hour for preaching.

At 11 o'clock Rev. J. L. Conner preached an able sermon, text, or subject. "We believe in the Resurrection of the Dead."

Saturday After-noon—Song by choir, prayer by Rev. Frank Lee. Closing service by general talks and admonitions by different preachers. The meeting closed.

ARTICLES OF FAITH

—o—

OF GOD—Article 1. We believe there is one, and but one living and true God. who is in personality, the Father, the Son, and the Holy Ghost. Equal and harmonious in every Divine perfection.

OF THE HOLY SCRIPTURES—Article 2. We believe that God is the Author of the Holy Bible, and that its teachings construe the only infallible doctrine of the government of His church.

OF ORIGINAL APOSTASY—Article 3. We believe that Adam was created holy; but by voluntary transgression fell into depravity, and consequently involved his posterity in sin.

OF FREE GRACE—Article 4. We believe that the Grace of God comprehends all spiritual blessings. That the Gospel is the power of God unto salvation.

That the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted, regenerated and saved.

OF CHRISTIAN FAITH—Article 5. We believe that Christian Faith is belief in Jesus Christ as the Son of God and Redeemer of the world, and we believe in the inspiration of the Holy Scriptures. That "Faith comes by hearing and believing, by the word of God.

OF REPENTANCE—Article 6. We believe that repentance is sorrow for sin, and the kind of sorrow which constitutes godly repentance must be preceded by effectually conviction of sin.

OF FREE AGENCY—Article 7. We believe that the human will is free, and that men have ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures.

OF PERSEVERANCE—Article 8. We do not believe under the Gospel dispensation that any soul is elected to eternal life unconditionally; but those who by faith perseveres to the end will be saved. That it is possible for men who have been converted, to "Make shipwreck of the Faith," turn again to sin and be finally lost.

OF GOOD WORKS—Article 9. We believe that good works is the result of Faith, and not of necessity. That those who have Faith will do works of righteousness; while those who have no faith can not do anything pleasing or acceptable unto God.

OF CHRISTIAN BAPTISM—Article 10. We believe that Christian Baptism is the immersion in water of a believer, in the name of the Father, Son and Holy Ghost. That Baptism can not be Scripturally administered without faith in the subject who receives it.

OF THE LORD'S SUPPER—Article 11. We believe the supper was instituted by our Saviour as a commemorative ordinance. That it was instituted for Christians

and that all Christians unite in observing that sacred service, regardless of names or denominational distinctions.

OF THE SOUL—Article 12. We believe that man is a living soul. That the body will die; but that the soul is immortal. That death is the separation of the mortal and immortal parts of human beings.

OF THE RESURRECTION—Article 13. We believe in the Resurrection of the dead. When the resurrection shall take place the soul and body will re-unite and form an immortal being. That the righteous will be received into a state of everlasting happiness, to reign with God for ever and ever. But the wicked will be bound by hand and foot and be cast into outer darkness. "The wicked are driven away in their wickedness, but the righteous have hope in death."

RULES OF DECORUM

Article 1. The Association shall be called to order by the Moderator who presided at the last session; former Clerk also officiating until the body is fully organized.

2. The Association shall be opened and closed with singing and prayer.

3. The moderator and Clerk shall be chosen by ballot at each session of the association. A majority of votes by the delegates present elects.

4. The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.

5. A majority of delegates present shall rule in all cases except the reception of members, then it shall be unanimous.

6. The Moderator shall not be entitled to vote, except in case of a tie and then he shall give the deciding vote. He shall also speak on any question after others has spoken, providing he appoints some one to the chair while he is speaking.

7. Only one person shall speak at the same time, and he shall arise and address the Moderator, and after recognition by the moderator, proceed.

8. No brother shall be interrupted while speaking, unless he departs from the subject under discussion, or uses words of personal reflection.

9. No person shall be allowed to speak more than twice on the same subject without leave of the association, nor more than fifteen minutes at a time.

10. No person shall laugh or talk during the time the debate is going on.

11. No person shall absent himself from the Association without leave of the Moderator.

CONSTITUTION

Article 1. This Association shall be known as the Jasper Free Will Baptist Association of Alabama, and Miss., being composed of ministers and delegates from the different churches forming the same, each church being entitled to three delegates.

2. This body shall be considered an Advisory Council, but having no authority over the affairs of the churches.

3. Each church in this Association shall be considered an advisory body, and shall control its own internal affairs in matters of discipline etc. It may, however, in extreme case, call aid from sister churches.

4. All questions of doctrine and matters of general interest shall be decided by a two-thirds vote of the association, and the decision shall be final.

5. The Officers of this association shall be a Moderator, Clerk and Treasurer, which shall be chosen by a majority vote at each session of the association.

6. The Association shall meet annually at such time and place as may be agreed upon by a previous annual session and shall not adjourn finally until all the business is transacted.

7. Churches wishing to become members of this association must adopt its Articles of Faith and conform to its usages.

8. We agree as churches of this Association to use our best influence to promote the interest of all moral and benovelent institutions, such as the Temperance Cause, Sunday Schools, Missionary work, etc.
