

The Next Session of this Association Will Convene on Saturday Before the First Sunday in October, 1931, With Union Hill Church, 2 Miles West of Hackleburg in Marion County, Alabama. Rev. W. D. Martin to Preach the Introductory Sermon.

PROCEEDINGS

Proceedings of the 44th Session of the Jasper Free Will Baptist Association which convened with Shady Grove Church in Franklin County, Alabama, on Saturday before the first Sunday in October 1930. After song by the choir and prayer by Rev. Ira Nix, the introductory sermon was preached by Rev. J. A. Godsey. Text: Luke 3rd chapter, 4th verse: "Prepare Ye The way of The Lord, Make his Paths Streight." After this an intermission of one hour was taken for refreshments.

EVENING SESSION, OCTOBER 4, 1930.

Song by the choir, and prayer by Rev. J. L. Conner. The former moderator and clerk being present, called the house to order and business was transacted as follows:

Report received and Committee discharged. By motion the Association adjourned to meet Monday morning at 8 o'clock.

SATURDAY NIGHT SERVICE

After song by the choir and prayer, Rev. J. H. Potts preach ed to a large audience. Text: Luke 7th chapter and the latter clause of the 45th verse.

SUNDAY MORNING

At 9 o'clock Rev. M. L. Hollis preached to a large audience of people. Text: Duct. 32nd chapter and 48th verse. The entire audience enjoyed this sermon.

SUNDAY MORNING AT 11 O'CLOCK

After song by the choir and prayer Rev. P. T. Keeton delivered a sermon on the "Communion." Text: 1 cor. 11th chapter and latter clause of the 24th verse. "This Do in Rememberanc of Me," after which the Lord's Supper was served and the Christians of all Denominations were invited to take of this supper. After this several Christians washed each others feet amid tears and joy.

SUNDAY NIGHT SERVICE

After songs, prayer and testamonies by several of Christians, Rev. J. L. Cooner preached an able dicorse to a large audience of good behaved people. Text: "The Church."

MONDAY MORNING SESSION, OCTOBER 6, 1920

The Association met persuant to adjournment. Song by the choir and prayer by Rev. A. L. Warren. There being a quorum present the body was called to order for business.

Next in order was to call the names of delegates. They were

called and all present answered to their names.

Next in order was to call for report of committees. We your committee on Document and order of business beg leave to report as follows:

Sec. 1. We recommend that this association meet on Saturday before the first Sunday in October 1931 at the place designated by the assembly of this session.

Sec. 2. We recommend that each minister make an annual

report to the association of his years work.

Sec. 3. We recommend that the present Moderator be paid \$5.00 at this session out of the association funds.

Sec. 4. We recommend the Treasury be paid \$5.00 out of the association's funds.

Sec. 5. We recommend that the clerk be paid \$10.00 for his service out of the association funds.

Sec. 6. We recommend that all of the Free Will Baptist Churches of the Jasper Free Will Baptist Association receive members into the church in full fellowship and not as candidates for baptism.

Sec. 7. We recommend that Bro. J. F. Ashmore be ordained at this session of the Association; Rev. W. D. Martin, Rev. A. L. Warren and Rev. J. S. Frederick as Ordaining Council.

Sec. 8. We recommend that Rev. W. D. Martin preach the Introductory Sermon at the next session of the Association.

Sec. 9. We recommend that none of our churches practice the doctorine of the Niclotines. By motion the report was received and adopted by section. REV. W. D. MARTIN, Chairman. Report received and committee discharged.

REPORT OF COMMITTEE ON SABBATH SCHOOL

We your committee on Sabbath School make the following report. We find and increased interest being manifested among our churches in Sunday School work. We urge that we do our best to organize Sunday Schools in all our churches and that we use our Free Will Baptist Literature printed at Ayden, N. C. Respectfully submitted REV. M. L. Hollis, as delegate to the General Conference.

2nd. Resolved that this Association elect a delegate to represent this body in the State Conference which will convene with Pleasant Site Church, 17 miles north of Sulligent, Ala., on

the highway leading from Amory, Miss., to Hamilton, Ala.,, and convenes on Wednesday, September 9, 1931. Resolved also that we, the delegates and ministers and visitors of the Jasper Free Will Baptist Association, extend our thanks to the members of the Shady Grove Church and the community for the able manner in which they have cared for us while with them. MINISTERS REPORT

Since the last session of this association I have traveled about 1800 miles, preached 200 sermons, prayed about 210 public prayers, visited about 500 homes, married 1 couple, conducted 5 funeral services, received into the church 152 members, organized 1 church, ordained 2 decons, pastored 2 churches, organized 4 Sunday Schools and have received for my services about \$100.00. Respectfully submitted, REV. W. D. MARTIN.

Since the last session of the association I have preached 18 sermons, I have offered 50 public prayers, attended 2 burrill services, visited the sick 12 times, married 2 couples, traveled 121 miles and have received \$6.00 for my service.

Respectfully submitted, REV. E. R. FRANKS.

Since the last session of the association I have pastored 1 churches:

1st. Union Hill Church. Preached 24 sermons, prayed 22 prayers, received for my service \$34.50, traveled 84 miles and paid out for traveling \$3.90.

2nd. Union Chapel Church. Preached 25 sermons, prayed 18 public prayers, received for my service \$45.50, traveled 660 miles and paid out for traveling \$12.60.

3rd. Free Waters Church. Preached 24 sermons, prayed 23 public prayers, received for my service \$32.40, paid out for traveling \$13.20 and traveled 405 miles.

4th. New Oak Grove Church. Preached 35 sermons, prayed 36 public prayers, paid for my service \$132.71, paid out for traveling \$33.85 and traveled 1290 miles.

Since the last session of the association I have preached 66 sermons, prayed 65 public prayers, traveled 1221 miles, received for my service \$44.78. paid out for myself \$20.09, baptised 2, 4 additions to the church and married 1 couple. Respectfully, REV. I. D. NIX.

Since the last session of the association I submit the following report of my work for the year ending October 1st 1930, to the Jasper Association of Free Will Baptist. Preached 294 sermons, pastored 4 churches; Red Bay, Guin Chapel, Brilliant Chapel and Friendship. I have preached for Red Bay two Sundays in each month, held 8 revivals, baptised 183. Total number received into the church 296, collected \$1370.00 on salary; amount received for Evangilistic work \$316.36; collected for home mission work \$20.00; total amount received for work \$1686.36; collected for education \$62.00; number of funerals conducted 5; marriages 3 couples. Underwood; Little Brown Creek. M. L. Hollis A. L. Warren, P. T. Keeton; Muscle Shoals, J. L. Cooner, J. S. Frederick.

2nd. By move and second that Bro. J. B. Nelson be appointed Treasury of the Association in the vacancies of W. J. Underwood, who resigned, as Bro. Nelson was the next highest in votes.

3rd. By motion the next session of this Association come together with a handshake one with another in token of love, peace and fellowship with each other.

4th. By a unanimous vote the next session of this Associat-

ion will convene with Union Hill Church, 2 miles west of Hack-legurg in Marion County, Ala., the same to convene on Saturday before the1stSunday in October 1931. Rev. W. D. Martin to preach the introductory sermon.

5th. Be it resolved that any minister of the Jasper Free Will Baptist Association who desires to set fourth the full functions of the Gospel, the same shall be made known to the Association by recommendation from the church or churches to which they belong, if upon examination they are found worthy the Association may ordain them, but all ordination must be done at the Annual Association.

6th. Be it resolved that we will not accept the Baptism of any unordained minister.

7th. By motion the articles of faith and rules of decorum and constitution be appended to our minutes.

8th. On motion the Association adjourned to meet at the next place named above. Song by the choir with handshake amid tears after benediction by the Moderator.

ARTICLES OF FAITH

Article 1. OF GOD—We believe there is one. And but one living and true God. Who is in personality the Father the Son and Holy Ghost; equal and harmonious in every Devine perfection.

Article 2. OF THE HOLY SCRIPTURE—We believe that God is the Author of the Holy Bible and that its teachings construe the only infalible doctrine of the governm't of His Church.

Article 3. OF ORIGINAL APOSTASY—We believe that Adam was created Holy; but by voluntary transgression fell intodepravity. And consequently involved his prosperity in sin.

Article 4. OF FREE GRACE—We believe that the grace of God comprehends all spiritual blessings. That the Gospel is the power unto salvation. That the Holy Spirit not only reproved the world of sin but is the means whereby sinners are converted, regenerated and saved.

Article 5. OF CHRISTIAN FAITH—We believe that Christian Faith is belief in Jesus Christ the Son of God and Re

deemer of the world. And we believe in the inspiration of the Holy Scriptures. That Faith comes by hearing and believing, by the Word of God.

Article 6. OF REPENTANCE—We believe that repentance is sorrw for sin and the kind of sorrow which constitutes god ly repentance must be pecceded by effectually conviction of sin.

Article 7. OF FREE AGENCY—We believe that the human will is free, and the men have ability to accept or reject the conditions of salvatin as they're revealed in the Holy Scripture

Article 8. OF PRESERVANCE—We do not believe under the Gospel dispensation that any soul is elected to enternal life unconditionally; but those who by faith persevert to the end will be saved. That it is possible for men who have been converted, to "Make Shipwreck of Faith," turn again to sin and be finially lost.

Article 9. OF GOOD WORKS—We believe that good works is the result of Faith. That those who have Faith will do works of righteousness; while those who have no Faith can not do anything pleasing or acceptable unto God.

Article 10. OF CHRISTIAN BAPTISM—We believe that Christian Baptism is in the emersion of a believer, in the name of the Father. Son and Holy Ghost.

That Baptism cannot be scripturally administered without Faith in the subject who receives it.

Article 11. OF THE LORD'S SUPPER—We believe the supper instituted by our Savior as a commemorative ordinance. That it was instituted for Christians and that all Christians unite in observing the sacred service, regardless of name admonitional distinctions.

Article 12. OF THE SOUL—We believe that man is a living soul. That the body will die, but that the Soul is immortal. That death is the separation of the moral and immoral parts of human being.

Article 13. OF THE RESURRECTION—We believe in the resurrection of the dead. When the resurrection shall take place the soul and body will reunite and form an immortal being. That the righteous will be received in a state of everlasting happiness, to reign with God forever and ever. But the wicked will be bound by hand and foot and be cast into outer darkness. "The wicked are driven away in their wickedness,

but the righteous have hope in the death."

RULES OF DECORUM

1. The Association shall be called to order by the Moderator who presided at the last session; former Clerk also officiating until the body is fully organized.

2. The Association shall be opened and closed with singing and prayer.

3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by the delegates present elects.

4. The names of delegates from the different churches shall be enrolled and called as often as necessary during the session.

5. A majority of delegates present shall rule in all cases ex cept the reception of members, then it shall be unanimous.

6. The Moderator shall not be entitled to vote, except in cases of a tie and then he shall give the deciding vote. He shall also speak on any question after others have spoken, providing he appoints some one to the chair while he is speaking.

7. Only one person shall speak at the time and he shall arise and address the Moderator and after recognition by the Moder-

ator proceed.

- 8. No brother shall be interrupted while speaking, unless he departs from the subject under discussion or use words of personal reflection.
- 9. No person will be allowed to speak more than twice on the same subject without leave of Association, not more than 15 minutes at a time.
- 10. No person shall laugh or talk during the time the debate is going on.
- 11. No person shall absent himself from the Association without leave of the Moderator.

CONSTITUTION

- 1. This Association shall be known as the Jasper Freewill. Baptist Association of Alabama and being composed of ministers and delegates from the different churches forming the same, each church being entitled to three (3) delegates.
 - 2. This body shall be considered an advisory council.
 - 3. All questions of doctrine and matters of general interest

shall be decided by two-thirds vote of the Association and the decission shall be final.

- 4. The officers of this Association shall be a Moderator, Clerk and Treasurer, who shall be chosen by a majority vote at session of the Association.
- 5. The Association shall meet annually at such time and place as may be agreed upon by a previous annual session and shall not adjourn finally, until all business it transacted.

6. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.

7. We agree, as churches of this Association to use our best influence to promote the interest of all moral and benevolent institutions, such as the Temperance Cause, Sunday School, Missionary Work, etc.
