To the 45th annual Session of the Jasper Free Will Baptis Association: I am happy to have the privilege to make the following report of my year's work to the ministry: Under God and by His goodness, I have pastored 2 churches Red Bay and Brilliant-Boston, giving Red Bay 3 Sundays in each month and Brilliant, Boston 1 Sunday. I have also pastored 1 church in the Vernon association, preaching for them on Saturday and Saturday night before the 2nd Sundays. The Lord has wonderfully blessed His work in these churches We have received into Red Bay church 25 members, Brilliant, Boston 23 members, Mt. Harmony 11. I have preached 294 sermons during the year, held 6 tent meetings where we have no churches, organized one church with 73 members, held 4 church meetings, baptised 81, taken 242 members into the churches, received \$1043.00 for pastorial work, for evangelistic work \$365.00. Total year's work \$140800, with house furnished by Red Bay church. Traveled during year 8700 miles, conducted 14 funerals, assisted in 5 others, ordained 5 deacons, preached one commencement sermon, 4 memorial sermons. Pray that the Lord will continue to bless me in his service.

Report of my year's work, I have preached about 38 sermons, prayed 85 public prayers, married 3 couples, received \$3.00, held 2 funerals services, visited the sick 20 times, organized 1 Sunday School, received into the church 30 members 19 by recommendations, 11 baptism, helped in 4 meetings, prayed for the sick 11 times. Respectfully, J F. Ashmore.

Since the last Association, I have preached 150 sermons, prayed 225 public prayers traveled 3500 miles, paid for my service \$250 00. paid for traveling expenses \$115.00, received into the church 74, pastored 4 churches, held 5 funeral services, married 5 couples. 2nd. By motion the next session of this Association come together with a handshake, one with another in token of love, peace and fellowship with each other.

3rd, By a unanimous vote, the next session of this Association will convene with New Oak Grove church, in Walker County, near Nauvoo. Ala., to convene on Saturday, before the First Sunday in October, 1932.

4th. Be it resolved that any minister of the Jasper Free Will Baptist Association, who desires to set forth the full functions of the Gospel, the same shall be made known to the Association by recommendation from the church or churches to which they belong. If upon examination they are found worthy, the Association may ordain them, but all ordinations must be done at the annual association.

5th. Be it resolved that we will not accept the baptism of any unordained minister.

6th. By motion the Articles of Faith and Rules of Decorum and Constitution be appended to our Minutes.

7th. On motion, the Association adjourned to meet at the place named above. Song by the choir, with haudshakes amid tears, after which benediction by the Modeator.

Art. 1 We believe there is one and but one living true God, who is in personality the Father, Son and Holy Ghost, equal and harmonious in every divine pertection. Art. 2 We believe that God is the author of the Holy Bible, and that its teachings construe the only infalible doctrine of the government of His church.

Art. 3. We believe that Adam was created holy but by voluntary transgression fell into depravity, and consequently involved his posterity in sin.

Art. 4. We believe that the grace of God comprehends all spiritual blessings, that the gospel is the power unto salvation, that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted. regenerated and saved.

Art. 5. We believe that christian faith is belief in Jesus Christ, the Son of God and Redeemer of the world, and in the inspiration of the Holy Scriptures that faith comes by hearing, and hearing by the word of God. . Art. 6. We believe that repentance is sorrow for sin and the kind of sorrow which constitutes godly repentance must be preceeded by effectual conviction

for sin.

Art. 7. We believe that the human will is free, and the men has ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures. Art 8, We do not believe under the gospel dispensation that any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men who have been converted to make shipwreck of faith. turn again to sin, and be finally lost.

Art. 9, We believe that good works is the result of faith and that those who have faith will do works of righteousness, while those who have no faith cannot do anything pleasing or acceptable to God.

#### Articles of Faith.

Art. 10. We believe that Christian baptism is in the emersion of a believer in the name of the Father, Son and Holy Ghost; that baptism cannot be scripturally administered without faith in the subject who receives it.

Art. 11. We believe the Supper instituted by our Savior as a commemorative ordinance; that it was instituted for Christians and that all Christians unite in observing the sacred service, regardless of name admonitional distinction.

Art. 12.-We believe that man is a living soul; that the body will die, but that the Soul is immortal; that death is the separation of the moral and immoral parts of human being.

Art. 13. We believe in the resurrection of the dead. When the resurrection shall take place the soul and body will reunite and form an immortal being: that the righteous will be received into a state of everlasting happiness to reign with God forever and ever, but the wicked will be bound hand and foot and cast into outer darkness. The wicked are driven away in their wickedness, but the righteous have hope in their death.

# **Rules of Decorum.**

1. The Association shall be called to order by the Moderator who presided at the last session, the former Clerk also officiating until the body is fully organized.

2. The Association shall be opened and closed by singing and prayer.

3. The Moderator and Clerk shall be chosen ty ballot at each session of the Association. A majority of votes by delegates present elects.

4. The names of delegates from the different churches shall be enrolled and called for as often as necessary during the session.

5. A majority of delegates shall rule in all cases except the reception of members, then it shall be unanimous.

6. The Moderator shall not be entitled to vote except in cases of a tie, and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, provided he appoints some one to the chair while he is speaking.

7. Only one person shall speak at the time and he shall arise and address the Moderator, and after recognition by the Moderator he shall proceed.

8. No brother shall be interrupted while speaking unless he depart from the subject under discussion or use words of personal reflection.

9. No person will be allowed to speak more than twice on the same subject without leave of the Association, not more than 15 minutes at a time.

10. No person shall laugh or talk while the debate is going on.

11. No person shall absent himself from the Association without leave of the Moderator.

#### **Constitution.**

This Association shall be known as the Jasper Free Will Baptist Association of Alabama, and being composed of ministers and delegates from the different churches forming the same, each church being entitled to three (3) delegates.

2nd. This body shall be considered an advisory

3rd. All questions of doctrine and matters of general interest shall be decided by Two thirds vote of the Association and the decission shall be final.

4th. The officers of this Association shall be a Moderator and Clerk-Treasurer, who shall be chosen by a majority vote at each session of the Association.

5th. The Association shall meet annually at such time and place as may be agreed upon by a previous Annual Session and shall not adjourn finally until all business is transacted.

6th. Churches wishing to become a member of this Association must adopt its Articles of Faith and conform to its usages.

7th. We agree, as Churches of this Association. to use our best influence to promote the interest of all moral and benevolent institutions, such as Temperance, cause Sunday School, Missionary work, etc.
