

# **PROCEEDINGS**

Of the Fiftieth Annual Session of the Jasper Free-Will Baptist Association, which convened with Mt. Olive Church in Marion County, Alabama, on October 3-4-5, 1936.

The meeting opened with singing by the choir and prayer by Rev. J. L. Connor, after which, in the absence of Rev. J. R. Williams, Rev. G. O. Parker preached the introductory sermon, to a large concourse of people. Text used—"Why call ye me Lord and do not do the things I say?" After which one hour was taken for dinner and refreshment. The delegates were requested to be back in the house by 1 o'clock ready for business.

## Saturday, October 3

Afternoon Session:—1. After song by the choir and prayer by Rev. G. W. Flippo, the house was called to order. The past Moderator being absent, the secretary oppointed J. L. Connor Moderator pro tem, urtil the body was organized.

- 2. Moved, seconded and carried that the body be organized, which was done by electing Rev. G. O. Parker Moderator and W. S. Flippo Secretary-Treasurer. By motion and second the Moderator appointed Rev. G. A. Godsey and Rev. 7. S. Fredrick as reading clerks.
- 3. The names of the churches were called and the letters were handed in and read, and the delegates' names were enrolled as per statistical table.

- 6. Moved and seconded that the Moderator appoint all committees.

Moved and seconded to rescind the act that has been in effect and appoint the committee on Documents and Order of Business at each session of the Association.

Potts to preach Sunday morning at 9:00 o'clock, Rev. G. O. Parker to preach at 11:00 o'clock, Rev. J. S. Fredrick to preach Sunday night, and Rev. T. B. Pike to preach Monday at 11:00 o'clock,

Next in order was to call names of the churches and con-

sign the delegates to their places of stay while the body was in session.

Moved and seconded that the body be dismissed to meet Monday at 8:00 o'clock.

#### Saturday Night Service

After singing by the choir and prayer, Rev. I. D. Nix preached an able discourse to a large audience of people. Text used was 3rd chapter and 14th verse of St John: "As Moses lifted up the serpent in the wilderness even so must the Son of Man be lifted up."

## Sunday Service

Sunday morning at 9:00 o'clock Rev. J. H. Potts preached to a large concourse of well-behaved people. Text used, Matthew, 5th chapter and 48th verse: "Be ye therefore perfect even as your Father which is in Heaven is perfect."

Sunday at 11:00 o'clock Rev. G. O. Parker preached an able discourse to a large concourse of wen behaved people. Text used, "A Prepared People for A Prepared Place." A collection was then taken u for Rev. A. L. Warren, amounting to \$22.61, after which the benediction was taken and the congregation dismissed to meet back at 7:00 o'clock for preaching Sunday night.

### Sunday Night Service

After singing by the choir and prayer by Rev. W. D. Martin, Rev. J. S. Fredrick preacher an able discourse on the Lord's Supper and foot-washing. Text used, 15th chapter and 9th verse of St. John: "As the Father hath loved me so have I loved you: continue ye in my love". After which the Lord's Supper was administered and all Christians were invited to partake of these emblems, and several Christians washe! each other's feet. The body was then dismissed to meet Monday morning at 8:00 o'clock.

## Monday Session, October 5

Song by the choir and prayer by Rev. S. F. Lee of the Vernon Association. Moved and seconded that Rev. S. F. Lee from the Vernon Association be seated with us.

The roll of delegates was called and absentees noted. The Moderator announced a quorum present and ready for the transaction of business.

- 1. A motion was made and seconded that by request of Bro. Arche Keeton, a member of the preacher's committee who is sick, that this body pray for him, which request was granted and prayer led by Rev. J. H. Potts.
- 2. A motion was made and granted that the names of the various cammittees be called, and by request of the Moderator the committees were asked to retire, make out their reports and

return to the house as soon as possible. While the committees were out the congregation held a glorious experience service.

By motion and second the report of Rev. W. D. Martin was received and accepted.

#### REPORTS OF COMMITTEES

ON DOCUMENTS and ORDER: We, your committee on Documents and Order of Business, beg leave to report as follows:

Section 1. We recommend that this Association meet on Saturday before the first Sunday in October, 1937: Also we recommend that this delegated body say where the next session of this Association shall be held.

Sec. 2. We recommend that this Association have all day service on Sunday and bring dinner to feed the people.

Sec. 3. We recommend that the Secretary-Treasurer be paid \$10.20 out of the finance funds.

Sec. 4. We recommend that the Moderator be paid \$5.00 out of the Association funds for his service.

Sec. 5. We recommend that Section5, Section is and Section 7 of last year's report of committee be dropped.

Sec. 6. We recommend that this Association hold three district meetings, the place to hold them to be decided by this body. Also that a committee be appointed to draw up resolutions for same. Committee was appointed to-wit: Rev. W. D. Martin and Rev. G. W. Flippo.

Sec. 7 We recommend that Rev. W. B. Martin be appointed evangelist for this Association for another year.

Sec. 8. We recommend that the pllpit committee arrange for 11:00 o'clock service on Sunday.

Sec. 9. We recomend that an assistant Moderator be appointed at this session to assist the Moderator at the next session of this Association.

Sec. 10. We recommend that Rev. W. D. Martin be granted further time to write the history of this Association.

Sec. 11. We recommend examination of Rev. L. D. Page and that Rev. W. D. Martin, Rev. J. S. Fredrick and Rev. J. O. Jones act as examining committee and if found qualified ords in him.

C., in their Sunday schools; also urge the members of the churches to subscribe for the Free Will Baptist paper printed at Oden, N. C..

- 1. By unanimous consent the next session of the Jasper Association will convene with Poplar Log Churh, four miles from Hamilton, on the old Hackleburg pike road, the same to convene on Saturday before the First Sunday in October, 1937.
- 2. Be it resolved that any minister of the Jasper Free-Will Baptist Association who desires to set forth the full functions of the Gospel, the same shall be made known to the Association by recommendation from the church or churches to which they belong. If upon examination they are found worthy the Association may ordain them, but all ordinances must be done at the annual Association.
- 3. Be it resolved that we will not accept the baptism of any unordained minister.
- 4. The ordaining council appointed to examine Rev. B. L. Page recommend that he be ordained to the full functions of the Cospel. Ordaining Council, to-wit: Rev. W. D. Martin Rev. J. S. Fredrick, Rev. J. O. Jones.
- 5. By motion and second the Articles of Faith and Constitution were ordered appended to our minutes.
- 6. By motion the Association adjourned to meet one year hence. Benediction and parting hand were taken.

By motion and second that the Moderator preach the introductory sermon at the next session of the Jusper Free-Will Association.

## Articles of Faith

- Art. 1. We believe their is one and but one living true Gcd, who is in personality the Father, Son and Holy Ghost, equal and harmonious in every civine perfection.
- Art. 2. We believe that God is the author of the Holy Bible and that its teachings construe the only infallible doctrine of the government of His church.
- Art. 3. We believe that Adam was created holy, but by voluntary transgression fell into depravity, and consequently irvolved his posterity in sin.
- Art. 4. We believe that the grace of God comprehends all spiritual blessings; that the gospel is the power unto salvation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted, regenerated and saved.

- Art. 5. We believe that Christian faith is belief in Jesus Christ, the son of God and Redeemer of the world, and in the inspiration of the Holy Scriptures, that faith comes by hearing and hearing by the Word of God.
- Art. 6. We believe that repentance is sorrow for sin and the kind of sorrow which constitutes godly repentance must be precerer by effectual conviction o sin.
- Art. 7. We believe that the human will is free, and that man has ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures.
- Art. 8. We do not believe under the gospel dispensation that any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men who have been converted to make shipwreek of faith, turn again to sin and be finally lost.
- Art. 9. We believe that good works is the result of faith, and that those who have faith will do works of righteousness while those who have no faith cannot do anything pleasing or aceptable to God.
- Art 10. We believe that Christian baptism is in the immersion of a believer in the name of the Father, Son and Holy Ghost, that baptism cannot be scripurally administered without faith in the subject who receives it.
- Art. 11. We believe the Supper instituted by our Savior is a commemorative ordinance: that it was instituted for Christians and that all Christians unite in observing the sacred service, regardless of name or denominational distinction.
- Art 12. We believe that man is a living soul; that the body will die, but that the soul is immortal; that death is the separation of the mortal and immoral parts of human beings
- Art. 13. We believe in the resurrection of the dead. When the resurrection shall take place the soul and pody will reunite and form an immortal being; that the righteous will be rec ived into a state of everlasting happiness to reign with God forever and ever, but the wicked will be bound hand and foot and cast into outer darkness. The wicked are driven away in their wickedness, but the righteous have hope in their death.

#### Constitution

- 1. This Association shall be known as the Jasper Free-Will Baptist Association of Alabama, and being composed of Ministers and delegates from the different churches forming the same each church being entitled to three (3) delegates.
  - 2. This body shall be considered an advisory council.
  - 3. All questions of doctrine and matters of general interest

- shall be decided by two-thirds vote of the Association, and the decision shall be final.
- 4. The officers of this Association shall be a Moderator and Clerk-Treasurer, who shall be chosen by a majority vote at each session of the Association.
- 5. The Association shall meet annually at such time and place not adjourn finally until all business is transacted. as may be agreed upon by a previous Annual Session, and shall
- Art 6. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.
- 7. We agree, as Churches of this Association, to use our best influence to promote the interest of all moral and benevolent institutions, such as Tecperance Cause, Sunday School, Missionary Work, etc.

#### Rules of Decorum

- 1. This Association shall be called to order by the Miderator who presided at the last session, the former Clerk also officiating until the body is fully organized.
  - 2. The Association shall be opened by singing and prayer.
- 3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by delegates present elects.
- 4. The names of delegates from the different churches shall be enrolled and called for as often as necessary during the session.
- 5. A majority of delegates shall rule in all rases except the reception of members; then it shall be unanimous.
- 6. The Moderator shall not be entiltled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, provided he appoints some one to the chair while he is speaking.
- 7. Only one person shall speak at the time and he shall arise and address the Moerator, and after recognition by the Moderator he shall proceed.
- 8. No brother shall be interrupted while speaking unless he shall depart from the subject under discussion or use word; of personal reflection.
- 9. No person will be allowed to speak more than twice on the same subject without leave of the Association—nor more than 15 minutes at a time.
- 10. No person shall laugh or talk while the debate is going on.

  11. No person shall absent himself from the Association without leave of the Moderator.
