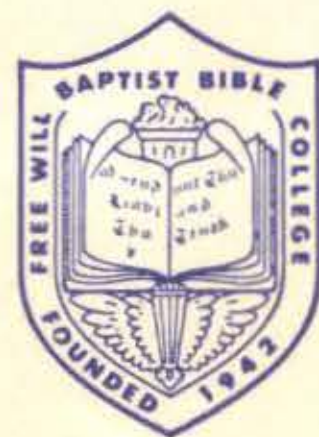

PROCEEDINGS

Of the Fifty-First Annual Session of the Jasper Free-Will Baptist Association, which Convened with Popular Log Church on October 2-3-4, 1937

The body opened with singing by the choir and prayer by Rev. J. H. Potts, after which Rev. G. O. Parker preached the introductory sermon. Subject used for his text, "A Christian Life In The Home and In The Church." After the sermon one hour was taken for dinner and refreshment.

Saturday Afternoon Session

1. Singing by the choir and prayer by Rev. J. D. Nix.
2. The former Moderator and Secretary-Treasurer being present, called the body together for business.
3. Next in order, the Moderator appointed Bro. John Powell and Bro. Wade Fowler as reading clerks. The names of the various churches were called and letters were read and delegates' names were enrolled, as per Statistical Table.

5. By motion made and carried to permanently organize the body by election of Moderator and Secretary-Treasurer, which was done by electing Rev. J. H. Potts Moderator, Rev. A. L. Warren Assistant Moderator, and W. S. Flippo Secretary-Treasurer.

6. Call for correspondents from sister Associations; whereupon Rev. Dan Lee from Manchester Association in Tennessee was seated with us; from State Line Association Bro. J. M. Howell was seated with us; from Morning Star Association Rev. John Smith was seated with us; from Vernon Bro. Staford Chaffin was seated with us. These brethren were given the right hand of fellowship and welcome with us.

7. Next in order, call for the report of the committee on preaching. Committee reports as follows: Rev. Dan Lee to preach Saturday night; Rev. Ira Nix to preach Sunday morning at 9 o'clock; Rev. O. S. Gardner to preach at 11 o'clock, and Rev. G. W. Flippo to preach at 3 o'clock. Also Rev. W. D. Martin to preach Monday at 11 o'clock.

8. Moved and seconded that the Moderator appoint all committees, and the following were appointed:

On Documents and Order of Business: Rev. G. O. Parker, Rev. J. A. Godsey, Rev. G. W. Flippo, Rev. W. D. Martin, Rev. A. L. Warren, with the Moderator and Secretary-Treasurer.

On Sabbath Schools: L. Mann, Rev. O. S. Gardner, Dobson Harris.

On Literature: W. D. Tidwell, Rev. Grady Hudson, R. L. Johnson.

On Deceased Ministers and Members: J. R. Franks, Rev. I. D. Nix, B. B. Pounders.

On Resolutions: Rev. J. O. Jones, R. E. Stone, Cliff Kennedy, Rev. J. L. Conner, Dewey Norris, Kellie Franks.

On Home Missions: J. T. Powell, J. C. Williams, Oscar Grishum.

On Temperance: Rev. O. S. Gardner, E. Thomas.

Next in order was to call the names of the churches and consign the ministers and delegates to their places of stay while the body is in session.

Moved and seconded to be dismissed to meet Monday morning at 8 o'clock. After benediction the congregation was dismissed to meet back for preaching Saturday night.

Saturday Night

After singing by the choir and prayer by Rev. J. L. Conner, Rev. Dan Lee preached an able discourse. Text used, St. John, 3rd chapter and 3rd verse: Jesus answered and said unto

him, "Verily, verily I say unto thee, except a man be born again he can not see the Kingdom of God."

Sunday Services

Sunday at 9 o'clock, after singing by the choir and prayer by Rev. Dan Lee, Rev. I. D. Nix preached to a large concourse of well-behaved people. Text used, "Without faith it is impossible to please Him." After which a few minutes intermission was taken and the congregation returned back to the house for preaching at 11 o'clock.

After song by the choir and prayer by Rev. H. A. Pitts, Rev. O. S. Gardner preached an able discourse. Text used, St. Luke, 22nd chapter and 46th verse: "And said unto them, 'Why sleep ye? Rise and pray lest ye enter into temptation.'" The congregation was dismissed to meet back at 3 o'clock Sunday evening.

After singing by the choir and prayer, Rev. G. W. Flippo preached to a large audience of people. Text used, 24th chapter, 44th verse: "Therefore be ye also ready, for in such an hour as ye think not the Son of Man cometh."

Sunday Night Service, October 3

After singing and prayer Rev. A. L. Warren preached to a large concourse of well-behaved people. Text used, Psalms 126th chapter and 6th verse: "He that goeth forth weeping and bearing precious seed shall doubtless come again with rejoicing and bringing his sheaves with him." After which the Lord's Supper was administered to a large concourse of Christians of different denominations. At Supper a large number of Christians washed each other's feet amid tears and shouting. This closed the Sunday service and the audience was dismissed to meet Monday morning at 8 o'clock.

Monday Morning, October 4, 1937

The body met pursuant to adjournment. After singing and prayer the Moderator called the body to order, ready for business.

1. The Secretary called the names of the delegates and all present answered to their names: after which the Moderator asked the various committees to retire, make out their reports and report back in the house as soon as possible. While the committees were out the congregation held an experience service, conducted by Rev. J. M. Hass. Prayers were offered for Bro. J. W. Burleson and Bro. H. L. Franks, the two oldest deacons of Mt. Olive church.

Next called for reports of committees, which were responded to as follows:

On Documents and Order of Business: Sec. 1. We recom-

mend that this Association meet on Saturday before the first Sunday in October, 1938; also we recommend that the delegated body decide where the next session of this Association shall convene.

Sec. 2. We recommend that the Secretary-Treasurer be paid \$10.00 out of the finance funds.

Sec. 3. We recommend that the Moderator be paid \$5.00 out of Associational funds.

Sec. 4. We recommend that this Association hold three district meetings, the places for holding them to be decided by this body. Also a committee was appointed to draw up resolutions for same. The committee was appointed, to-wit: Rev. W. D. Martin and Rev. G. W. Flippo.

Sec. 5. We recommend that Rev. W. D. Martin be appointed Evangelist for this Association for the year 1938.

Sec. 6. In electing Moderator for this Association we recommend that the man receiving the highest vote be Moderator and the second highest be Assistant Moderator.

Sec. 7. We recommend that this Association appoint or elect a standing committee on examination and ordination of preachers, and that this committee be composed of three of the best qualified preachers of this Association, and that this committee hold office as long as they are in good standing with this Association. We also recommend that Rev. W. D. Martin, Rev. G. W. Flippo and Rev. G. O. Parker be appointed on this committee.

Sec. 8. We recommend that this Association liberate Bro. H. A. Pitts to preach the Gospel; also we recommend the examination and ordination of Bro. W. C. Raburn to preach the Gospel of our Lord and Savior Jesus Christ.

Sec. 9. Be it enacted by this session of this Association, that any church which misrepresents itself to the Association shall be guilty of Discipline offense of this Association, and when the Discipline is used, if the church shows no penitence it shall be ex-communicated from this Association.

Sec. 10. Be it enacted by this session of the Jasper Association, that any pastor who allows his church to misrepresent itself to the Association shall be guilty of Discipline offense. After Discipline is used, if he shows no penitence he shall be ex-communicated from this Association.

Sec. 11. Be it enacted at this session of the Jasper Association, that the treatise of the Faith and Practice of the Free-Will Baptist be adopted.

Sec. 12. Be it enacted by this session of the Jasper Association, that all deacons of the various churches be and are hereby declared as standing delegates.

On Temperance: Be it resolved by this body that we go on record against intoxicating drinks in any form, for all of the evidence points with unerring certainty to the fact that drunkenness has materially increased since the repeal of the 18th amendment; that the pretended interest of the liquor people in the welfare of our youth was a smoke screen, and as soon as they succeeded in the forcing of repeal they resorted to every diaboli-

cal means possible to increase the sale of liquor, and especially to our young people. The courts are all crowded with all kinds of crime caused by drunkenness. In order to fight the evil influence of the liquor interests and to promote temperance, we make the following resolutions:

1. That our Sunday School Superintendents and teachers of our Sunday Schools teach temperance lessons to pupils of our Sunday Schools.

2. That all of our preachers preach special sermons on the evils of intemperance.

3. That members of this body use all their influence at the voting places against the so-called legalizing of intoxicating liquors in any form.

ARTICLES OF FAITH

Art. 1. We believe there is one and but one living true God, who is in personality the Father, Son and Holy Ghost, equal and harmonious in every divine perfection.

Art. 2. We believe that God is the author of the Holy Bible and that its teachings construe the only infallible doctrine of the government of His church.

Art. 3. We believe that Adam was created holy, but by voluntary transgression fell into depravity, and consequently involved his posterity in sin.

Art. 4. We believe that the grace of God comprehends all spiritual blessings; that the Gospel is the power unto salvation; that the Holy Spirit not only reproves the world of sin, but is the means whereby sinners are converted, regenerated and saved.

Art. 5. We believe that Christian faith is belief in Jesus Christ, the son of God and Redeemer of the world, and in the inspiration of the Holy Scriptures, that faith comes by hearing and hearing by the Word of God.

Art. 6. We believe that repentance is sorrow for sin and the kind of sorrow which constitutes Godly repentance must be preceded by effectual conviction of sin.

Art. 7. We believe that the human will is free, and that man has ability to accept or reject the conditions of salvation as they are revealed in the Holy Scriptures.

Art. 8. We do not believe under the Gospel dispensation that any soul is elected to eternal life unconditionally, but that those who by faith persevere to the end will be saved; that it is possible for men who have been converted to make shipwreck of faith, turn again to sin and be finally lost.

Art. 9. We believe that good works is the result of faith, and that those who have faith will do works of righteousness while those who have no faith cannot do anything pleasing or acceptable to God.

Art. 10. We believe that Christian baptism is in the immersion of a believer in the name of the the Father, Son and Holy Ghost, that baptism cannot be scripturally administered without faith in the subject who receives it.

Art. 11. We believe the Supper instituted by our Savior is a commemorative ordinance; that it was instituted for Christians and that all Christians unite in observing the sacred service, regardless of name or denominational distinction.

Art. 12. We believe that man is a living soul; that the body will die, but that the soul is immortal; that death is the separation of the mortal and immortal parts of human beings.

Art. 13. We believe in the resurrection of the dead. When the resurrection shall take place the soul and body will reunite and form an immortal being; that the righteous will be received into a state of everlasting happiness to reign with God forever and ever, but the wicked will be bound hand and foot and cast into outer darkness. The wicked are driven away in their wickedness, but the righteous have hope in their death.

CONSTITUTION

1. This Association shall be known as the Jasper Free-Will Baptist Association of Alabama, and being composed of Ministers and delegates from the different churches forming the same, each church being entitled to three (3) delegates.

2. This body shall be considered an advisory council.

3. All questions of doctrine and matters of general interest shall be decided by two-thirds vote of the Association, and the decision shall be final.

4. The officers of this Association shall be a Moderator and Clerk-Treasurer, who shall be chosen by a majority vote at each session of the Association.

5. The Association shall meet annually at such time and place as may be agreed upon by a previous Annual Session, and shall not adjourn finally until all business is transacted.

6. Churches wishing to become members of this Association must adopt its Articles of Faith and conform to its usages.

7. We agree, as Churches of this Association, to use our best influence to promote the interest of all moral and benevolent institutions, such as Temperance Cause, Sunday School, Missionary Work, etc.

Rules of Decorum

1. This Association shall be called to order by the Moderator who presided at the last session, the former Clerk also officiating until the body is fully organized.

2. The Association shall be opened by singing and prayer.

3. The Moderator and Clerk shall be chosen by ballot at each session of the Association. A majority of votes by delegates present elects.

4. The names of delegates from the different churches shall be enrolled and called for as often as necessary during the session.

5. A majority of delegates shall rule in all cases except the reception of members; then it shall be unanimous.

6. The Moderator shall not be entitled to vote except in case of a tie, and then he shall give the deciding vote. He shall be entitled to speak on any question after others have spoken, provided he appoints some one to the chair while he is speaking.

7. Only one person shall speak at the time and he shall arise and address the Moderator, and after recognition by the Moderator he shall proceed.

8. No brother shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.

9. No person will be allowed to speak more than twice on the same subject without leave of the Association—nor more than fifteen (15) minutes at a time.

10. No person shall laugh or talk while the debate is going on.

11. No person shall absent himself from the Association without leave of the Moderator.
