Art. 8. CONSTITUTION

This Association shall be known as the Jasper Free Will Baptist Association of Alabama, and being composed of ministers and delegates from the different churches forming the same, each church being entitled to three (3) delegates.

6. The Moderator shall not be entitled to a vote except in case of a tie and then he shall give the deciding vote, he shall be entitled to speak on any question after others have spoken, provided he appoints some one to the chair while he is speaking.

7. Only one person shall speak at a time and he shall arise and address the Moderator, and after recognition by the Moderator, he shall proceed.

10. No person shall laugh or talk while the debate is going on.
