Section I This association shall be known as the Jasper Free Will Baptist Association of Alabama; and shall be composed of ordained ministers, deacons, members of the General Board, and delegates from the several churches forming the same. All ordained ministers, deacons and members of the General Board shall be considered standing delegates provided they are members and in good staning with a local church that is part of this association; and provided such church is in good standing with this body.

Section II Churches wishing to become a member of this association must adopt its articles of Faith, the National Treatise and make formal written request. Each church shall be entitles to three (3) delegates. ARTICLE II AUTHORITY

Section I This body shall be considered an advisory council having no authority over the internal affairs of any local church unless said church depart from the Articles of Faith and from the National Treatise. Whenever conditions warrant it, this association shall have power to reprimand or exclude any local church.

Section II The association shall have power to deal with ministers who may become guilty of deviating from Free Will Baptist Doctrine, whose character may become questionable; or who shall in any other way conduct himself so as to bring reproach upon the ministry.

Section III All questions of doctrine and all matters pertaining to a local church, or to an individual minister or group of ministers, shall be decided by a two-thirds vote of this association. All other matters shall require only a majority. Exception; any church desiring membership in this body must obtain unanimous vote of delegated body when in annual session.

Section IV Each church of this association shall be urged to pro mote and support all State and National Projects of the denomination.

Section V No church shall have the right to accept as members those who have not been baptized by an ordained minister.

Section I The officers of this association shall be a moderator, an assistant moderator, a clerk-treasurer, and an assistant clerk-treasurer who shall be elected annually.

Section II Other governing organs of this association shall be a General Board, an Executive Committee, a Credential Committee, and as many other committees as deemed necessary by the moderator.

Section III The General Board shall consist of the moderator and clerk along with one person from each church that is a part of this body. Each person from the local churches shall serve for two years with one half being elected each year as so specified in the printed minute. It shall be the responsibility of this board to formulate all items of general business during the annual session of this association as well as any other responsibility so relegated by the moderator or the body. When this association is not in sesion, this board shall have power to act as the body; but such action must be approved by the association.

Section IV The Executive Committee shall consist of the moderatar and clerk along with five (5) others from the General Board. These five shall be elected each year by the General Board. This committee shall function as-or instead of-the General Board, when directed to do so by the moderator, the General Board or the Association.

Section V The Credential Committee shall consist of three (3) persons with the senior member in point of service replaced each year. Recommendations for replacement shall come from the General Board. It shall be the responsibility of this committee to examine all letters coming to this body from churches, ministers, and other associations. This committee shall also examine all ministers who become a part of this body either by ordination or by letter. It is expected that all ministers coming from other associations will present letters of recommendation; however in some cases the committee may see fit to recommend the acceptance of such persons who have not yet received such letters. Any item of business pertaining to ministers or conduct of ministers must originate with this committee. Business matters handled by this committee may be referred to the association or to the General Board.

Section VI. The moderator of this association shall be regarded as an ex-official member of all boards and committees.

ARTICLE III

ORGANIZATION

ARTICLE IV

MEETINGS

Section I This association shall meet annually on Friday before the first Sunday in October at a place determined at the previous session; and shall not adjourn finally until all business is transacted.

Section II. The associational year shall end August 31 each year and all letters to the association should be mailed to the clerk no later than the first Sunday in September of each year.

Section III There shall also be as many Quarterly Meetings as shall be deemed necessary during each year.

Section IV. The officers of the Quarterly Meeting shall be a moderator, an assistant moderator, a clerk-treasurer, and an assistant Clerk treasurer, who shall be elected annually.

ARTICLE V

ORDINATIONS

Section I Each church shall have the right to select and ordain all deacons who serve in such church. The ordaining council shall consist of two ministers and at least one deacon; or of one minister and at at least two deacons.

Section II Any man who becomes convinced that the Lord has called him to preach the gospel shall be licensed by the church of which he is a member. After he has been licensed for a period of time and has proved his worth the local church shal then make formal request to this association that he be ordained. This local church, of which he is a member, and which licensed him, must be able to show proof of his worthiness as to his ability, sincerity and desire. If after he has been examined by the responsible ones of this body, he then be found worthy; he shall be ordained by this association. All ordi nations to the ministry must be done at the annual session.

Section III All ministers are required to report yearly to the Credential Committee of this body. Such report shall be for year beginning September 1 and ending August 31; and shall be due September 1 of current year. Any minister who fails to comply shall be dropped from roll of ministers.

ARTICLE VI

DISCIPLINE

Section 1 Any church placed on probation by this association shall represent to Quarterly Meetings and to the annual session by letter and fees; but shall not have the right to vote by delegates, standing or otherwise, in either quarterly meetings or the annual session as long as such church is on probation. Exception; any minister who is a member of such church but in good standing with this association and pastoring another church shall not be so penalized.

Section II No minister having been put on probation by this association shall have the right to vote in either quarterly meetings or the annual session.

Section I This constitution and rules of decorum may be amended at any annual session of this association by a two-thirds vote of delegates present; provided proposed amendment is presented in writing, read one day, placd on the table, and adopted the next day.

1. This Association shall be called to order and presided over by officers elected at the last session.

3. The names of delegates shall be noted and referred to as often as is neessary.

4. The Moderator shall not be entitled to a vote except in case of a tie and then he shall give the deciding vote. He shall be entitled to speak on any subject after others have spoken, provided someone else serves as Moderator while he speaks.

5. Only one person shall speak at a time and he shall arise and address the Moderator, and after recognition by the Moderator, he shall proceed.

6. No person shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.

7. No person will be allowed to speak more than twice on the same subject without permission from the Association-nor more than fifteen (15) minutes at a time.

8. No person shall laugh or talk while discussion is going on.

9. No delegate shall absent himself from the Association without leave of Moderator.

10. Any minister absent from the Annual Session of this Association for two years in succession without legal excuse shall be dropped from roll of ministers.
