PROCEEDINGS

The ninety-fourth session of the Jasper Association of Free Will Baptist convened with New Liberty Free Will Baptist Church, October 3, 1980, at 9:00 a.m. Rev. Roger Houston was moderator.

The session opened with the congregation singing "I Shall Never Forget that Day" and "I Have Found the Way", led by Rev. Ray Ritch. Rev. Fred Jones prayed the opening prayer. Rev. Ralton Ray Edgar, brought the devotion. He read from I John 4:7-21 and made some comments on the subject of "love". Rev. Woodrow Matthews then led in prayer.

Bro. Smith, a deacon of the New Liberty Church, gave the welcome, due to the hospitalization of the pastor, Rev. Malone Cobb.

The moderator appointed the following committees: **Obituary:** Ruby Eaton, Myrtle Aultman, Letus Atkinson. **Appreciations:** Gail Gunnin, Lucy Cox, Curt Hunter. **Finance:** Emma Osborn, Sis. Bevans, Aaron Wright.

After the clerk read the roll of delegates, a motion was made, seconded, and carried to seat the delegates.

The moderator asked for visiting delegates to stand; there were none present.

The clerk read the General Board Report. A motion made, seconded and carried to adopt the report item by item. All the items carried.

Rev. Woodrow Matthews offered some recommendations concerning missionary Dave Franks.

1. It is recommended that each church of the Jasper Association send \$125.00 over the period of one year to help Bro. Franks in the purchase of land for the mission in Brazil.

2. It is recommended that each church of the association help in providing a car for Bro. Franks on his furlough, in 1981.

3. It was also recommended that a Dave Franks account be established in the Jasper Association.

A motion was made, seconded and carried on each recommendation.

The moderator appointed a committee to assist in this effort. The members are: Rev. Woodrow Matthews, Rev. Ray Ritch and Rev. Roger Houston.

Report of the Quarterly meeting was read by the clerk. A motion made, seconded and carried to adopt the report.

Rev. Ray Ritch announced the Alabama State Association to be held at the Centerpoint Free Will Baptist Church, November 6, 7, and 8, 1980. The moderator declared a recess. Bro. R. L. Miles led in prayer.

MORNING SERVICE

The morning service began with singing, "Heavenly Sunlight", "Wonderful Words of Life", and "Are You Washed in the Blood", led by Rev. Mike Cordell. Rev. Byron Meyer led in prayer.

Bro. Dwayne Hughes sang, "Fill My Cup" as the special music. Rev. Roger Houston brought the Moderator's message. He read Isaiah 1:1-18 and preached for the subject; "The Need of Revival". He pointed out the hinderances to revival, the evidences of revival, and the conditions of revival. He closed in prayer. Bro. Smith gave the instructions for the noon meal. Bro. Letus Atkinson led in prayer.

AFTERNOON SESSION

The afternoon session was opened with the congregation singing "He Keeps Me Singing", "The Old Account" and "At the Cross" led by Rev. Mike Cordell. Bro. Donald Kivette led in prayer.

The Obituary report was read by the clerk. A motion made, seconded and carried to adopt the report. The moderator asked the congregation to stand in a few moments of silent prayer in memory of those who have gone to be with the Lord. Bro. Dwayne Hughes led in prayer.

Bro. Walter Sloan brought the afternoon message. He read Psalms 139:23-24, 143:10-12, Deuteronomy 6:5 and Proverbs 23:26. He pointed out three things that God hates and that Christians ought to hate. God hates quitting; Psalms 101:3, Luke 9:62; God hates idleness: Proverbs 18:9 and God hates every false way, Psalms 119:104. He then closed in prayer.

The session was dismissed in prayer by Rev. Donnie Gunnin to meet at the Northwest Alabama Free Will Baptist Youth Camp, Saturday, October 4, 1980.

SATURDAY MORNING

The Saturday morning session opened with the congregation singing, "He Keeps Me Singing" and "Jesus Saves" led by Bro. Dwayne Hughes. Bro. Fray Stone led in prayer.

Dr. Robert Picirilli from the Free Will Baptist College brought a message. He read Matthew 7:7-12, Luke 11:5-13. His subject was on "prayer". He gave the basis for prayer; father-child relationship; the promise Jesus gives as an encouragement to prayer; and finally, the responsibility of the Christian in prayer, Matthew 7:12, Luke 6:30-31.

The moderator recognized visitors, Rev. Dennis Reeves and some laymen of the Souls Harbor Free Will Baptist Church were visiting to consider joining this association.

The clerk read the roll of delegates. A motion was made, seconded and carried to seat the delegates.

The clerk read the roll of ministers. The moderator then appointed the following men as fraternal delegates: Rev. Wise Holcomb to the Mississippi State Line Association and Rev. Richard Cordell to the

Vernon Association.

Rev. Richard Cordell offered a resolution to the association as follows:

Whereas, the Jasper Association of Free Will Baptists is an organization solely for the purpose of Christian fellowship and carrying out collective effort, and

Whereas, the sessions of this association are designed to contribute to this fellowship and collective effort, and

Whereas, the entire leadership and body is needed to contribute to such efforts,

Be it therefore resolved,

that officers on boards, committees or organizations not meet at the same time the association is in session or when the regular worship sessions are in progress.

A motion was made, seconded and carried to adopt the resolution.

Rev. Woodrow Matthews gave the Credentials committee report. A motion was made, seconded and carried to adopt item by item. All the items were adopted.

Bro. Don Collins gave the treasurer report. Motion made, seconded and carried to adopt the report.

The right hand of fellowship was given to Rev. Garvin Page, pastor of the Brilliant Free Will Baptist Church.

Rev. Woodrow Matthews gave the report of the Youth Camp Board. Motion made, seconded and carried to adopt the report.

Clerk read the Appreciation Committee Report. Motion made, seconded and carried to adopt the report.

Rev. Richard Cordell gave information concerning the Pastor's and Workers Conference, February 9-11 at the Forestdale Free Will Baptist Church. He also reminded the body of the Annual Missionary Conference.

Rev. Woodrow Matthews gave a report on the cost of the noon meal at the camp. Motion made, seconded and carried to pay the difference out of the treasury.

The moderator declared a recess. Rev. Clovis Tucker led in prayer.

MORNING SERVICE

The morning service began with the congregation singing "Since Jesus Came into My Heart" and "Love Lifted Me", led by Bro. Dwayne Hughes sang a special in song, "Jesus Is the Sweetest Name I Know". The moderator introduced Dr. Robert Picirilli for the morning message. He read Philippians 2:2-11. His subject was on what this passage reveals about Christ. First, the incarnation of Christ; secondly, the humiliation of Christ; thirdly, the exhortation to immolation of Christ; and, finally, the glorification of Christ. He closed in prayer.

Rev. Fred Jones led in prayer for the noon meal.

AFTERNOON SESSION

The afternoon session opened with the congregation singing "At the Cross", "At Calvary", led by Bro. Dwayne Hughes. Bro. Walter Sloan led in prayer.

Rev. Carlton Lambert gave the Children's Home Report. Motion made, seconded, and carried to accept the report as information.

Clerk read the Finance report. Motion made, seconded and carried to adopt the report.

The following officers were elected for the coming year:

Moderator: Rev. Roger Houston; **Assistant Moderator:** Rev. William Pate; **Clerk:** Rev. Byron M. Meyer; **Assistant Clerk:** Rev. Mike Cordell; **Treasurer:** 1Bro. Don Collins.

A motion made, seconded and carried to adjourn the session. Rev. Roger Houston led in prayer.

GENERAL BOARD REPORT

The General Board of the Jasper Association of Free Will Baptists met September 25, 1980 at Hamilton Free Will Baptist Church. Moderator Roger Houston presided over the meeting. The meeting was opened with a song led by Bro. Don Collins. Prayer was by Bro. Woodrow Matthews.

The following recommendations were discussed and passed:

1. We recommend that Bro. Byron Meyer be elected to the Credentials Committee for a three-year term.

2. We recommend that Bro. Richard Cordell be elected to the Board of Christian Education; his term to expire in 1985.

3. We recommend that Bro. Lamar Cox be elected as Children's Home Trustee.

4. A. We recommend that Bro. Woodrow Matthews be elected to the Youth Camp Board of Directors. His term to expire in 1983.

B. We recommend that Bro. Fred Jones be elected to the Youth Camp Board of Directors. His term to expire in 1982.

5. We recommend that the first quarterly meeting be held January 24th of 1981. We recommend that this meeting be held at Mt. Olive Free Will Baptist Church. We recommend that the March 28th meeting be held at Gum Springs Free Will Baptist Church. We recommend that the June 27th meeting be held at Pocahontas Free Will Baptist Church.

We recommend that the first day of the Annual Meeting, October 2, 1981, be held with Free Water Free Will Baptist Church, and the second day, October 3, 1981, be held with the Hackleburg Free Will Baptist Church.

6. We recommend that each church of the Jasper Association give to the Youth Camp on a systematic basis i. e. monthly or quarterly.

7. We recommend that the moderator be paid sixty-five [\$65.00] dollars, the assistant moderator twenty [\$20.00] dollars, the clerk one hundred twenty-five [\$125.00] dollars, the assistant clerk fifty [\$50.00] dollars, and the treasurer seventy-five [\$75.00] dollars.

8. We recommend the following men be elected to the General Board; James Robinson, Bethlehem; William Roberts, Carbon Hill; Trenton Johnston, Calvary; Ronald Watson, Edgar's Chapel; Edward Holland, Good Springs; J. H. Sullins, Lone Star; Letus Atkinson, Mt. Olive; Aaron Wright, New Liberty; Thomas Booth, Parrish; Clyde Freeman, Shady Grove; Jim Burgess, Union Chapel; Jerry Stevens, Winfield; Wymon Holcomb, Gum Springs; O'Neal Childers, Holly Springs; and Dickie Dees, Cooper.

9. We recommend that the money for retired ministers be divided equally between those who are retired at this time.

10. We recommend that each church send an offering to each annual meeting for retired ministers and that each church support this cause regularly. We also recommend that each church support regularly the causes of foreign missions, home missions, home for the children and Free Will Baptist Bible College.

11. We recommend that each church urge its General Board member to attend the meeting of the General Board.

12. We recommend that the church send as many men delegates to the associational meetings as possible.

CONSTITUTION OF THE JASPER ASSOCIATION OF FREE WILL BAPTISTS

ARTICLE I NAME

This body shall be known as the Jasper Association of Free Will Baptists of Alabama.

ARTICLE II MEMBERSHIP

SECTION I. The membership of the Jasper Association shall consist of all churches that, upon the approval of this body, shall become members.

SECTION II. A local church that wishes to become a member of this Association must adopt the National Treaties and make formal written request. A two-thirds vote of the delegates present must be recorded.

ARTICLE III REPRESENTATION

Each church holding membership in this Association shall be entitled to three [3] delegates. Ministers and deacons who are in good standing with this Association and members of the General Board shall be standing delegates.

ARTICLE IV OFFICERS

The officers of the Jasper Association shall be a moderator, an assistant moderator, a clerk, an assistant clerk, and a treasurer each of whom shall be elected at the close of each regular session.

ARTICLE V BOARDS

SECTION I. General Board [a] Composition. The General Board shall be composed of the moderator, assistant moderator, clerk, assistant clerk, and treasurer, and one member from each local church that is a part of this body. Each member from a local church shall serve a two year term with one-half of the members being elected each year. [b] Executive committee. An Executive Committee shall consist of the moderator, assistant moderator, clerk, and treasurer and five [5] members from the General Board. These five members shall be elected annually by the General Board. This committee shall function as the General Board when said Board is not in session. [c] Duties. The General Board shall formulate all items of general business during the annual session of the Association, as well as other responsibility so delegated by the body. When this Association is not in session, this Board shall have power to act as the body.

SECTION II. Board of Christian Education. The Board of Christian Education shall consist of five [5] members. Each member shall serve for a five [5] year term one term expiring each year.

SECTION III. Directors of North West Alabama Free Will Baptist Youth Camp shall be composed of three [3] members who shall serve for a term of three [3] years each with one term expiring each year.

ARTICLE VI STANDING COMMITTEES

SECTION I. Credentials Committee. The Credentials Committee shall consist of three [3] persons with the senior member in point of service replaced each year. Recommendations for replacement shall come from the General Board. It shall be the responsibility of this committee to examine all letters coming to this body from churches, ministers, and other associations. This committee shall also examine all ministers who become a part of this body either by ordination or by letter.

It is expected that all ministers coming from other associations will present letters of recommendation; however, in some cases the committee may see fit to recommend the acceptance of such persons who have not yet received such letters. Any item of business pertaining to ministers or conduct of ministers should be presented first to this committee. Business matters handled by this committee may be referred to the Association or to the General Board.

SECTION II. The moderator of this Association shall be an ex-officio member of all boards and committees.

ARTICLE VII MEETINGS

SECTION I. This Association shall meet annually on Friday before the first Sunday in October at a place determined at the previous session; and shall not adjourn finally until all business is transacted.

SECTION II. The associational year shall end August 31st and all letters to the Association should be mailed to the clerk no later than the third [3rd] Sunday in September of each year.

SECTION III. There shall be three [3] quarterly meetings during each associational year. The annual meeting of the Association shall take the place of the fourth [4th] quarterly meeting.

SECTION IV. The officers of the Jasper Association shall serve as the officers of the Quarterly Meeting.

ARTICLE VIII ORDINATION

SECTION I. Any man who becomes convinced that the Lord has called him to preach the Gospel shall be licensed by the church of which he is a member. [The church should contact the Credentials Committee for a copy of "Guidelines for Licensed Ministers"] After he has been licensed for a period of one [1] year and has proved his worth, the local church shall then make formal request to this Association that he be ordained. The local church, of which he is a member, must be able to show proof of his worthiness as to his character, doctrine, ability, sincerity, and desire. If after he has been examined by the responsible ones of this body, he then be found worthy, he shall be ordained by this Association. All ordinations to the ministry must be approved at the annual session or a quarterly meeting.

SECTION II. Each church shall have the right to select and ordain all deacons who serve in such church. The ordaining council shall consist of two ordained ministers and at least one deacon or one ordained minister and at least two deacons.

SECTION III. Candidates for ordination to the ministry shall present their request for ordination to the Credentials Committee at least by the time of the last regular meeting before the ordination using forms prepared and approved by this body.

SECTION IV. Preachers coming to us from other Free Will Baptist Associations shall present their requests for membership to the Credentials Committee at the time of the quarterly meeting of the annual session, and said requests may be acted on at that session.

B. Preachers coming to us from other denominations shall present their requests to the Credential Committee at the time of a quarterly meeting or the annual session. Such requests shall be acted upon at the time of the following quarterly meeting or annual session.

Revised October 6, 1979.

SECTION V. All ministers are required to report yearly to the Credentials Committee of this body. Such report shall be for year beginning September 1st and ending August 31st, and shall be due September 1st of current year. Any minister who fails to comply shall be dropped from the roll of ministers.

ARTICLE IX DISCIPLINE

SECTION I. This body shall be considered an advisory council having no authority over the internal affairs of any local church unless said church depart from the Articles of Faith or from the National Treatise. Whenever, conditions warrant it, this Association shall have power to withdraw fellowship from any local church.

SECTION II. Any church being dealt with because of a disciplinary problem shall represent to the quarterly meeting and annual session by letter and fees, but shall not have the right to vote by delegates, standing or otherwise, until the matter is settled. Exception: Any minister who is a member of such church but is ministering to another church that is in good standing with the Association shall not be so penalized.

SECTION III. All questions of doctrine and all matters pertaining to a local church, or to an individual minister or group of ministers, shall be decided by a two-thirds vote of this Association.

SECTION IV. No minister whose conduct is being questioned by this Association shall have the right to vote in either the quarterly meeting or annual session.

SECTION V. The pastor, who preaches the word of God, ministers to the needs of the members, and exercises general leadership within the congregation is expected to unite with the local church if he is not a member when called... "When the minister become pastor of a given local church, it is his responsibility to obtain good standing in the association of which that church is a member if he is not already in good standing therein." [A Treatise of the Faith and Practices of the Original Free Will Baptists, 1973 pp. 50 A; Page 59B.]

SECTION VI. Each church of this Association shall be urged to promote and support all district, state and national projects of the

denomination.

SECTION VII. No church shall accept as members those who have not been baptized by an ordained minister.

ARTICLE X AMENDMENTS

SECTION I. This Constitution may be amended at any annual session of this association by a two-thirds vote of delegates present, provided proposed amendment is presented in writing, read one day, placed on the table, and adopted the next.

RULES OF DECORUM

1. This Association shall be called to order by the moderator and presided over by officers elected at the last session.
2. The association shall be opened and closed by singing and prayer.
3. The names of delegates shall be noted and referred to as often as is necessary.
4. The moderator shall not be entitled to a vote except in case of a tie and then he shall give the deciding vote. He shall be entitled to speak on any subject after others have spoken, provided someone else serves as moderator while he speaks.
5. Only one person shall speak at a time and he shall arise and address the moderator, and after recognition by the moderator, he shall proceed.
6. No person shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.
7. No person will be allowed to speak more than twice on the same subject without permission from the moderator nor more than five [5] minutes at a time.
8. No person shall laugh or talk in a disturbing manner while discussion is going on.
9. No delegate shall absent himself from the association without leave of the moderator.
10. Any minister absent from the annual session of this association for two years in succession without legal excuse shall be dropped from the roll of ministers.
11. These Rules of Decorum may be amended at any annual session of this association by a two-thirds vote of delegates present, provided proposed amendment is presented in writing, read one day, placed on the table, and adopted the next.

GUIDELINES FOR LICENSED MINISTER IN THE JASPER ASSOCIATION

I. RULES PERTAINING TO THE LICENSED MINISTER

A. Qualifications for the Licensee

1. He must be a member of a church which belongs to the Jasper Association.
2. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. His present and prospective educational qualifications should also be considered. Upon completion of such an examination, the local church shall determine whether or not to grant license. The ministerial license shall be valid for a period of one year but is renewable annually.
3. He must have his license renewed annually by said church and kept in force until ordination.

B. The Activities of the Licensee

1. According to the general practices of Free Will Baptists, a licensed minister is urged to afford himself of every opportunity to preach the word. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of pastoring a church and officiating at the observances of the ordinances and wedding.
2. The licensee should consider the period between his receiving license and being ordained as a time of study and training in preparation for his calling.

C. His Relationship to the Association

1. The clerk of the church should report the names of licensed ministers to the clerk of the Association who will forward a copy of these guidelines to each licensee.
2. Licensed ministers are urged and expected to attend the regular meetings of the Jasper Association and the Quarterly Meetings.

II. SUGGESTIONS FOR PREPARATION FOR ORDINATION

- A. Attend Free Will Baptist Bible College if possible
- B. Attend ALABAMA BIBLE INSTITUTE
- C. Seek the counsel of an experienced pastor of pastors.
- D. Make as thorough a study as possible of the following:
 1. The Holy Bible
 2. Systematic Theology

3. Homiletics
4. Pastoral Theology and Church Administration
5. Evangelism
6. Church History [especially F. W. B. history]

III. A SUGGESTED SCHEDULE OF WORK LEADING TO ORDINATION

A. As soon as licensee feels that he is qualified to become a candidate for ordination, he should request a list of study questions from the Credentials Committee of the Association. We would strongly encourage him to proceed with his examination before entertaining a definite call to a church.

B. At least two months before the Credentials Committee meets, he should secure the examination. He should make three copies of the completed examination [one for each member of the Committee], and send them to the Credentials Committee no later than two years before its meeting.

C. The candidate is required to pass an oral examination administered by the Committee.

D. The Committee will report to the candidate on whether he passed or what areas he may need additional study in.

E. When the approved candidate has passed the examination, the Committee will recommend his ordination to the Association. This recommendation will be made only after the candidate has been licensed for one full year. It is recommended that the candidate have definite prospects of a church pastorate or another form of Christian service that would justify his being ordained.
