PROCEEDINGS

The Ninety-Eighth Session of the Jasper Association of Free Will Baptists convened with the Carbon Hill Free Will Baptist Church, Friday, October 5, 1984 at 9:00 a.m., Rev. Bud Hill, Assistant Moderator, presiding over the session. The session was opened with the congregation singing, "Victory In Jesus," led by Bro. Duane Hughes. Bro. Hughes then led the opening prayer. The Assistant Moderator then recognized Rev. Carrol Jones, pastor of the host

church, who welcomed us to the church. Rev. Bill Smith gave the response. Rev. Bud Hill then brought the Moderator's Message in the place of the Morning Devotion. Bro. Hill spoke from Matthew 5, on "A Light in a Dark Place."

The Assistant Moderator appointed the following committees: Appreciation - Betty Bevans, Emma Osborne, Joyce Bozeman. Finance - Paul Jaggers, David Hayes, Morris Tidwell. Obiturary - Rosa Johnson, Verla Wright, Willie Reed. Following the reading of the roll of delegates by the Clerk, the Assistant Moderator gave the charge regarding the responsibilities of delegates. Motion was made, seconded and carried to seat the delegates.

The General Board Report was read by the Clerk and a motion was made,

seconded and passed to adopt the report item by item.

Items No. 1, 2, 3 - Those to fill vacancies on the General Board were elected at this time.

Item No. 18 - Motion made, seconded and carried to table action until Saturday Session.

Item No. 19 - Location for the Second Quarterly Meeting to be held March 23, 1985 at the New Liberty FWB Church.

Item No. 20 - Location for the Third Quarterly Meeting to be held June 22, 1984 at the Free Water FWB Church.

Item No. 21 - Location for the first day of the Annual Session to be held Friday October 4, 1985 at the Cedrom Grove FWB Church.

Item No. 22 - Tabled until Saturday Session.

The Assistant Moderator recognized Rev. Woodrow Matthews who brought a financial report of the Board of Christian Education. The report was adopted as read. Bro. Matthews then respectfully resigned from the Board. Motion, seconded and carried to respectfully and regretfully accept his resignation. The Assistant Moderator then recognized the Clerk who gave the 1984 Quarterly Meeting Report. Motion was made, seconded and carried to adopt the report. The Assistant Moderator declared a recess of the Association.

MORNING SERVICE

Congregational singing opened the Morning Worship Service led by Bro. Duane Hughes. Sister Nellie Jackson provided the special music by singing, "The Master of the Sea." Rev. Vern Gunnels then brought the Morning Message from I Kings 17:17 on "The Widow's Son." Rev. Carrol Jones was then called on to pray the prayer of blessing on the food and the dismissal.

AFTERNOON SESSION

Bro. Duane Hughes led the congregation in "I'd Rather Be An Old Time Christian." Rev. David Crowe then led in prayer. The Business Session was opened and an offering was taken with Rev. Woodrow Matthews leading in prayer. The Assistant Moderator then recognized the Chairperson of the Obituary Committee who gave the report. The report was received as read

was followed by a moment of silent prayer for the departed and public grantude expressed for the wonderful lives of those who were carried to be with the Lord. The Chairperson of the Appreciation Committee was then recognized who gave a partial report which was accepted by a rising vote of gratitude by the multitude. The Chairman of the Credentials Committee was then recognized who gave report, and it was accepted item by item:

The Report of the Committee on Constitutional and By-Laws Changes had their recommendations read by Rev. David Hayes. Motion was made, seconded and carried to table until Saturday Session. The Assistant Moderator was given the privilege of appointing delegates at the State Association.

Bro. Hughes then led in "Land Where Living Waters Flow". The Afternoon Message was brought by Rev. David Crowe from Matthew 2:11 as he spoke on the title, "Look For Me At Jesus Feet." The session was then dismissed in prayer led by Rev. William Pate.

SATURDAY MORNING SESSION

The Saturday Session of the Annual Meeting of the Jasper Association was held at the Northwest Alabama Youth Camp. Bro. Duane Hughes opened the session by leading the congregation in "At Calvary". Rev. Bud Hill led in prayer and then welcomed everyone to the session. Rev. Wise Holcomb was then recognized who brought the Morning Devotion from Acts 17:23 on "Go In The Name of Jesus." He encouraged us all to be a missionary at home. The Business Session was opened by the Assistant Moderator seating the delegates. A season of prayer followed. Rev. Woodrow Matthews was then recognized who gave the report on the Northwest Alabama Youth Camp. The report was accepted as read. Bro. Matthews then challenged each Association to raise \$4,000 each to pay off the debt by June 1, 1985. Rev. David Crowe was then recognized who gave a verbal report on the Teen Week of Camp, and also read the report of Rev. Mike Cordell on the Ir. Week of Camp. Rev. Vern Gunnels was then elected to fill the unexpired term of Rev. Woodrow Matthews on the Board of Christian Education, to expire in 1988. The Hamilton FWB Church then invited the January 26, 1985 Quarterly Meeting and Pocahontas FWB Church invited the second day of the Annual Meeting, October 5, 1985. Motion was made, seconded, and carried to accept their invitations. Motion was made, seconded and carried to take off the table the Constitution and By-Laws Changes. These changes were then voted on item by item. For these changes see the Amended Constitution and By-Laws in the back of the 1984 Minu. The Assistant Moderator then assigned representatives to other Associations: State Line - Rev. David Crowe; Vernon - Rev. Jimmy Martin; Mt. Moriah -Rev. Harvey Luke. The Assistant Moderator then declared a short recess.

SATURDAY MORNING WORSHIP SERVICE

The Morning Worship Service was opened by Bro. Duane Hughes leading the assembly in "I Love To Tell The Story." The Assistant Moderator then introduced Rev. Arlo Peppers who delivered the Morning Message from Psalm 61:2 entitled, "The Rock That Is Higher Than I." Rev. David Hayes then prayed the blessing on the food.

SATURDAY AFTERNOON SESSION

The hymn, "Love Lifted Me", was led by Bro. Duane Hughes to open the Afternoon Session. The Assistant Moderator opened the Business Session again to consider any further Associational Business. The Financial Committee gave its report which was accepted as read. The Treasurer's Report was then read by Bro. Don Collins. It was accepted as read. The Appreciation Committee then gave its final report which was accepted by a rising vote of gratitude by the congregation. The Assistant Moderator then recognized Rev. Richard Cordell who gave a report on the upcoming Missionary Conference in January 1985. He also provided information regarding the date and place of the Pastor's and Worker's Conference. Bro. Cordell requested that the Association send \$200.00 for the Pastor's and Worker's Conference. Bro. Cordell also provided for all, booklets with information about Southeastern FWB College. Finally he challenged each Association to take the recommendation of the State Association to raise \$15 per church for 3 years to send to the State Association to help finance the 1988 National Association Meeting to be held in Birmingham, AL. The Assistant Moderator then suggested that we finish paying for the food for lunch out of the offering and the remainder of the offering to be placed in the Board of Christian Education. One of the Constitutional Changes was the forming of a Missions Board. The following were elected to serve:

Motion was then made, seconded and carried to adjourn. Rev. Roger Houston led in prayer of adjournment.

GENERAL BOARD REPORT

The General Board of the Jasper Association of Free Will Baptists met September 6, 1984 at the Winfield FWB Church with Assistant Moderator Rev. Bud Hill presiding. The meeting was opened by a devotion by Bro. Duane Hughes who spoke to us from Judges 7:15-21. Bro. Hughes then led us in prayer.

The Moderator recognized the representatives from each church. Thirteen churches were represented with seven others who were officers of the Association.

The following recommendations were discussed and passed:

- 1. We recommend that the terms of the General Board members from the following churches be filled with nominations by each church and any positions not filled to be filled with recommendations from the floor. Their terms to expire in 1986: Bethlehem, Good Springs, Lone Star, Parrish, Shady Grove, Union Chapel, Gum Springs.
- 2. We recommend the following be elected to the General Board, to fill unexpired terms ending 1985: Brilliant Charles Dozier, Cedrom Grove -Donald Kivette.
- 3. We recommend the following be elected to the General Board, whose term is to expire in 1986: Carbon Hill Walter Harbin, Calvary Herbert Boshell, Mt. Olive Letus Atkinson, New Liberty Aaron Wright, Winfield Duane Hughes, Holly Springs David Baldwin.
- 4. We recommend that each church urge its General Board Member to attend the meeting of the General Board designated for the 1st Thursday in September 1985 and that the meeting place be decided at the Annual Session following nominations for General Board Members.
- 5. We recommend that Rev. Donald Kivette be elected to the Children's Home Board of Trustees.
- 6. We recommend that Rev. David Crowe be elected to the Board of Christian Education. His term to expire in 1989.
- 7. We recommend that Bro. Duane Hughes be elected to the Board of Christian Education. His term to expire in 1986 filling unexpired term of Rev. Terry Booker.
- 8. We recommend that Rev. Bill Smith be elected to the Youth Camp Board. His term to expire in 1987.
- 9. We recommend that Rev. Donald Kivette be elected to the Youth Camp Board. His term to expire in 1985 filling the unexpired term of Rev. Fred Jones.
- 10. We recommend that Rev. William Pate be elected to the Credentials Committee. His term to expire in 1989.
- 11. We recommend that Rev. Phillip Cook be elected to the Credentials Committee. His term to expire in 1987 filling the unexpired term of Rev. Dale Pitts.
- 12. We recommend that Rev. David Crowe be elected as State General Board Member. His term expiring in 1986.

- 13. We recommend that the Moderator be paid sixty-five (65) dollars, the Assistant Moderator twenty (20) dollars, the Clerk one hundred (100) dollars the Assistant Clerk eighty-five (85) dollars, and the Treasurer one hundred (100) dollars.
- 14. We recommend that each church send an offering to each Annual meeting for retired ministers and that each church support this cause regularly.
- 15. We recommend that the money for retired ministers be divided equally between those who are retired at this time.
- 16. We recommend that each church support regularly the causes of Foreign Missions, Home Missions, Children's Home, Free Will Baptist Bible College, Southeastern Free Will Baptist College, California Christian College, and Hillsdale Free Will Baptist College.
- 17. We recommend that each church give to the Youth Camp on a systematic basis (i.e.) monthly or quarterly.
- 18. We recommend that the First Quarterly Meeting be held January 26, 1985, and the location be determined at the Annual Meeting.
- 19. We recommend that the Second Quarterly Meeting be held March 23, 1985 at the Mt. Pleasant FWB Church.
- 20. We recommend that the Third Quarterly Meeting be held June 22, 1985 and the location to be determined at the Annual Meeting.
- 21. We recommend that the first day of the Annual Meeting be held Friday, October 4, 1985 and the location to be determined at the Annual meeting (1984).
- 22. We recommend that the second day of the Annual Meeting be held Saturday, October 5, 1985 and the location to be determined at the Annual Meeting (1984).

To this end we agree to labor for the promotion of educational and denominational enterprises, and the support of missions, the success of Sunday Schools, and evangelistic efforts for the salvation of the world. And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

- 6. The sinfulness of Man. Man was Created innocent, but by disobedience fell into a state of sin and condemnation. His prosperity, therefore, inherits a fallen nature of such tendencies that all who come to years of accountability, sin and become guilty before God.

- 7. The Work of Christ. The Son of God by His incarnation life, sufferings, death and resurrection effected for all a redemption from sin that is full and free, and is the ground of salvation by faith.

8. The Terms of Salvation. The conditions of salvation are: (1) Repentance of sincere sorrow for sin and hearty renunciation of it. (2) Faith or the unreserved committal of one's self to Christ as Saviour and Lord with purpose to love and obey Him in all things. In the exercise of saving faith, the soul is renewed by the Holy Spirit, freed from the dominion of sin, and becomes a child of God. (3) Continuance in faith and obedience until death.

9. Election. God determined from the beginning to save all who should comply with the conditions of Salvation. Hence by faith in Christ men become His elect.

10. Freedom of Will. The human will is free and self-controlled, having power to yield to the influence of the truth and the Spirit, or to resist them and perish.

11. Salvation Free. God desires the salvation of all, the Gospel invites all, the Holy Spirit strives with all, and whosoever will may come and take of the water of life freely.

12. Perseverance. All believers in Christ, who through grace persevere in holiness to the end of life, have promise of eternal salvation.

13. Gospel Ordinances. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet Washing, an ordinance teaching humility, is of universal obligation, and is to be ministered to all true believers.

- 14. Tithing. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel [Matthew 23:23], and the apostle Paul said, "Upon the first day of the week let everyone of you lay by him in store, as God hath prospered him" [I Cor. 16:2a.]
- 15. The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

CONSTITUTION OF THE JASPER ASSOCIATION OF FREE WILL BAPTISTS

ARTICLE I NAME

This body shall be known as the Jasper Association of Free Will Baptists of Alabama.

ARTICLE II MEMBERSHIP

SECTION I. The membership of the Jasper Association shall consist of all churches that, upon the approval of this body, shall become members.

SECTION II. A local church that wishes to become a member of this Association must adopt the National Treaties and make formal written request. A two-thirds vote of the delegates present must be recorded for acceptance into this Association.

ARTICLE III REPRESENTATION

Each church holding membership in this Association shall be entitled to three (3) delegates. Ordained ministers and deacons who are in good standing with this Association and members of the General Board shall be standing delegates.

ARTICLE IV OFFICERS

The officers of the Jasper Association shall be a moderator, an assistant moderator, a clerk, an assistant clerk, and a treasurer each of whom shall be elected at the close of the annual session.

ARTICLE V BOARDS

SECTION I. General Board (a) Composition. The General Board shall be composed of the moderator, assistant moderator, clerk, assistant clerk, treasurer, and one member from each local church that is a part of this body. Each member from a local church shall serve a two year term with one-half of the members being elected each year. (b) Executive committee. An Executive Committee shall consist of the moderator, assistant moderator, clerk, treasurer and five (5) members from the General Board. These five members shall be elected annually by the General Board. This committee shall function as the General Board when said Board is not in session. (c) Duties. The General Board shall formulate all items of general business during the annual session of the Association, as well as other responsibilities so delegated by the body. When this Association is not in session, this Board shall have power to act as the body.

SECTION II. Board of Christian Education. The Board of Christian Education shall consist of five (5) members. Each member shall serve for a five (5) year term with one term expiring each year.

SECTION III. Board of Directors of the North West Alabama Free Will Baptist Youth Camp. This Association shall be represented to the Board of Directors of the North West Alabama Free Will Baptist Youth Camp by three (3) members. Each member shall serve a term of three (3) years with one term expiring each year.

SECTION IV. Mission Board. The Mission Board shall consist of five (5) members. Each member shall serve for a five (5) year term with one term expiring each year. The Mission Board's responsibilities will be to help set up mission conferences and to promote Foreign and Home Missions in the Jasper Association.

ARTICLE VI STANDING COMMITTEES

SECTION I. Credentials Committee. The Credentials Committee shall consist of five (5) persons with the senior member in point of service replaced each year. Recommendations for replacement shall come from the General Board. It shall be the responsibility of this committee to examine all letters coming to this body from churches and other associations, as well as, all ministerial reports. This committee shall also examine all ministers who become a part of this body whether by ordination or by letter. It is expected that all ministers coming from other associations will present letters of recommendation; however, in some cases the committee may see fit to recommend the acceptance of such persons who have not yet received such letters. Any item of

business pertaining to ministers or conduct of ministers should be presented first to this committee. Business matters handled by this committee may referred to the Association or to the General Board.

SECTION II. The moderator of this Association shall be an ex-officio member of all boards and committees.

ARTICLE VII MEETINGS

SECTION I. This Association shall meet annually on Friday and Saturday before the first Sunday in October at places determined at the previous session; and shall not adjourn finally until all business is transacted.

SECTION II. The associational year shall end on August 31st and all letters to the Association should be mailed to the clerk no later than the third (3rd) Sunday in September of each year.

SECTION III. There shall be three (3) quarterly meetings during each associational year. The annual meeting of the Association shall take the place of the fourth (4th) quarterly meeting.

SECTION IV. The officers of the Jasper Association shall serve as the officers of the Quarterly Meeting.

ARTICLE VIII ORDINATION OF MINISTERS AND DEACONS

SECTION I. Any man who becomes convinced that the Lord has called him to preach the gospel shall be licensed by the church of which he is a member. (The church should contact the Credentials Committee for a copy of "Guidelines for Licensed Ministers"). If, after a period of one (1) full year, he has been called to an approved work such as pastor, assistant pastor, youth minister, full-time evangelism, or misisonary work, he may then be examined by the responsible ones of this body to determine his worthiness for ordination. The local church, of which he is a member, must be able to show proof of his worthiness as to his character, doctrine, ability, sincerity, and desire. If, after having been examined, he then be found worthy, he shall be ordained by this Association. All ordinations to the ministry must be approved at the annual session or at a quarterly meeting of the Jasper Association.

If, after the period of one (1) full year has expired, the licensee has not been called to an approved work, his license may then be renewed each year or until he has been called to an approved work. No one may be ordained who has not been called to an approved work.

SECTION II. Candidates for ordination to the ministry shall present their request for ordination to the Credentials Committee, (using forms prepared and approved by this body), at least by the time of the last regular meeting prior to the ordination date requested.

SECTION III. Preachers coming to us from other Free Will Baptist Associations shall present their requests for membership to the Credentials Committee at any quarterly meeting or annual session and said requests may be acted upon at that session.

SECTION IV. Preachers coming to us from other denominations shall present their requests to the Credentials Committee at any quarterly meeting or annual session. Such requests shall be acted upon at the time of the following regular meeting be it quarterly meeting or annual session.

SECTION V. All ministers are required to report yearly to the Credentials Committee of this body by presenting their cards to the Associational Clerk. Such report shall be for year beginning September 1st and ending August 31st, and shall be due at the annual session in October. Any minister who fails to comply shall not be issued a card of good standing.

SECTION VI. Each church shall have the right to select and ordain all deacons who serve in such church. The ordaining council shall consist of two ordained ministers and at least one deacon, or one ordained minister and at least two deacons.

ARTICLE IX DISCIPLINE

SECTION I. This body shall be considered an advisory council having no authority over the internal affairs of any local church unless said church depart from the Articles of Faith or from the National Treatise. Whenever conditions warrant it, this Association shall have power to withdraw fellowship from any local church.

SECTION II. Any church being dealt with because of a disciplinary problem shall represent to the quarterly meeting and annual session by letter and fees, but shall not have the right to vote by delegates, standing or otherwise, until the matter is settled. Exception: Any minister who is a member of such church but is ministering to another church that is in good standing with the Association shall not be so penalized.

SECTION III. All questions of doctrine and all matters pertaining to a local church, or to an individual minister or group of ministers, shall be decided by a two-thirds vote of this Association.

SECTION IV. No minister whose conduct is being questioned by this Association shall have the right to vote in either the quarterly meeting or annual session.

SECTION V. The pastor who preaches the word of God, ministers to the needs of the members, and exercises general leadership within the congregation is expected to unite with the local church if he is not a member when called . . . "When the minister becomes pastor to a given local church, it is his responsibility to obtain good standing in the association of which that church is a member if he is not already in good standing therein." (A Treatise of the Faith and Practices of the Original Free Will Baptists, 1973, 50 A; Page 59B.)

SECTION VI. No church shall accept as members those who have not been baptized by an ordained minister.

ARTICLE X AMENDMENTS



This Constitution may be amended at any annual session of this association by a two-thirds vote of delegates present, provided proposed amendment is presented in writing, read one day, placed on the table, and acted upon the following day.

RULES OF DECORUM

- 1. This Association shall be called to order by the moderator and presided over by officers elected at the previous annual session.
- 2. The association shall be opened and closed by singing and prayer.
- 3. The names of delegates shall be noted and referred to as often as is necessary.
- 4. The moderator shall not be entitled to a vote except in case of a tie and then he shall give the deciding vote. He shall be entitled to speak on any subject after others have spoken, provided someone else serves as moderator while he speaks.
- 5. Only one person shall speak at a time and he shall arise and address the moderator, and after recognition by the moderator, he shall proceed.
- 6. No person shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.
- 7. No person will be allowed to speak more than twice on the same subject without permission from the moderator nor more than five (5) minutes at a time.
- 8. No person shall laugh or talk in a disturbing manner while discussion is going on.
- 9. No delegate shall absent himself from the association without leave of the moderator.
- 10. Any minister absent from the annual session of this association for two years in succession shall be dropped from the roll of ministers. Exception: Full-time evangelists or Missionaries serving in other states or countries, students who are attending college, those serving in the armed forces.
- 11. These Rules of Decorum may be amended at any annual session of this association by a two-thirds vote of delegates present, provided proposed amendment is presented in writing, read one day, placed on the table, and acted upon the following day.

GUIDELINES FOR LICENSED MINISTERS IN THE JASPER ASSOCIATION

I. RULES PERTAINING TO THE LICENSED MINISTER

- A. Qualifications for the Licensee
- 1. He must be a member of a church which belongs to the Jasper Association.
- 2. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. His present and prospective educational qualifications should also be considered. Upon completion of such an examination, the local church shall determine whether or not to grant license. The ministerial license shall be valid for a period of one year but is renewable annually.
- 3. He must have his license renewed annually by said church and kept in force until ordination.
- B. The Activities of the Licensee
- 1. According to the general practices of Free Will Baptists, a licensed minister is urged to afford himself of every opportunity to preach the word. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of officiating at the observances of the ordinances and weddings.
- 2. The licensee should consider the period between his receiving license and being ordained as a time of study and training in preparation for his calling.
- C. His Relationship to the Association
- 1. The clerk of the church should report the names of licensed ministers to the clerk of the Association who will forward a copy of these guidelines to each licensee.
- 2. Licensed ministers are expected to attend regular meetings of the Jasper Association and the Quarterly Meetings.

II. SUGGESTIONS FOR PREPARATION FOR ORDINATION

- A. Attend Free Will Baptist Colleges or Bible Institutes if possible.
- B. Seek the counsel of experienced pastors.
- C. Make as thorough a study as possible of the following:
 - 1. The Holy Bible
 - 2. Free Will Baptist Doctrine
 - 3. Systematic Theology
 - 4. Homiletics
 - 5. Pastoral Theology and Church Administration
 - 6. Evangelism
 - 7. Church History (especially FWB history)

III. A SUGGESTED SCHEDULE OF WORK LEADING TO ORDINATION



A. As soon as licensee feels that he is qualified to become a candidate for ordination, he should request a list of study questions from the Credentials Committee of the Association. We would strongly encourage him to proceed with his examination before entertaining a definite call to a church.

B. At least two months before the Credentials Committee meets, he should secure the examination. He should make five copies of the completed examination (one for each member of the Committee), and send them to the Credentials Committee no later than two months before its meeting.

C. The candidate is required to pass an oral examination administered by the Committee.

D. The Committee will report to the candidate on whether he passed or what areas he may need additional study in.

E. When the approved candidate has passed the examination, the Committee will recommend his ordination to the Association. This recommendation will be made only after the candidate has been licensed for one full year. It is recommended that the candidate have definite prospects of a church pastorate or another form of Christian service that would justify his being ordained.
