Jasper Association of Free Will Baptists District Meeting

MINUTES OF THE JANUARY 24, 1998 MEETING

The January Meeting of the Jasper Association of Free Will Baptists convened on Saturday, January 24, 1998 at the Pocahontas Free Will Baptist Church. Moderator, Rev. Danny Williams, called the meeting to order at 9:00 AM. Bro. Brad Williams led us in singing "Kneel At The Cross" accompanied by Sis. Stephanie Sparks at the piano. We also sang "Rescue The Perishing". Prayer was rendered by Rev. Tom Scott of the Red Bay Free Will Baptist Church. Welcome was given by Rev. Roger Lucas, Pastor of the Host Church. Bro. Brad Williams led us in singing "Old Time Power".

Moderator then called for the seating of Delegates for this meeting. MSC that delegates be seated.

The January Meeting of the Jasper Association is used to hear from missionaries that are in the Annual Missionary Conference. We will list them and highlights of their comments in the order in which they spoke that day.

Rev. Dennis Haygood, Missionary to South Huntsville, Alabama. Gave greetings from the Southpark Free Will Baptist Church. Shared about how the Lord allowed them to get the building that they are using for services. It was the Lord's working things out. He used Deuteronomy 31:12-13 as his text. He spoke of men, women, children, strangers (foreigners), mixed that we are to reach. We must trust, fear, and honor the Lord.

Dave Franks, SR, Missionary to Belo Horizonte, Brazil. Bro. Franks used Matthew 13:37-43 as text. He emphasized that "...the field is the world...." He stated that it is worth every ounce of effort and every cent of money in going to these fields. He thanked Free Will Baptists for forty (40) years of help. God has blessed the efforts. He gave examples of God's working in the lives of Brazilians. Stated how that God is now calling "Nationals" to teach, preach, etc. In closing he stated that they would only be in Brazil two more years before retiring.

Rev. Len Blanchard, Missionary to Carslbad, New Mexico. Bro. Blanchard used Psalm 17:15 as his text. Context was that we are not satisfied until we get to be with Jesus. He has been in Carlsbad two years and 10 months. as Associate Missionary. They are averaging 38. They started with four. They are involved in a Cross Cultural Ministry. Asked us to pray for them as they serve. Contributions are needed for their account because as Associate Ministry you don't get paid unless the money comes in to your account. He used Acts 5:20 - "Go, stand, speak in the temple all the words of this life." "Not only Saviour, but deliverer as well."

Rev. Walter "Dub" Ellison, Missionary to Uruguay, South America. Bro. Ellison went to Uruguay in 1964 and is now retired. He called to our remembrance that when he went to Uruguay in 1964 that Alabama was referred

to as a "sleeping giant" in our denomination. He stated that Alabama will be in the majority as far as workers in Uruguay are concerned. More staff from Alabama than any place else. Stated that he had just finished up his responsibilities there in Uruguay. He gave *thanks* for allowing him to serve and the support given for him to do so. He urged support for the ACTS 1:8 Plan adopted by the State Association. He used Acts 20:32 as his text.

After taking a break for fellowship and refreshments we continued the meeting with Bro. Brad Williams leading us in singing "Are You Washed In The Blood?"

Rev. Tim Johnson, Missionary to Spain. Bro. Johnson talked about his upcoming assignment to Spain. Spain has a reputation as being a hard country to evangelize with the Gospel. Less than 1% are Christians in Spain. He used Colossians 4:2-7 as his text as background for his call to go to Spain as a missionary. Stated that he needs to leave this summer.

Rev. Paul Collins, Missionary to Harrisonburg, Virginia. He used Romans 15:30 as his background. Gave account of his vision for mission work. Had an accomplished work in Darlington, South Carolina. Has received call to go to Harrisonburg, Virginia, a growing area with a vas opportunity for people to be won to our Lord Jesus Christ.

Rev. Carlos Rubio, Missionary to United States Hispanic Community. Bro. Rubio talked of our Missionaries who brought the Gospel to Mexico and won his Pastor to Jesus. He talked about all the missionaries that followed, especially Rev. Fred Jones who taught Mexican people to take over the work in Mexico. He shared about going to Free Will Baptist Bible College in Nashville and that he is now a graduate of that school. He has the call of God to be a Missionary to Spanish speaking people in Free Will Baptist churches here in the United States.

Rev. Kevin Stacy, Missionary/Teacher in Central Asia. Bro. Kevin stated that this is a new field for Free Will Baptists. He shared about his trip to the Uighur people group of Central Asia. Told about a man who wanted to have a Bible study and later came to Christ. That man also led his friend to Christ. Bro. Kevin stated, "I am excited about going for the Lord Jesus."

Rev. Tim Osborn, Missionary to Memphis, Tennessee. Bro. Osborn used as his text 1 Thessalonians 5:24. Bro. Tim is a native of the State of Alabama. His home church is the Russellville Free Will Baptist Church, Russellville, Alabama. He has been pastoring in the state of North Carolina, He is going to the city of Memphis, Tennessee which, of course, is a large metropolitan area. Pray for the Lord's leading as they follow Him.

Bro. Mike Corley. Missionary to Russia. Bro. Corley used Isaiah 55:11 as his text. Bro. Mike is a product of Home Missions. He is a member of the Madison Free Will Baptist Church, Madison, Alabama which was started as an Alabama

Home Mission project in 1987. He also gave thanks for the adoption of the ACTS 1:8 Program. He shared that he is a Free Will Baptist layman. He shared the story of a layman Sunday School teacher who was responsible for leading the late Rev. D. L. Moody to the Lord. He will be working in close relation with the Russian Baptists who, as we are, are Arminian in doctrine.

Rev. Roger Raper, Associate Missionary, Ft. Collins, Colorado. He, as Bro. Blanchard, is an Associate Missionary. They only receive what money comes in to their account each month. It is important that we be faithful in sending to their accounts. He gave *thanks* for our support to their ministry there in Ft. Collins. He used 2 Corinthians 5:19-21 as his text and dealt with the ministry of Reconciliation. He shared about a family in Colorado being reconciled after several years of feuding. We're in the greatest work on earth, the Ministry of Reconciliation. The precious thing of being a missionary is seeing people coming to Christ. *That* makes all the difference.

Rev. Jaimie Lancaster, Newly Appointed Missionary to Uruguay. Bro. Jaimie stated that he is leaving the oldest Free Will Baptist Church, (in Alabama) the Mt. Moriah Church to become the newest Free Will Baptist Missionary in Uruguay. The Mt. Moriah Church is his home church. Stated that in 1985 he knew that he could go to another country and serve. He spent a summer in Japan as Summer Missionary. Told of a missionary placing in his hands the strategy for Uruguay. Decided that they were going regardless of who is serving there with them. Shared about a three (3) hour service when they went to the field. Could feel the presence of the Lord. Gave thanks for the 34 years of service already given by our missionaries. He used Matthew 26:3-13 as his text.

Rev. Danny Williams in capacity as Chairman of the Alabama ACTS 1:8 Committee gave the following report. He used as his text for the comments Romans 10:13-15. ACTS 1:8 is short for Alabama Coming Together for the Saviour. He gave Bro Mike Dankson credit for the title. He stated that it costs 33% of money to raise monies. On top of that it takes 18-24 months to do it and get to the field of service. With this program in effect all of the above will be reduced significantly. The Budget for this year is \$192,000.00 Which is 70% of the Total Budget. It has been accepted well statewide since its adoption at the Alabama State Association of Free Will Baptists in November 1997.

Rev. Rick Cash in capacity as the new Alabama Free Will Baptist Promotional Secretary gave the following report. He used 1 Samuel 22:1-2 as his text. He shared that he will also continue to be the Trinity Free Will Baptist Camp Director as well as the State Promotional Secretary and shared how that the two are correlated. Noting the increase in the work load how that God is placing people to help with that. A secretary, maintenance worker and youth worker have all been secured to help with the ministry. The secretary is a part-time paid position. The others are volunteers.

In the area of Business the Association voted to receive Bro. Ricky Robinson into the Association. He was ordained by the Carbon Hill First Free Will Baptist Church. He was recommended after review by the Credentials Committee of the Jasper Association.

MSC -- That a round of applause be given for our Senior Missionaries present: Rev. Dave Franks, Sr., Missionary to Brazil and Rev. Walter Ellison, Retired Missionary, Uruguay.

After a time of announcements and prayer requests we had prayer for our missionaries and Rev. Trellis Mayhall who would be having surgery on Monday.

MSC -- To adjourn, with Bro. Bryan Silas praying the closing prayer.



And may the God of peace sanctify us wholly, and preserve us blameless unto the coming of our Lord Jesus Christ.

ARTICLES OF FAITH

13. Gospel Ordinances. Baptism, or the immersion of believers in water, and the Lord's Supper, are ordinances to be perpetuated under the Gospel. Feet Washing, an ordinance teaching humility, is of universal obligation, and is to be ministered to all true believers.

Matthew 28:19; I Cor. 11:23-26; St. John 13:4-17

14. Tithing. God commanded tithes and offerings in the Old Testament; Jesus Christ endorsed it in the Gospel (Matthew 23:23), and the apostle Paul said, "Upon the first day of the week let everyone of you lay by him in store, as God hath prospered him"

(I Cor. 16:2a.)

15. The Christian Sabbath. The divine law requires that one day in seven be set apart from secular employments and amusements, for rest, worship, holy works, and activities, and for personal communion with God.

Genesis 2:3; Luke 24:1-6; Acts 20:7

16. Resurrection, Judgement and Final Retribution. The Scriptures teach the resurrection of all men at the last day. They that have done good will come forth to the resurrection of life, and they that have done evil unto the resurrection of damnation; then the wicked will "go away into eternal punishment, but the righteous into eternal life."

John 5:28-29; Acts 17:31; II Cor. 5:10

CONSTITUTION OF THE JASPER ASSOCIATION OF FREE WILL BAPTIST

ARTICLE I NAME

This body shall be known as the Jasper Association of Free Will Baptist of Alabama.

ARTICLE II MEMBERSHIP

SECTION I. The membership of the Jasper Association shall consist of all churches that, upon the approval of his body, shall become members.

SECTION II. A local church that wishes to become a member of this Association must adopt the National Treaties and make formal written request. A two-thirds vote of the delegates present must be recorded for acceptance into this Association.

ARTICLE III REPRESENTATION

Each church holding membership in this Association shall be entitled to three (3) delegates. Ordained ministers, deacons and General Board members who are in good standing with this Association, shall be standing delegates.

ARTICLE IV OFFICERS

The Officers of the Jasper Association shall be a moderator, an assistant moderator, a Clerk/Treasurer, and assistant Clerk/Treasurer, each of whom shall be elected every two (2) years with the election coming on even years. No officer shall serve more than two (2) consecutive terms.

ARTICLE V BOARDS

SECTION I. General Board (a) Composition. The General Board shall be composed of the moderator, assistant moderator, clerk/treasurer, assistant clerk/treasurer, the pastor and one member from each local church that is a part of this body. Each member from a local church shall serve a two year term with one-half of the members being elected each year. (b) Executive committee. An Executive Committee shall consist of the moderator, assistant moderator, clerk/treasurer and five (5) members from the General Board. These five members shall be elected annually by the General Board. This committee shall function as the General Board when said Board is not in session. (c) Duties. The General Board shall formulate all items of general business during the annual session of the Association, as well as other responsibilities so delegated by the body. When this Association is not in session, this Board shall have power to act as the body.

SECTION II. Board of Directors of the Trinity Free Will Baptist Camp. The Jasper Association shall be represented to the Board of Directors of the Trinity Free Will Baptist Youth Camp by three (3) members. Each member shall serve a term of three (3) years with one term expiring each year.

SECTION III. Mission Board. The Mission Board shall consist of five (5) members. Each member shall serve for a five (5) year term with one term expiring each year. The Mission Board's responsibilities will be to help set up mission conferences and to promote Foreign and Home Missions in the Jasper Association.

SECTION IV. State Board Member. The Jasper Association Moderator shall represent this Association to the General Board of the Alabama State Association. In his absence, the Assistant Moderator will serve as his proxy.

SECTION V. Childrens Home Trustee. This person shall represent the

Jasper Association on the Childrens Home Board of Trustees. This member to be elected each year and give report during each Annual Session of this Association.

ARTICLE VI STANDING COMMITTEES

SECTION I. Credentials Committee. The Credentials Committee shall consist of five (5) persons with the senior member in point of service replaced each year. Recommendations for replacement shall come from the General Board. It shall be the responsibility of this committee to examine all letters coming to this body from the churches and other associations, as well as, all ministerial reports. This committee shall also examine all ministers who become a part of this body whether ordination or by letter. It is expected that all ministers coming from other associations will present letters of recommendation; however, in some cases the committee may see fit to recommend the acceptance of such persons who have not yet received such letters. Any item of business pertaining to ministers or conduct of ministers should be presented first to this committee. Business matters handled by this committee may be referred to the Association or to the General Board.

SECTION II. Nominating Committee. Shall consists of Five (5) members, elected for period of Five years, with the senior member in point of service expiring each year. It shall be responsibility of this Committee to make nominations for Associational Officers and submit such nominations to the General Board.

SECTION III. Finance Committee. The Finance Committee shall consist of three (3) members elected for a period of three years, with the senior member in point of service expiring each year. It shall be the responsibility of this committee to examine the financial report and bank statements of the Association, verify their accuracy, and report to the Association at the Annual Session.

SECTION IV. The moderator of this Association shall be an ex-officio member of all boards and committees.

ARTICLE VII MEETINGS

SECTION I. This Association shall meet annually on Friday and Saturday before the first Sunday in October at places determined at the previous session; and shall not adjourn finally until all business is transacted. All business possible to be conducted on first day of each annual meeting and second day of each annual meeting be used for Worship, Preaching and any business as required to be conducted. Nominating Committee to meet annually on first Tuesday night of August at seven p.m. at Hamilton FWB Church and General Board to meet annually on second Monday Night of August at seven p.m. at Winfield FWB Church.

SECTION II. The associational year shall end on August 31st and all letters to the Association should be mailed to the clerk no later than the third (3rd) Sunday in September of each year.

SECTION III. There shall be two (2) other District Meetings during the Associational year. The meetings will be held in January and June.

SECTION IV. The officers of the Jasper Association shall serve as the officers of the District Meeting.

ARTICLE VIII MINISTERS AND DEACONS

SECTION I. Any man who becomes convinced that the Lord has called him to preach the gospel shall be licensed by the church of which he is a member. (The church should contact the Credentials Committee for a copy of "Guidelines for Licensed Ministers").

If, after a period of one (1) full year, he has been called to an approved work such as pastor, assistant pastor, youth minister, full-time evangelism, or missionary work, he may then be examined by the responsible ones of this body to determine his worthiness for ordination. The local church, of which he is a member, must be able to show proof of his worthiness as to his character, doctrine, ability, sincerity, and desire. If, after having been examined, he then be found worthy, he shall be ordained by this Association. All ordinations to the ministry must be approved at the annual session or at a quarterly meeting of the Jasper Association .If, after the period of one (1) full year has expired, the licensee has not been called to an approved work, his license may then be renewed each year or until he has been called to an approved work. No one may be ordained who has not been called to an approved work.

SECTION II. Candidates for ordination to the ministry shall present their request for ordination to the Credentials Committee, (using forms prepared and approved by this body), at least by the time of the last regular meeting prior to the ordination date requested.

SECTION III. Preachers coming to us from other Free Will Baptist Associations shall present their request for membership to the Credentials Committee at any quarterly meeting or any quarterly meeting or annual session and said request may be acted upon at that session.

SECTION IV. Preachers coming to us from other denominations shall present their requests to the Credentials Committee at any quarterly meeting or annual session. Such request shall be acted upon at the time of the following regular meeting be it quarterly meeting or annual session.

SECTION V. All ministers having been previously approved by this Association, shall receive a Card of good standing annually upon receipt of Church Letter listing all approved ministers of that Church.

SECTION VI. Each church shall have the right to select and ordain all deacons who serve in such church. The ordaining council shall consist of two ordained ministers and at least one deacon, or one ordained minister and at least two deacons.

ARTICLE IX DISCIPLINE

SECTION I. This body shall be considered an advisory council having no authority over the internal affairs of any local church unless said church depart from the Articles of Faith or from the National Treatise. Whenever conditions warrant it, this Association shall have power to withdraw fellowship from any local church.

SECTION II. Any church being dealt with because of a disciplinary problem shall represent to the quarterly meeting and annual session by letter and fees, but shall not have the right to vote by delegates, standing or otherwise, until the matter is settled. Exception: Any minister who is a member of such church but is ministering to another church that is in good standing with the Association shall not be so penalized.

SECTION III. All questions of doctrine and all matters pertaining to a local church, or to an individual minister or group of ministers, shall be decided by a two-thirds vote of this Association.

SECTION IV. No minister whose conduct is being questioned by this Association shall have the right to vote in either the quarterly meeting or annual session.

SECTION V. The pastor who preaches the word of God, ministers to the needs of the members, and exercises general leadership within the congregation is expected to unite with the local church if he is not a member when called..."

When the minister becomes pastor to a given local church, it is his responsibility to obtain good standing in the association of which that church is a member if he is not already in good standing therein." (A Treatise of the Faith and Practices of the Original Free Will Baptist, 1973, 50 A: Page 59B.)

SECTION VI. No church shall accept as members those who have not been baptized by an ordained minister.

ARTICLE X AMENDMENTS

This Constitution may be amended at any session of this association by twothirds vote of voting body present, provided proposed amendment is presented in writing, read, placed on the table, and acted upon during later session.

RULES OF DECORUM

- l. This Association shall be called to order by the moderator and presided over by officers elected at the previous annual session.
- 2. The association shall be opened and closed by singing and prayer.
- 3. The names of delegates shall be noted and referred to as often as is necessary.
- 4. The moderator shall not be entitled to a vote except in case of a tie and then he shall give a deciding vote. He shall be entitled to speak on any subject after others have spoken, provided someone else serves as moderator while he speaks.
- 5. Only one person shall speak at a time and he shall arise and address the moderator, and after recognition by the moderator, he shall proceed.
- 6. No person shall be interrupted while speaking unless he shall depart from the subject under discussion or use words of personal reflection.
- 7. No person will be allowed to speak more than twice on the same subject without permission from the moderator nor more that five (5) minutes at a time.
- 8. No person shall laugh or talk in a disturbing manner while discussion is going on.
- 9. No delegate shall absent himself from the association without leave of the moderator.
- 10. Any minister absent from the annual session of this association for two years in succession shall be dropped from the roll of ministers. Exception: Full-time evangelists or Missionaries serving in the other states or countries, students who are attending college, those serving in the armed forces.
- 11. These Rules or Decorum may be amended at any annual session of this association by the two-thirds vote of delegates present, provided proposed amendment is presented in writing, read one day, placed on the table, and acted upon the following day.

GUIDELINES FOR RETIRED MINISTERS TO BE ELIGIBLE FOR SUPPORT FROM JASPER ASSOCIATION

- 1. That the local church present in writing to the association a recommendation of the minister involved, stating his qualifications for support.
- 2. The proposed minister must have served in the Jasper Association for at least a total of ten (10) years as pastor of affiliated churches.
- 3. The proposed minister would be at least sixty-five (65) years of age or totally disabled.

GUIDELINES FOR LICENSED MINISTERS IN THE JASPER ASSOCIATION

I. RULES PERTAINING TO THE LICENSED MINISTER

- A. Qualifications for the Licensee
 - 1. He must be a member of a church which belongs to the Jasper Association.
- 2. He must give evidence to his church that he is divinely called to preach, whereupon the local church is authorized to examine him for license. This examination should include the areas of the candidate's life, doctrine, reputation, and his convictions and abilities regarding the work of the ministry. His present and prospective educational qualifications should also be considered. Upon completion of such an examination, the local church shall determine whether or not to grant license. The ministerial license shall be valid for a period of one year but is renewable annually.
- 3. He must have his license renewed annually by said church and kept in force until ordination.
- B. The Activities of the Licensee
- 1. According to the general practices of Free Will Baptist, a licensed minister is urged to afford himself of every opportunity to preach the word. He is free to exercise all the privileges and responsibilities of an ordained minister with the exception of officiating at the observances of the ordinances and weddings.
- 2. The licensee should consider the period between his receiving license and being ordained as a time of study and training in preparation for his calling. C. His Relationship to the Association
- 1. The clerk of the church should report the names of licensed ministers to the clerk of the Association who will forward a copy of these guidelines to each licensee.
- 2. Licensed ministers are expected to attend regular meeting of the Jasper Association and the Quarterly Meetings.

II. SUGGESTIONS FOR PREPARATION FOR ORDINATION

- A. Attend Free Will Baptist Colleges or Bible Institutes if possible.
- B. Seek the counsel of experienced pastors.
- C. Make as thorough a study as possible of the following:
 - 1. The Holy Bible
 - 2. Free Will Baptist Doctrine
 - 3. Systematic Theology
 - 4. Homiletics

6. Evangelism

7. Church History (especially FWB history)

III. SUGGESTED SCHEDULE OF WORK LEADING TO ORDINATION

- A. As soon as licensee feels that he is qualified to become a candidate for ordination, he should request a list of study questions from the Credentials Committee of the Association. We would strongly encourage him to proceed with his examination before entertaining a definite call to a church. However, no one may be ordained who has not been called to an approved work. (See ARTICLE VIII SECTION I).
- B. At least two months before the Credentials Committee meets, he should secure the examination. He should make five copies of the completed examination (one for each member of the Committee), and send them to the Credentials Committee no later than two months before its meeting.
- C. The candidate is required to pass an oral examination administered by the Committee.
- D. The Committee will report to the candidate on whether he passed or what areas he may need additional study in.
- E. When the approved candidate has passed the examination, the Committee will recommend his ordination to the Association. This recommendation will be made only after the candidate has been licensed for one full year. The candidate should have definite prospects of a church pastorate or another approved work that would justify his being ordained.
